
FORECAST AND ANALYSIS OF CALIFORNIA NEW LIGHT VEHICLE MARKET


New Light Vehicle Registrations Likely to Exceed 1.9 million units in 2015

The California new vehicle market remained on its steady upward path in the Fourth Quarter of 2014, and the positive trend is likely to continue in 2015 as well. New light vehicle registrations in the state were up 8.5 percent in the Fourth Quarter of last year, the third consecutive increase of greater than 8 percent. As shown on the graph below, the market has fully recovered from the recessionary low point in 2009. New light vehicle registrations in '09 were just above 1 million units. This year's predicted total of 1.91 million is 84 percent higher than the '09 total. Other key trends in the state market:

- Among the top 15 selling brands, Jeep, Lexus, Subaru, Mazda, and BMW had the biggest percentage increases in 2014.
 New registrations for each of the five brands increased by more than 15 percent (see page 2).
- Japanese brand registrations increased 9.5 percent last year and market share was up 0.7 points. Detroit Three market share declined, while Korean brands were up slightly.
- Used vehicle registrations increased 4.6 percent. Three year old or newer vehicles were up 13.7 percent, as supply shortages are easing.

California Quarterly New Light Vehicle Registrations: Percent Change vs. Year Earlier






Manufacturer Share of California New Vehicle Market 2014


RETAIL MARKET RECAP

New Retail Car Registrations in California Exceed 1 million Units in 2014

As shown on the graph below, retail sales have been the engine driving the state's automotive market during the past five years. New retail car and light truck registrations in California increased 93 percent last year from 2009 levels. Fleet registrations were up by just 14 percent during the same period.

The table below summarizes new retail light vehicle market results during 2013 and 2014. (Note: the information presented includes retail registrations only, and excludes fleet transactions.) The Southern California retail market increased 8.4 percent, while Northern California was up 8.0 percent.





Used Vehicle Market Starts to Recover; Market Increased 4.6 Percent in 2014

Below is a list of key trends in the California used vehicle market:


- Used registrations in the state increased 4.6 percent from 2013 to 2014.
- The California new vehicle market continued to post larger percentage gains. New registrations increased 8 percent in 2014. As shown on the graph below left, new vehicle registrations decreased slightly from the Third to the Fourth Quarter of last year (a typical seasonal event), while six year old or newer used registrations increased slightly.
- Used car registrations were up 4.7 percent last year, while light trucks increased 4.5 percent. Korean brand used registrations improved 21.8 percent.
- ➤ Toyota Camry narrowly beat Honda Civic as the best-selling model in the state for vehicles six years old or newer. Toyota Corolla, Honda Accord, and Nissan Altima followed Civic (see page 6).




Franchised Dealership Share of State Used Vehicle Market Exceeded 20% in 2014


Used and New Vehicle Registrations in California - 2012 thru 2014
