No.F.6(1)/2015-LGE(S):— Pursuant to the provisions of Article 140(A) of the Constitution of Islamic Republic of Pakistan, sub-section (2) of Section 34 of the Sindh Local Government Act, 2013 read with sub-rule (1) of Rule 12 of the Sindh Local Councils (Election) Rules, 2015 and all other powers enabling it in that behalf; the Election Commission of Pakistan hereby issues the schedule for 2<sup>nd</sup> Phase of Election to fill the category of seats of the member District Council from the Union Council, Chairman and Vice Chairman, directly elected Members in each Union Council and Union Committee and directly elected Members from the Wards of each Municipal Committee and Town Committee in the Local Institution of Districts Matiari, Tando Allahyar, Tando Muhammad Khan, Thatta, Sujawal, Badin, Hyderabad, Dadu, Jamshoro, Shaheed Benazirabad, Naushehro Feroze, Sanghar, Mirpurkhas, Umerkot and Tharparkar of Sindh Province and call upon the electors of each Union Council, Union Committee and Ward of the above mentioned districts to elect their representatives and specifies in relation thereto, the following dates:

- With a view to ensure that elections to the Local Governments of above mentioned districts are conducted in accordance with the provisions of Article 218(3) of the Constitution, the Election Commission of Pakistan directs that:
  - All Executive Authorities in the Federation and in the Provinces shall neither announce any development project nor use State Resources in Local Government Elections calculated to influence the elections in favour of a particular candidate;
  - (ii) If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under Section 68 of the Sindh Local Government Act, 2013;
  - (iii) No transfers / postings of the civil servants shall be made after the issuance of Election Schedule of the Local Government Elections without prior approval of the Commission till the publication of election results;
  - (iv) Any holder of public office, who is found to have violated any provision of Election Laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law;

Note: The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays during the schedule period.

All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours (08:00 A.M. to 04:00 P.M.) and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
