TERMS AND CONDITIONS :


1. The items are sold on an "AS IS, WHERE IS " basis. Thus, no warranty or representation as to functionality and serviceability.
2. A bidder is presumed to have viewed and inspected all items. Interested bidders may obtain further information from the PIA Disposal Committee Secretariat and inspect the unserviceable properties at the former PIA Gym provided that prior coordination is made with the Disposal Secretariat.
3. Each bid shall -
 - a. Contain a price offer for each lot. The highest total amount will be the winning bidder.
 - b. A Bidder's Bond, in cash or certified/managers check equivalent to 10% of the total amount of the bid. This amount shall be forfeited in case the winning bidder fails/refuses to pay the full amount of his/her total bid after issuance of **NOTICE OF AWARD**.
4. Upon receipt of notice of award the winning bidder shall immediately remove the items at the storage area, otherwise, storage cost shall be charge and/or the award will be forfeited at the

option of PIA.

5. Applicable taxes, fees and other imposts are sole responsibility of the winning bidder, including compliance with government rules and regulations relative hereto, if any.
6. This process is an invitation to make an offer. PIA reserves the right to reject any and all bids, waive any defect(s) and/or accept any offer that is more advantageous to the government.
