# 4. Transport (World Cup Rules Art. 11)

- Official airport: Prague Airport Václav Havel
- The organizing committee will arrange transportation between the Prague Airport Václav Havel and the hotels. 1 transport (from and to the airport) free of charge
- Price for additional transport:

Additional transports from Prague Airport to Nové Město na Moravě can be organized by the OC on request.

Price list transport Prague Airport – NMNM / NMNM – Prague Airport:

- 1-4 persons 150 € (personal car one way)
- 5-7 persons 200 € (minivan one way)
- 8-40 persons 500 € (bus one way)
  - Payment conditions: cash only during accreditation
  - Transport requests have to be sent to the OC until January 12th, 2016
- The transportation between the hotels and the stadium will be provided free of charge by the organizer on request.

#### 5. Payment (World Cup Rules Art. 10 and 13)

- Accommodation costs: Teams will pay directly in their hotels (accommodation costs for persons from the pay lists will be paid by the OC directly to the respected hotels).
- Carrying costs/Reimbursement :

  - All payments will be done by bank transfer or in cash (EUR)

### 6. Waxing facilities (World Cup Rules Art. 14)

# 9. Special permissions for truck driving

Vehicles with weight over 7.5 tones, and also vehicles over 3.5 tones with an attached trailer are prohibited to drive on Czech major roads and highways on Sundays from 13:00 – 22:00. Special permission may be obtained from the Czech Ministry of Transport in case of one-time sport events. The electronic toll system is applied on highways in the Czech Republic. The toll is applied to all motor vehicles with gross vehicle **weight over 3.5 tons**.






#### 10. Income tax information for prize money:

- For reducing the income tax for non-European citizen the athletes have to provide the confirmation for paying social taxes (Form A1 link to the form)


