**SC directs Centre to withdraw all orders making Aadhaar mandatory; Directs UIDAI not to share personal data with any govt. agency**

The Supreme Court has directed the Government of India to withdraw all orders, which make the Aadhaar card mandatory for availing any service.

The court has also directed the Unique Identification Authority of India (UIDAI) not to share any information pertaining to an Aadhaar card holder with any government agency without the prior permission of the card holder.

The Supreme Court was hearing the petitions challenging the Constitutional validity of Aadhaar card with those opposing the mega project saying it was not backed by any statute and compromises with national security.

**RBI to utilise unclaimed bank deposits of 3650 crore rupees for education and awareness among depositors**

The RBI has decided to utilise unclaimed bank deposits, which are estimated at 3,650 crore rupees for education and awareness of depositors. The apex bank has announced the Depositor Education and Awareness Fund Scheme for the purpose.

In a notification issued in Mumbai, RBI said the fund would be utilised for promotion of depositors' interest by imparting necessary education and awareness about the banking sector.

**Camera that made it to Moon fetches over 7 lakh dollars in auction in Vienna**

The only camera that made it to the moon and came back to Earth has fetched 7,60,000 dollars at an auction in Vienna.

The Hasselblad 500 was part of the equipment carried by the 1971 Apollo 15 mission, and the only camera ever brought back from the moon. Vienna auctioneers Galerie Westlicht identifies the new owner as Japanese businessman Terukazu Fujisawa.

The owner of an electronics chain placed his winning bid of 5,50,000 Euros by phone. Bidding had started on Saturday at 80,000 Euros or roughly 1,10,000 dollars.

## Another step for strengthening of coastal surveillance of Lakshadweep



The Crew and Officials with Indian Coast Guard Ship C-406 berthed at Embarkation Jetty, Kavaratti.

**Kavaratti:** Indian Coast Guard Ship C-406 arrived Kavaratti on 16 Mar. 2014 all the way from M/S L&T Surat for strengthening the coastal surveillance of

Lakshadweep islands. The ship was commissioned by Shri JS Saharia IAS, the Chief Secretary of Maharashtra on 17 Feb. 2014 at Mumbai.

The Commander, Indian Coast Guard District Headquarters No.12 (Lakshadweep) Kavaratti welcomed the Commanding

Officer and men on board at Katchery Jetty on arrival.

ICGS C-406 is commanded by Deputy Commandant Kunal Kumar, and has a complement of 11 Coast Guard personnel. ICGS C-406, an Interceptor class of Coast Guard Ship with 27.8 mtr length and 96 tons displacement is propelled with water jets and have endurance of 500 nautical miles at 25 knots and is capable of streaming at speeds upto 45 knots.

This vessel is fitted with latest state of the art navigation and communication equipment, medium range armament and an electro optical camera. The ship is capable to carry out search and rescue operations anti-piracy, anti poaching, medical evacuations in Lakshadweep waters.

**Malaysian PM says missing airliner MH370 with 239 people on board crashed into South Indian Ocean**

The Malaysian Government says that the Malaysia Airline aircraft which went missing with 239 people on board, has crashed in the southern Indian Ocean.

Malaysian Prime Minister Najib Razak made this announcement at a press conference in Kuala Lumpur today.

Najib said that the government has reached

the conclusion on the basis of information provided by British satellite company Inmarsat.

The Malaysia Airlines Boeing went missing on March 8, one hour after taking off from Kuala Lumpur. Five Indians and an Indo-Canadian were among the passengers on board the flight.

**ICC T-20 WC Cricket: India beat England in Mirpur**

New Delhi : India beat England by 20 runs in their second and final warm-up match of the ICC Twenty-20 Cricket World Cup at Mirpur.

Earlier England won the toss and elected to field. India scored 178 runs at the loss of four wickets in 20 overs. Virat Kohli scored unbeaten 74 runs and SK Raina was out at 54 runs.

In Group-B qualifier, Ireland beat United Arab Emirates by 21 runs under the Duckworth-Lewis method in a rain-affected match at Sylhet.

South Africa beat New Zealand by two runs, while Sri Lanka defeated The Netherlands by 9 wickets in the two group matches of the ICC Twenty20 World Cup at Chittagong, Bangladesh.

**Kavaratti:** In a progressive move to ensure the long-term well-being of fish stocks in the Indian Ocean, the Fisheries Department of Lakshadweep, on 12<sup>th</sup> March, 2014, issued an order temporarily restricting fishing around the northern island of Bitra for two weeks in the months of March and April this year. The order (F.No. 45/2/2007FY) follows the discovery that a unique phenomenon known as an 'aggregation' of a fish species called square-tail groupers takes place around the island several times during the first quarter of every year. Groupers are a mid-sized fish valued as food in foreign markets. During aggregations, numerous adult groupers gather in a small area to spawn, making them highly vulnerable to threats.

Cell) S N Srivastava said, one of the arrested terrorist is a Pakistani national named Waqas who is wanted in connection with several blasts in the country including the serial blasts at Zaveri Bazaar in Mumbai on 12th of July in 2011.

He said that Waqas was arrested in Ajmer yesterday morning.

**Unique Groupers Fish Aggregation**

If such aggregations are subjected to fishing, not only would a large fraction of adults in the population be lost, but also the annual reproduction of this species would be seriously affected. Eventually, the entire population of groupers could itself be lost.

Interestingly, the fishing restriction was also formally requested by the Village Dweep Panchayat of the island of Bitra, when it was informed that commercial fishing boats were likely to have removed over three tons of groupers during the aggregations that took place in February alone this year. One of the researchers studying the aggregation said, "Groupers are never a big concern or preferred food species for the island-

ers of Bitra. Yet, when they learnt about the potential danger to groupers, it was admirable that the islanders came forward to protect the unique phenomena."

The order, issued on 12 March 2014, is a rare marine fisheries regulation based on actual, "in water" population of the species rather than usual catch landing data or computer-generated models which act only as a proxy for population status. Researchers working in the area point out that the proposed order was intimated to stakeholders much before ratification, and that such communications go a long way to improve understanding and acceptance of such measures. Efforts are also ongoing to sensitize

commercial boat owners about the uniqueness and importance of the grouper spawning aggregation.

Additionally, the response by the Lakshadweep administration, the Fisheries Department along with the Departments of Science and Technology at Director's Levels as well Forest and Environment is a unique example of conservation action for a species that does not have protection under the Wild Life Protection Act (1972). It sets a crucial precedent for the conservation of species and areas that are not listed in the Act. It also demonstrates that timely government interventions and co-ordination, as has been shown by the Lakshadweep Administration, can ensure that long-term existence of a natural resource is valued over short-term profits.

The Special Commissioner said, Waqas's motive was to meet his aides in Ajmer and plan a terrorist attack. Mr Srivastava said that the Rajasthan Anti Terrorist Squad assisted the Delhi Police in nabbing the fugitives. He said, a huge cache of arms and explosives including detonator, electronic circuits were

recovered from those arrested.

Meanwhile, the Rajasthan Police has issued a red alert in the entire state especially in Jodhpur and Jaipur in view of the arrest of the terrorists. Security has been beefed up at airports, railway stations, hospitals

and important religious places. Hotels have been asked to keep an eye on the movement of visitors.

Termining the arrest of four suspected Indian Mujahideen terrorists by special cell of Delhi Police as a "big success", Home Minister Sushilkumar Shinde today said it would

## Missing Malaysian plane: Chinese planes spot suspicious objects in southern Indian Ocean

**New Delhi :** Chinese planes today spotted suspicious objects in the southern Indian Ocean as the search for the missing Malaysian plane MH370 intensified with more nations joining the hunt for the missing jet in the desolate area.

The white and square objects were spotted by crew of a Chinese plane searching for the Malaysia Airlines. Australia said it had been informed and would try to locate the objects.

According to Australian Maritime Safety Authority 10 aircraft were involved in today's search for the plane.

France provided new satellite images of possible debris of the airliner while in another possible lead, Australia said it has spotted a wooden cargo pallet in the southern Indian Ocean, expressing increasing hope of a breakthrough in locating the jet.

Intense search is on for the Malaysian plane that went missing on 8<sup>th</sup> march with 239 people on board as India, China and Japan also deploying surveillance aircraft.
