	NARRATIVE DESCRIPTION (What victim(s) said/what the mandated reporter observed/what person accompanying the victim(s) said/similar or past incidents involving the victim(s) or suspect) Gigi Jordan, mother of a boy, Jude Jordan (DOB: 07/13/2001), reports that Jude has recently (since early, 2008) disclosed to her that Emille Tzekov (Jude's biological father who has relinquished his parental rights) abused him (Jude), including oral penetration, anal penetration (unknown if digital or penile), forced ingestion of feces, putting needles under his fingernails and in the webs between his fingers, choking him, and needle-pricking his chest and legs. Jude has suffered developmental delays and medical conditions that may be a direct effect of this alleged abuse. Gigi Jordan is concerned that Mr. Tzekov may be similarly abusing his one-to-two-year-old son, whom she has never met, but whom she believes exists. Gigi Jordan will respond to questions at (303) 371-9400. She requests that any investigation include great care not to divulge any information to Mr. Tzekov that would cause him to suspect that she provided the information leading to this report of suspected child abuse.

Dear Mr. Tili,

Thank you for calling me back for additional information on 3/31/2008, in response to my report to San Francisco Child Protective Services of 3/30/2008. You requested a list of names of the people suspected of being involved. The names below were provided to me by Gigi Jordan, who reports that her son, Jude Jordan, identified these people as being involved in his abuse.

Gigi Jordan: Mother of Jude. Date of Birth: 12/2/60.

Resided with her son in San Francisco in early 2008, much of 2007, and probably earlier.

Mother and son also lived in Montecito, CA (Santa Barbara County) in recent years.

Legal residence: 272 Ridge Drive, Stateline, NV 89449

Ms. Jordan reports that shortly prior of February 4, 2008, Jude told to his mother that his adoptive father, Ray Mirra (Date of birth: 6/22/1958), his biological father, Emille Tzekov (Date of Birth: 8/14/1970), Ray's wife, Shawna Mirra, and Sarah Flatley, planned in the car, with Jude present, to kill Jude, Ms. Jordan, and Ms. Jordan's psychologist. He also began to disclose these people's extensive sexual and physical abuse of himself. Ms. Jordan took her son into hiding from the alleged abusers in a hotel.

February 4, 2008, Ms. Jordan first contacted me, having found me through my website on ritual abuse (www.endritualabuse.org), concerned that ritual abuse might explain her son's behaviors and the disclosures he had begun to make, Jude's behaviors and disclosures, reported by Ms. Jordan, were consistent with that of other victims of ritual abuse. Ms. Jordan retained me to provide her with consultation to help her to keep her son safe and to help him psychologically. Ms. Jordan had also retained a number of attorneys and security specialists to try to keep her son and herself safe. She initially provided me with no names except her own.

Near February 7, 2008, Ms. Jordan's therapist made a suspected child abuse report.

On February 13, 2008, 7:32pm, I made a suspected child abuse report to San Francisco Child Protective Services, P. O. Box 7988, San Francisco CA 94120 by phone with Dwayne Kinner. I was only able to provide the name of Ms. Jordan. I explained that mother and son were in hiding. Mr. Kinner asked how Ms. Jordan had learned of me. I told him that it was through my website. Mr. Kinner expressed to me his suspicion about the existence of ritual abuse.

3/28/2008, Friday, Ms. Jordan took her son to Wyoming to obtain help from Flint Waters, Wyoming Division of Criminal Investigation of the Wyoming, and of the Internet Crimes Against Children Task Force, since her had reported his having been used for child pornography. Mr. Waters sent police to the airport to provide her Jude and Ms. Jordan with protection. The police questioned Ms. Jordan and did not believe her disclosures. They placed her on a 72-hour hold in Cheyenne Regional Medical Center Behavioral Unit, and placed her son with Family Services.

3/31/2008, the hospital released Ms. Jordan on her own recognizance prior to her scheduled hearing of 4/1/2008, apparently having assessed her as credible and sane.

Jude Jordan: DOB: 07/13/2001. School: Mission Delores School, 16th and Delores, San Francisco

This is a private school. Jude has speech delays. Ms. Jordan reports that Jude has been extensively evaluated since he was small for apparent developmental delays and medical problems. She reports that some people believed Jude to have autism. But, she claims that top autism experts have told her that his symptom picture did not really fit autism.

Ms. Jordan reported to me on 3/30/2008 that her son identified the following abusers and victims: (I will try to get further information. She could only talk to me briefly while in the hospital)

Residing in California:

Emille Tzekov. Male. DOB: 8/14/1970. Birth father of Jude Jordan.

Sarah Flatley, currently in San Francisco, will be relocating to Pennsylvania.

Gabe Womvle. Age 15.

Rita Cristman

Ed Cristman

Victims: children of the Cristman: Thea (10-girl) and Julian (15-boy)

Henry (child victim)

Henry's parents are abusers

Other child victims named whose parents are not abusers:

Hoard, Bea (girl-2), Gabriella (girl-6) and Isabella (girl-10)

Gabriella and Isabella attend the San Francisco School

Their non-abusive parents are Lisa and Jeff Hoard of 22nd street in Noe Valley, near San Francisco, between Noe Street and Sanchez.
