# 法庭服務指南

## 香港特別行政區的法院及司法機構

司法機構負責本港的司法工作,聆訊一切檢控及民事訴訟,完全獨立於行政及立法機構。

## 香港特別行政區的法院架構是怎樣的?

終審法院是香港特別行政區最高的上訴法院,根據香港法例 第484章《香港終審法院條例》及其他法例所賦予的權力,處 理針對高等法院(上訴法庭及原訟法庭)的民事及刑事判決 而作出的上訴及有關事項。

上訴法庭負責處理來自原訟法庭和區域法院民事、刑事案件的上訴,同時亦處理競爭事務審裁處、土地審裁處、各審裁 處及其他法定組織的上訴。

原訟法庭對民事和刑事案件均有無限的司法管轄權。該法庭 亦處理來自各級法院的上訴,包括裁判法院、小額錢債審裁 處、淫褻物品審裁處、勞資審裁處及小額薪酬索償仲裁處。 在刑事審訊中,原訟法庭法官與7人陪審團一起審理案件;而 在法官的特別指令下,陪審團的成員數目可增至9人。

競爭事務審裁處是根據香港法例第619章《競爭條例》設立的 高級紀錄法院,負責處理有關競爭事宜的法律程序。

區域法院處理涉及款項5萬元以上、但不超過100萬元的民事訴訟,而刑事案件中,區域法院法官的判刑上限是7年監禁。

家事法庭主要負責處理離婚及有關的事宜<sup>,</sup>包括贍養費及子 女的福利等。

本港共有7所裁判法院,裁判法院的刑事司法管轄權非常廣泛,負責審理多種可公訴罪行及簡易程序罪行,判刑上限為監禁2年和罰款10萬元。但是,當法庭同時處理兩項或以上的可公訴罪行時,裁判官可判處最高3年的刑期。就某些條例而言,單一罪行可判監禁3年和罰款500萬元。

土地審裁處有權力裁定業主根據香港法例第7章《業主與租客(綜合)條例》或普通法而提出的收回樓宇管有權申請,及審理有關建築物管理的爭議,審裁處亦有權力裁定政府因進行公共發展而根據有關條例強制收回土地而需評估賠償的申請,及審理差餉租值/地租值上訴和《房屋條例》涵蓋的處所

的市值評估上訴。多數份數業主根據香港法例第545章《土地 (為重新發展而強制售賣)條例》為售賣土地重新發展而提出申 請,審裁處有權力作出裁定。

勞資審裁處審理勞資糾紛,索償款額並無上限,但所處理的申索,必須是在同一申索中至少有一名申索人所追討的款項是超過8千元,或該申索涉及超過10名申索人。審裁處採用非正式的聆訊模式,訴訟雙方不得由律師代表。

小額錢債審裁處審理其享有司法管轄權之民事申索案件,但 款額不可超過5萬元。這裡採用非正式的聆訊模式,而訴訟雙 方不得由律師代表。

淫褻物品審裁處為物品或在公眾地方展示的其它事物鑑定類 別,並且評定是否含淫褻或不雅成分。

死因裁判法庭負責調查死亡個案及如認為有需要的話,進行 研訊。

少年法庭負責審理被控人為兒童或16歲以下的少年人的案件,但不包括殺人罪。此外,少年法庭也可為兒童或少年人發出照顧或保護令。該法庭分別設於東區、九龍城、荃灣、粉嶺及屯門裁判法院內。

# 法律參考資料及圖書館組

司法機構圖書館約有館藏197,000冊,基本上都是普通法方面的資料,主要存放於高等法院圖書館、終審法院圖書館及區域法院圖書館內。另外於各內庭、裁判法院及審裁處亦存有一些藏書供法官及司法人員使用。高等法院圖書館收藏了超過65,000冊書籍及期刊;終審法院圖書館及區域法院圖書館則分別收藏約9,200及10,700冊。司法機構圖書館提供法律參考及資訊服務、影印和其他服務予法官及司法人員、司法機構職員、法律專業人士和法律系學生。

## **GUIDE TO COURT SERVICES**

## Hong Kong's courts and its judiciary

The Judiciary is responsible for the administration of justice in Hong Kong. It hears all prosecutions and civil disputes. It is completely independent of the executive and legislative branches of the Government.

## What is the structure of Hong Kong courts?

The Court of Final Appeal is the highest appellate court in the Hong Kong Special Administrative Region. It has jurisdiction in respect of matters conferred on it by the Hong Kong Court of Final Appeal Ordinance, Cap. 484 and by any other law. It hears appeals on civil and criminal matters from the High Court (the Court of Appeal and the Court of First Instance).

The Court of Appeal hears appeals on all civil and criminal matters from the Court of First Instance and the District Court. It also hears appeals from Competition Tribunal, Lands Tribunal and various Tribunals and Statutory Bodies.

The Court of First Instance has unlimited jurisdiction in both civil and criminal matters. It also hears appeals from Magistrates' Courts, the Small Claims Tribunal, the Obscene Articles Tribunal, the Labour Tribunal and the Minor Employment Claims Adjudication Board. For criminal trials, judges of the Court of First Instance sit with a jury of seven (nine on the special direction of the judge).

The Competition Tribunal is a superior court of record set up by the Competition Ordinance, Cap 619 to deal with legal proceedings concerning competition matters.

The District Court hears civil disputes of a value over \$50,000 but not more than \$1 million. Its criminal jurisdiction is limited to 7 years' imprisonment.

The Family Court deals mainly with divorce cases and related matters such as maintenance and the welfare of children.

There are 7 Magistrates' Courts. They exercise criminal jurisdiction over a wide range of indictable and summary offences meriting up to 2 years' imprisonment and a fine of \$100,000. However the court may impose sentences of up to 3 years' imprisonment where there are two or more indictable offences being dealt with at the same time. Indeed under some Ordinances a single offence may carry 3 years' imprisonment and a fine of \$5 million.

The Lands Tribunal has jurisdiction to determine applications by

landlords for possession of premises under the Landlord and Tenant (Consolidation) Ordinance, Cap. 7 or under the Common Law. The Tribunal also deals with cases arising from disputes in relation to building management. The Tribunal also hears applications for the determination of compensations caused by land resumption and payable by the Government because of public developments pursuant to the relevant ordinances, and determine appeals against the assessment of rateable value / government rent or market value of property under the Housing Ordinance. The Tribunal can determine applications made by majority owners of a land for the sale of the land for redevelopment purpose under the Land (Compulsory Sale for Redevelopment) Ordinance, Cap. 545.

The Labour Tribunal deals with labour disputes. There is no upper limit on the amount of claim, but the Tribunal only hears cases which the amount of claim exceeds \$8,000 for at least one of the claimants in a claim or which the number of claimants in the claim exceeds 10. Hearings are informal and no legal representation is allowed.

The Small Claims Tribunal hears civil claims within its jurisdiction of up to \$50,000. Hearings are informal and no representation by lawyers is allowed.

The Obscene Articles Tribunal determines and classifies whether or not an article or other matter publicly displayed is obscene or indecent.

The Coroner's Court conducts investigations and if necessary holds inquests into the deaths.

The Juvenile Court hears charges against children or young persons under the age of 16, except where the charge is one of homicide. It may also make care or protection orders in respect of children or juveniles. It sits in the Eastern, Kowloon City, Tsuen Wan, Fanling and Tuen Mun Magistrates' Courts.

## **Legal Reference and Library Section**

The total collection of the Judiciary Libraries is about 197,000 volumes basically of common law materials housed mainly in the High Court Library, Court of Final Appeal Library and District Court Library. Some collections are located in the chambers, Magistrates' Courts and Tribunals for judges and judicial officers. More than 65,000 volumes of books and serials are located in the High Court Library and about 9,200 and 10,700 volumes are respectively in the other two libraries at the Court of Final Appeal and the District Court. The Judiciary Libraries provide legal reference and information services, photocopying and other services to the judges and judicial officiers, staff of the Judiciary, members of the legal profession and law students.

Enquiries about application for the use of library facilities may be made to the High Court Library.

## **Court Language Section**
