## Regulation of the Centro Studi Giuridici Europei

(English translation —only the Italian text is authentic— [interpolations are written in red blocks in square braquets])

- **Art. 1.—** To obtain the *«Attestato di frequenza»* [certificate of attendance] of the Centro Studi Giuridici Europei, one must demonstrate one has attended the lectures of the European Law Seminar for at least 24 hours.
- Art. 2.— To obtain the "Diploma di diritto comparato" [Diploma of comparative law] of the Centro Studi Giuridici Europei, one
  - a) be holder of a laurea specialistica in Giurisprudenza or a laurea magistrale in Giurisprudenza [5-year Italian equivalents of English LL.B.] or an equivalent diploma (the admissibility of the diploma is assessed unilaterally by the Secretary of the European Law seminar);
  - b) have attended the lectures of the Seminar for two years, whether they are consecutive or not;
  - c) have passed, for each one of the two years of attendance to the seminar, the examinations for three subjects chosen among the lectures given during the two weeks of the seminar, provided that these three lectures were not all given during the same week. For each one of the two years of attendance to the seminar, at least two of those three exams must be passed in another language than the native language of the student.
- **Art. 3.—** The "*Diploma di Studi Europei*" [*Diploma in European studies*] of the Centro Studi Giuridici Europei may be awarded to students who are not holders of the diploma required at article 2, *litt*. a, but who attended the lectures and passed the exams in accordance with *litt*. b) and c) of article 2.
- **Art. 4.—** To pass an examination, the student must obtain a score between 18/30 and 30/30. Professors may grant honours at their discretion.
- Art. 5.— To obtain the « Diploma di Diritto europeo approfondito » [postgraduate diploma of specialization in European law] or the « Diploma di Studi europei approfonditi » [postgraduate diploma of specialization in European studies], one must:
  - a) have attended the lectures of the Seminar for three years, whether they are consecutive or not;
  - b) be holder of the *«Diploma di diritto europeo»* or, respectively, the *«Diploma di Studi Europei»* mentioned at the articles 2 and 3 of this regulation;
  - c) pass an oral examination assessing a dissertation, the subject of which must have been chosen at least a year prior to the examination, with the consent of a member of the teaching staff.
- **Art. 6.—** The subject of the dissertation must have been communicated to and approved by the Board of directors of the Centro Studi Giuridici Europei.
- **Art. 7.—** Two copies of the dissertation must be sent to the secretary of the Seminar at least one month before the oral examination. Both copies, a final version of which must be supplied, shall be signed by the assistant of the examination panel. The assistant of the examination panel shall certify the two copies of the final version he or she has received as conform copies.
- **Art. 8.—** The examination panel is composed of the Head of the Law Faculty or a substitute he/she has appointed, the director of the Seminar or a substitute he/she has appointed, and the professor assisting the examination panel. The minutes of the oral examination shall be filed in the register of the minutes of the Centro Studi Giuridici Europei.
