WHICH HOOSIER OCCUPATIONS MAY SUFFER FROM A SKILLS GAP?

The direct identification of a skills gap in a particular occupation is difficult. While business and industry leaders provide anecdotal evidence of occupational shortage, these claims are not sufficient to identify a skill gap. This is simply because difficulty in filling open positions might have other causes. For example, businesses might find insufficient workers because the offered wage is not high enough to command workers with the right skills.

Overall changes in the number of workers in a particular occupation may also be misleading. For example, the quantity of jobs in a particular occupation could rise or fall in the face of a skills gap. A skills gap could mean there are too few works to meet demand, and so the number of workers in that occupation could decline due to a skills gap. Conversely, there could be extraordinary demand for a worker in an occupation but insufficient skills within the labor force to accommodate that growth. So, the actual number of workers employed offers little evidence of a skills gap.

The only truly good evidence of the existence of a skills gap is provide by wage data. Employers are bound by the laws of economics, and as such, will pay more for the right workers in occupations in which there is a skills gap. Wage growth alone is not a sufficient condition in the identification of a skills gap. It is however a necessary condition: If a skill gap exists, the shortage of skilled workers willput upward pressure on wages leading to increase in real (inflation adjusted) wages.

To help identify which occupations potentially suffer a skills gap in Indiana, we consult the Bureau of Labor Statistics, Occupation and Employment Data. We focus on 786 occupations found in Indiana, examining wage growth from 2008 through 2011 (the most recent data available). In the following tables we report the occupational code and occupational title from 2011, the mean hourly wage in both 2011 and 2008, and the nominal and inflation adjusted wage growth for each occupation. We also include occupations which have



become newly classified since 2008, inferring from their newness that they are in higher demand and may suffer a skills gap.

Not all the occupations on this list suffer a skills gap. Some occupations, especially those which are not sensitive to labor markets (such as postmasters and judges) may experience wage growth unrelated to skill shortages. Also, occupations may experience significant labor derived productivity growth, and thus experience wage growth unrelated to the available supply of workers. It is difficult to disentangle the impact of productivity increases and a skills gap, particularly in production related occupations. We note that dishwashers have experienced wage growth, which is unlikely to be due to a skills shortage. Also, union contracts may play a role in wage changes that are not linked to skills shortage. Moreover, a very modest level of wage growth may be the artifact of the type of statistical sampling employed by the Bureau of Labor Statistics. Still, occupations do not experience wage increases cannot be shortage occupations.

Finally, this is state-level data, and labor markets are local. There could be a shortage of workers with the right skills in one location, and a surplus in another. This disequilibrium in labor markets should be viewed as temporary, as households and businesses migrate. This list should be helpful in identifying which occupations are currently facing a skills gap in Indiana. However, the presence of an occupation on this list does not guarantee there is a skills gap or shortage associated with it. Roughly 48 percent of Indiana occupations have experienced wage growth in inflation-adjusted terms since 2008.
