ORDINANCE NO. 237-61

CALLING AND PROVIDING FOR A SPECIAL ELECTION TO BE HELD IN THE CITY AND COUNTY OF SAN FRANCISCO ON TUESDAY, NOVEMBER 7, 1961, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS OF THE CITY AND COUNTY OF SAN FRANCISCO PROPOSITIONS TO INCUR BONDED DEBTS OF THE CITY AND COUNTY FOR THE ACQUISITION, CONSTRUCTION AND COMPLETION BY THE CITY AND COUNTY OF SAN FRANCISCO OF THE FOLLOWING MUNICIPAL IMPROVEMENTS, TO WIT: \$115,000,000 MUNICIPAL WATER SYSTEM; \$1,100,000 FORT FUNSTON; \$3,282,000 PUBLIC WELFARE; AND THAT THE ESTIMATED COST TO THE CITY AND COUNTY OF SAID MUNICIPAL IMPROVEMENTS IS AND WILL BE TOO GREAT TO BE PAID OUT OF THE ORDINARY ANNUAL INCOME AND REVENUE OF THE CITY AND COUNTY AND WILL REQUIRE EXPENDITURES GREATER THAN THE AMOUNTS ALLOWED THEREFOR BY THE ANNUAL TAX LEVY; ALL IN ORDER TO DO AND PERFORM ANY AND ALL OF THE MATTERS HEREINABOVE REFERRED TO; FIXING RATE OF INTEREST OF SAID BONDS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY BOTH PRINCIPAL AND INTEREST THEREOF, PRESCRIBING NOTICE TO BE GIVEN OF SUCH ELECTION AND CONSOLIDATING THE SPECIAL ELECTION WITH THE GENERAL MUNICIPAL ELECTION.

Be it ordained by the People of the City and County of San Francisco:

Section 1. A special election is hereby called and ordered to be held in the City and County of San Francisco on Tuesday, the 7th day of November, 1961, for the purpose of submitting to the electors of said city and county propositions to incur bonded indebtedness of the City and County of San Francisco for the acquisition, construction and completion by the city and county of the hereinafter described municipal improvements in the amounts and for the purposes stated:

(a) MUNICIPAL WATER SYSTEM BONDS, 1961.

\$115,000,000 to pay the cost of the improvement of the municipal water supply system, including water storage, transmission and distribution facilities, pipelines, tunnels, dams, reservoirs, additions to existing reservoirs, pumping plants, planning and designing of all facilities, and enlargement of Don Pedro Dam for storage of water allocated to irrigation districts under the Raker Act to augment the storage capacity of the Hetch Hetchy system, together with lands, easements, rights of way, access roads, pipes, pumps, machinery and all other works, property and structures necessary or convenient therefor;

(b) FORT FUNSTON BONDS, 1961.

\$1,100,000 to pay the cost of approximately 116.394 acres of land, and all structures thereon, constituting part of the property known as Fort Funston in the City and County of San Francisco, title to which is vested in the United States of America, and incidental expenses connected with the acquisition of said property, to be used for recreation and park purposes;

(c) PUBLIC WELFARE BONDS, 1961.

\$3,282,000 to pay the cost of the acquisition of land within the City and County of San Francisco for construction of a building thereon and the necessary equipment of the same, incidental expenses connected with the acquisition of said property, and all other works, properties and structures necessary or convenient thereto, to be used for the conduct and transaction of the business of the Public Welfare Department of the City and County.

Section 2. The estimated costs of the municipal improvements described in Section 1 hereof were fixed by the Board of Supervisors by the following resolutions and in the amounts specified:

Municipal Water Bonds, Resolution No. 291-61, \$115,000,000; Fort Funston Bonds, Resolution No. 438-61, \$1,100,000; Public Welfare Bonds, Resolution No. 478-61, \$3,282,000.

That all of said resolutions were passed by more than two-thirds of the Board of Supervisors and Resolution No. 291-61 approved by the Acting Mayor, and Resolution No. 438-61 and Resolution No. 478-61 approved by the Mayor, and in each of said resolutions it was recited and found that the sums of money specified were too great to be paid out of the ordinary annual income and revenue of the city and county in addition to the other annual expenses thereof or other funds derived from taxes levied for those purposes and will require expenditures greater than the amounts allowed therefor by the annual tax levy.

The method and manner of payment of the estimated costs of the municipal improvements described herein are by the issuance of bonds of the City and County of San Francisco in the principal amounts specified.

Said estimates of cost as set forth in said resolutions, and each thereof, are hereby adopted and determined to be the estimated costs of said improvements, and each thereof.

Section 3. The special election hereby called and ordered to be held shall be held and conducted and the votes thereat received and canvassed, and the returns thereof made and the result thereof ascertained, determined and declared as herein provided and in all particulars not herein recited said election shall be held according to the laws of the State of California providing for and governing elections in the City and County of San Francisco, and the polls for such election shall be and remain open during the time required by said laws.

Section 4. The said special election hereby called shall be and hereby is consolidated with the General Municipal Election to be held Tuesday, November 7, 1961, and the voting precincts, polling places and officers of election for said General Municipal Election be and the same are hereby adopted, established, designated and named, respectively, as the voting precincts, polling places and officers of election for said special election hereby called, and as specifically set forth, in the official publication, by the Registrar of Voters of precincts, polling places and election officers for the said General Municipal Election.

The ballots to be used at said special election shall be the ballots to be used at said General Municipal Election and reference is hereby made to the notice of election setting forth the voting precincts, polling places and officers of election by the Registrar of Voters for the General Municipal Election to be published in the San Francisco Chronicle on or about October 20, 1961.

Section 5. On the ballots to be used at such special election and on the voting machines used at said special election in addition to any other

matter required by law to be printed thereon, shall appear thereon the following, each to be separately stated, and appear upon the ballots as separate propositions:

(a) "Municipal Water System Bonds, 1961. To incur a bonded indebtedness in the sum of \$115,000,000 for the acquisition, construction and completion of transmission and distribution facilities, dams, reservoirs, and all other works, properties and structures for the Municipal Water Supply System improvements."

(b) "Fort Funston Bonds, 1961. To incur a bonded indebtedness in the sum of \$1,100,000 for the acquisition of approximately 116.394 acres of land, constituting part of Fort Funston, all structures thereon, and incidental expenses, for recreation and park purposes."

(c) "Public Welfare Bonds, 1961. To incur a bonded indebtedness in the sum of \$3,282,000 for acquisition of land and construction of a building thereon, and equipment of same for the conduct and transaction of business of the Public Welfare Department."

To vote for any proposition where ballots are used, and to incur the bonded indebtedness to the amount of and for the purposes stated herein, stamp a cross (x) in the blank space to the right of the word "Yes." To vote against any proposition and thereby refuse to authorize the incurring of a bonded indebtedness to the amount of and for the purposes stated herein, stamp a cross (x) in the blank space to the right of the word "No."

Where voting machines are used at said special election said voting machines shall be so arranged that any qualified elector may vote for any proposition by pulling down a lever over the word "Yes" under or near a statement of the proposed proposition appearing on cardboard, paper or other material placed on the front of the machine, and said act shall constitute a vote for the proposition, and by pulling down a lever over the word "No" under or near a statement of the proposed proposition appearing on cardboard, paper or other material placed on the front of the machine, shall constitute a vote against the proposition. Said voting machines and the preparation of the same shall comply in all respects with the provisions of law.

Section 6. If at such special election it shall appear that two-thirds of all the voters voting on said proposition voted in favor of and authorized the incurring of a bonded indebtedness for the purposes set forth in said proposition, then such proposition shall have been accepted by the electors, and bonds shall be issued to defray the cost of the municipal improvements described herein. Such bonds shall be of the form and character known as "serials," and shall bear interest at a rate not to exceed 6 per centum per annum, payable semiannually.

The votes cast for and against each of said respective propositions shall be counted separately and when two-thirds of the qualified electors, voting on any one of such propositions, vote in favor thereof, such proposition shall be deemed adopted.

Section 7. For the purpose of paying the principal and interest on said bonds, the Board of Supervisors shall, at the time of fixing the general tax levy and in the manner for such general tax levy provided, levy and collect annually each year until such bonds are paid, or until there is a sum in the Treasury of said city and county set apart for that purpose to meet all sums coming due for the principal and interest on said bonds, a tax sufficient to pay the annual interest on such bonds as the same become due and also such part of the principal thereof as shall become due before

the proceeds of a tax levied at the time for making the next general tax levy can be made available for the payment of such principal.

Section 8. This ordinance shall be published once a day for at least seven (7) days in the San Francisco Chronicle, a newspaper published daily in the City and County of San Francisco, being the official newspaper of said city and county and such publication shall constitute notice of said election and no other notice of the election hereby called need be given.

ARGUMENT FOR PROPOSITION "A"

The drought for the past three years has created a water shortage that makes the immediate enactment of Proposition "A" an urgent necessity.

San Francisco for years has had one of the finest water systems of any city in the world. It has created and maintained that system independently of any State water system. (The State Water Program you voted on last year had nothing to do with San Francisco.)

San Francisco, as in the past, has to take care of its own water supply and Proposition "A" carries on that tradition of farsightedness and intelligent planning.

And it does it WITHOUT A CENT OF TAXES.

NO TAXES—to expand our pipeline delivery capacity to keep ahead of our needs for the next 25 years.

NO TAXES—to provide water storage in the mountains so that no foreseeable future drought would give us any cause for worry, up to the year 2015.

Not only does it cost nothing in taxes, but makes it possible for San Francisco to reduce its water rates.

There never was a better bargain offered to any community. All it costs you is the time it takes to vote Yes on Proposition "A" this November 7.

Why Proposition "A" Will Cost Nothing

Proposition "A" will cost nothing because the bonds to be issued to construct the pipelines and the dams will be entirely paid for out of the revenue from water and power. This is nothing new—this is the way San Francisco has been paying for its water program right along.

It's the best water program in the State of California. The planning began back in 1901 when steps were first taken to obtain the rights to the Hetch Hetchy water of the Yosemite National Park. Over the years, those rights have been obtained; a water system has been constructed that has served well and faithfully; and from time to time, with the expansion of population, and the increase in the per capita consumption of water, the system has been enlarged and improved.

Proposition "A" is the latest and greatest in a long line of steady intelligent improvements.

How Proposition "A" Insures Our Water Supply

Proposition "A" meets the needs of the San Francisco system in two ways:

1. It expands the system delivery capacity to 305 million gallons a day, or enough to meet all needs until 1985. The present capacity is 180 million gallons, and the present rate of use is 170 million gallons a day. The citizens' group supporting Proposition "A" has prepared a chart that makes this development most vivid. You will find it in the argument prepared by the Water for San Francisco Committee.

2. It more than doubles our capacity to store the excess water of the "wet" years, which would otherwise be wasted. The huge new Don Pedro Dam alone will make available for San Francisco an additional 740,000 acre feet of water as a safeguard against drought years.

This bond issue, because it is self-liquidating, will not require any support from taxes. This is attested by the conclusion of the City Controller, Harry D. Ross: "In my opinion the servicing of the proposed bonded debt will not affect the tax rate of the City and County of San Francisco."

Proposition "A" Has Universal Support

"If it doesn't cost anything in taxes, where will the money come from?" is the natural question.

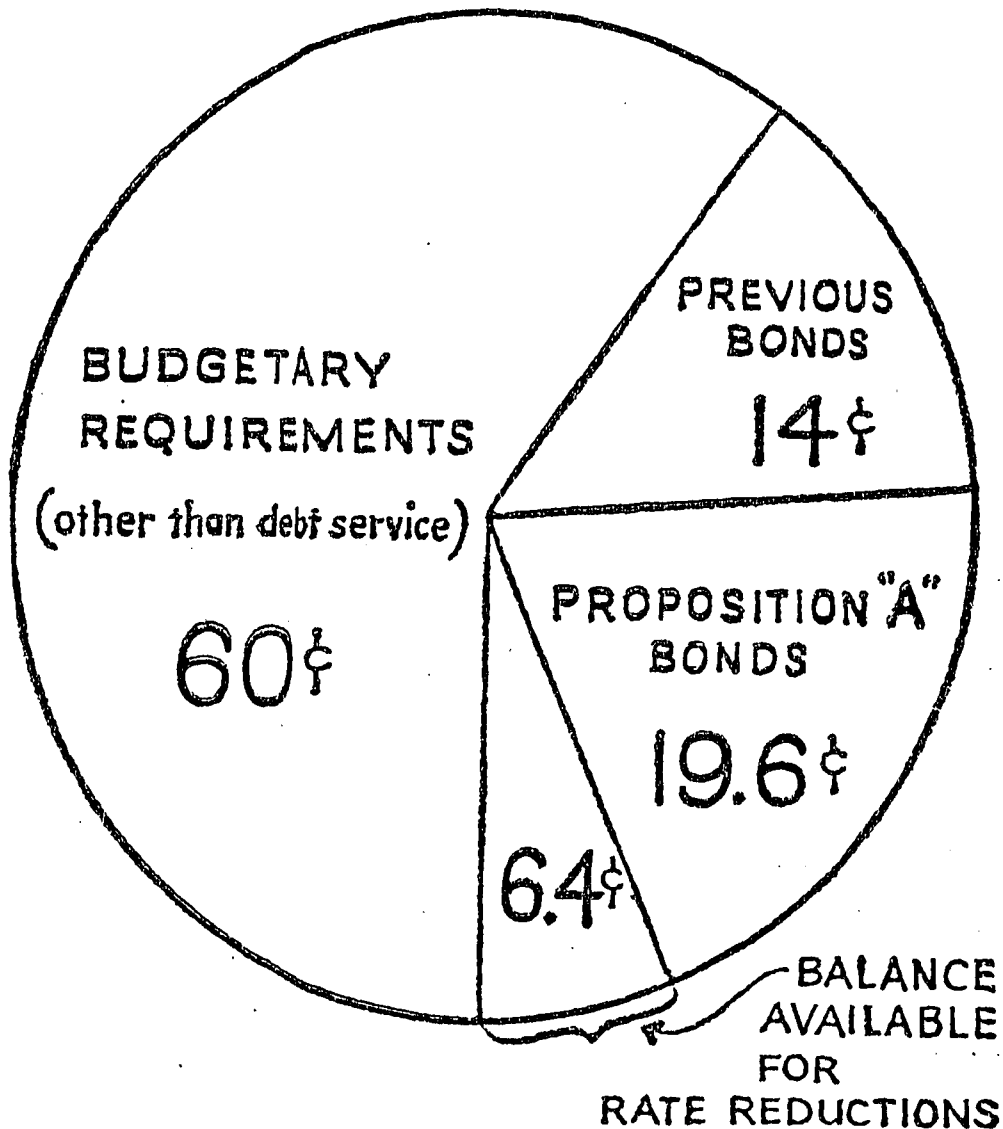
The answer is simple and clear. Proposition "A" will pay for itself, just as San Francisco's previous water system improvements have paid for themselves right along—from the revenue from the sale of water and power.

Vote Yes on "A"—It Pays Its Way!

Proposition "A" represents an outlay of \$115,000,000. That's a lot of money, but not a penny of it is from taxes. The investment will actually make it possible for the City to reduce water rates.

Here is a graphic forecast of how it is planned to disburse the revenue dollar, averaged over the next 20 years.

THE WATER AND POWER REVENUE DOLLAR
(estimated average use on a 20-year basis)



Out of every dollar, about 60 cents will be used to pay the budgetary expense of the system—operating costs, maintenance, wages, reconstruction, main extensions within the city, etc.

Fourteen cents of every dollar would be used to pay off the bonds that already exist, voted for previous expansion needs.

Proposition "A" bonds would cost 19.6 cents of the revenue dollar. The balance, 6.4 cents, is the income available for rate reductions.

These figures were compiled by the careful conservative accounting methods of the City Controller's office. They are based on past and present experience with our water and power system. There's no wishful thinking here—just a clear-headed prediction that Proposition "A" will never require a penny of tax money and will pave the way to a series of rate reductions over the next few years.

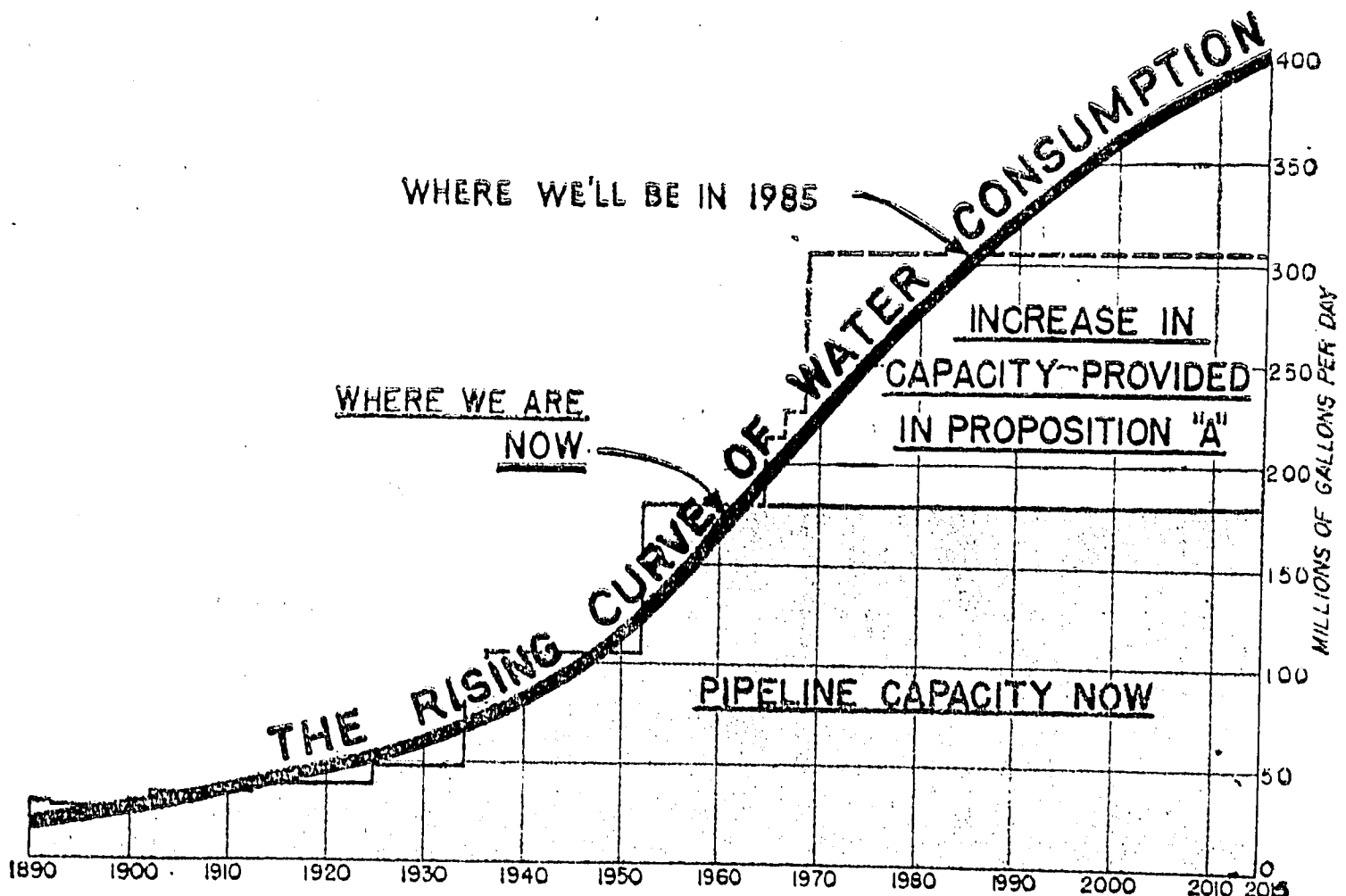
Vote Yes! Proposition "A" Is Urgently Needed!

Proposition "A" is designed to equip our San Francisco water system to cope with the threat of drought and water shortage over the next half century.

We've had three successive years of serious drought. Our water reserves are at an all-time low. Proposition "A," by building dams to store water in the mountains (water that would otherwise be wasted), will eliminate any future worry about having enough water, if another series of drought years should occur.

But Proposition "A" also expands our pipeline delivery system to meet our rapidly rising use of water.

This chart shows why we have to expand our pipeline capacity—to bring the water from our great reservoirs in the high Sierra.



Note that in 1910 we were using about 35 million gallons of water a day. We've risen to a point where we're now using an average of 170 million gallons a day. But note the pipeline capacity—it's at 180 million gallons a day. The curve of consumption is going to pass it, very soon—unless Proposition "A" is passed and construction starts immediately.

Proposition "A" will raise our delivery capacity to 305 million gallons a day. It is expected that we will need that much water by 1985.

CONTROLLER'S STATEMENT PURSUANT TO CHARTER SECTION 183 PROPOSITION "A"

Municipal Water System Bonds, 1961. To incur a bonded indebtedness in the sum of \$115,000,000 for the acquisition, construction and completion of transmission and distribution facilities, dams, reservoirs, and all other works, properties and structures for the municipal water supply system improvements.

Should the proposed \$115,000,000 Municipal Water System Bonds, 1961, be authorized and when all bonds shall have been issued, it is estimated that approximate costs would be as follows:

Based upon the work program submitted by the Public Utilities Commission, the estimated average amount required to pay the interest thereon and redemption thereof would be approximately \$5,758,000 annually for twenty-eight years.

In my opinion, the servicing of the proposed bonded debt will be paid from water and power revenues and will not affect the tax rate of the City and County of San Francisco.

ARGUMENT FOR PROPOSITION "B"

Vote "Yes" on Proposition "B"

For Fort Funston-Land Acquisition

When the Federal General Services Administration declared approximately 116 acres at Fort Funston to be surplus property, the Recreation

and Park Commission recognized that this was the last sizeable area that could be acquired for Recreation and Park purposes and unanimously approved recommending to the Board of Supervisors that a bond issue be submitted to the electorate at the General Election to be held on November 7, 1961.

Vote Yes on Proposition "B"

The purchase price of \$1,100,000 represents 50% of the actual appraised value; therefore, it would seem to be of prime importance to the City and County of San Francisco to take all the necessary steps to assure reservation of the area for public park and recreation purposes.

Vote Yes on Proposition "B"

The purchase of Fort Funston by the City is in no way intended to prevent the State of California from acquiring and developing this area as a State Park, for which the State Park Commission has expressed their desire when funds are available.

VOTE YES ON PROPOSITION "B" because official 1960 census figures indicate that San Francisco has a relatively small area of park land in relation to its population, compared with other major cities.

PROPOSITION C

Public Welfare Bonds, 1961. To incur a bonded indebtedness in the sum of \$3,282,000 for acquisition of land and construction of a building thereon, and equipment of same for the conduct and transaction of business of the Public Welfare Department.

ARGUMENT FOR PROPOSITION "C"

For Efficient Welfare Operations Vote "Yes" on Proposition "C"

VOTE "YES" ON PROPOSITION "C" to provide one centrally located, accessible building designed for Public Welfare purposes. This will result in greatly increased efficiency, substantial improvement in service to the public, and material savings in operating costs.

The Public Welfare Department serves over 35,000 persons—primarily the aged, disabled, blind and children. They come from all parts of San Francisco to the department's two, widely-separated, inconvenient offices in old, outmoded buildings.

VOTE "YES" ON PROPOSITION "C" and carry out the repeated recommendations of Grand Juries by providing a single, centrally-located, modern and efficient Public Welfare Building to replace these old, worn-out, inadequate and inefficient structures never intended for the purposes for which they are now being used. One was built as the office of the Treasure Island world's fair and the other was built 45 years ago as a juvenile detention home.

Under existing laws it is anticipated that the Federal and State governments will pay to San Francisco, on a refund basis, approximately 45% of the total cost of this building, including bond interest, except for land purchase. It is also anticipated that a further \$400,000 can be realized through sale of the city-owned property occupied by the Public Welfare Department at Bush and Stockton Streets. This property, adjacent to the new Sutter-Stockton Garage, is valuable for commercial use and its sale would return it to the city's tax rolls.

VOTE "YES" ON PROPOSITION "C." It will result in greater efficiency in departmental operations and in service to the public. It will save both time and money.

Public Welfare Bonds, 1961. To incur a bonded indebtedness in the sum of \$3,282,000 for acquisition of land and construction of a building thereon, and equipment of same for the conduct and transaction of business of the Public Welfare Department.

Should the proposed \$3,282,000 Public Welfare Bonds, 1961, be authorized, and when all bonds shall have been issued, and after evaluation of estimated additional operation and maintenance expenses at current price levels as contained in reports submitted by the Department of Public Works and the Public Welfare Department, and using the 1961-1962 assessment roll as the basis for calculating the effect upon the tax rate, in my opinion, the approximate costs and effect on the tax rate would be as follows:

The provisions of existing law indicate that, subject to availability of funds, a portion (estimated by the Department of Public Welfare at \$1,648,500) of the construction costs of the proposed building may be paid to the City and County of San Francisco by the State and Federal governments.

The present plan of the Public Welfare Department is to offer for sale the existing Welfare Building at 585 Bush Street upon completion of the proposed building. The Real Estate Department has advised that its current preliminary appraisal of the Bush Street property is \$400,000.

PROPOSITION D

Amends Charter Section 59. Requires that the appointment of the Chief Administrative Officer be subject to confirmation and approval of the Board of Supervisors.

CHARTER AMENDMENT

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said city and county by amending Section 59 thereof to provide that the appointment of the Chief Administrative Officer shall be subject to confirmation and approval by the Board of Supervisors and to delete obsolete provisions in the section.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held therein on November 7, 1961, a proposal to amend the charter of said city and county by amending Section 59 thereof so that the same shall read as follows:

NOTE: Additions or substitutions are indicated by bold face type; deletions are indicated by ((double parentheses)).

Chief Administrative Officer

Section 59. The mayor shall appoint a **qualified person** as chief administrative officer ((a qualified person who)), **subject to confirmation and approval by the board of supervisors.** The appointee shall have been a resident of the State of California for at least five years immediately preceding his appointment. The requisite qualifications of such appointee shall be administrative and executive ability and experience for the position to be filled. ((The first such appointment shall be made immediately after twelve o'clock noon on the 8th day of January, 1932. He shall be paid an annual salary of twelve thousand dollars (\$12,000).))

He shall be subject to suspension and removal in the same manner as elective officers. He shall also be subject to removal by a vote of not less than two-thirds of the board of supervisors, on the basis of written charges, and, if he so requests, only after a public hearing on such charges before the board of supervisors not less than five days nor more than fifteen days after the filing thereof, and prior to the date on which the supervisors shall vote on the question of his removal, but on the filing of written charges, and pending and during such hearing, the supervisors, by majority vote, may suspend him from office. The written charges and any reply thereto by the chief

administrative officer shall be entered at length in the journal of the board of supervisors. The action of the board of supervisors in removing the chief administrative officer shall be final.

ARGUMENT FOR PROPOSITION "D"

Appointment of the chief administrative officer is a responsibility of such importance that it should not be delegated to one man alone. The charter at present states the mayor shall appoint a chief administrative officer. This amendment would add the words "subject to confirmation and approval by the board of supervisors." The appointment of the controller, an equally important officer, has always been subject to approval by the board of supervisors.

The chief administrative officer has jurisdiction and appointive power over many of the thirty-two boards, commissions, and departments in the city. His term of office is limited only by retirement or resignation; or by removal for official misconduct or moral turpitude; or by a two-thirds vote of the board of supervisors. Thus, he will normally be in office through several administrations of elective officials.

This amendment in no way changes the duties of the chief administrative officer. It does divide the responsibility for his appointment between the mayor and the board of supervisors, all chosen by the voters.

PROPOSITION E

Amends Charter Section 43. Reduces membership of Library Commission from eleven to seven, effective January 8, 1964. Deletes obsolete material.

CHARTER AMENDMENT

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the charter of said city and county by amending Section 43 thereof, relating to the Library Department.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held therein on November 7, 1961, a proposal to amend the charter of said city and county by amending Section 43 thereof so that the same shall read as follows:

NOTE: Additions or substitutions are indicated by **bold-face type**; deletions are indicated by ((double parentheses)).

Library Department

Section 43. The library department shall be under the management of a library commission consisting of eleven members who shall be appointed by the mayor and shall serve without compensation.

((The eleven library trustees constituting the board of library trustees in office at the time this charter shall go into effect shall, by lot, classify their respective terms of office so that three of such terms shall begin at twelve o'clock noon on the 15th day of January, 1932, 1933, and 1934, respectively, and two such terms shall begin at twelve o'clock noon on the 15th day of January, 1935.)) The term of each commissioner shall be four years, at the expiration of which the mayor shall appoint his successor.

The library commission shall appoint a librarian and a secretary who shall hold office at its pleasure. The librarian shall be the chief executive of the department and shall be the appointing officer for the department as provided in section 20 of the charter.

((Commencing on the 1st day of January, 1942, all positions in the library department except those of librarian and secretary of the library commission and part time services carrying compensation of less than \$80 per month including valuation of maintenance or other allowances shall be subject to the civil service provisions of this charter, and upon said date, any incumbent of such position in the library department, hereby made subject to civil service, who shall have held such position continuously for one year prior thereto, shall be deemed appointed to such position under the civil service provisions of this charter.))

The library commission shall be the successors in office of the board of library trustees holding office at the time this charter shall go into effect and shall have all the powers and duties thereof, except as in this charter otherwise provided.

Effective January 8, 1964, the library commission shall be reduced in number to seven members; and of the eleven members making up the commission immediately prior to said date, the last seven to have received appointment shall comprise the commission on said date. Notwithstanding any other provision of this section, the term of each of the remaining four members shall on that date automatically terminate.

PROPOSITION F

Amends Charter Section 172.1.11. Provides for City contribution to Health Service System for all administrative expense and to defray additional cost of coverage of retired members. Repeals and rearranges part of section, with no substantial change.

CHARTER AMENDMENT

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the charter of said city and county by amending Section 172.1.11 thereto, relating to the Health Service System fund.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held therein on November 7, 1961, a proposal to amend the charter of said city and county by amending Section 172.1.11 thereto, as follows:

NOTE: Additions or substitutions are indicated by bold-face type; deletions are indicated by ((double parentheses)).

Section 172.1.11. There is hereby created a health service system fund. The costs of the health service system shall be borne by the members of the system and retired persons, the City and County of San Francisco because of its members and retired persons and the San Francisco Unified School District because of its members and retired persons. A retired person as used in this paragraph means a former member of the health service system retired under the San Francisco City and County Employees' Retirement System.

The city and county and the school district shall each contribute to the health service system fund ((an amount equal to the amounts contributed thereto by its members and retired persons of the system; provided, however, that for the fiscal year commencing July 1, 1958, such contributions by the city and county and the school district shall be one-fifth (1/5) of the amount contributed thereto by the members of the system; and that for the fiscal year commencing July 1, 1959, such contributions by the city and county and the school district shall be one-half (1/2) of the amount contributed thereto by the members of the system; and that for the fiscal year commencing July 1, 1960, and for each fiscal year thereafter, the contributions by the city and county and the school district shall be equal to the amounts contributed thereto by the members of the system;)) amounts sufficient for the following purposes, and subject to the following limitations:

(a) All funds necessary to efficiently administer the Health Service System;

(b) Matching contributions for the fiscal year commencing July 1, 1962, and each fiscal year thereafter, equal to the amounts contributed thereto by members of the system, provided, however, that the total amount contributed by the city and county and the school district to the health service system fund in each fiscal year, for this purpose, shall not exceed an amount equal to the tax yield that can be produced in each fiscal year by six cents in the tax rate on each one hundred dollars

(\$100.00) valuation of the real and tangible personal property assessed in and subject to taxation by the city and county and the school district.

(c) Monthly contributions required from retired members participating in the system shall be equal to the monthly contributions required from members in the system; provided, however, that for the fiscal year commencing July 1, 1962, and for each fiscal year thereafter, the city and county and the school district shall contribute funds sufficient to defray the difference in cost to the system in providing the same health coverage to retired members as is provided for active employee members thereof.

((Commencing with the fiscal year beginning July 1, 1958, and each fiscal year thereafter the monthly contribution required from retired persons participating in the system shall be equal to the monthly contribution required from members thereof.))

The city and county and the San Francisco Unified School District shall not contribute to the health service system fund any sums, ((including administrative expenses)) except as hereinbefore set forth, on account of participation in the benefits of the system by members' dependents, retired persons' dependents, persons who retired and elected not to receive benefits from San Francisco City and County Employees' Retirement System and resigned employees and teachers defined in section 172.1.6.

It shall be the duty of the board of supervisors and of the board of education annually to appropriate to the health service system fund such amounts as are necessary to cover the obligation of the city and county and of the San Francisco Unified School District hereby imposed. Contributions to the health service system fund of the city and county and of the school district shall be charged against the general fund or the school, utility, bond or other special fund concerned. ((The controller shall transfer to the health service system fund all sums in any other fund now standing to the credit of the health service system.))

ARGUMENT FOR PROPOSITION F

Vote "Yes" on Proposition F

There has been a Health Service System for the benefit of city and county employees for many years. However, in the course of time various inequities have developed. The purpose of this amendment is to wipe out two of these unfair features.

During the last decade employers in private industry have almost universally adopted group insurance plans for the benefit of their employees, and frequently for the dependents of employees as well. In almost every instance, as official surveys show, the full cost of these benefit plans is paid for by the employer.

San Francisco City and County employees, however, pay more than one-half of the cost of their own insurance and 100 percent of the cost for their dependents, and in addition they pay for the administrative costs of running the Health Service System.

The proposed amendment would place the administrative costs of the Health Service System on the City and County, more in line with the general prevailing practice in private industry. City employees will continue to pay more than one-half of the cost of their own insurance.

The second inequity that would be eliminated by the proposed amendment relates to retired persons. Rising costs of medical care for the elderly are a familiar fact. Under the City Charter, the premium paid by a retired employee is fixed at the same amount as the premium for an active young working employee. This means that the additional hospital, medical and surgical expenses incurred by retired persons are being paid for by the active employees. It means that the premiums charged to employees are unfairly loaded. The amendment calls for the City and County to pay the difference between what a retired person actually pays and what it costs the Health Service System to provide the required protection.

In short, the proposed amendment is a step in bringing the Health Service System in line with prevailing practice in the community. City and County employees will still pay more than one-half of the cost for their own insurance and 100 percent of the cost for their dependents. But they will not be saddled with the administrative costs of the system, nor will the active employees be bound to subsidize the greater health costs of retired persons.

ARGUMENT AGAINST PROPOSITION "F"

Vote "No" on Proposition "F" More Tax Support for Employees' Health System

Proposition "F" makes two changes in the financial support of the city and county employees' health system. The taxpayers are asked to pay the administrative cost and the extra cost for coverage of retired employees.

These two changes will cost \$616,744 a year on present estimates; as the number of retired employees increases this cost will rise. Some \$596,044 would affect the tax rate, equal to 4.2 cents in your rate.

San Franciscans voted for taxpayer support of the health system in 1957. This was a pioneering move among large government agencies. The state is just beginning financial support for its employees next year. Other large California counties and cities still do not have taxpayer support for health plans.

The charter now provides a limit equal to 6 cents in the tax rate for city support of the health system—this now amounts to \$861,337 a year. Proposition "F" would raise the city subsidy to \$1,478,081 annually—an amount equal to more than 10 cents in the tax rate. These costs would rise with assessment roll increases and larger numbers of retired employees.

The Municipal Conference asks you to vote "NO" on "F" because it makes an excessive demand upon the citizens and taxpayers.

Charter Amendment, Amending Section 172.1.11 Relating to the Health Service System Fund.

Should proposition "F" be enacted, in the judgment of this office, which is based on an actuary's report using current Health Service System statistics, the increase in the annual cost of government of the City and County of San Francisco is estimated to be \$616,744.

In my opinion, based on the 1961-1962 assessment roll, \$596,044 of the above annual cost will be financed from ad valorem taxes and is equivalent to four cents (\$0.04) in the tax rate annually.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held herein on November 7, 1961, a proposal to amend the charter of said city and county by adding section 151.6 thereto, reading as follows:

Section 151.6. Notwithstanding the provisions of sections 35.5.1, 36.2, 150, 151, 151.3, or any other provision of this charter, the board of supervisors may provide by ordinance for the payment of the costs of replacing or repairing equipment, property, or prostheses of any uniformed officer or employee of the police department, fire department, sheriff's office or municipal railway, such as, but not confined to, eyeglasses, hearing aids, dentures, watches or articles of clothing necessarily worn or carried by such employee when any such items are damaged in the line of duty without fault of the employee. If the items are damaged beyond repair, the actual value of such items may be paid. The value of such items shall be determined as of the time of the damage thereto.

The board by a three-fourths vote of all of its members may make similar provision in relation to any other officer or employee where it finds that the damage or loss was occasioned by unusual circumstances or the occurrence of an extraordinary event.

The board is authorized to enact any and all ordinances necessary to carry out the provisions of this section.

PROPOSITION H

Amends Charter Section 154. Provides for method of conducting disciplinary hearings through use of independent hearing officers. Repeals and rearranges other parts of section, making no substantial change.

CHARTER AMENDMENT

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the charter of said city and county by amending Section 154 thereof, relating to disciplinary hearings of employees.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election

to be held on November 7, 1961, a proposal to amend the charter of said city and county by amending Section 154 thereof, so that the same shall read as follows:

NOTE: Additions or substitutions are indicated by **bold-face type**; deletions are indicated by ((double parentheses)).

Suspension and Dismissal for Cause

Section 154. No person employed under the civil service provisions of this charter who has completed a probationary period of appointment, exclusive of members of the police and fire departments as provided under section 155, hereof, ((in a position defined by the commission as "permanent")) shall be removed or discharged except for cause, upon written charges, and after an opportunity to be heard in his own defense. The written charges shall specify the grounds for such charges and shall give notification of the time and place where the charges will be heard. Such written charges and notice of hearing may be presented to the accused employee by personal service by the appointing officer or his representative or by mailing such statement to the accused employee's last known address. Pending ((such)) the hearing, the appointing officer may suspend the person so accused ((; but such suspension shall not be valid for more than thirty days, unless hearing upon the charges shall be delayed beyond such time by the act of the accused person. When charges are made, the appointing officer shall, in writing, notify the person accused of the time and place when the charges will be heard, by mailing such statement to his last known address. The appointing officer shall publicly hear and determine the charges, and may exonerate, suspend or dismiss the accused.)) provided that the written charges and notice of hearing must be presented or mailed to the employee within five (5) days of the date of suspension. The appointing officer, with the approval of the civil service commission, may delegate to the head of any utility, institution, bureau, or other subdivision the authority to prepare and to present written charges to an employee under their jurisdiction and to suspend such employee pending hearing on such charges. The hearing shall be held not later than thirty days after the date of notification of charges unless such hearing shall be delayed beyond such time at the request of the accused employee.

The accused employee, unless he desires to waive his right to a hearing on the charges, shall within ten calendar days from date of notification of the charges, file with the appointing officer a written notice of intention to answer the charges.

The civil service commission shall contract for the services of a hearing officer or officers who shall be qualified in accordance with standards to be established by the civil service commission, provided that such hearing officer shall not be an officer or employee of the City and County of San Francisco, and shall assign the hearing officer to hear the charges. The appointing officer may designate a departmental representative to prepare and to present the case to the hearing officer and to represent the appointing officer at the hearing. At the conclusion of the hearing, the hearing officer shall prepare a proposed decision for submission, together with a summary of the evidence presented at the hearing, to the appointing officer. The hearing officer may propose that the employee be exonerated or may propose any of the following penalties: suspension of the employee; reduction in the rate of pay of the employee for a specified temporary period, not to exceed six months and not to exceed one step in the salary range, provided that the rate

of pay may not be reduced below the minimum rate of pay established for such class; reduction in rank of the employee; dismissal of employee.

The appointing officer upon receipt of the proposed decision may adopt it in its entirety, or, if a penalty is proposed, may remit the penalty entirely, or may reduce or increase the proposed penalty and adopt the balance thereof, or may decide the case on the record, with or without taking additional evidence, provided that any penalty assessed by the appointing officer shall be within the limits of the penalties designated above. If the employee is exonerated the appointing officer may, at his discretion, remit the suspension and may order payment of salary to the employee for the time under suspension, and the report of such suspension shall thereupon be expunged from the record of service of such employee. The civil service commission shall immediately be notified of the charges when made, of the hearing, and of the finding thereon. The ((finding)) decision of the appointing officer shall be final, unless within thirty days therefrom the ((dismissed)) employee appeals to the civil service commission. The appeal and all proceedings shall be in writing and shall briefly state the grounds therefor, provided that with the approval of the civil service commission oral argument may be received to supplement such written proceeding. The civil service commission shall examine into the case and may require the appointing officer to furnish a ((record)) transcript of the hearing and may require in writing any additional evidence it deems material, and may, thereupon ((,)) deny the appeal or may reduce or increase the penalty or make such other decision as it deems just. The order or decision of the commission upon such appeal shall be final and shall forthwith be enforced by the appointing officer. If the civil service commission shall reverse or alter the ((finding)) decision of the appointing officer it may, in its discretion, order that the employee affected be paid salary from the time of his discharge or suspension, or may order restoration of salary if the penalty was temporary reduction in rate of pay, or reduction in rank.

The civil service commission may hear and determine any charge filed by a citizen or by the authorized agents of the commission when the appointing officer neglects or refuses to act.

((Removal or discharge)) **Disciplinary action** as stated above may be ((made)) taken for any of the following causes but not limited exclusively thereto: incompetence, habitual intemperence, immoral conduct, insubordination, discourteous treatment of the public, dishonesty, inattention to duties, or engaging in prohibited political activities. The civil service commission shall define such causes as enumerated above by rule, and no act or omission shall constitute cause for disciplinary action unless provided by rule of the civil service commission.

The civil service commission shall enact any and all rules necessary to administer and interpret the provisions of this section. Nothing in this section shall limit or restrict rules adopted by the commission governing layoffs or reduction in force.

The appointing officer may, for disciplinary purposes, suspend a subordinate for a period not exceeding thirty calendar days in any six month period; and suspension shall carry with it the loss of salary for the period of suspension. If, in the opinion of the appointing officer, disciplinary action in addition to thirty days suspension in any six month period is required, then the appointing officer shall proceed in accordance with the provisions of this section for written charges and hearing. The suspended employee shall be notified in writing of the reason for such suspension, and if the suspension be for more than five days but less than sixteen days, the employee

shall, at his request, be given a hearing by the appointing officer. If the suspension be for sixteen days or more, the employee shall at his request be given a hearing before a hearing officer assigned by the civil service commission. The hearing officer shall prepare a summary of the hearing and a proposed recommendation for submission to the appointing officer. The decision of the appointing officer in all cases of suspension for disciplinary purposes shall be final. If after the hearing the appointing officer shall decide that the suspension or any portion of it was not justified, the appointing officer in his discretion may order that the suspension or any portion of it be expunged from the personal records of the employee and that the employee be paid salary for such period of suspension that is so expunged.

The civil service commission shall include in its annual budget or supplemental requests, funds for the employment under contract of hearing officers, and for other expenses directly related thereto, and the mayor shall approve and the board of supervisors shall appropriate sufficient funds for such purpose in accordance with the budgetary and fiscal procedures provided in this charter.

ARGUMENT FOR PROPOSITION H

Vote "Yes" On Proposition H

This charter amendment has been presented by the Civil Service Commission and has been approved for inclusion on the ballot by the Board of Supervisors. The purpose of the amendment is to correct a procedure now included in the charter which years of experience has proved to be unsatisfactory. This charter amendment will provide for a qualified Hearing Officer, rather than the appointing officer as is now the case, to take evidence and to hear cases of disciplinary action against permanent civil service employees. This amendment would benefit the city in the following respects:

1. It would correct the situation in which the appointing officer, when holding a hearing on disciplinary action of a permanent civil service employee, now acts as accuser, prosecutor, judge and jury.

2. The amendment provides that a hearing will be held by a disinterested, impartial officer trained and qualified to develop the facts in these types of cases, and to recommend equitable action. The Hearing Officer will have the technical knowledge of the laws and rules governing these procedures and will be able to properly evaluate the evidence and to keep out extraneous issues.

3. The appointing officer will still retain authority within the department for disciplinary action, but such action will be based on a proper development of the factual situation.

4. The use of a qualified Hearing Officer will tend to equalize where desirable disciplinary action for similar offenses. This is not the case at the present time.

5. A wider range of penalties is provided for consideration of the appointing officer in imposing disciplinary action. Besides suspension or

dismissal, the proposed amendment would permit consideration of temporary reduction in the rate of pay, or reduction in rank. There are cases in which such disciplinary action would be a more reasonable penalty than suspension or dismissal.

6. The right to appeal to the Civil Service Commission from disciplinary action taken after a hearing remains unchanged. The appeal procedure to the Civil Service Commission is clarified to the extent that the charter amendment would specifically permit an appeal to the Civil Service Commission from a period of suspension assessed by the appointing officer after a hearing held for the purpose of determining whether the employee should be dismissed.

7. The appointing officer still retains final authority for suspension of a subordinate for a period not exceeding thirty days, but in the case of a suspension of more than fifteen days, the employee would have the right to request a hearing before a Hearing Officer. The appointing officer would thus have the benefit of independent review of such cases.

8. The use of a Hearing Officer has been found to be a more satisfactory and desirable procedure in other public agencies.

9. The correction of procedures in disciplinary actions will reflect itself in better working conditions and better morale of city employees. This, in turn, will lead to improved services for the citizenry of San Francisco. Better disciplinary procedures will promote efficiency and economy and result in savings to the taxpayers and others who pay the costs of city and county operations.

10. Savings will result from the fact that the time which appointing officers must now give to hearing disciplinary cases will be transferred to the Hearing Officer whose hourly rate of pay will be substantially less than that of the appointing officer.

Proposition I enables the purchase of the Fox Theatre property, bounded by Market, Polk, Hayes and Larkin Streets, for convention and other public assembly purposes, at the discretion of the San Francisco Board of Supervisors.

The Fox Theatre, which is located directly across Hayes Street from the Civic Auditorium, is a natural and essential expansion of the City's civic center convention and exhibition plant. The Fox Theatre will provide San Franciscans with a medium-sized public assembly facility urgently needed to make available necessary convention space during the Civic Auditorium remodeling already underway. It moreover fills the need for the medium-sized meeting facility which is becoming more and more important in attracting major conventions and has been adopted by other leading convention cities with which San Francisco must compete.

Vote Yes On Proposition I

San Francisco's thriving convention business, which injects \$37,500,000 annually into our economy, representing according to Federal Reserve Bank estimates more than \$900,000,000 in its annual flow through San Francisco trade channels, threatens to "level off" unless present facilities can be expanded.

Acquiring the Fox Theatre, along with the off-street parking this property provides, will enable San Francisco to increase its lucrative convention business in step with increased number of hotel and motel rooms now being constructed to meet the rising competition from other cities.

The need for a supplementary auditorium at Civic Center has long been recognized. It was confirmed by professional planning specialists, including the Mayor's Technical Coordinating Committee on Civic Center Development. That Committee concurred with the findings of a 1958 survey by the Industrial Planning Associates in recommending that the Fox Theatre be acquired by the City and County as a part of the long-range program of Civic Center Development.

Vote Yes On Proposition I

Reports by the City Engineer, the City Architect and the Superintendent of Building Inspection indicate the building is in good condition. The San Francisco Convention and Visitors Bureau states: "If the Fox Theatre is not purchased at this time, according to Director of Property, Philip Rezos, eventually a new facility of like capacity will be required by the City at a cost of over \$14,000,000 rather than the \$1,050,000 which is the present price of the Fox."

Vote Yes On Proposition I

The Fox Theatre has an unsurpassed location convenient to the theatres, hotels and other convention facilities. Besides helping to fill the void existing during the rehabilitation of the Civic Auditorium it will further help to create new convention business after the Civic Auditorium returns to full operation in 1965.

The use of the Theatre will permit two different conventions to meet simultaneously in the Civic Center, and in freeing the main arena of the Civic Auditorium of meetings, will permit the Civic Auditorium to be used for trade show exhibits and other events necessary to the modern convention while meetings are held in the Fox Theatre.

Acquisition of the Fox Theatre also will fill a need for medium-sized, local cultural, theatrical and other events to supplement convention use when not required for convention purposes, a growing problem now being faced by existing City facilities.

Vote Yes On Proposition I

As a result of the Fox Theatre facility attracting more and larger conventions to San Francisco, the increase of outside money spent in our City by increased numbers of conventioners will add many times the additional income from rentals of the Theatre, to the City's business, industry and payrolls.

The City of San Francisco has many other obligations far more important than taking obsolete structures off the hands of owners who understandably want to dispose of them. We can't afford to play Santa Claus to those owners.

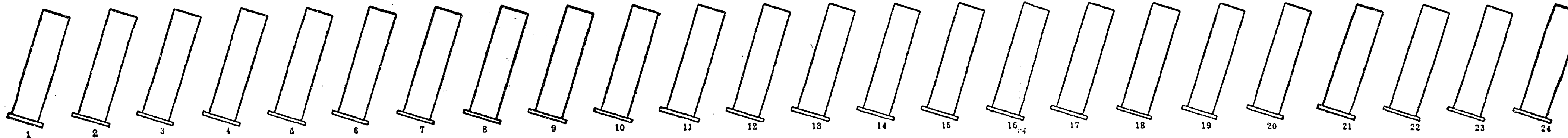

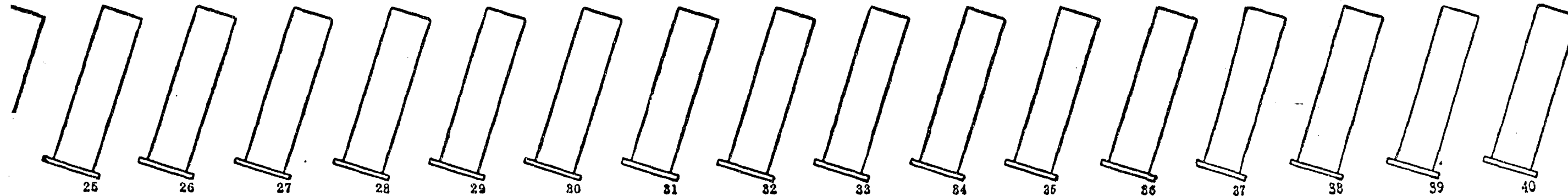
