If the geographic area is composed of all or part of two or more municipalities, nominations shall be filed with the school board election clerk of the municipality wholly or partly within the geographic area having the largest population of the board's electoral group, who shall send the names of the candidates by registered mail within 48 hours after the closing of nominations to the school board election clerk of each municipality that is wholly or partly within the geographic area. If the distance between the residence of a person seeking nomination and the office of the school board election clerk with whom nominations must be filed is greater than 100 kilometres, the clerk shall, for the purpose of making it easier for the person or the person's agent to file the nomination, delegate such of his or her powers as may be necessary to, (a) the school board election clerk of the municipality in which the person seeking nomination resides, if the person resides in a municipality; (b) the school board election clerk of the municipality to which the unorganized territory in which the person seeking nomination resides is attached for election purposes, if the person resides in unorganized territory that is attached to a municipality for election purposes and the territory that is attached is part of the same geographic area as the municipality for election purposes; (c) the school board election clerk whose office is in the same geographic area and is closest to the person's residence, in any other case. *Education Act*, O.Reg. 412/00, s. 11.
