

NOK President's Report by Michael L. Kelly

It was a real pleasure visiting with many of you at our recent Natives of Kodiak, Inc. Annual Shareholders meeting. David Anderson and I were grateful for the opportunity to provide more details and additional insights into our FY 2010 financial performance, the NOK Board of Directors Strategic Planning Retreat in Anchorage, current business operations, and ongoing business development efforts to generate profits, create value and improve the financial well-being of every shareholder.



As you probably know, the first ten months of this year have been particularly challenging for American families, businesses, and governmental organizations. As I write this report, we continue to be dogged by "The Great Recession", a stock market in turmoil, delays in passing the FY 2012 Federal Budget, and other assorted challenges.

NOK has enjoyed some very positive accomplishments including being recently featured in a major construction periodical; *U.S. Builders Review*. The three-page article portrays NOK and its subsidiaries in an extremely favorable light and should serve as an excellent marketing tool for us in the future.

I share such information with you not to alarm or discourage you, but to let you know that we have to exercise extreme caution and prudence in our business decisions to avoid placing your hard-won ownership interests (Shareholder's Equity) at undue risk. The good news is that, based on the best available information, we expect FY 2012 to be a profitable year for NOK and its subsidiaries. However, we are also forecasting our profitability to be slightly less than last year's profitability.

Despite the significant challenges noted above, we have enjoyed some very positive accomplishments, to include being recently featured in a major construction periodical; *U.S. Builders Review*. The three-page article on NOK and its subsidiaries portrays us in an extremely favorable light and should serve as an excellent marketing tool for us in the future. We recently received a contract through our KOMAN-Propper, LLC Joint Venture to manufacture and sell up to \$18.5 million in trousers the U.S. Navy. Due to the relatively long lead time to receive the required specialized fabric and other materials, the manufacturing of these garments will be delayed until after the start of the new calendar year. We also have several other military uniform proposals in progress at this time.

Regarding our construction management operations... During the 21 years I served in the U.S. Air Force, I evaluated a number of classified military security programs. This experience has proven valuable as we continue to develop our construction capabilities to help the Federal Government do a better job of storing and protecting its classified information. We recently entered into a Teaming Arrangement with SCIF Constructors, LLC, one of the premier classified facility construction and security training companies in the United States. Although KOMAN Diversified Services, LLC has successfully upgraded five classified storage facilities, SCIF Constructors, LLC has completed almost seven hundred. Given their extensive experience and well-established contacts within the Intelligence and National Security communities and our SBA 8(a) Small Disadvantaged Business capabilities, we expect great things to come from this partnership.

NOK continues to be blessed with a wonderful Board of Directors, extremely talented and dedicated employees, very capable teaming partners and business associates, and a reputation for the highest standards of business integrity and operational capabilities. Through ongoing aggressive joint marketing efforts with our established teaming partners, we have also positioned ourselves to take full advantage of construction, apparel, and other contractual opportunities as soon as the FY 2012 Federal Budget is approved and Contracting Officers are authorized to obligate newly appropriated funds.

In closing, although FY 2011 has been a challenging year, the Board of Directors, David Anderson, and I felt compelled to reward each of our shareholders for your continued support of our collective efforts. Therefore, the Board recently approved a \$12.50 per share Special Dividend at this very special time of year. I continue to genuinely appreciate the Board of Directors' and your support during these difficult economic times and wish you a Very Merry Christmas and the Happiest of New Years.





NOK's 37th Annual Shareholder Meeting







Where were you born, Laurence? I was born right here in Kodiak on December 11, 1932.

Where did you grow up? I grew up in Kodiak. Our house was right where Wells Fargo is now, on a hill. Urban Renewal leveled that whole hill after the earthquake and tidal wave, in 1964.

Who are your parents? Nina Kashaveroff Anderson and Julius Anderson. My mom was born in the Old Afognak Village, and my dad was born in the Old Kaguyak Village down at the south end of the Island.

Where did your Swedish name come from? My grandfather on my dad's side was Charlie Anderson from Göteborg, Sweden.

So, you've got Aleut, Russian and Swede in your ancestry? Yes, that's right. My daughter is working on our genealogy right now. We're related to the Squartsoffs in Ouzinkie too. My dad passed away when he was 59 years old and my mom passed away at an early age too, she was 55 years old. After my dad passed away, my mom did laundry for Kraft's butcher shop to keep the family going and she also got my dad's social security. That's how we kept going. When I got older, I went to work at the Donnelly & Acheson store as a helper. After working for Donnelly & Acheson, I worked for Kraft's store delivering groceries out of a truck – Fred Mahle was the driver. One thing I remember is that he always let me pack that 100 lb. bag of potatoes up to Sutliff's apartments on Pillar – up Alder Lane.

How many siblings did you have? There were nine of us: Nick, me, Patrick, Edna, Margaret and Julius. My parents lost three babies before I was born, from whooping cough.

What did you like to do as a kid? I liked to go play on the beach. I had a wooden boat with a string tied onto it, so I could go along the shore – the nail was at an angle, you see, so I could pull it along the shore.

What was your favorite childhood memory? My mother. No matter which one of the children needed a babysitter, she would walk miles to help. She was a very happy, go-lucky woman. When I got punished for not getting home on time or something, she would bring me up supper after my dad went to the beach. My dad was strict, you see. If we did something wrong, we went upstairs with no supper. I'm thankful that he was strict, to this day. My mother was a very kind-hearted and happy person. She always told me to treat people like you wanted to be treated and they always return the same to you. Her words were really true about that.

What was Kodiak like when you were a kid? Kodiak was a sleepy little village. You would wake up in the morning and smell the wood smoke – it was a peaceful little town. There was no Aleutian Homes then and the Catholic Church was right where the Fish and Game building is now. And people seemed to be happier in those days – we could leave our doors open. We never locked our doors. (Continued on next page...)

Who influenced you the most? Who was your role model? My dad – he always told me when you do something, you do it right the first time. Don't do a sloppy job 'cause you'll do it over again! When we had our wood stove, I used to row over to Near Island in the skiff to get wood and bring it back and pack it up to the house. My dad and I sawed it up with one of them big saws. You remember those big saws, don't you?

Did you have a childhood dream and did it come true? The jail was right next to our house, so I could always watch the police men. I always wondered what it would be like to be a police officer and years later I became a police officer.

How long did you do that? Seven and a half years as a police officer. I was offered the Chief of Police job, but I didn't want it. I didn't think I had enough experience with administration stuff. I told them I'd rather be on the street patrolling – I didn't want to be behind the desk all day. They transferred me temporarily to the boat harbor, and I ended up being the first Harbormaster in Kodiak. I did that for seven years. I collected fees from the Harbor and took them up to City Hall and I also kept the garbage out of the harbor – I hauled it in my old truck. In the winter, I shoveled a narrow path down all the floats by myself. Sixteen, seventeen hours a day I worked. I watched for fires and boats sinking, overheated stoves and people falling overboard drunk. I had to make my own arrests. It was a nerve-wracking job. People would shoot seagulls and I would have to give them a warning. One guy chased me down the harbor with 12-gauge shotgun - he was drunk. I ran all the way down the transient float to the NUNIVAK and hid under the upper bow. He came by and went back up. I waited until morning to go aboard his boat and woke him up and told him to leave the harbor immediately or you're going to jail! The guy didn't even remember, but he left that same day.

When was the first time you left the Island? When I was in high school (1949), I got to go to Anchorage with the basketball team. I was on the second team that ever came out of Kodiak; on the Bears basketball team. And we won the tournament then. We played Cordova, Wasilla, Valdez, Nome and the Navy Base here on the Island.

When did you get married? I got married in 1956 to my wonderful wife Haroldean Skonberg, from Chignik, Alaska. Our 55th Wedding Anniversary was October 25, 2011.

How did you meet? I met my wife when I was over in Chignik fishing. Nick Nekeferoff, Allen Chernoff and I went to her house for breakfast. Skonbergs always cooked for everybody there. And I saw her there, and I immediately had a crush on that woman the first time I saw her. And that's a fact. We ended up getting married in 1956.

How old were you when you had kids? I think I was 22 when I got married, and we had kids right away. We had nine children; five girls and four boys. There's Gerald, Alice, Laurence, Jr., David, Renee, Darlene, Doreen, Clifford and Darnell. We lost Laurence, Jr. in a car accident when he was 19 years old.

As an adult, what was one of your best times? One of the things I enjoyed most was being Santa Clause, for 53 years. We'd take names on Christmas Eve and I would tell them to leave their gifts in their cars and callidars with the names on them. Sometimes my daughter-in-law, Sherry, would help me. When I would go into people's houses, she would come in with me and I would call the names in that family and the kids would come running to me. They were always so surprised that I knew their names. Those kids were so happy and the families were so thankful to us for coming there. We went to thirty houses every Christmas Eve.

At this stage in life, can you share any wisdom or advice for others? You know, if you have a dream and you believe that dream – truly follow it, because it will come true. Always remember something else too – always respect other people and their opinions, because sometimes you may be wrong and they may be right.



37th Annual Meeting Election Results

The 37th Annual Meeting of NOK Shareholders was held on Saturday, September 17, 2011 in Kodiak, Alaska at the Kodiak Elks Lodge. Forty-one NOK shareholders attended the meeting with 51.77 percent of NOK shareholders represented in person or by proxy. In the 2011 election, three Directors were re-elected to serve three-year terms. All of the Directors re-elected in the 2011 election were recommended by the NOK Board of Directors.



Leonard 'Pat' Heitman was re-elected in the 2011 election to continue his service as a Director on the NOK Board; a position he has held for a total of 28 years, including serving on the original Board of Directors of Natives of Kodiak, Inc. Pat resides in Kodiak with his wife, Carolyn, and the couple have six children and seven grandchildren. Pat says of his service on the NOK Board, "I enjoy working for Natives of Kodiak, Inc. and believe the best is yet to come."



Alutiig Museum Earns Accreditation

It took 14 years and an enormous amount of work, but the Alutiiq Museum achieved a long held dream in July - national accreditation. Bestowed by the American Association of Museums, accreditation is the highest level of professional certification for museums in the United States. It indicates that a museum meets the most rigorous standards of practice in everything it does, from caring for collections, to serving the public and even preparing for emergencies.

"We set accreditation as a goal 14 years ago when we were developing the Museum's program and policies" said Deputy Director Amy Steffian. "I remember



the meeting where our board and staff decided that accreditation could be a great measure for our work, that we could model the museum's practices after those standards. We wanted the world to see that a tribal museum could be both a culturally meaningful institution and a first class, professional museum. It's thrilling to know that we accomplished that goal."

The Alutiiq Museum is just the seventh museum in Alaska and the second Tribal Museum in the United States to be accredited. The initial certification will last 15 years, then the museum must apply to renew its accreditation. "This is a milestone for the Alutiiq Museum," said Executive Director Sven Haakanson, Jr. "Accreditation is the professional seal of approval. It lets others know that the Alutiiq Nation has a model museum."

Many people helped the Museum reach its accreditation goal. "We are especially grateful, to Scott Carrlee of the Alaska State Museum who made us believe that we were ready to begin the application process, and provided an exceptional summer intern, Elizabeth Manekin, to launch our bid," said Haakanson. "Once we were in the program, it took the entire board and staff two years of application writing, documentation, correspondence, and finally a site visit to reach this day. It was a team effort and we did it. It feels amazing."

NOK Vice-President's Report by David Anderson

It's hard to believe that it's already been a year since I retired from the Alaska State Troopers, serving the people of this great state we live in. Although it has been a big learning curve for me, it has been a great pleasure serving our shareholders this past year. We have a great team in Kodiak and in Anchorage, at our KOMAN office. We are always looking for new opportunities, not only in the 8(a) arena, but with local businesses as well. We believe by expanding into the community, NOK will make a stronger presence. I'm proud to say that we have landed an \$18.5 million contract with Propper International clothing. (See NOK President's Report for more details). We are also trying to figure out ways to use the land at Spruce Cape and Boy Scout Lake that is in the best interest of our shareholders.



We have been working with the FAA on the Woody Island dock project for the

past several months. We transferred the dock back to the FAA, which takes the liability off NOK. As land owners, we will continue to have the same access to the dock as we did before, as will all land owners on Woody Island. We made sure that nothing would change the access.

Recently, I have been elected to serve as the Chairman of the Koncor Forest Products Board of Directors. Koncor is a Joint Venture of NOK and Ouzinkie Native Corporation that deals with logging on Afognak. We will continue to make sure that we get the best value for our logs.

Along with our teaming partner Bering Straits Native Corporation, we take care of the BOSS contract doing all the maintenance on Kodiak's Coast Guard Base. This will be the first year in the Contract that NOK and KOMAN will turn a profit, although these numbers have not been finalized. I do encourage any and all shareholders to bring an application by the office, and join the Teamsters Local 959 to get on the hiring list. There are potentially many great paying jobs with great benefits. As many of you know (those who received phone calls prior to our annual meeting) we need your votes. As we increase our shareholder base, because of shares being willed and gifted, it takes more of us to vote to reach a guorum. It only takes a few minutes to vote online or to fill out the proxy card. Remember, in the packet that we send there are two colored envelopes included; one for the NOK Shareholders Permanent Fund Trust vote and one for the NOK vote. Both of these need to be voted.
