Biographical Sketch

State Representative Harry Hollins' legislative career spanned sixteen years, 1963-1979. After retiring from the legislature, he served as head of the Louisiana Real Estate Commission and Louisiana Racing Commission. He sponsored legislation in 1970 creating the Sabine River water diversion project, and in 1978 he headed a legislative subcommittee investigating Sherman Bernard, State Insurance Commissioner. Hollins died at 1989 at age 56.

Scope and Content Note

The collection consists of the political papers of Harry Hollins, 1960-1989. It includes documents, clippings, speeches, correspondence, and materials relating to the racing commission and the state insurance boards and committees.
