SG-P6A:- A cachet identical to **SG-P6A** was in use at the South Georgia Post Office in October 2009.

SG-P9A:- This cachet was used crossed out in black crayon on a cover addressed to Mr Rolf Nilsen, Grytviken, Syd Georgia, cancelled in Sandefjord on 13 3/ 18/ 1961. The cover also bears back stamps "Oslo Ank Utland" dated 10-7-61 and Sandefjord 11-7-61. However, the return address given was Mr Erik Nilsen, 86 Convent Pl, Yonkers, New York. The cover, which also bears SG-P18, was found on the floor of the Manager's Villa in Grytviken in 1977!

SG-P16:- The cachet was used on 1 02. SE 10 (**SG62**).

SG-P17:- The cachet was present at King Edward Point in October 2009. It has been seen applied to a cover bearing a Belgian stamp cancelled in Barcelona on 15 1 01 and bearing a South Georgia receiving cancel dated 11 FE 01 (**SG27**).

SG-P18:- This cachet was used on a cover addressed to Mr Rolf Nilsen, Grytviken, Syd Georgia, cancelled in Sandefjord on 13 3/ 18/ 1961. The cover also bears back stamps "Oslo Ank Utland" dated 10-7-61 and Sandefjord 11-7-61. However, the return address given was Mr Erik Nilsen, 86 Convent Pl, Yonkers, New York. The cover, which also bears **SG-P9A**, was found on the floor of the Manager's Villa in Grytviken in 1977!

5. Magistrate's Office Markings (Page 13)



SG-MA2(A):- This much earlier use of a South Georgia Magistrate's Office cachet was reported to me by Stefan Heijtz in August 2005. It is on the reverse of a cover cancelled with SG 4 dated 2.45PM 28 DE 36. The size of the letters of the text "★ Magistrate's Office ★ South Georgia" is smaller than on SG-MA2. A further example has been seen dated 6-APR 1936 on the rear of a cover.

SG-CH14 (October 2009)

SG-CH5:- The latest reported date of use is now 24 MR 82 (SG21).

SG-CH11:- This cachet was still in use in October 2009.

SG-CH14:- This cachet was still at King Edward Point in October 2009 but was stated to be no longer in use.

SG-CH15:- Further dates of use have come to light. Please replace the existing text on page 15 by the following:

This cachet has been reported dated 29 NOV 1981 and -7 DEC 1981 on covers cancelled with **SG17** dated -9 DEC 1981, dated 30 DEC 1981 & -1 JAN 1982 on covers cancelled with **SG17** on 29 JAN 1982 and dated 18 MAR 1982, 20 MAR 1982, 21 MAR 1982, 23 MAR 1982 and 24 MAR 1982 on covers cancelled with **SG21** on 27 MR 82. It was used by Cindy Buxton and Annie Price during the 7 months they spent filming for Anglia Television in a hut at St. Andrews Bay from October 1981 to April 1982. The cachet also appears dated 13 DEC 1981, 14 DEC 1981 & 15 DEC 1981 on covers and postcards cancelled at Stanley which were carried to the Falkland Islands on HMS ENDURANCE 1.

SG-CH18:- This cachet was still occasionally in use in October 2009 on philatelic Mail. It is no longer used in passports.



SG-CH19:- Bird Island Research Station Cachet first seen on a cover cancelled KING EDWARD POINT 12 OC 02.

SG-CH20:- Large Coat of arms cachet for use in passports; earliest reported date of use on a cover 26 DE 02 (**SG27**). The cachet was still in use occasionally in October 2009.



Smaller version of the Coats of Arms Cachet SG-CH20 first seen dated NOV 21 2008 on a cover cancelled with SG62 on 1 21. NO 08. Three identical hand stamps (A) to (C) were in use for stamping passports in October 2009.



SG-CH22

SG-CH22:-This cachet is first reported on mail dated 22 MR 01 (SG27) for the opening of the new BAS Research Station Everson House at King Edward Point. It has since reappeared on a postcard sent by Stefan Heijtz from Grytviken on 1 27. OC 09 (SG62 (1)). Sarah Lurcock has confirmed that this hand stamp is located at King Edward Point.



SG-CH23 and SG-CH24:-Sarah Lurcock has confirmed that these two "fun" cachets were present at King Edward Point in October 2009.







The cachet was used by the South Georgia Postal Officer Sarah Lurcock on the Pobjoy Mint Stand at The **SG-CH25:-**London Festival of Stamps International Stamp Exhibition from 8th to 15th May 2010. It was used on some postcards and envelopes which were subsequently sent to South Georgia for cancelling.

This cachet was reported in Polarinfo, N°134, May 2011. It has appeared on a cover cancelled with SG62 **SG-CH26:**on 1 8. FE 13. This could be the cachet SG-CH25 with the wording 'LONDON 2010 FESTIVAL OF STAMPS' removed.

SG-PRI-18:- The origin of this cachet is not known. It was used on mail cancelled 22 MR 01 (**SG27**) for the opening of the new BAS Research Station Everson House at King Edward Point

SG-PRI-19:- This adhesive label refers to the opening of Everson House on 22 March 2001.

SG-PRI-20:- This cachet was used on covers from SOUTH GEORGIA cancelled with **SG27** dated 20 SE 01 and 2 MR 02 to commemorate the 90th Anniversary of the 2nd German Antarctic Expedition under Wilhelm Filchner.

SG-PRI-21:- This cachet for M/S PARMA was used on a cover cancelled with SG17 on 30 APR 1980.

SG-PRI-22:- This cachet was privately produced by The Polar Postal History Society of Great Britain and it appears only in light blue on postcards cancelled at SOUTH GEORGIA with **SG12** on 17 JAN 1975.

SG-PRI-23:- This cachet was privately produced by The Polar Postal History Society of Great Britain and it appears only in light blue on postcards cancelled at SOUTH GEORGIA with **SG12** on 31 JAN 1975. The postcards also bear a second cancel of **SG12** dated 3 FEB 1975.



SG-PRI-24:- This cachet was used by Bernd Lukas during a cruise on MS Delphin during February 2010. It was used at Port Lockroy (**A12** dated 07 .02. 2010) and South Georgia (**SG62 (2)** dated 2 12. FE 10).

11. South Georgia - Cachets associated with Whaling Activities (Pages 25-26)



SG-WH-09:- This cachet has only been reported used to cancel a stamp (3d 1954 FID Ships definitive issue) on an envelope addressed to Roy M Milner.

12. The South Georgia Museum (Pages 26-27)








- **SG-MU7:-** This cachet is first reported used on a postcard cancelled at SOUTH GEORGIA on 13 DE 02 (**SG27**). It is 39 mm in diameter and was in use at the South Georgia Museum.
- SG-MU8:- This cachet is identical in design to SG-MU7 but is 50 mm in diameter. It was also in use at the South Georgia Museum. So far only one date of use has been reported to me 23 JA 03 (SG27).
- **SG-MU9:-** This cachet is virtually identical to SG-MU8 except for the fact that the border is now a rope rather than a simple circle. It was first reported to me used in the 2007/08 summer season when it was available for free use by visitors to the museum.





- **SG-MU10:-** The revised dated Museum cachet is similar to **SG-MU5** but the JAMES CAIRD is illustrated in the colour of the ink rather than being white. In addition the wording "James Caird 1916" appears under the boat.
- SG-MU11:- The revised undated Museum cachet is similar to SG-MU6 but the JAMES CAIRD is illustrated in the colour of the ink rather than being white. In addition the wording "James Caird 1916" appears under the boat. It was first reported used in the 2007/08 summer season when it was available for free use by visitors to the museum.

The illustration of **SG21** dated 24 MR 82 shown in the book is inaccurate, having been produced by modifying an example of **SG24**. In particular the gap between "S." and the "G" of "GEORGIA" is too large. The complete **SG21** section should be replaced by the following:

SG21:- Metal canceller, 24.3mm in diameter, introduced only 17 days before the Argentine occupation. It can be distinguished from **SG24** by virtue of the full stop after "IS" and a smaller gap between "S." and the "G" of "GEORGIA". Robert Headland has reported that he used this canceller on some 60 items of mail. The figures given in the table relate to items of mail that Robert Headland took in his personal luggage when he was deported by Argentine Forces and repatriated. Unaddressed philatelic covers are also known dated 24 MR 82 bearing the £3 HMS ENDURANCE stamp issued in 1980.





- SG-NU01:- Two identical cancellers were produced when the name on South Georgia stamps changed to "Falkland Island Dependencies" with the definitive issue of 5 May 1980. However SG17 continued in use until 16th March 1982. Why these cancellers were never used is unclear. It could be because the wording should read "Dependencies" and not "Dependency".
- **SG-NU02:-** Two first day of issue cancellers were produced for the 'Princess of Wales 21st Birthday' issue which was due to be released on 1st July 1982. However, due to the Fenlands War, the issue was delayed until 7th September 1982 and the two cancellers were not used.
- **SG-NU03:-** The first day of issue canceller produced for the 'Scouts of the Quest' issue of 15th October 2007 proved to be unsuitable due to the small size of the circumferential text which led to illegible impressions. Although the cancel was printed on the FDC liner, FDCs bearing this cancel have not been reported.

"South Shetlands" positioned above the date such that a line drawn under "South Shetlands" cuts the annular inscription before the "F" of "FALKLAND" and after the second "S" of "ISLANDS". It can be distinguished from **B3** by virtue of the fact that the line "South Shetlands" is slightly lower and there are larger gaps between the "D" of "DEPENDENCY" and the "F" of FALKLAND and between the "Y" of "DEPENDENCY" and the "S" of "ISLANDS" than on **B3**. Impressions of **B4** also tend to be very light. The canceller was destroyed in a fire on 8th September 1946.

A-C-05:- This oval ANTARCTIC HERRITAGE TRUST cachet first appeared in blue on a cover cancelled with **A10** dated 25. DE 05. It is usually seen in combination with the positional dated cachet **A-C-06**. The latest date of use seen is 16.02. 2009 (**A11**).

A-C-06:- Positional Cachet with date line first seen in blue dated 22 DEC 2005 on a cover cancelled with **A9** on 22.12.05. The latest date seen is 16 FEB 2009 on covers cancelled with **A11** dated 16 .02 .2009.

A-C-07: The cachet was reported *in Polarinfo* December 2009 and *Polarkurier* 1/2010, page 40. Examples have been reported on mail cancelled at Port Lockroy from 04 .02. 2010 (A12) to date.

A-C-PRI01 and A-C-PRI02:- These privately produced cachets were supplied by a dealer to the BAT Postal Officer Terry Lay during the 2002/2003 Season. Terry later used them on covers cancelled at Port Lockroy.

A-C-PRI03 and A-C-PRI04:- Unaddressed "SAGA ROSE 2004" and "SAGA ROSE 2005" souvenir covers have appeared on the market produced by Benham Covers. The SAGA ROSE visited Port Lockroy on 29th January 2004 and 31st January 2005. The covers from both years bear a 40p BAT definitive showing Base A, Port Lockroy, cancelled by a 'postmark' depicting the ship and bearing the dates JAN 2004 (**A-C-PRI03**) and JAN 2005 (**A-C-PRI04**) respectively. Thanks to the efforts of Stefan Heijtz, it has been confirmed by the Post Office Administration Sales in Stanley after consultation with Crown Agents who in turn contacted both the Foreign and Commonwealth Office and Benhams that:-

"The cachet is a privately produced souvenir cachet and not an official postmark of the Territory".

Unaddressed souvenir covers also exist cancelled with A7 dated 29 JAN 2004.

Mail from the SAGA ROSE exists cancelled with **A7** dated 31 JAN 2005, the last day of use of the canceller. SAGA ROSE arrived at Port Lockroy at 9pm local time on 31st January 2005 and the station staff stayed up late cancelling all the philatelic mail from the ship prior to midnight when the new self-inking canceller **A9** was introduced (source BAS on-line diary for Port Lockroy 2005/4).

A-C-PRI05:- Benham Covers again produced a private "fantasy postmark" in 2007 for use on covers commemorating the visit of the SAGA ROSE to Port Lockroy (There may well have been an example for 2006). The fantasy postmark is again applied to the 40p BAT definitive showing Port Lockroy. There is no evidence to suggest that these covers were ever at Port Lockroy. The ship visited Port Lockroy on 31st January 2007.

POSTMARKS

D-C-PRI01 (New on Page 80):- Privately produced rubber cachet, diameter 33 mm. The appearance of this cachet is very similar to some of the officially produced cachets and rubber cancellers for BAS Bases. There has not been a British Post Office at HOPE BAY since February 11th 1964 when Base D closed and this cachet was not authorised by the BAT Postal Authorities. The cachet was used during the privately organised cruise, the "Nordenskjöld Polar History Expedition", aboard the POLAR STAR. The cachet was applied to philatelic covers cancelled at the location of the old British Base during the cruise. The site is now occupied by a Uruguayan Base and the Argentinean Base Esperanza is nearby. Postcards exist, which have passed through official postal services with the cachet cancelling BAT stamps. The use of the cachet in this way was unofficial/unauthorised and the postcards were posted in Cambridge England, not in Antarctica.

BASE KG:- FOSSIL BLUFF, ALEXANDER ISLAND (Lat. 71°20'S, Long. 68°17'W)

Fossil Bluff is a forward facility for refuelling aircraft and is operated by Rothera station during the Antarctic summer season between October and March. There is a 1200 m unprepared snow runway (skiway) marked by drums 1 km south of the station.

De Havilland Canada DHC-6 Twin Otter aircraft ferry drums of fuel from Rothera to Fossil Bluff each summer to maintain the size of the fuel depot. The station is 90 minutes flying time from Rothera. It is used extensively as a jumping-off point for further operations into Antarctica. The next 'traditional' stop for the Twin Otters is Sky Blu, 85 minutes away.

Fossil Bluff houses four people in comfort but is normally operated by two to three.

The base has been in use intermittently since 20 February 1961. Occupied during the winters of 1961, 1962, and 1969-75, it has been used every summer since 1975. The first people to overwinter in 1961 were Cliff Pearce and John Smith (meteorologists) and Brian Taylor (geologist) who carried out a thorough and systematic investigation of the local geology.

THE CACHETS

During the Antarctic Summer of 1994/95 Dr R I Lewis Smith and Dr P Convey spent three months at Rothera and on Alexander Island assessing the biological potential of field sites where the future terrestrial programme was to be focussed. Dr R I Lewis Smith used two cachets on mail he sent from Fossil Bluff via Rothera.

Dr R I Lewis Smith again visited Alexander Island during the 1997/98 Antarctic summer season where he investigated the colonization by mosses un UB-B transparent and opaque cloches established in December 1994 in areas of barren terrain.







ALEX-CH01:- The following dates have been recorded: Rothera 19 DE 94 (R11A); 27 DE 94 (R6), 1 FE 95 (R6), and 22 FE 95 (R6). It also appears on a cover cancelled at Faraday on 17 DE 94 (F16).

ALEX-CH02:- The following dates have been recorded: Rothera 19 DE 94 (**R11A**); 27 DE 94 (**R6**), 1 FE 95 (**R6**), and 12 JA 98 (**R11A**). On the 1998 date the cachet was used to cancel the stamps with the Rothera postmark applied alongside.

ALEX-CH03:- The cachet was used by a joint Belgian/British group carrying out research in the Alexander Island Region. All covers recorded have been posted at Rothera. The only postal date reported is 13 NOV 2001 (R14). The covers were clearly flown out from Rothera to Stanley, because they arrived in Europe before the James Clark Ross reached Rothera. (This cachet was previously listed as R-C-PRI12.)

THE POSTMARKS

Fossil Bluff has never had a post office. Mail was handled at Base T, Adelaide Island from 1961 to 1976 and at Base R, Rothera from 1977 to date. Covers exist cancelled at Base T or Base R with handwritten annotations indicating the covers were sent from Fossil Bluff.

R6/R6A (Pages 113 to 114):- Closer inspection of cancels from ROTHERA has revealed that **R6/R6A** was replaced in the 1998/1999 season by a new canceller **R15**. **R15** has slightly larger lettering than **R6** but is otherwise very similar, both cancellers being metal and 24mm in diameter. The difference is just noticeable to the naked eye on originally sized examples and hence a new canceller number has been introduced. The following dates listed in the book for **R6/R6A** should therefore be **deleted**. These dates are now allocated to canceller **R15** (New at the end of Page 116).

The spacing of the bottom of the letters is the same on both cancellers. Thus, because the letters on R15 are taller, the letters are closer together at the top on R15 than on R6. This is particularly noticeable on the "THE" in the middle of "ROTHERA". The overall effect is that the letters look taller and narrower on R15 than on R6.

R11 (Page 115):- In view of the information above concerning **R6** and **R15**, the question arises as to whether all dates listed for **R11** relate to the same canceller. At present, no difference in the lettering on the different star variations has been detected. The "dot" that appeared below the "O" of "ROTHERA" in the 1997/98 season does not appear to be constant and is not associated with a particular "star" variation.

BASE W - LOUBET COAST (Page 117)

In 2009, the Base W Hut on Detaille Island was designated under the Antarctic Treaty System as Historic Site and Monument N°83 and the responsibility for maintaining the hut was eventually transferred from BAS to the UKAHT. Some repairs and restoration work were carried out during January and February 2011 and the work continued in January and February 2013.

Without any prior announcement a seasonal post office operated from approximately 17th January to 12th February 2013. The next visit by a UKAHT team is expected to take place in 2018.

It is not believed that any philatelic covers were produced and it seems that only those tourists lucky enough to have visited the hut during late January and early February 2013 have examples of the postmark.



BRIEF HISTORY

James Ross Island is situated to the east of the Trinity Peninsula to the South of Hope Bay. No permanent BAS base has been located there but BAS scientists have visited the island at regular intervals.

A 28-person BAS geological and biological expedition spent six weeks at James Ross Island and neighbouring islands in January-February 1989, supported by RRS JOHN BISCOE 2. 20 souvenir covers were cancelled with a James Ross Island Antarctica circular cancel **JRI-01** on the first day of the land operations on 12th January 1989. These covers were despatched from Signy with an additional Signy **H10** cancel dated 25 MR 89. Two registered covers cancelled with **JRI-01** were despatched from Signy on 14 FE 89 when the party returned to Signy on board JOHN BISCOE 2. The cachet **JRI-CH01** and the cancel **JRI-01** were supplied by Ronald Lewis Smith, a member of the BAS Expedition.

THE CACHETS





JRI-CH01:- The cachet in red appears on expedition covers cancelled at Signy Island on 14 FE 89 (2 registered covers) and 25 MR 89 (20 souvenir covers), which also bear JRI-01 dated 12 JAN 1989. It was also used on one cover cancelled at Stanley on 25 JA 89 and on a further cover cancelled at Signy on 18 FE 89. The covers also bear cachets of RRS JOHN BISCOE (2). A few other covers cancelled at Signy may exist.

JRI-CH02:- This John Farmar cachet appears with the date 15 MAR 1983 on covers cancelled LONDON M.M. on 15 April 1983 and South Georgia on -3 MAR 1983 (SG22). This "cachet" was also used to cancel a 3p James Clark Ross definitive stamp issued 1973 on some covers that also bear various H.M.S. ENDURANCE cachets.

THE POSTMARK

JRI-01:- This canceller only exists dated 12 JAN 1989 used on BAT stamps or as a cachet dated 12 JAN 1989. It was used without date as a cachet on at least one cover which was cancelled in Stanley on 25 JA 89. The cancel is always accompanied by cachet **JRI-CH01** in red and by a Signy or Stanley cancel. The canceller was produced by Ronald Lewis Smith of BAS.

It had been intended to introduce the new self-inking cancellers simultaneously for all four BAT post offices and the three Falkland Islands post offices. However, SIGNY received the canceller in November 2004 when the JAMES CLARK ROSS brought the summer party to open the base and the base commander immediately brought the new canceller into use. Just to complete the confusion, the new canceller was used on 7th December 2004 with the month set to 01. Unfortunately cancels from the 2004/05 season tend to be incomplete.





SUSPECT POSTMARKS

This section lists postmarks, which have not been officially confirmed as having existed, or which are unauthorised copies, e.g. forgeries.

SUSPECT POSTMARKS OF THE FALKLAND ISLANDS DEPENDENCIES 1944-1949

(based on information and illustrations provided by Douglas Jeffery, Robin Sherman, Edward Caesley, and John Youle)

A cover addressed to Bulgin & Son bearing a suspect type B3 postmark dated '5 FEB 1944' back stamped with a suspect Port Stanley postal canceller dated '8 FEB 1944' appeared as lot 2233 in the Grosvenor Auction N° 40 held on 22^{nd} and 23^{rd} May 2008. It was described as follows:-

"Falkland Islands: 1943-45 Operation Tabarin: South Shetlands: Overprint set of eight (first printings) used on envelope addressed to England with 'false' violet cancellations dated '5 FEB 1944' (genuine date stamps but applied by the Crown Agents at their premises in Millbank, London) and similarly 'false' Port Stanley '8 FEB/44' transit back stamp. Ex Belfield. Estimate £80 - £100".

There are series of similar first day covers from all four Dependencies and they have been reported addressed to three different stamp dealers – Bulgin & Son, John Lister Ltd and Messrs Stafford Allen & Sons Ltd. The covers have a Port Stanley back stamp which in all cases is dated 3 days after the date on the Dependencies postmark. The Port Stanley postmark vaguely resembles Stanley Post Office type PS 3 (A to E). The reported postmarks and back stamps are illustrated below.



It is likely that the 2^D and 6^D Thick Maps stamps cancelled Graham Land 1 FEB 1946 were removed from a First Day Cover. To date none of these postmarks has been reported on the UPU issue of 10th October 1949.

All the postmarks shown only vaguely resemble the genuine postal cancellers in use at the time. The following information may help in distinguishing the "suspect" from the genuine item.

1. The genuine 23.5mm PORT STANLEY single-ringed cancellers types 3A and 3B were not introduced until November/December 1944 and they always have the month in two upper case letters. Their predecessors were double-ringed and larger 25-26mm having a code letter above the date and no star. The month again was in two upper case letters.

- 2. Genuine FDCs from the South Shetlands dated 5 FEB 1944 and from the South Orkneys dated 21 FEB 1944 were received and back stamped in Stanley on 6 MR 44. [FDCs from Graham Land (Port Lockroy) dated 12 FEB 1944 were also back stamped in Stanley on 6 MR 44.] These dates relate to the opening of bases in the Falkland Islands Dependencies during the **Secret** WII Military expedition "Operation Tabarin". The sets of 8 overprinted Falkland Islands stamps were not made available to the general public until after the return of the expedition. Thus there were no philatelic FDCs available to the general public. This does not apply for South Georgia where the 8 stamps overprinted "South Georgia Dependency of" were officially released on 3 APR 1944.
- 3. The gaps between the "F" of "FALKLAND" and the first "D" of "DEPENDENCY" and between the second "S" of "ISLANDS" and the "Y" of "DEPENDENCY" are much too large on the South Shetlands, South Orkneys and Graham Land cancellers.
- 4. Both the South Georgia cancels are suspect because the month is in one upper case and two lower case letters. The genuine postal cancellers which they resemble (SG7 & SG8) always have the month in two upper case letters. The cover dated 16 Feb 1948 bears a Port Stanley registration label (not a South Georgia label) which appears to be type 12A not introduced until 1957.

5. The 6 DEC 1948 South Shetlands cancel is "suspect" because the genuine postal cancellers which it resembles (B3 & B4) were destroyed in a fire on Deception Island on 8th September 1946.

Stefan Heijtz lists FDCs for the Thin Maps issue of 16 February 1948 as unknown. He lists FDCs of the 2½d value from South Georgia as being dated 14 April 1949. I have not seen a genuine FDC for the Royal Silver Wedding issue of 1948 from any of the Dependencies but it appears they exist dated 6 December 1948 from South Georgia.

Edward Caesley, despite enquiries with the British Library (who acquired Crown Agents Archive) and the Falkland Islands Archive, has been unable to confirm that the Crown Agents produced any of these covers and in the author's humble opinion it appears unlikely that the Crown Agents would risk their reputation by "fabricating" FDCs which have in all likelihood been nowhere near the Falkland Islands, let alone the Dependencies.



ALL-C-20:- The new official "PHILATELIC CLERK" cachet was introduced at the beginning of the 2009/2010 Season to replace ALL-C-11 which had run out of years. It seems that the cachet was applied to mail sent to the BAS bases via Stanley before the departure of the RRS James Clark Ross. The cachet has been recorded dated 23 OCT 2009 on mail sent from Rothera on 01 .12 .2009 (R17), Halley on 30 .1 .10 (Z18) and Port Lockroy on 6 .12 (2009 missing) (A12). However, the Philatelic Clerk, Hugh Marsden, only visited Signy and Grytviken!

ALL-C-21:- The cachet was produced by Terry Lay for his trip as BAT Postal Clerk to Rothera in December 2010. It has appeared on covers cancelled at Rothera with R18 dated 3 .12. 2010.

ALL-C-22:- The cachet was produced by Geoffrey Barber for use by Terry Lay, BAT Postal Clerk. It is first reported used in BAT dated -3 DEC 2010 on covers cancelled at ROTHERA with R17 dated 3 .12. 2010. It was also used dated -7 NOV 2010 on mail cancelled in Stanley on 17. 12. 10. The text is in blue and the date in red. Please note that the cachet is nearly identical to ALL-C-09. However, the spacing of the wording is slightly different.

ALL-C-23:- The wording layout on this cachet is identical to that on ALL-C-11 but the date line is in smaller print. It is also known that this is a new cachet because Terry Lay has reported that ALL-C-11 ran out of years and that he introduced this new cachet during his trip to Rothera in December 2012. The dates reported so far are 17 DEC 2012 (postmark Port Lockroy A12 22 .12. 2012), 21 DEC 2012 (postmark Rothera R16 21. 12. 12) and -3 JAN 2013 (postmark Stanley 5 / 04. 1. 13).

SHIPS' CACHETS

ROYAL RESEARCH SHIP SHACKLETON (pages 157 to 158)

The following corrections are necessary on pages 157 and 158. RRS SHACKLETON did not go to the Antarctic during the 1983/84 season. The cover reported bearing **SH-07** cancelled at SOUTH GEORGIA 14 DE 83 was originally sent South in the 1975/76 season. However, it was returned to the sender bearing the cachet but without passing through the post and the stamps were not cancelled at that time. The owner then sent the envelope South again in 1983 resulting in the 14 DE 83 cancellation on the stamps. Thus the last Antarctic voyage of RRS SHACKLETON was in the 1980/81 season.

Thanks to Rev. Father M.N.W. Edwards I can report on the life of the SHACKLETON after she was retired by the NERC. In 1984 she was re-named GEOTEC BETA and re-registered in London. Her owners were Hydrosphere Shipping Ltd. In 1992 she changed name again, this time to PROFILER and her owners were Gardline Shipping Ltd. In 1992 her name was changed to SEA PROFILER and registration changed to Panama, but ownership remained the same. However, in 1998 her owners changed to Gardline Surveys Ltd and she is still going strong after 50 years!

SH-03:- Further observation has shown that the example of SH-03 illustrated in the book has been amended by hand to correct N.H.P. to B.H.P in the final line of the cachet. I am now able to illustrate also the uncorrected version.

ROYAL RESEARCH SHIP JOHN BISCOE 1 (page 159)

JB1-01:- Two further examples have come to light on covers cancelled at ADMIRALTY BAY JA 31 55 and DECEPTION ISLAND 31 DE 55.



JB1-03:- This early use of a Commanding Officer cachet has only recently come to light. It appears dated 6 APR 1956 on covers cancelled at THE ARGENTINE ISLANDS with **F3** dated FE 24 56 and SIGNY ISLAND with **H2** dated 29 MR (56). From the dates the cachets must be from the final season of R.R.S. JOHN BISCOE 1. The cachet differs in detail from **JB2-08**. In particular the date line type is larger.

ROYAL RESEARCH SHIP JOHN BISCOE 2 (Pages 159 to 160)

Cachets **JB2-03**, **JB2-06** and **JB2-08** dated 12 MAY 1957 appear on a cover cancelled at TRISTAN DA CUNHA on 17 JAN 57. This is the date of the visit of H.M.Y. BRITANNIA. Did JOHN BISCOE 2 really visit on this date as well??

- JCR-14:- The 2002/2003 season cachet has been reported on mail from SOUTH GEORGIA dated 12 OC 02 (SG27), from SIGNY dated 25 OC 02 (H14), PORT LOCKROY dated 11 DEC 2002 (A8) and from ROTHERA dated 5 DEC 2002 (R15), 6 DEC 2002 (R15).




KRS JAMES CLARK ROSS VOYAGE 13 2003/04



- JCR-16:- The 2004/2005 season cachet has been reported on mail from SOUTH GEORGIA dated 7 N0 04 (SG27), PORT LOCKROY dated 9 DEC 2004 (A7) and ROTHERA dated 18 DEC 04 (R14) and 24 JAN 2005 (R14). The 1st attempt to reach ROTHERA in December 2004 failed due to the ice conditions and the JAMES CLARK ROSS did not finally arrive at the base until 23rd January 2005.




RRC JAMES CLARK ROSS VOYAGE 15 2005/06 JCR-17

- JCR-18:- The 2006/07 cachet includes the common spelling mistake of "ANTARTIC" for "ANTARCTIC". The cachet was used at ROTHERA on 15.12.06, 16.12.06 and 22. 3.07 (all R16) and at SIGNY on 23.12.06 (H19). All impressions seen are weak in the area of the forward superstructure.



JCR-20: Dates reported are STANLEY 14.11.08, SIGNY 17. 11. 08 (H19), SOUTH GEORGIA 1 21. NO 08 (SG62) and STANLEY 03. 12. 08.



JCR-22: The cachet is reported on mail from SOUTH GEORGIA postmarked with SG62 (1) dated 30. OC 09, and 5. FE 10, from PORT LOCKROY with A12 dated 23 .12. 2009 and 27 .02. 2010, from SIGNY with H19 dated 06. 11. 09 and 30. 3. 10, from ROTHERA with R17 dated 3 .12. 2010 and from HALLEY with Z18 dated 01. 3. 10.

JCR-23: The cachet is reported on mail from SOUTH GEORGIA postmarked with SG62 (1) dated 24. NO 10 and from ROTHERA with R17 and R18 dated 3.12.2010.

JCR-24: The cachet is first reported on mail from ROTHERA postmarked with R18 dated 3 .12. 2010. Most examples seen have a white area where the cachet did not properly register. This cachet is similar to JCR-18 in that the word "ANTARTIC" is incorrectly spelt.



The above images of JCR-25 to JCR-27 are reduced to 50% linear.

- JCR-25: This large cachet approx. 6.6cm in diameter has appeared on covers cancelled at ROTHERA with R18 on 3.12. 2010. Most examples seen have a white area where the cachet did not properly register.
- JCR-26: The cachet approx. 6.6cm in diameter appeared on covers cancelled at SOUTH GEORGIA with SG62 dated 1 04. NO 11, at SIGNY with H19 dated 18. 11. 11 and 20. 1. 13 and at HALLEY dated ?? 3. 12 and 25. 12. 12 (both **Z18**).
- JCR-27: The cachet approx. 6.6cm in diameter appeared in red on covers cancelled with R16 at ROTHERA on 21.12.12, at SIGNY on 20. 1. 13 (H19), at HALLEY on 02. 3. 13 (Z18) and at SOUTH GEORGIA on 1 11. MR 13 (SG62).

It has also been used on covers cancelled at ROTHERA with R18 on 3.12. 2010.
- JCR-PRI-02:- This large coloured adhesive label was privately produced. It appears on covers cancelled at SOUTH GEORGIA on 22 MR 01 (SG27).

ESH-02:-The earliest reported date of use of the tonnage cachet is now 29 NO 99 (SG27) at South Georgia.

The arrival of RRS DISCOVERY II at Macquarie on 13th December 1950 is confirmed by Milner. Milner reports that RRS DISCOVERY II visited Heard Island in September 1951.

They have not been seen on any mail from the ship when she was used for the Discovery Investigations from 1929-1951. **DIS2-07A** is a variation **of DIS2-07** with the '2' of the day entered by hand in black ink. Unfortunately the number it is written over cannot be deciphered.

CD-03:- This tonnage cachet has only been seen on a cover cancelled at Halley with **Z7** on 19 FE 90. The RRS CHARLES DARWIN has never called at Halley and was not in Antarctic waters during the 1989/90 season.

CACHETS OF OTHER RELIEF SHIPS OF THE BAS BASES (Page 169)

S.S. FITZROY (add prior to MV TOTAN on page 169)

S.S. FITZROY was operated by the Falkland Islands' Company for inter farm transport in the Falkland Islands and for transport of goods between Montevideo and the Falkland Islands. She was also used during Operation Tabarin and in the early years of the Falkland Islands Dependencies Survey for supplying the FIDS Bases.

FITZ-01:- This single line cachet appears on covers cancelled at Deception Island on 14 JAN 1946 with canceller **B4** and in Graham Land on 15 JAN 1946 with canceller **E1A** (Base A?). It is accompanied by a single line signature cachet reading "Frederick Jones" on both covers.

FITZ-02:- The cachet differs from **FITZ-01** by virtue of the spacing of the lettering. It has only been reported used at Port Stanley, Falkland Islands, on 20 NOV 1952.

PRO-08:- The earliest recorded date is now 20 MAR 1962 at TRISTAN DA CUNHA with CAPE TOWN 26 III 62 or TRISTAN Cachet dated 20 MAR 1962.

PRO-10A:- Len and Sue Farmer report a "new" PROTECTOR cachet PRO-10A used on a cover cancelled at TRISTAN DA CUNHA on 21 APR 1964. This cachet differs significantly from the cachet PRO-10 in use at the time. The wording of PRO-10A seems to have been typed and appears in a bright pink colour. It could perhaps have been printed on the cover using a Roneo machine. The example of PRO-10 shown dated –2 APR 1964 is on a cover postmarked CAPE TOWN PAQUEBOT 7 IV.64-14.00. It is in a bright pinkish-red colour.

PRO-13:- The earliest recorded date is now 19 DEC 1966 with the stamps postmarked 12 JA 67 (**B6**) at Deception Island.

HMS PROTECTOR 2 - A173 - 23rd June 2011 to date (New after Page 172)

On 21st March 2011, the Minister of Defence, Lord Astor, announced in the House of Lords that the Norwegian ship MV POLARBJØRN launched 2001 would be leased for three years by the Royal Navy from the Rieber shipping Company while the future of HMS ENDURANCE 2 was decided.

The ship arrived in Portsmouth on 23rd May 2011 bearing the name MV PROTECTOR. She was renamed HMS PROTECTOR on 1st June 2011 and commissioned on 23rd June 2011, the 50th Anniversary of the entry into force of the Antarctic Treaty. The ship is similar in appearance to RRS ERNEST SHACKLETON also owned by the Rieber Shipping Company and leased to NERC/BAS.

The new ice patrol vessel could not be named HMS ENDURANCE while HMS ENDURANCE (2) was still commissioned. [The Royal Navy frequently reuses ships' names after the previous ship of the same name has been decommissioned. I assume that, if the Royal Navy decides to buy the ship after the expiry of the lease, it will keep the name HMS PROTECTOR.

I shall use 'PRO2' to distinguish any cachets reported from those of its predecessor as ice patrol vessel. However, I understand that the current ship is the 6th Royal Navy vessel to be commissioned under the name PROTECTOR.



END1-01:- The earliest recorded date is now 19 NOV 1968 with the stamp cancelled LONDON MARITIME MAIL 25 NOV 1968.


END1-01A:- The earliest recorded use is now with no date but "N°30" inserted in the date line with the stamp cancelled LONDON MARITIME MAIL 31 JAN 1969. This is rather surprising, because END1-01 was still in use at

this time!

END1-DE-11:- A further date of use has been reported - ADELAIDE ISLAND 15 FE 71 (T1). The cachet is applied in

mauve.

END1-DE-13A:- A much earlier date of use has come to light 10 JUN 1974 at PORTSMOUTH AND SOUTHSEA (10 JNE 1974).

END1-DE-31:- Thanks to Terry Lay I can now illustrate a further departmental cachet from the first HMS ENDURANCE. The cachet was applied to letters (not the envelopes) requesting photos of HMS ENDURANCE after her return to Chatham following the Falklands Conflict. The date line is clearly not part of the cachet.

END1-DE-32:- This cachet has only been reported on a cover cancelled at Stanley on 7 MR 88.



appears on a cover bearing a very light cachet **END1-03** dated "1971". It was sent by Merrill and delivered to Harry Evans at his official bank address during the postal strike. The GB 5d stamp is uncancelled. Harry applied a bank receiving mark dated 3 MAR 1971 to the cover.

- **END1-MIS-10** is very similar to the penguin cachet **END1-JF-16** used in 1983. This little fellow, however, appears on a cover from SOUTH GEORGIA with the SOUTH GEORGIA stamps cancelled with a cachet similar to **END1-JF-28** dated 09 DEC 1988. The stamps are also cancelled with a LONDON MARITIME MAIL cancel dated 4 JA 1989.
- END1-MIS-11 has been used during 1983 on covers signed by Nick Barker bearing GB stamps cancelled PORTSMOUTH 14 OCT '83 and on covers signed by E. MacGregor franked with Gibraltar stamps cancelled GIBRALTAR 15 NO 83.
- END1-MIS-12 was around for some time yet does not appear on any of my own covers. This single line cachet appears on a cover cancelled in LONDON on 31 JAN 1969 and on a further cover bearing both END1-06A and END1-DE-05 dated 2 FEB 1983, the cover being cancelled at JAMESTOWN, St HELENA on FE 4 83. A further example exists in blue on an envelope cancelled BFPO LONDON 24 APR 69 with backstamp P'MOUTH 25 APR 69. The cover also bears END1-DE-01 in blue and END1-01 in red dated 20 APR 1969.



- END2-05:- The cachet is first reported used dated -6 MAR 1995 (SOUTH GEORGIA 95 MR 12). The cachet is still in use. The latest date seen is 20 JUL 2005 on covers cancelled, Trafalgar 200, International Festival of the Sea, PORTSMOUTH 2 July 05 (BFPS 2863). Part of the body and tail of the Albatross is missing
- END2-10:- This cachet (in red) appears on covers cancelled at STANLEY 5 JA 01. The covers also bear END2-07 (in black) dated 01 JAN 2001. It has also appeared on a cover from PORT LOCKROY cancelled with A8 on 29 NOV 2001 and a cover from Halley cancelled with Z17 on 07 FEB 2002. In 2003 it has appeared on covers from SOUTH GEORGIA cancelled with SG27 dated 11 FE 2003 and is still in use, the latest date seen being on a cover cancelled with R17 dated 21 .02. 2008. I have been informed that there is likely to be more than one copy of this cachet. One example is reported to be available for use in a shop in Stanley.
- END2-11:- The cachet in black dated 10 JAN 2006 appears on a cover cancelled at Rothera with R16 on 22. 2. 06.



END2-12:- A second "WHEN HELL FREEZES OVER" cachet has come to light. It can clearly be distinguished from **END2-10** because the text is now in three lines and the lines representing the sea are curved rather than pointed. The cachet has been reported on a cover cancelled at Punta Arenas, Chile, on 18 DIC 2008.

END2-DE-16:- This appears to be a privately produced cachet in that it does not fit the design of the official departmental cachets. It appears on a cover cancelled with **R17** dated 21 .02. 2008. The wording is applied in blue with the date 05 FEB 2008 in red and relates to a helicopter flight from HMS Endurance to the Ukrainian Vernadsky Base (formerly BAS Base F 'Faraday') on 5th February 2008.

END2-DE-17:- The cachet dated 10 DEC 1995 was applied to a cover from Signy cancelled with H14 dated 12 FE 96.

H.M.S. ENDURANCE 2 was severely damaged in the Magellan Strait in December 2008 when the engine room and lower decks were flooded. The ship returned to the UK on board the semi-submersible transporter ship MV TARGET arriving Portsmouth 8th April 2009.

H.M.S SCOTT replaced H.M.S. ENDURANCE 2 for the 2009/2010 and 2010/2011 Antarctic Summer Seasons.

On 21st March 2011, the Minister of Defence, Lord Astor, announced in the House of Lords that the Norwegian ship MV POLARBJØRN launched 2001 would be leased for three years from the Rieber shipping company to replace HMS ENDURANCE 2. The MV POLARBJØRN was commissioned under the name HMS PROTECTOR on 23rd June 2011.

A decision on the future of HMS ENDURANCE 2 is awaited.

HMS SCOTT - H131 (New after page 186)

HMS SCOTT replaced HMS ENDURANCE 2 for the 2009/2010 and 2010/2011 Antarctic Summer Seasons. HMS SCOTT is an ocean survey vessel of the Royal Navy, and the only vessel of her class. She is the third Royal Navy ship to carry the name, and the second to be named after the Antarctic explorer, Robert Falcon Scott. She was ordered to replace the survey ship HMS HECLA. The ship is not ice-strengthened.
