2. As we do not have qualified persons in Homiletics to be appointed immediately, we have decided to involve the following persons to help: (Consent letters attached).

  - b. Rt. Rev. Dr. Pothi Rajulu
  - c. Rev. Dr. Ajith Prasadam
3. We are not involving Rt. Rev. Dr. James Srinivasan and Dr. Siga Arles for teaching.
4. We involve qualified teachers from the branches of Social Analysis and Communication for teaching select sections of course outlines.
5. As per the observations of the Commission we have already made arrangements for purchase of books in the following areas: We have received many books and we have placed the order for more books. (see details in attachments)
  - a. Craft of constructing sermon
  - b. Homiletical theories
  - c. Recent trends in Homiletics
  - d. Collections of sermons
  - e. Church and ministry
6. We have made necessary provision in the Seminary budget for the purchase of books in this area.
7. Regarding M.Th. Religions, as we have a special focus on Pali language and Dalit religions, only now we are able to develop students qualified in Pali. We have reapplied to the Senate for permission. We are happy to know that an Evaluation Commission has been appointed and we await for their visit.
8. As per the decision of the Senate, the present two students will write the first year examinations to the Senate.
9. We have reshuffled the courses to equally share the workload of the students in two years.(Details attached)
10. Having realized the importance of this course in Pastoral ministry and as no other College/Seminary offers such a course, in spite of some limitations in fulfilling completely some recommendations of the Senate, we request the Senate to consider this a very special one and permit us continue to offer this course.

**Compliance Report for B.D. Program in English medium**

The Management and the members of Faculty of MTSC thank the members of the Senate working Committee for accepting our request to offer new B.D. program from the academic year 2010-2011. We also thank the members of the Evaluation Commission.

As per the suggestion of the Evaluation Commission, our Bishop and the College Board have taken the following steps.

The following faculty development has been made from June 2010.

Miss. Holi Kali has been appointed in the field of History of Christianity as full time faculty.

Mrs. Helena has been appointed as part – time faculty in the field of Women Studies.

Rev. D. Michael Raj and Rev. A. Mohan, our full time faculty members have M.A. in the branch of Sociology and Philosophy respectively.

We are looking for candidates in the field of Christian Ministry and Psychology to be appointed from June 2010.

Budgetary provision of Rs. 5 lacs per year for next three years and improved hostel facilities are as follows:

**Hostel Facilities for Boys:**

In Men's Hostel we have 30 rooms (10 rooms in each floor) out of which we are using two rooms in the first floor as guest rooms, one as store room, one as medical/sick room and another one shared by two of our Non-teaching staff. Male students are accommodated in the 25 rooms and each room is shared by 3 or 4 boys from different ethnic backgrounds and denominations. We take extreme care in allotting the rooms so that there will be not regional, denominational or racial divisions between the students during their stay in our seminary. They were provided with bunker cots and some individual cots, brick cupboards, table and chairs. As per the suggestion of the Evaluation report, we are working on the possibilities for accommodating two B.D. students in a room, since our men's hostel rooms are big and spacious enough to accommodate two persons in a room. As usual this year also, in the month of May, we will be doing the needed repairing works in the hostel rooms, toilets and bathrooms.

**Hostel Facilities for Girls:**

The present Girl's hostel is situated at the first floor of the Principal's residence which consists of two big dormitories in which six girls are accommodated. They are provided individual bunker cots and wooden or steel shelves to keep their belongings. Besides they were also provided with table and chairs for their studies. As per the suggestions of the Evaluation report, we may not be able to provide individual rooms for the girls due to the lack of facilities available as of now. Even though they were accommodated in the dormitories, they are provided with good cots, shelves, tables and chairs. Our Girls Hostel can easily accommodate 15 girls. As of now, we have only 6 students staying in Girls' hostel. May be when the strength increase to more than 15 we will have to seriously think of extending our girls' hostel facilities. As of now, for the forthcoming academic year, there may not be any problem in accommodating the girls in the present facilities that we have.



**Indian Theological Seminary, Avadi, Chennai**

**Compliance Report**

The Senate Evaluation Commission consisting of Rev. Dr. Ravi Tiwari, Rev. Dr. P. Mohan Larbeer and Fr. Dr. John Mathews was scheduled to visit GGM's Indian Theological Seminary on September 12, 2009. However, as Fr. Dr. John Mathews was unable to visit ITS on the 12<sup>th</sup>, he made a solo trip on the 16<sup>th</sup>.

The Evaluation Commission appreciated some aspects as well as expressed the need for improvement in several areas of GGM's Indian Theological Seminary. The Seminary and its administration is grateful to the Evaluation Commission for its wise advice and suggestions for growth and development.

**Library:**

Funds for the construction of a new library are available. The new library will be equipped with all of the books on the B.D. syllabus and will have more space for reading and storing books. As of now, ITS has been able to attain through purchases and donors, one-third of the books on the syllabus. Funds to purchase the remaining two-thirds are available. The remaining books will go on the shelves before the commencement of the next academic year.

**Physical Features:**

1. A Television will be provided for the students for recreation purposes and to be more aware of current affairs.
2. More computers with internet facility will be added in the new Library. A separate computer lab has been planned in the layout of the new Library.

**ITS's plans for implementation:**

1. Teaching staff are already provided with a job description at the beginning of the academic year describing the various responsibilities of faculty members. The work load of the faculty is also distributed according to the Senate requirement.
2. Plans to construct staff Quarters on campus are underway.
3. ITS has already started the Provident Fund for its employees, Study Leave is also available to Faculty who plan to upgrade their academic qualifications.
4. ITS already has a separate budget.
5. As of now, ITS has several student leaders who are responsible for various college activities. Upon the recommendation of the Senate, from the next academic year, the student leaders will form a society to discuss student issues.
6. Students from various denominational backgrounds are welcome to study at ITS. As of now, we have students from Methodist, Presbyterian, Lutheran, CSI, Pentecostal, Baptist, Independent etc. Any student who adheres to the ITS Statements of Faith is eligible for admission.
7. Two faculty members and three non-teaching staff members have worked for ITS for five to ten years. The Seminary hopes to take steps to encourage current teaching and non-teaching staff to continue likewise..
8. The improvement of the Library is at the top of the list for growth and development in ITS. Funds for the construction of the new library and for the purchase of books on the B.D. syllabus are available. The new books will be shelved before the commencement of the B.D. course.
9. As per the recommendation of the Senate, new books in all the disciplines are being sought and purchased. Similarly, subscriptions to new journals are being made and reference books attained through purchase or generous donors.

10. Improved accommodations for students are also at the top of the list of priorities. Plans for a separate dormitory for female students and better equipped rooms for both male and female students. A separate floor of the female dormitory will be set aside for apartments for married students.
11. Plans to stabilize the Seminary's financial status are underway.
  - a. ATA courses will be handled separately.
  - b. Service Rules of the Seminary are attached.

**Senate Recommendations:**

1. ITS has taken note of all the Senate suggestions and is in the process of implementation.
2. ITS already has faculty members in the branches of Christian Ministry and Sociology and has employed two additional faculty members for Religions and Women's Studies. Please find attached copies of Mr. Murugesan's certificates. Mrs. Helena has not received her degree from the Senate as yet. Enclosed is a copy of her mark list.
3. Ms. N.G. Prasuna will complete her D.Th. thesis by May 31, 2010, prior to the commencement of the B.D. course.
4. Steps to better equip the Library with books, periodicals and journals are being taken and will be ready before the next academic year.

**Conclusion:**

GGM's Indian Theological Seminary has taken and is continuing to take various steps to upgrade itself to the standard set by the Senate of Serampore for the B.D. course. We hope and pray to be ready and to begin in the 2010-2011 academic year. We thank the Senate for all the encouragement, prayers and support that ITS has enjoyed for the past ten years as a B.Th. Seminary. It is indeed a blessing to be a part of the Senate Family as we begin this new course. Thank you once again.

**Report of the Evaluation Commission**

**June 26, 2010**

The Senate of Serampore received an application from United Theological College, Bangalore to commence MTh programme in the Department of Christian Theology after an interval of three years. As per the regulation, the Senate appointed a Commission consisting Dr. K.A. Abraham, Dr. Wati Longchar and Dr. Ravi Tiwari, Registrar, as members, to assess the status of the Department to offer M.Th in Christian Theology which was discontinued in 2007. Due to unexpected circumstances, the Registrar was not able to participate. So in consultation with the President of the Senate, it was decided to request the Chairperson of the Academic Council, Dr. P. Mohan Larbeer, to coordinate the Commission. The Commission visited the College on June 26, 2010.

The Commission members had a good and pen discussion, met the department Faculty Members and M.Th students who are selected for admission for this academic year. The commission members also met three members of the Governing Board (Principal, Bursar and Secretary of the Council who is also a faculty member). They visited library, class rooms and hostel.

3. Dr. D.J. Prabhakar has been teaching since September 2007 and will be completing three years of teaching in August 2010..
4. Dr. Mohan Razu's name is given as adjunct Faculty but it was informed by the Principal that he has been dismissed by the college.
5. Dr. P.J. Rufus who belongs to department of Ethics is listed as adjunct faculty and he has not completed three years of teaching as required.
6. Dr. K.C. Abraham and Dr. Godwin Shiri's names are given as adjunct faculty.

6. There is no written agreement between the faculty and the college regarding the faculty's commitment of the period of service to the college.
7. It was informed that since two of the professors left the college, they could not offer the course and it was discontinued in 2007.
8. The same can be repeated in future since there is no any written agreement between the college and the faculty regarding their stay.
9. There is no guarantee of the present faculty members staying till the present batch completes the course.
10. As per the information received from the Principal it is necessary to get permission from the Executive committee, the highest body before anyone apply for jobs, and before leaving, lecturers should give three months notice and the professors need to give six months notice in advance.
11. It is better the college seriously plan to promote one more person preferably a woman to qualify for teaching at least with M.Th to meet any eventuality.

### **FACILITIES**

1. All the single students are given single rooms and married students are provided quarters.
2. Rooms are having all basic necessity for students.
3. Class rooms are spacious. There are enough numbers of class rooms.

### **SCHOLARSHIP**

First year students do not get any scholarship and only in the second year they will get as per the rules which is 75%, 50% and 25%.

### **FINANCE**

1. The department is not having any specific budget allotment. It is covered by the total budget of the college.
2. There is no specific allotment for the department library books and journals. Out of the total library budget of Rs.34,25,000, only Rs.4,50,000 is allotted for the books which is for B.D., M.Th., and D.Th programmes.

### **LIBRARY**

1. Library has reasonably enough collection of books
2. Library has qualified librarian and staff.
3. They have linked with ATLA e journal facilities.
4. As per the information they also get gift books from their friends and supporters.
5. The overall amenities at UTC and facilities etc are conducive to study and research.

### **STUDENTS**

1. Five students are admitted for this academic year.
2. They had strict selection process.
3. Two of them are under Faculty Development programme and others have strong hope that they will get immediate opportunities.

### **OBSERVATIONS**

1. The college linked both Theology and Ethics and formed as one department.
2. It is appreciable that UTC has been waiting to restart the M.Th Christian Theology course till they are able to fulfill the requirements.
3. It is advisable that the college do not depend on retired persons for teaching but better to encourage their own resources available in the campus.
4. They have a very qualified person in the faculty to teach Christian Theology but that person is not even recognized as adjunct or supportive staff.
5. There seems to be a delinking between MTh Theology and MTh Women's studies in the College which is against the spirit of ID programme within the Serampore framework. Even the Faculty members of Women's studies could be used as the adjunct faculty of theology and vice-versa.
6. Even the subject on Feminist Theology is taught by a male professor when two women experts on this subject are available.
7. It would have been helpful if the Dean of P.G studies participated in the commission discussion to get an overall picture of the post graduate studies. Due to the absence of the P.G. Dean the commission members could not get the full picture of the P.G. Department and interconnection between different departments.
8. This programme was stopped since two of the faculty members left for some other jobs and there is no guarantee that it will not repeated.

9. College do not have any strict agreement with the staff for a minimum period so that there is a guarantee for the continuation of staff at least for the guaranteed period.
10. As per the Senate requirement of Rs. Three lakhs need to be the budgeted for Library for any M.Th course but in their total budget for books only Rs.4.5 lakhs is allotted for books for all the departments
11. It also should be noted that outflow of the faculty is also because of low salary so it is advisable that the college should seriously consider giving Senate recommended salary.

#### **RECOMMENDATIONS**

- i. They have fulfilled all the present basic requirements of the Senate to restart the M.Th course.
- ii. It will be advisable that the Dean of P.G. studies takes responsibility to coordinate the future commissions.
- iii. The college also should find another person and send that person for higher studies under faculty development programme in case of any eventuality.
- iv. It will be good to find a woman as a third faculty.
- v. It will be good if the college takes effort to implement the Senate's suggested salary proposal.
- vi. There is a need for enough budget allotment for the library in their total college budget.
- vii. In the light of above observation, the Senate may give clearance and allow the college to offer M.Th in Christian Theology from 2010 academic session.

**Report of the Evaluation Commission**

**June 25, 2010**

The United Theological College, Bangalore applied to commence MTh programme in its Department of Women's Studies. The Senate of Serampore College (University) appointed a Commission consisting Dr. Mary John, Dr. Gabriela Dietrich and Dr. Ravi Tiwari, Registrar, as members, to assess the status of the Department to offer M.Th in Women Studies which was discontinued in 2007. Due to unavoidable circumstances, the Registrar was not able to participate. In consultation with the President of the Senate, it was decided to depute the Chairperson of the Academic Council, Dr. P. Mohan Larbeer, to coordinate the Commission. Accordingly the Commission visited the college on June 25, 2010.

The Commission members met the Principal, Faculty Members and students of the Department, MTh Students. They also met three members of the Governing Board, who are residing in the campus. They visited hostel, class rooms and library.

**FACULTY**

1. There are two senior women faculty members in the department.
2. One faculty member has done her doctoral studies in systematic theology but opted to concentrate in Women Studies for a long time and she is considered expert in this field.
3. Another faculty member has done D.Th in women studies.
4. In the application Dr. Leela Rao name is mentioned as supportive staff but in the discussion with the Principal and the Secretary of the College Council it was said that it is a wrong information.
5. Last time the course was discontinued because one of the two faculty members went for sabbatical leave, now there is no assurance that that experience may not repeat again.
6. There is also possibility of one or even two of the faculty members can go for better opportunity, in that case the course will be stopped again.
7. The College does not have any agreement with the faculty members for their minimum stay.
8. There is no guarantee of the present faculty members staying till the present batch completes the course.
9. At present there are two version regarding staff policy; one of the department faculty members expressed the opinion that only at the time of leaving the institution, three months notice is necessary, but it is not necessary to inform the management before applying anywhere. According to the Principal, on the other hand, it is necessary to get permission before applying anywhere, and before leaving, lecturers should give three months notice and professors need to give six months notice in advance.
10. There is a need to have one more faculty member at least at the level of M.Th with research experience.

**FACILITIES**

1. The present two student are in the ladies hostel and provided a shared room. First year students are given two bedded room and second year students are given single room.
2. Rooms are having necessary facilities for a student.
3. First year male students are having single room accommodation so the college should think of providing single accommodation for girls students also.

## **SCHOLARSHIP**

Both the students are getting 75% of scholarship out Rs.66,600 which is full annual fees.

## **FINANCE**

1. The women studies department is supported by Kirkenatie Holland and the assurance is already given for funding for about Rs.4,45,000 until 2011.
2. There are two version regarding their support to women studies library grant. According to the women studies staff the grant includes Rs. One lak for the women studies library but according to the bursar kirkenatie do not give any money for the women studies library.
3. In the college library budget out of Rs.34,25,000 only Rs.4,50,000 is allotted for the books.

## **LIBRARY**

1. Library has reasonably enough collection of books but it is scattered in different department stakes
2. There are very limited exclusive journals and magazines.
3. They have recently introduced online documentation
4. Library has qualified librarian and staff.
5. They have linked with ATLA e journal facilities which helps them to access to present and past journals.

## **STUDENTS**

1. Three students have applied and all the three got the admission.
2. One student from outside India did not join due to visa problem
3. Other student are from North East India
4. Both of them are having fear about their future that too after hearing the stories of the former students of UTC women studies department who came for the consultation.
5. Two students were not informed at the time of interview that the admission is a conditional one and it depends on the recommendation of the Evaluation Commission and the approval of the Working Committee.
6. Both the students do not have basic requirements to join M.Th. One student has done only one paper in her B.D another one student has done two papers. So there is a need for them to do three months preparatory qualifying course as per the prerequisite of the Senate.

## **OBSERVATIONS**

1. This exclusive women studies M.Th discipline should be seen in the light of the recent B.D new curriculum where different disciplines are clustered and the anticipating new curriculum.
2. The future of the students should be seriously taken consideration and should not be dealt lightly
3. Most of the seminaries do not offer three courses related to women studies and maximum few seminaries only offer Serampore compulsory course that is only one paper for that they may not require one full time faculty member.
4. At the same time the identity of the women studies should be some how recognized, it should not be diluted.
5. This programme was stopped since one of the two staff went for sabbatical and there is no guaranty that it will not be repeated.
6. It should have started again immediately after the arrival of that staff but there is a gap of three years.
7. College do not have any strict agreement with the staff for a minimum period so there is a possibility that staff can leave at any time if there is any ecumenical post available by just giving three months/six months notice. Then only the students are the sufferer.
8. If anyone of the staff leaves at any time then the whole programme will suffer; what the college genuinely expect to promote will not happen.
9. As per the Senate requirement of Rs. Three lacs should be the budget allotment for any MTh course but in UTC budget only Rs.4.5 lacs allotted together for all the courses.
10. Women studies related journals and magazines need to be increased.

## **RECOMMENDATIONS**

- i. It is advisable to integrate the women studies with some related subjects like theology, mission or history so that the student can manage two areas in teaching and ultimately the colleges also will be benefited.
- ii. The college should get written agreement from the present two staff that they will continue for at least till the completion of the present batch.
- iii. The college also should find another person and send that person for higher studies under faculty development programme in case of any eventuality.
- iv. There is a need for enough budget allotment for the library in their total college budget.

- v. The students need to do three months pre requisite qualifying course in the college to qualify themselves for M.Th.
- vi. In the light of above the course can be started after UTC sending the compliance report of the above recommendations.

**I. Introduction:**

The Academic Committee of the Senate of Serampore College received an application from the Tamilnadu Theological Seminary, Madurai, for offering M.Th. in Religions, in English medium along with the existing branches they are offering, and had constituted a Commission consisting of the following members (WC/12/10):

The Evaluation Commission visited the Seminary on July 09, 2010.

The Commission met with the Principal, the faculty and the staff of the Religions Department. The Commission visited the campus, hostel, classrooms and Library.

**II. Observation:**

1. The Commission noted that the following can be considered as the core faculty for the branch of Religions:

1. It is noted that Dr. Kerstin Karin Neumann has a Ph.D., which does not have language requirements for the degree.
  2. It is noted that the visiting professors may be available but without any commitment for next 3-5 years.
  3. The College has Rev. Dr. Bikkhu Bodhipala to take care the courses in Pali and special study in Buddhism but he is only a visiting professor.
  4. Professor Ramani has a specialization in Ethics and has to be considered as professor in that department though he may take courses related to his studies at Ph.D., at M.Th. level.
  5. The Commission noted that the condition for M.Th. studies in Religions was granted to TTS in 2006 but it has not avail the opportunity and could not offer the course in Religions for last 4 years.
  6. It is also noted that the department of Religions has suggested but not available any course in Dalit and

- South Indian (Tamilnadu) religious traditions in graduate and post –graduate level.
7. It is also noted that the special study of Buddhism, non-Brahmanik religions are not being offered at B.D. level.
  8. The Commission noted that satisfaction with courses in Pali language offered and a few students has appeared in Senate examination.
  9. The Commission noted that the College has enough accommodation for single and family in the campus. It also has satisfactory provision for the classrooms for the students.

### **III. Library:**

1. The Commission noted that the library is quite equipped in the field of studies.
2. It was, however, noted that the College has not updated itself in the fields of non-Brahmanic and Dalit religions. It is also not spent the stipulated amount for up-gradation.
3. The Commission also noted that more computers/internet connections are provided in the library. The e-library section has been added and online journals and books are now available to the students.

### **IV. Suggestions:**

The Commission suggested the following:

- i. The library should be up-dated in the branch of Religions.
- ii. The College should encourage studies of non-Brahmanik, South Indian religious traditions and Dalit religions, both at B.D. and M.Th. level.
- iii. Students should have done language (Pali) and also complete a course in special study of Buddhism during their B.D. studies.
- iv. Those who have not qualified in Buddhism (in Pali and special studies in Hinduism) should be asked to appear in qualifying examination through Senate of Serampore College.
- v. The College should not depend upon the visiting professors and try for core faculty while taking help from the visiting professors, part time professors and professors with more than 3 years of experience at B.D. level.
- vi. Scholarship programs for the studies of non-Brahmanik religious traditions and in the South Indian religious traditions may be offered to encourage these studies.
- vii. A separate block to accommodate M.Th. students be considered as an urgent need and provision should be made as early as possible before admitting new students or affiliating M.Th. in other branches.

On the basis of the observations, the Commission recommends that

#### **Recommendations:**

- i. The Tamilnadu Theological Seminary, Madurai may commence M.Th. studies in Religions from Academic Session 2011-2012 subject to submission of compliance report.
- ii. A scholarship program for the studies of non-Brahmanik, South Indian religious traditions and Dalit religions, both at B.D. and M.Th. level may be offered to encourage these studies.
- iii. As per the Senate stipulation, the affiliation shall be for 5 years: 2010-2015 and all the courses, except integrated courses, should be examined by the Senate.

**I. Introduction:**

The Academic Committee of the Senate of Serampore College received an application from the Gurukul Lutheran Theological College, Chennai, for offering M.Th. in Christian Ethics, in English medium along with the existing branches they are offering, and had constituted a Commission consisting of the following members: (Sen/09, WC/July/09)

The Evaluation Commission visited the College on July 10, 2010.

The Commission met with the Principal, the faculty and the staff of the Christian Ethics Department. The Commission visited the campus, hostel, classrooms and Library.

**II. The List of Faculty for Christian Ethics branch:**

  - a. Education: M.Com., Ph.D.

**III. Observation:**

1. The Commission noted that Dr. George Zachariah is the only core faculty of the College in the branch of Christian Ethics.
2. Dr. Samuel W. Meshack did have M.Th. in Ethics but his specialization is in Communication in which he is core faculty member of the college. He also has the responsibility of the Principal.
3. Dr. Felix Wilfred is mentioned only as a visiting professor.
4. Dr. George Zachariah is overburdened and need some helping hand for teaching at M.Th. level.
5. The College was offering Post graduate studies in Christian Theology, which is discontinued for the present though it has a plan to recommence the same.

**IV. Library:**

1. The Library is large with all the physical facilities available in terms of desk for students.
2. The department has its own library, some books and journals are available. It also has the personal collection of the professors for the benefit of the students.
3. The process for remodeling of the library is on the table, which may provide more space.
4. Online library is available for the use of the students.
5. Internal facilities are also available to students for their personal computers.
6. The project for availability of library on-line, involving some theological colleges is under planning stage.
7. The library is still weak in most of the recent publication in Christian Ethics, especially, social.

**V. Facilities:**

1. The College has now separate classrooms for M.Th. studies. The move provides modern equipments for classroom teaching at least at M.Th. level.
2. It is also noted that the professor's room has the provision for departmental teaching.
3. The hostel accommodation for Post graduate students is not available in the campus: the students should be accommodated in the hostel in the campus, which is mentioned for B.D. students.
4. The girls' hostel has enough accommodation for both at B.D. and P.G. level and some rooms in the girls' hostel often remain unoccupied. The number of students at Gurukul is increasing and they need more accommodation both for the family, single and women candidates.

**VI. Suggestions:**

1. The scholarship or financial assistance to students, specially independent, who have no sponsors, may be taken for serious consideration.
2. The computers for the personal use of M.Th. students may also be provided so that they can prepare their class presentation, project and other materials.
3. The library budget should be 1.5 lacs p.a. and it needs to be increased in the context of offering M.Th. in Christian Ethics.
4. There should be a proper plan for procuring books in the library before 1970 and also up-gradation of the books in other branches as well.
5. Separate block to accommodate M.Th. students be considered as an urgent need and provision should be made as early as possible, before affiliating M.Th. in other branches or admitting more students.
6. The faculty has taken to consideration the suggestion of the Senate to decide to offer only 5 branches at M.Th. and D.Th. level at the Gurukul campus.
7. Faculty of the College may also think of cooperation with nearby theological colleges in assisting M.Th. study program in the branches, which are not offered at Gurukul.
8. Provisions for minimum of 15 students per batch, per year at M.Th. level, in each branch may be taken into consideration.
9. Provide enough professors to deal with the courses.

On the basis of the observations, the Commission recommends that:

**Recommendations:**

- i. The GLTC, Chennai take immediate steps to update the library in the branch of Christian Ethics.
- ii. The college has to spend 1.5 lacs for procuring books in the branch of Christian Ethics and subscribe journals.
- iii. The college should appoint one person with doctoral degree (D.Th. or its equivalent) in Ethics to strengthen the department, preferably before the end of this academic session.
- iv. M.Th. study in Christian Theology may also be commenced as early as possible and 2 professors with doctoral degree to be appointed as early as possible.
- v. Subject to submission of the compliance report within October 10, The college can commence M.Th. in the branch of Christian Ethics from the academic session 2010-2011, as authorized by the Senate.
- vi. No students shall be admitted in 2011 unless the recommendations are complied with.
- vii. The College be informed that as a policy of the Senate all courses except the integrated one, shall be Senate examined for first two years.
- viii. As per the Senate stipulation the affiliation shall be for 5 years: 2011-2016 and all the courses, except integrated course, shall be examined by the Senate.

1. **Preamble:**

‘Nav Jyoti Postgraduate and Research Centre’ is a federated faculty formulation of three theological training institutions located in North and Northwest India. Its formulation is intended to avoid duplicating the work of postgraduate teaching and research and to offer courses which the three institutions cannot afford or effectively offer individually. Hence Dharma Jyoti Vidya Peeth, Faridabad, Haryana, New Theological College, Dehradun, Uttarakhand and Centre for Dalit/Subaltern Studies, New Delhi have set up a joint faculty consisting of qualified Faculty drawn from these three institutions.

Such Federated Faculty would meet a pressing need for a centre of advanced theological study and research in North and North-West India. The three institutions through the following agreed structure would share their resources, personnel and libraries for advanced theological education.

2. **The Name:**

Nav Jyoti Post Graduate and Research Centre (NJPGRC)

3. **STRUCTURE:**

A. **Management:** The Centre will be managed by a Committee consisting of the Principals of Dharma Jyoti Vidya Peeth and New Theological College and the Director of Centre for Dalit/Subaltern Studies and one other member appointed by each Institution from their qualified Faculty. The Committee will be responsible for the administrative, admission, academic and financial matters of the Centre. The Committee shall appoint the following office bearers, one from each Institution, on a three year rotation. The Committee shall meet at least three times in an academic year.

B. **Office-Bearers:**i. **Chairperson**

One of the Principals or heads of Institutions in rotation shall be the Chairperson for three years of the Federated Faculty. He/She shall preside over the meetings of the Managing Committee.

ii. **Registrar**

One of the Committee members in rotation shall be the Registrar of the Centre. He/she should be responsible for coordinating the function of the Centre such as announcing the admission, giving advertisements, correspondence, taking care of the Senate related matters, keeping records and giving notice for the Committee meetings in consultation with the Chairperson, recording Minutes, keeping accounts and other administrative matters.

The Registrar shall act as the Coordinator of the Centre.

iii. **Dean of Studies**

One of the Committee members in rotation shall be the Dean of Studies of the Centre. He/she should be responsible for the academic affairs such as orientation, allotment of courses, assigning teachers, organizing seminars, arranging classes and any other academic related matters assigned by the Managing Committee.

C. **Office:**

The office of the NJPGRC shall be at the following address:

Dharma Jyoti Vidya Peeth, Fazipur Khader, Chandpur P.O., Faridabad, Haryana

D. **Fees:**

Each Institution will collect the fees due and distribute them as follows:

- i. Accommodation and mess charges, assessed at the rate prevailing at the Institution of residence, will be paid to the Institution.
- ii. Tuition fees will be paid to the Centre. This includes Senate affiliation, Board, registration, examination and thesis fees.
- iii. The three Institutions will meet the Centre’s Board and affiliation fees jointly.

**E. Finance:**

The Centre should take initiatives to mobilize funds for the effective functioning of the Centre.

**F. Scholarship:**

Scholarship will be instituted and it will be disbursed as decided by the Managing Committee.

**G. Faculty:**

Core, Visiting, Superannuated and Staff on Study Leave.

**The Name:**

Ecumenical Research Institute in North East (ERINEI)

**Structure:**

**Management:**

1. A Management Committee (comprising the Registrar, the two Principals, two PG Dean/Director of two Institutions, General Secretary of CBCNEI and Administrative Secretary i/c Theological Education of KJP Assembly and one representative from the Governing Board of Each College/Seminary) will act as authority under the rules and regulation of the Senate of Serampore College. The Committee will be responsible for all matters concerning academic and general administration of the Institute.
2. The Institute will be managed by Registrar in collaboration with the PG Committees of the two theological Institutions.

**Registrar**

A member of the Post Graduate teaching Faculty of either College will be nominated as Registrar of the Institute. He/she will be appointed for a period of five years beginning from January 2010.

**Resources:**

1. The two theological Institutions will have sufficient human resources in few selected fields of study. The Institutions would further give priority to develop faculty in the areas where teachers fall short.
2. Besides, Library resources of the two Institutions we have made an arrangement with Sacred Heart Theological College, Shillong and Oriens Theological College, Shillong, and North Eastern Hills University, ICSSR-NERC, NEC Library and other.

**Admission:**

Admission of students will be done through the ERINEI.

**Fees:**

- i. Senate Affiliation Fees: Both ETC and JRTS will equally share to pay the Senate Affiliation fees of ERINEI.
- ii. Senate Fees: The students will pay the Senate Fees through the Institute.
- iii. Colleges Fees: Students will pay Tuition Fee and other required fees worked out by the Institute.

**Rules and Regulations:**

The Management Committee will frame Rules and Regulations for procedures for the smooth running of the Institute as and when necessary with the approval of the respective governing bodies.

Dear Sir,  
Greetings from Aizawl Theological College!  
Aizawl Theological College is already a Senate-affiliated college offering the BCS programme and facilitating the Dip.C.S. programme since the past several years.

The Mizoram Synod Theological Education Board in its meeting on February 20, 2010 discussed the matter of offering the BCS and Dip.C.S. programmes in Mizo. In other words, coaching would be given in Mizo and students will write the examination in Mizo. The Board therefore resolved to ask the permission of the Senate of Serampore College to register our students for writing the BCS and Dip.C.S. Examinations in Mizo beginning from the 2011 academic year. Many more persons will be attracted to do the programmes in the Mizo language. It would consequently strengthen theological reflection and expression in Mizo as well as facilitate growth in theological maturity.

As you are aware Mizoram has the second highest literacy percentage in the country. Mizo students will find it very attractive to do the BCS and Dip.C.S. courses in Mizo. Mizo literature is also highly developed. Courses are offered in Mizo literature even at the post-graduate and doctoral levels in Mizoram University, which is a central university. (Kindly see attached document).

Aizawl Theological College library is also equipped with adequate literature in Mizo language. The Library has 14,848 Mizo books and subscriptions to 35 Mizo journals/magazines. Besides, the library has a collection of 37,886 books and subscriptions to 202 journals/magazines in English. Aizawl Theological College also has a well-qualified faculty; most of the teachers are Mizo as can be seen from the enclosed list. Moreover we have several M.Th qualified pastors/ministers to help, if required, in the BCS programme and much more B.D. qualified pastors/ministers to help in the Dip.C.S. programme. We also have adequate classroom facilities in the college and as well as in churches and Mizoram Synod institutions for running the programmes.

We therefore request the Senate of Serampore College to grant us permission to conduct the programmes in Mizo and to allow the candidates to write the examinations in Mizo.
