Center for the First-Year Experience

Academic Advising

Most students enter Lincoln University excited, eager, and a little nervous. Many have questions about adjusting to their new surroundings, or how difficult classes may be. The Center for the First-Year Experience (CFYE) works to alleviate many of the stressors that first-year students have through an array of programs they offer.

Some of the programs they offer are described below. For more information, please stop by or call. Their information is provided below:

Advisors

The CFYE advises all students who have not declared a major at the University with 29 credit hours or less. The professional advisors in this department will work with you to create an academic plan for graduation, and a schedule that works with your life.

Advising Etiquette

- Call to make an appointment
- If you aren't able to attend your appointment or you need to reschedule, always call or email your advisor – this is a courteous
- Arrive on time or early for your appointment

Scheduling Appointments

Each semester you will be responsible for scheduling an appointment with your advisor to discuss your academic progress and plan for your future courses. At LU, academic advisors are also faculty members and teach a full-time load of courses. Please keep this in mind when setting up an appointment with them. Try to schedule appointments during their regularly scheduled office hours, or determine if they have appointment time blocks for registration. You will be eligible for pre-registration each semester if you meet the following criteria:

1. You are not on academic or social probation or suspension
2. You do not have an unpaid balance with Student Accounts
3. You do not owe any parking tickets or library fines
4. You do not have any other miscellaneous holds on

General Education Courses

In the first year, many students concentrate on completing general education requirements. General Education requirements, or GE's are a 47-hour required block of educational courses that encompass the knowledge, skills, and attitudes which should be the common experiences of all educated individuals, so that they can engage effectively in a life-long process of inquiry and decision-making and an appreciation of the fine arts. 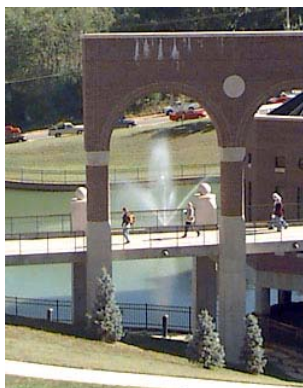

Grade Point Average (GPA)

Grade point average is the average number of grade points earned per credit hours attempted. In the cumulative GPA calculation, if a course is repeated, then only the highest grade earned is included in the total grade points calculation, and the credit hours are counted only once in the total credit hours attempted.

Activity physical education grades are included in grade point average calculations. Credit-by-examination (departmental and/or CLEP) and cooperative education credits are not calculated into the GPA. Transfer credit is not included in the GPA calculation except for purposes of granting honors and graduation honors. Courses in which a —PR, —I, —X, —H, —S, —U, or —W are received are not included in computing the GPA.

Developmental courses (e.g., Basic Mathematics, Basic Algebra, Basic English) are not included in the total number of credit hours a student earns towards a degree.

Repeated Courses

A student may repeat for a higher grade any course in which a "D" or "F" was earned, and must repeat a course in which a "PR" was earned. Only the highest grade earned will count in the GPA if the previous grade is a —D or —F. A course in which a "B" or "C" is earned may not be retaken in order to achieve a higher grade. If a course is repeated, all grades obtained in that course remain on the student's transcript.

Release of Student Information

The Federal Education Right to Privacy Act (FERPA) protects the privacy of student educational records, including financial information and prevents Lincoln University from providing that information to any third parties, including parents. FERPA.

What is FERPA?

The Family Educational Rights and Privacy Act of 1974, also known as the Buckley Amendment, is designed to protect the privacy of student records. The Act provides for the student's right to inspect and review educational records, to seek to amend those records, and to limit disclosure of information from those records. The Act applies to all institutions that are recipients of federal funding. Maintaining confidentiality of student records is everyone's responsibility, whether you are faculty, staff or student.

Who is protected under FERPA?

FERPA protects all students who are currently enrolled or formerly enrolled, regardless of their age or parental dependency status. FERPA does not apply to deceased students or persons who have applied but have not attended.

Parental Access to Student's Educational Record

When a student reaches the age of 18 or begins attending a postsecondary institution (regardless of age), FERPA rights transfer from the parent to the student. The student must sign a Third Party Release form with the Records office if he/she wishes to allow a parent to obtain information about a student record. This means that this form must be completed and on file in the Records Office before a parent can receive any information, including payment amounts and balances.

To obtain a copy of the Third Party Release Form you can visit the Records Office on the ground floor of Young Hall in room B-4.

Academic Resources and Tutoring Services

Center for Academic Enrichment (CAE)

Supplemental Instruction

Coordinated through the CAE, Supplemental Instruction gives students in difficult courses an opportunity to study with a group of students from the same class. Outside-of-class study sessions are led by SI student leaders who know the course content, attend class regularly, and are approved by the instructor. SI guarantees focused study time; students who participate in SI study sessions generally earn higher course grades.

Tutorial Services

Center for Academic Enrichment provides professional tutoring in writing and mathematics. Students may schedule individual appointments for one-on-one tutoring for any Lincoln University writing assignment and/or for any mathematics course work. Group tutoring workshops and exam reviews are also available. More information on math or writing tutoring may be found on the CAE website.

CAE Computer Lab

A computer lab housed in the CAE is available as an open lab to all students. The CAE lab offers e-mail, word processing and Internet capabilities.

The Success Connection (TSC)

The TSC is a mentoring/tutoring initiative designed to enhance the student's academic and social experience. TSC utilizes the knowledge and skills of retired faculty, staff, and Lincoln Alumni to assist in areas such as study habits, organizational skills, and test preparation, as well as social and character development.

Scholarships

Internal

Students and families interested in obtaining information regarding scholarships and grants may contact financial aid. Departmental Student Labor

SATISFACTORY ACADEMIC PROGRESS POLICY

Purpose

The intent of this policy is to 1) ensure that students using financial aid programs are demonstrating responsible use of public funds in pursuit of their educational goals; 2) set standards for monitoring all financial aid recipients' course completion rates each term, warning individual students when progress is so slow that financial aid eligibility may run out before completion of the degree program; and 3) give students whose progress does not meet the standards of this policy at least one term of financial aid on a probationary basis in which to improve their academic progress.

Satisfactory Progress Standards

To remain eligible for financial assistance, a student must:

- complete courses at an overall rate which will ensure graduation within the maximum time frame;
- earn credit for a reasonable number of credit hours toward a degree or certificate each term;
- complete developmental and incomplete courses in a timely manner;
- graduate prior to the maximum time frame specific term and cumulative grade point average, consistent with the University's academic policy;

Maximum time frame- to retain financial aid eligibility, as student must complete his/her degree program within a specified time limit defined in cumulative attempted hours for undergraduate/graduate students. Attempted hours, for this purpose, include regular and developmental course hours, as well as accepted transfer credit. Once a student reaches the maximum time frame, he/she is ineligible for financial aid unless additional time to complete the degree is approved through appeal. Maximum time to degree completion is as follows:

First baccalaureate degree	160 attempted hours
Second baccalaureate degree	42 attempted hours
Master degree (38-hour program)	48 hours

Overall completion rate- completion rates reflect the rate at which students earn credit for courses attempted (e.g. a student earning nine of twelve hours would have a 75% completion rate). A student must meet an increasing standard of completion as he/she moves through the degree program in order to graduate within the maximum time frame. Satisfactory completion rates for this student are as follows:

0-36 cumulative attempted hours	70% completion
36.1-60 cumulative attempted hours	75% completion
60.1-84 cumulative attempted hours	80% completion
84.1+ cumulative attempted hours	85% completion

0-42 cumulative attempted hours	85% completion

Notification of Financial Aid Probation or Termination

The Department of Student Financial Aid will send a warning letter to any student who is placed on probation or a termination letter to any student who is no longer eligible for financial aid. The letter will be sent to the student's local address during any term of enrollment and to the permanent address during term breaks. It is the responsibility of the student to maintain current addresses with the Office of Admissions and Records.

Reinstatement Undergraduate with greater than 160 attempted hours and no degree- The student must appeal on the appropriate form and provide a graduation plan signed by his/her academic advisor. If the plan is considered reasonable, the student will receive financial aid on probation for one or more terms until the degree is completed.

Student on Financial Aid probation- The student may regain eligibility in one or two ways after a term of financial aid probation: a) by meeting the completion standards which applies to the student after financial aid probation under this policy (e.g. at least 36 attempted hours with a 70% completion rate) or b) by completing 12 credit hours (or less if approved) with a 2.00 semester term grade point average.

Student with grade changes- The student can regain financial aid eligibility by notifying Student Financial Aid of the grade change, including grades posted for incomplete courses.

Student previously suspended- A student loses financial aid eligibility at the time of Suspension from the University and must appeal on the appropriate form to receive approval for a term of financial aid probation if reinstated or readmitted.

Student terminated under prior policies or for zero completion- The student must complete at least 12 hours with a 2.00 grade point average at his/her own expense and then may appeal to receive financial aid on a probationary basis.

Appeals

A student who does not meet the undergraduate or graduate overall completion rates specified in this policy will be placed on probation for one term following identification of unsatisfactory progress.

For all other purposes, a student who desires to appeal termination of his/her financial aid eligibility must appeal in writing, usually on a form designated for that purpose, to the Department of Student Financial Aid by the date indicated in the termination letter. The Director of Financial Aid may take action on the appeal or forward it to the Financial Aid Appeals Committee for review. The committee's decision may be appealed to the Director; the Director's decision may be appealed to the Vice-President for Student Affairs.

The Financial Aid Appeals Committee appointed by the Vice-President for Student Affairs, shall have a membership that consists of two faculty and/or staff members familiar with University academic policy in addition to a member of Student Financial Aid, and Student Accounts Receivable. It may also have an additional member who participates in general committee matters. The committee considers, in a timely manner, appeals that are referred to it. The committee normally reviews on the written record and does not conduct hearings unless unusual circumstances warrant such. A student is encouraged to submit third party written documentation to support his/her appeal.

Student Accounts and Payment Arrangements

The goal of the Student Accounts Office is to serve and support Lincoln University students and their families by providing accurate and timely information related to their accounts according to the university policy and procedures. The office will answer questions regarding billing statements, payments received, or charges assessed to your account.

Schedule of Basic Fees

The schedule of basic fees as listed represents college charges. It does not include amounts for books and supplies, travel expenses, medical expenses other than health insurance, or miscellaneous fees that may be required. All tuition and fees are due and payable at the time of registration, unless other financial arrangements have been made. The schedule of basic fees may be found online.

Tuition Refunds due to Withdrawal

Refunds for Fall, Spring, and Summer

Tuition refunds are issued to eligible students based on the official date of withdrawal. Students must officially inform the college that they are withdrawing from class(es) by completing a withdrawal form and having it processed with the Record's Office.

Refund Schedule for 8-week classes

For eight-week sessions, a 100% refund is allowed during the first calendar *week* of session. No refunds are available after the first week.

Refund Schedule for 4-week classes

For four-week classes, a 100% refund is allowed on the first *day* of the session. No refunds are available after the first day of session.

Note: Students are required to complete the withdrawal process with the Records Office, or the drop process on WebAdvisor, or with an advisor to receive any refund of fees.

Health Services and Student Health Insurance

Lincoln University's Student Health Services (SHS), located in the Thompkins Center, is here to protect and maintain the health of all currently enrolled students. Medical services are provided at no cost. Should tests, x-rays, and other services beyond the scope of the Center be recommended, the Student Health staff will assist students with referral and insurance billing. Any on-going medical condition such as, but not limited to, diabetes, hypertension, epilepsy or migraine is the responsibility of the student's primary care physician (PCP). SHS will monitor the student's health in collaboration with the PCP.

The staff of the Health Center provides a full range of primary care services, including treatment for acute and chronic illnesses, injuries, STDs, etc., and routine care.

Walk-Ins and Appointments

Patients are seen on a walk-in basis by the full-time nursing staff. Patients will be seen in the order of arrival, unless their condition is of an urgent nature. Patients can be seen by the Nurse Practitioner on Tuesdays from 1:00 pm to 3:00 pm and Wednesdays and Thursdays from 8:00 am to 10:00 am, by appointment only. Patients should contact Student Health Services at (573) 681-5476 to schedule an appointment.

Care for Ongoing Health Needs

If you have ongoing health care needs and are under the care of your private physician, the Health Center staff can team with your physician to provide lab work, blood pressure checks, or other care as needed, for continuity while you are at Lincoln University.

Medications

The Health Center dispenses a wide range of over the counter (OTC) and prescription medication commonly prescribed by university physicians.

Laboratory Testing

The following laboratory testing is available, on-site, at the SHC:

- Pregnancy
- Urine Analysis
- Blood Glucose
- Strep Throat
- Mononucleosis
- And More!!

Other testing can be provided and sent to an outside laboratory for results. Lab processing fees may apply.



STD Testing/Treatment

The Health Center provides HIV and Syphilis Testing free of charge during clinic hours. All other STD testing is performed during the Family Nurse Practitioner (FNP) hours with a lab processing fee attached. STD Testing performed by the FNP is by appointment only, please contact Student Health Services to schedule. STD Treatment is also provided during clinic hours.

Health Requirements

Completed Medical Health History: A medical history form must be on file in the Student Health Services Office prior to the student's registration.

Immunizations: the following immunizations (vaccinations) are required: Two (2) doses of MMR (Measles, Mumps, and Rubella) - 1st dose at age 12 - 15 months or later; 2nd dose at age 4 - 6 or older. Not required for students born before 1956. If records are not available, medical confirmation that the student had the disease(s) or a titer, blood test, showing immunity to measles, mumps and rubella will be accepted.

Meningococcal Vaccination: Students residing in on-campus housing are required by state law to receive the meningococcal vaccine or sign a waiver refusing the vaccination. The Student Health Center will maintain records on each student's vaccination status that reside in on-campus housing.

Continuing Education/Dual Credit Students: If a student is not required to be on campus nor interact with the general campus population, the health requirements can be waived (i.e., Fort Leonard Wood Campus, Dual Credit High School Students).

Student Health Insurance

Lincoln University requires all registered students taking 12 or more credit hours be enrolled in the Lincoln University Student Insurance Plan **unless** proof of comparable coverage is provided. All registered International Students taking credit hours must be enrolled in the plan. For further information, please visit Student Insurance Plan website or contact the Student Health Center.

The above requirements are supported by documentation from the American College Health Association (ACHA).

Please note: Immunizations requirements for international students may vary, depending on personal medical history and travel. Please contact the Student Health Center for further information.

S.H.A.P.E

The Student Health Advocacy & Peer Education (S.H.A.P.E.) is a student organization that educates peers and promotes the quality and delivery of care that the Student Health Center provides for the students on the Lincoln University campus.

SHAPE serves as a liaison between the Student Health Center and Lincoln students as well as student government and organizations. Members are asked to attend various prevention and health promotion events that SHAPE sponsors throughout the year.

SHAPE members are students who are interested in promoting and representing the Student Health Center. Membership strives to promote the university's diverse population. All students who are interested in furthering the goals of SHAPE should apply online.

Residential and Commuter Students

You will be assuming responsibility for decisions and actions that directly impact your personal and academic life. This is a time of transition during which we are dedicated to assisting you in achieving the best educational experience possible. Do I have to live on campus?

University Policy requires the following students to live on campus:

- All unmarried students under 21 years of age, whose primary domicile is beyond a 60-mile radius of Lincoln University, are required to live in the University residence halls for four consecutive semesters.
- Veterans of the U.S. Armed Forces are exempted from the On-Campus Housing Policy.
- Any student who has established a local primary domicile at least one year prior to entering the University is also exempted. Proof of domicile is required.

For more specific information on the housing policy we encourage you to review the Lincoln University Student Handbook, or the Lincoln University Undergraduate Bulletin.

Students seeking exemption from the On-Campus Housing Policy must submit a written appeal form by the last day of July for the upcoming fall semester and the last day of December for the upcoming spring semester to the Residential Life Appeals Board located in 117 Young Hall.

Personal Property and Liability

The University is not liable for any personal property brought onto campus by students. In the event space is not initially available to accommodate all students affected by the on-campus housing policy, a waiting list will be maintained and students on that list will be given priority when semester housing assignments are made the following year. Notification of housing assignments will be sent to students' local addresses prior to the end of the spring semester of their initial year at the University. Room and board are mutually inclusive components of on-campus residency.

Meal Plans

All residential students are required to have a meal plan. Plans vary from 10, 14, to 19 meals per week. Meal plans are also available for commuter students. For more information about meal plans and rates, please visit the website at: <http://www.lincolnu.edu/pages/2107.asp>.

Lincoln University Police Department



The Lincoln University Police Department (LUPD) has multiple responsibilities, which include traffic and parking operations, law enforcement, investigations, fire and safety inspections, monitoring chemical hazards, and crime prevention. The mission of the LUPD is “to help provide a safe, enjoyable environment to live, work and study.”

Timely Warnings

In the event that a situation arises, either on or off campus, that, in the judgment of the Chief of the Police Department, constitutes an ongoing or continuing threat, a campus wide "timely warning" will be issued. The warning will be issued through the college email system to students, faculty, and staff.

Depending on the particular circumstances of the crime, especially in all situations that could pose an immediate threat to the community and individuals, the LUPD may also post a notice on the campus-wide electronic bulletin board on the LUPD website at: www.lincolnu.edu/pages/2631.asp.

Parking Permits

Parking permits are required to park on campus between the hours of 7:30 a.m. to 5 p.m. , Monday through Friday. Students are not allowed to park in reserved spaces. University students are also not allowed to park in a handicap space without a University parking permit or state issued placard that indicates "disabled."

Lincoln University parking permits can be purchased at the Cashier's Office in Young Hall. Student Parking Permits are \$35.00 per year. Students may purchase a residential (on-campus) or commuter student permit.

Purchasing a Permit and Vehicle Registration

To register your vehicle and purchase a parking permit you need a valid photo ID (Lincoln ID or state-issued identification), current and valid proof of insurance, and a completed Vehicle Registration form submitted to the Cashier's Office (1st floor Young Hall).

Disability Services



Lincoln University provides services for students with disabilities, including visual and hearing impairments, in accordance to the Americans with Disabilities Act and Section 504. These services are located in 304 Founders Hall.

Guidelines on Submitting Documentation for Disability Services

Lincoln University provides assistance to students with a documented disability. Documentation of the disability needs to be on file with the Coordinator of Disability Services before requests can be granted.

- A qualified professional such as a psychologist, neurophysiologist, psychiatrist, counselor, doctor, or trained school personnel is appropriate to provide the documentation. The report must include a specific diagnosis based on the Diagnostic and Statistical Manual (DSM-IV) diagnostic criteria.
- A well-written interpretative summary based on a comprehensive evaluative process is a necessary component of the documentation. Each accommodation recommended by the evaluator must include a rationale. The diagnostic report must include specific recommendations for accommodations that are realistic and that postsecondary institutions can reasonably provide. A detailed explanation as to why each accommodation is recommended must be provided and should be correlated with specific functional limitations.
- A description of the current functional limitations on how the condition currently impacts the individual should be outlined. The documentation needs to be thorough enough to demonstrate whether and how a major life activity is substantially limited by providing a clear sense of the severity, frequency and pervasiveness of the condition.

Although prior documentation may have been useful in determining appropriate services in the past, current documentation must validate the need for services based on the individual's present level of function in the educational setting.

Rights of Students with Disabilities

- Equal access to courses, programs, services, facilities, and activities offered through the University.
- An equal opportunity to learn, and to receive reasonable and appropriate accommodations and academic adjustments with the goal of diminishing the effect of a disability on academic functioning.
- Appropriate confidentiality of all information related to the disability.
- Be treated with respect and courtesy.

Responsibilities of Students with Disabilities

- Meet the University's qualifications and essential technical, academic and institutional standards.
- Self-identify in a timely manner as an individual with a disability when an accommodation is needed.
- Provide documentation from an appropriate professional source that confirms the presence of a disability which identifies functional limitations and provides support for the requested accommodations.
- Follow the specific, published procedures for requesting and obtaining reasonable and appropriate accommodations.
- Assume personal responsibility to meet with faculty, and to request assistance through other campus resources.
- Abide by the University's standards and guidelines for behavior and academic integrity.
- Treat all University staff and faculty with respect and courtesy.

Rights of Disability Services

- Request current, appropriate and comprehensive documentation, completed by an appropriate professional that supports a request for reasonable accommodations.
- Select the most appropriate or equally effective accommodations and/or academic adjustments through discussion with the student.

Responsibilities of the Office of Disability Services

- Ensure that all programs, courses, and services through the University are offered in the most integrated and appropriate setting.
- Provide information regarding policies and procedures to students with disabilities and assure its availability in accessible formats upon request.
- Provide or arrange for reasonable and appropriate accommodations and/or academic adjustments for students with disabilities on an individualized basis and with documentation verification.
- Maintain appropriate confidentiality of records and communication concerning students with disabilities except where disclosure is permitted or required by law or authorized by the student.



Career and Counseling Services

The mission of Career, Counseling & Disability Services (CC&DS) is to provide high quality service in the areas of personal, academic, social, and career counseling to the University's diverse student population (i.e. academically at-risk students, physically challenged students and non-traditional student population). Additionally, Career, Counseling & Disability Services serves as a support system in conjunction with the academic areas, while simultaneously promoting student growth and development, thus contributing to the learning process beyond the classroom.

Personal – Attending college can be exciting, but it can also add a stress factor to your life. Personal counseling is available to help you address concerns such as: anxiety, depression, relationship problems, and academic stress.

Academic – Most students have developed the skills in secondary school to be successful in college, but the academic demands of the University may present a challenge that requires a modification and/or development of new skills. We will work with the student and their advisor to access the student in developing skill sets to be successful.

Career – During individual consultation, students explore with a counselor possible career paths. Career assessment instruments such as the Self-Directed Search and the Strong Assessment are used to assist in the career exploration process. Additionally the usage of the Occupational Dictionary provides information for: specific jobs, educational requirements, work environment, salary, and the number of job positions needed in the future.

Referral/Confidentiality

Outside referrals are made through the Director. It is preferred that a relationship is established with the student, prior to the outside referral, if this is possible. All counseling information will be held in the strictest confidence. Confidential information regarding the student will not be released without the student's permission.

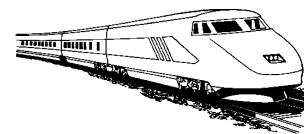
Martin Luther King Drum Major Award

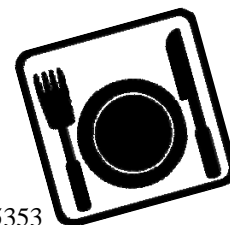

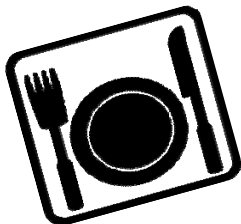

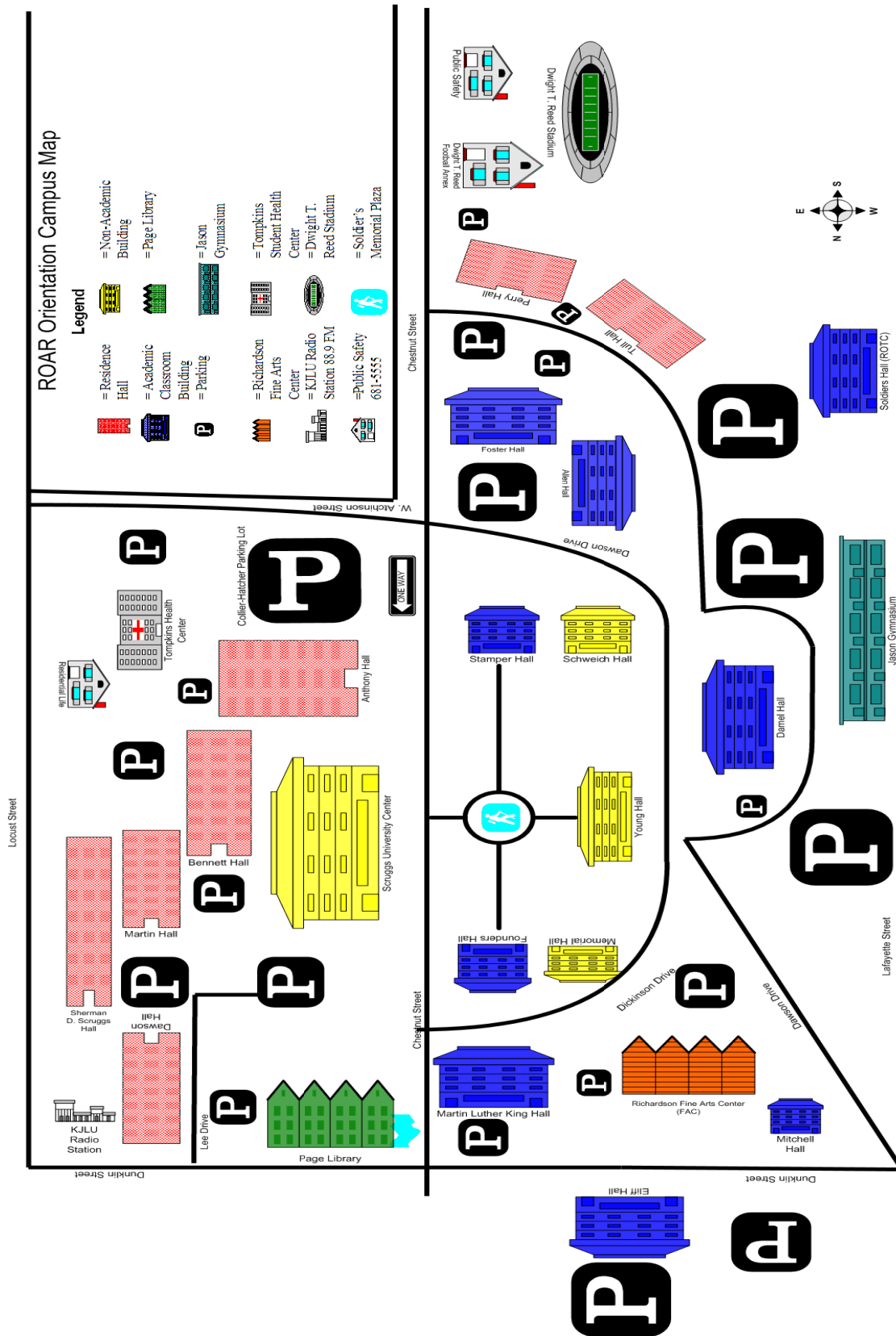
