## JACKIE McConnell: HISTORY OF VIOLATIONS OF THE HORSE PROTECTION ACT

Formal sanctions have been imposed on Jackie McConnell by the U.S. Dept. of Agriculture pursuant to the Horse Protection Act (HPA), 15 U.S.C. §§ 1821 et seq., on three separate occasions, beginning as early as 1979:

<u>First offense</u>: May 26, 1979, Jackie McConnell, charged as trainer for entering horse named "Threat's Black Power" in Ninth Annual Fun Show in Shelbyville, Tenn. A USDA Veterinarian classified "Threat's Black Power" as the *sorest horse at the show*." The USDA Veterinarian described the horse as having an "*exhausted, steaming, defeated appearance*" and testified the horse's front legs were covered with raised scars that when touched were found to be "*very sore*" causing "*extreme pain.*" McConnell received a \$750 civil penalty and a 6-month disqualification from Sept. 9, 1985 through Mar. 8, 1986.

**Second offense:** Sept. 1, 1989, McConnell charged as trainer for entering horse named "Executive Order" (owned by Floyd Sherman) in the TN Walking Horse National Celebration in Shelbyville, Tenn. while sore. McConnell received \$2,000 civil fine and 2-year disqualification from Mar. 19, 1995 through Mar. 18, 1997.

**Third offense**: Sept. 3, 1998, Jackie McConnell entered "Regal By Generator" in 1998 TN Walking Horse National Celebration in Shelbyville, Tenn., for the purpose of showing or exhibiting "Regal By Generator" while sore. McConnell received a civil fine of \$2,200 and a 5-year disqualification from Oct. 31, 2006 through Oct. 30, 2011.<sup>3</sup>

# Offense	Violator	HPA Violations, Penalties, Judicial Decisions & Orders		
First Offense	Jackie McConnell	<u>Violation</u> : On May 26, 1979 Jackie McConnell (and others) entered and exhibited "Threat's Black Power" while the horse was sore at the Ninth Annual Fun Show in Shelbyville, Tenn. McConnell was found to have violated 15 U.S.C. § 1824(2) for showing and exhibiting a horse who was "sore" in violation of the Horse Protection Act (HPA or the Act).		
		<u>Penalty</u> : McConnell, as trainer, assessed civil penalty of \$750 and disqualified for 6 months. <sup>4</sup>		
		Judicial Decision & Final Order: In the court's final decision and of findings of facts included that McConnell: "was well-versed in the hose characteristics and susceptibility to pain through the use of the trainmethods and action devices that he employed. The horse was twice as being sore while it was in his training, prior to the incident in quest When examined by [USDA Veterinarian] Dr. James, 'Threat's Black Poappeared to him to be 'a bad sore horse.' The horse was in such obtained distress that Dr. James ordered it photographed to show the protestance it had assumed to keep weight off its painful front forelimbs, as as its dropped head, and overall dejected appearance. Dr. James class him as the sorest horse at the show." Also, the USDA Veterina described the horse as having an "exhausted, steaming, defeappearance" and observed the horse's front pasterns to be covered appearance. The pasterns to be covered appearance.		
		<u>Disqualification dates</u> : 09/09/1985 – 03/08/1986 <sup>7</sup>		
Second Offense	Jackie McConnell	<u>Violation</u> : Jackie McConnell charged as trainer who entered "Executive Order" in TN Walking Horse National Celebration in Shelbyville, Tenn. on Sept. 1, 1989 while sore. <u>Penalty</u> : McConnell assessed civil penalty of \$2000 and received a 2-year		
		disqualification. <sup>9</sup>		
		Judicial Decision & Final Order: The Judicial Officer's findings of fact included that McConnell was at all relevant times the trainer of "Executive Order" who was owned by long-term McConnell client Floyd Sherman, stating: "Mr. Sherman placed 'Executive Order' with Mr. McConnell in order to have the horse trained." The Sherman family (Floyd and Beverly and their daughter Patricia Kelly) have been associated with McConnell since at least 1987 and have a number of documented HPA violations, warning letters, and/or tickets.		
		<u>Disqualification dates</u> : 03/19/1995 – 03/18/1997

Third Offense	Jackie McConnell	<u>Violation</u> : On Sept. 3, 1998, Jackie McConnell entered "Regal By Generator" in 1998 TN Walking Horse National Celebration in Shelbyville, Tenn., for the purpose of showing or exhibiting "Regal By Generator" while sore. 11		
	<u>Penalty</u> : McConnell received a civil fine of \$2 disqualification. 12			
		Judicial Decision & Final Order: "Jackie McConnell is disqualified for a period of 5 years from showing, exhibiting, or entering any horse, directly or indirectly through any agent, employee, or device, and from managing, judging, or otherwise participating in any horse show, horse exhibition, horse sale, or horse auction."   Disqualification dates: 10/31/2006 – 10/31/2011
