One researcher who has Enos Curry married to Sarah Cochran claims Enos Curry is the son of Hiram Mirach Curry.¹ He is head of household on the census of 1783 at Tyrone Twp., Westmoreland County, Pennsylvania, as Myrack Curry, with 1 white in the household.² He was Baptist.³ He was admitted as candidate for ministry in 1792 at Mayslick, Mason Co., Kentucky.⁴ He is listed on tax rolls as Hiram Currey in 1792 at Mason Co., Kentucky.⁵ He resided between 1792 and 1794 at Mays Lick, Mason Co., Kentucky, and was a Baptist preacher and teacher at the first school in Mays Lick.

6.7 He was listed on the tax rolls owning 200 acres on Stone Lick watercourse of BullCreek of John Craig's survey between 1792 and 1801 at Mason Co., Kentucky.8 He was witness to will of Benjamin Thrailkill on 27 Mar 1793 at Mason Co., Kentucky.9 He was messenger, along with Cornelius Drake, to Elkhorn Baptist Association meeting representing Mays Lick church reporting 9 received by letter, 1 dismissed, 58 members at South Elkhorn, Kentucky. 10 He was teacher in 1794 at Mayslick, Mason County, Kentucky.¹¹ He was listed on tax rolls as Hyrummirick in 1795 at Mason Co., Kentucky.¹² He was listed on tax rolls as Curry, M. Hiram in 1796 at Mason Co., Kentucky. 13 He was listed on the tax rolls as Curry, Hiram Mirum in 1797 at Mason Co., Kentucky. 14 He was messenger to Elkhorn Baptist Assication meeting along with J. Singleton for Stone Llck Church reporting 42 baptised, 9 received by letter, 3 dismissed and 76 members at Clear Creek, Kentucky. 15,16 He was listed on tax rolls as Curry, Hiram M between 1799 and 1801 at Mason Co., Kentucky. 17 He appeared on the census of 1800 at Mason Co., Kentucky. 18 He and Sarah (--?--) (1516) sold land to James Riggs of Bourbon Co. KY land in Mason Co. KY being part of Craig's Survey by James Luston's most north corner to Philip Donovan line on 30 Dec 1800 at Mason Co., Kentucky. 19 He baptized Elder John Gutridge in the Ohio RIver three miles above Maysville in 1801 at Brook Church, Mason County. Kentucky.²⁰ He was mentioned in minutes of meeting of Bracken Association of Baptists held on 19 Sep 1801 at Stone Lick, Kentucky.²¹ He and Sarah (--?--) (1516) sold land to James Riggs of Mason Co. KY 15 acres of land being part of John Craig's patent of 1000 acres located by Edward's line for 15 pounds on 16 Apr 1802 at Mason Co., Kentucky.²² He sold land to James Luston of Mason Co. KY part of John Craig patent by Richard Parker's corner, then west line of Parker and Hamar to Philip Donovan on 30 Dec 1802 at Mason Co., Kentucky.²³ He performed marriage of Aquilla Denham and Harriet Thompson on 26 Jun 1804 at Adams County, Ohio.²⁴ He performed marriage of Phebe Cary and Alexander Reed on 4 Jun 1805 at Franklin County, Ohio.²⁵ He was on list of voters in 1806 at Salem Township, Champaign County, Ohio.26 He was listed on tax rolls as Curry, H. Merack in 1806 at Champaign County, Ohio.²⁷ He performed marriage of Thomas Morris to Margaret Dawson on 29 Jun 1806 at Champaign Co., Ohio.²⁸ He was listed on tax roles as Curry, Mirach H in 1807 at Champaign County, Ohio.29 He preached at the courthouse on 8 Jan 1807 at Ohio.³⁰ He preached a sermon after the Masonic oration after 22 Jun 1807 at Ohio.³¹ He performed marriage of John Ross to Margaret Price in 1808 at Champaign County, Ohio.32 He held the office of state senator between 1808 and 1811 representing Champaign County, Ohio.33 He was appointed W. M. on a warrant empowering the lodge to hold meetings in Urbana and Springfield alternately in 1809 at Urbana, Ohio.34 He performed marriage of George Hunter and Ruth Fitch in 1809 at Urbana, Champaign County, Ohio.35 He was appointed trustee of Miami University on 9 Feb 1809 at Ohio.36 He was member board of trustees of Miami University on 17 Feb 1809 at Ohio.37 He

officiated at marriage of Mr. George Hunter and Miss Ruth Fitch on 20 Apr 1809 at Champaign County, Ohio.38 He performed marriage of Wm H. Fyffe to Maxamilla Petty on 27 Sep 1809 at Champaign County, Ohio.³⁹ He performed marriage of John Thompson to Polly Frankerbrger on 20 Nov 1809 at Champaign County, Ohio. 40 He was listed on the tax rolls as Curry, M. Hivans owning 100 acres in 1810 at Buck Creek, Champaign County, Ohio.41 He was elector (voter) in Union Township (Twp. 4, R11) on 8 Oct 1811 at Champaign County, Ohio.⁴² He erected block house on banks of stream in 1812 opposite Oldtown on bank of Stony Creek, about 1 1/2 miles south of town of DeGraff, Logan Co., Ohio.43 He was member between 1812 and 1814 at Harmony Lodge, Urbana, Champaign Co., Ohio, serving as Worthy Mason.⁴⁴ He was listed as trustee of Miami University on 14 Mar 1812 at Ohio.45 He held the office of member of Ohio House of Representatives between 1813 and 1814 representing Champaign County, Ohio.46 He taught school in old tavern stand referred to as the old George Fithian and John Enoch stand on lot No. 63 circa 1816 at Champaign County, Ohio.⁴⁷ He was listed on the tax rolls owning 170 acres in 1816 at Buck Creek, Champaign County, Ohio.48 He was held the office of Representative from Champaign County, Ohio in 1816.49 He was listed on the tax rolls owning 170 acres in 1817 at B. Creek, Champaign County, Ohio.50 He was appointed state treasurer to replace W. M'Farland who resigned on 3 Jan 1817 at Ohio. 51,52,53,54,55,56,57,58 He welcomed President Monroe to the Capital [of Ohio] by a neat and approriate speech in Aug 1817 at Columbus, Ohio.59 He, Treasurer of Ohio, along with Ralph Osborn, Auditor and Jeremiah McLene, Secretary, oversaw improvements in state prison circa 1818 at Ohio. 60,61,62 He was listed on the tax rolls owning 170 acres in 1818 at B. Creek, Champaign County, Ohio.63 He was listed on the tax rolls owning 170 acres in 2 parcels in 1819 at Buck Creek, Champaign County, Ohio.64 He provided bond for marriage of Josseph MARK and Rebecca CURRY; also provided consent for marriage on 12 Apr 1819 at Boone Co., Kentucky. 65 He deposited \$100,070 in the Franklin Bank of Columbus on 17 Sep 1819 at Columbus, Ohio. These funds were seized by John L. Harper from the Bank of the United States at Chillicothe. 66 He was summoned to appear in case filed by The United States of America, District of Ohio, sct on 23 Nov 1819 at Chillicothe, Ohio.67 He was submitted report to General Assembly of the State of Ohio from office of Treasurer, State of Ohio on 6 Dec 1819 at Ohio.68 He along with Ralph Osborn, Auditor; and the President and Directors of the Franklin Bank of Columbus were served with a writ of injunction from the Bank of the United States for the recovery of their money before 17 Dec 1819 at Ohio. 69 Circa 1820 at Ohio when the case (suit of attachment against Osborn & Harper) came to trial the opposing counsel agreed that an order should be issued to the State treasurer (Hiram M. Curry) that the total tax, plus interest on the specie, should be returned to the Bank. This the treasurer refuesed to do without a warrant ... He was thereupon placed under nominal arrest by a Federal marshal and all his property, including his keys, was attached.⁷⁰ He was listed on the tax rolls owns 170 acres in 2 parcels and resides out of county in 1820 at Champaign County, Ohio.71 He resigned as treasurer of State of Ohio in Feb 1820 at Ohio. 72,73 He resigned as state treasurer of Ohio before 3 Mar 1820.74 During a dispute with the Bank of the US an officer for the state of Ohio seized \$98,000 in gold, silver and notes. This was placed in charge of the State Treasurer, Mr. H. M. Curry.⁷⁵ He was held the office of "late" Treasurer of state before 4 Dec 1820 at Ohio.⁷⁶ He was accused of owing the State of Ohio \$11,111 under a resolution proposed by Mr. Willson and agreed to by the Ohio House of Representatives on 7 Dec 1820.77 He was listed on the tax rolls owns 170 acres in 2 parcels and resides out of county in 1821 at Champaign County, Ohio.78 He was served with a writ of attachment commanding him to return into court a description of every note taken from the U.S. office of discount and deposit on 4 Jan 1821 at United States Circuit Court, Columbus. Ohio.79 He married Elizabeth Lane (5373) on 30 Aug 1821 at Franklin Co., Ohio; by C. Henkel. 80,81,82,83 He was conducted services held by Universalist people in a schoolhouse in 1828 at

Sheffield Twp., Tippecanoe Co., Indiana.⁸⁴ He and IN Tippecanoe Co. 1830 Census (5622) appeared on the census of 1830 at Village of Fairfield, Tippecanoe County, Indiana, listed as Hiram m. Curry with 1 male 70-80, 1 female under 5, 1 female 5-10, 1 female 15-20 and 1 female 30-40.^{85,86} He was conducted services for Universalist Church in a school house between 1838 and 1839 at Sheffield Township, Tippecanoe Co., Indiana.^{87,88}

1 Hiram M.² Currey (532) was a lawyer at Peoria, Peoria Co., Illinois.⁸⁹ He was admitted into the practice of law, the 1st attorney of Rush Co. and was at once made prosecutor on 4 Apr 1822 at Rush Co., Indiana.^{90,91} He was admitted to practice law on 26 Sep 1822 at Indianapolis, Indiana.^{92,93} He was appointed the first prosecuting attorney on 10 Oct 1822 at Shelby County, Indiana.94 He resigned as prosecuting attorney in Apr 1823 at Rush Co., Indiana.95 He married Rachel Harris (1291) on 28 Sep 1824 at Edgar Co., Illinois. The couple was married by John W. McReynolds, a licensed minister of the gospel of the Methodist Episcopal Church.^{96,97} He was assessed \$225 in 1825 at Ten Mile Creek, Illinois.98,99,100 He was appointed Constable circa Jul 1825 at Peoria Co., Illinois.¹⁰¹ He purchased lot 9 in Block No. 2 at \$51.00 during the first public sale of lands on 10 Jul 1826 at Peoria, Peoria Co., Illinois. 102, 103, 104 His nomination for justice of peace for Peoria County was approved by Illionois House of Representatives on 25 Dec 1826.^{105,106} His nomination by the Illinois House of Representatives for justice of peace of Peoria County was approved on 26 Dec 1826.¹⁰⁷ Hiram's (532) confirmation by Senate of nomination by the Illinois House of Representatives for justice of peace representing Peoria County was announced on 27 Dec 1826.108 He was commissioned justice of peace on 5 Jan 1827 at Peoria Co., Illinois. 109,110 He was a candidate for county commissioner on 14 Aug 1828 at Peoria Co., Illinois. 111 He was a candidate for justice of peace on 18 Oct 1828 at La Salle District, Peoria Co., Illinois. 112 He was an early settler in Spring Bay Township, Tazewell County, Illinois, in 1829.^{113,114} He received 28 votes for justice of the peace and was elected to the office on 29 Aug 1829 at LaSalle Precinct, Peoria Co., Illinois. 115,116,117 He was issued commission as justice of peace for county of Peoria by Illinois General Assembly on 10 Sep 1829.¹¹⁸ He was Justice of Peace on 9 Nov 1829 at Peoria Co., Illinois. 119 He owned land in 1829 at Spring Bay, Woodford Co., Illinois; in Spring Bay Township being in T27NR4W of 3rd PM and small corner of T28N.^{120,121} In 1830, Hiram M. Currey (532) was to have performed a marriage ceremony in the home of John Hammett but did not arrive until late having come from near Mossville, Peoria Co., Illinois. 122 He appeared on the census of 1830 at Peoria Co., Illinois, listed with 1 male age 10-15, 2 males age 30-40, 1 female under 5, 1 female age 20-30.123 He was commissioned major of Peoria battalion on 4 Mar 1830 at Illinois. 124 He, a private, served in Capt. Pike's Co. of the Rock River Rangers in the IL Vol. Mil in the Sac & Fox War between 16 Jun 1831 and 26 Jun 1831 at Illinois. Hiram M. Currey enrolled at Fort Armstrong. 125,126 He performed the first marriage solemnized between white people in this region between Harris W. Miner and Miss Nancy Gross circa 1832 at Stark Co., Illinois. 127,128 He was appointed along with Charles Ballance as commissioners to a road towards Knoxville that passes on north line of at SW1/4 S5 T10N R9E, Peoria Co., Illinois, in 1832.¹²⁹ He served as a member of Peoria Company during the Black Hawk War in 1832 at Peoria, Peoria Co., Illinois. 130 He held the office of Commissioner on the conduct of the Pottawatomi between 1832 and 1833 at Illinois. 131 He began military service on 23 Apr 1832 at Illinois as 2 Sergt in Capt. Eads' Co. Mtd. Rangers, Stillman's Batt'n, Ill. Mtd. Vols. 132,133 He was listed on muster roll of Captain Abner Eads Company of Mounted Ranging Volunteers enrolled on an Order from Commander in Chief of the Militia of the State of Illinois to Brigadier General Isaiah Stillman for the service of the United States and served as Orderly Sergt. from May 17th to the 21st of May between 23 Apr 1832 and 28 Jun 1832 at Peoria, Peoria

Co., Illinois.¹³⁴ He ended military service on 28 Jun 1832 at Illinois having served as 2 Sergt. in Capt. Ead's Co. Mtd. Rangers, Stillman's Batt'n, III. Mtd. Volunteers. 135,136 He was addressee in letter from Henry Atkinson dated on 16 Nov 1832 while residing in at Peoria, Peoria Co., Illinois.¹³⁷ He sent letter and petition to General Atkinson regarding burning of land and bridge by Winnebago Indians on 6 Dec 1832 from Peoria, Illinois. Letter is signed Hiram M. Curry, major Peoria Add Battn of III Militia. 138 He applied to enter land (SW 1/4 S5 T10N R9E of 4th Principle Meridian) by preemption agreeably to Act of Congress of 19 June 1834 in 1834 at Peoria Co., Illinois.¹³⁹ He purchased the SW1/4 Section 9 Township 9N Range 8E of the 4th Principal Meridian from Lewis Hallock and Sophia his wife of Peoria Co., IL on 17 Oct 1834 at Peoria, Peoria Co., Illinois. 140 He sold the SW1/4 Section 9 Township 9N Range 8E in the Military Bounty Tract of Illinois to Blewford Stringer for \$200.00 on 18 Oct 1834.141 He was mentioned in tax list in 1835 at Peoria, Peoria Co., Illinois. 142 He taught school in 1836 in a cabin near where the residence of Moses Neal now stands, Peoria Co., Illinois. 143 He was involved in a land dispute with Isaac Underhill regarding whether Hiram M. Curry was actually residing on the land he had claimed by preemption being the SW fractional quarter Section 5 Township 10 North Range 9 East of the 4th principal meridian between 1836 and 1840 at Peoria County, Illinois. 144 He filed land entry papers on 19 Mar 1836 at Peoria Co., Illinois, claiming he occupied and raised a crop on the SW fraction quarter of Section 5 Township 19 N Range 9 East of 4th principal Meridian in year 1833.145 He filed land entry papers paying \$44.20 for the SW fractional guarter of Seciton 5 Township 10 N Range 9 E of the 4th principal merdian containing 35 acres on 30 May 1836 at Peoria County, Illinois. He purchased 35.36 acres at a federal sale for \$1.25 per acre recorded in arch. vol. no: 697, page 130 on 30 May 1836 at S5 T10N R09E, Peoria Co., Illinois. 147,148 He sold 78 and 99/100 acres in the E 1/2 NW 1/4 S30T11NR9E of 4th principal meridian for \$800.00 on 9 Jul 1836 at Peoria Co., Illinois, to Thomas M. Currey (1341).¹⁴⁹ He purchased land from Linus Scoville and Elizabeth his wife of county of Peoria state of Illinois being the NW 1/4 Section 30 Township 11N Range 9E of 4th principal meridian on 9 Jul 1836 at Peoria Co., Illinois. 150 He purchased the E 1/2 of the NW 1/4 Section 30 Township 11N Range 9E of the 4th Principal Meridian being 78 and 99/100 acres for \$150 on 9 Jul 1836 at Peoria Co., Illinois, from Linus Scoville and his wife Elizabeth Scoville. 151 His certificate #8250 for SW1/4 S5T10NR9E was cancelled on 3 Oct 1838 at Peoria Co., Illinois. 152 He was a candidate for representative in 1840 at Peoria, Peoria Co., Illinois.¹⁵³ He is head of household on the census of 1840 at La Salle Precinct, Peoria, Peoria Co., Illinois, as Hiram Curry. Listed were 1 male under 5, 1 male 30-40, 1 female under 5, 1 female 30-40.154 He purchased land being the E1/2 of the NW1/4 Section 30 Township 11N Range 9E of 4th principle meridian on 23 Nov 1840 at Peoria Co., Illinois, from Thomas M. Currey (1341).¹⁵⁵ He sold land by quit claim to Isaac Underhill the S 1/2 of Section 5 Township 10N Range 9E of 4th principal meridian acquired by virtue of preemption for the sum of \$150.00 on 28 Mar 1842 at Illinois. 156 He was commissioned lieutenant colonel of 1st regiment on 31 Dec 1842 at Illinois.^{157,158} He was member of school trustees on 27 Nov 1844 at Woodford Co., Illinois.¹⁵⁹ He went to the gold fields circa 1849.160

Burke (533) and Elizabeth Ann Bland (534), on 3 Aug 1856 at Weston, Platte County, Missouri. 196,197,198 He appeared on the census of 14 Aug 1860 at Kickapoo, Leavenworth Co., Kansas. 199 He purchased land that was received by patent by James Dillard for military warrant for service in war of 1812 containing 160 acres on 15 Sep 1860 at Leavenworth Co., Kansas.²⁰⁰ He began military service on 8 Oct 1864 at Atchison, Atchison Co., Kansas.²⁰¹ He ended military service on 27 Oct 1864.²⁰² He is head of household on the census of 20 Jul 1870 at Kickapoo Twp., Leavenworth Co., Kansas, as Hiram M. Curry, a 32 year old white male laborer born Illinois. Enumerated with were Angelina Jane Burke (531), Sarah Evelina Curry (555), John Henry Curry (556), Mary Caroline Curry (557), Hiram Miles Currey (517), and William Quincy Curry (558).²⁰³ He received patent from United States for NW 1/4 S26T7R21 on 3 Nov 1871 at Leavenworth Co., Kansas.²⁰⁴ He and Angelina Jane Burke (531) sold at a sheriff's sale NW 1/4 S26T7R21 on 15 Dec 1871 at Leavenworth Co., Kansas, to Moses J. Patterson.²⁰⁵ He is head of household on the census of Jul 1875 at Kickapoo Twp., Leavenworth Co., Kansas, as H. M. Curry, a 40 year old male farmer born ILL who came to Kansas from MO. Enumerated with were Angelina Jane Burke (531), Sarah Evelina Curry (555), John Henry Curry (556), Mary Caroline Curry (557), Hiram Miles Currey (517), William Quincy Curry (558), James Gilbert Curry (559), and Elizabeth Jane Curry (560).²⁰⁶ He and Angelina Jane Burke (531) and Gulford Hornbuckle and Sarah E. Hornbuckle, his wife filed petition on 5 May 1876 at Weston, Platte County, Missouri, against John M. Burke and Milton E. Burke seeking partition of E 1/2 SW 1/4 S34 T54 R36 in Platte County.²⁰⁷ He and Angelina Jane Burke (531) along with Gilford Hornbuckel and his wife Sarah petitioned John M. Burk and Milton E. Currey, a 44 year old white male farmer born IL whose father was born KY and whose mother was born IN. Enumerated with were Angelina Jane Burke (531), John Henry Curry (556), Sarah Evelina Curry (555), Mary Caroline Curry (557), Hiram Miles Currey (517), William Quincy Curry (558), Elizabeth Jane Curry (560), and Dora Ann Curry (561).²¹¹ He is head of household on the census of Jul 1885 at Delaware Twp., Leavenworth Co., Kansas, as H. M. Curry, a 50 year old married male farmer born IL who came to KS from MO who was honorably discharged in 1865 from the Kansas Militia. Enumerated with were Angelina Jane Burke (531), John Henry Curry (556), William Quincy Curry (558), Hiram Miles Currey (517), James Gilbert Curry (559), Elizabeth Jane Curry (560), Dora Ann Curry (561), and Marion Franklin Curry (562).²¹² He and Angelina Jane Burke (531) sold by Deed of sale to Leavenworth Northern and Southern Railway Co. 100 feet wide easement - 50 feet each side of railroad W 20 acres of S 40 acres of SE 1/4 S25 T9 R22E from station 808-42 to station 814-40, 1 37/100 acres on 11 Jan 1887 at Leavenworth Co., Kansas.²¹³ He and Angelina Jane Burke (531) sold by Deed of sale to W. H. Bond coal and other mineral rights on the E side SE 1/4 S25 T9 R22 1 acre; and S. side SE 1/4 S25 T9 R23 20 acres on 12 Jun 1889 at Leavenworth Co., Kansas.²¹⁴ He and Angelina Jane Burke (531) sold by Sheriff's deed to Samuel J.
