# President's Message — 1988

In the belief that it is proper for an incoming President to gain first hand knowledge of the conditions and difficulties under which Member Unions operate, the 1988 season provided me with a unique opportunity.

Two internal tours by International Board Countries, England and New Zealand, enabled me to visit and meet officials and players in virtually all States and Territories during 1988, and which will culminate in an official visit to the Northern Territory in January, 1989.

I can therefore report that generally speaking our Member Unions are soundly based and functioning, with an essential emphasis upon progressive management.

The playing season brought forth a mixture of success and disappointment, but against a background of change involving player and coaching personnel, it can be said that the season established a promise of better things to come.

I offer the sincerest congratulations to the following players for personal achievements:-

- \* Simon Poidevin, O.A.M., who was awarded a Medal of the Order of Australia for his services to Rugby and who reached a record 50 Test caps for Australia;
- Rob Lawton, David Carter, James Grant and Peter Kay, who received their first Australian cap for representing against England;
- Lloyd Walker and Tim Gavin, who were awarded their first Australian cap for representing against New Zealand.

The playing season started well with Australia winning the Hong Kong Sevens in superb style, but the team was unable to reproduce its form in the Bi-Centennary International Sevens at Concord, being defeated by Scotland in the semi-final. New Zealand fully deserved their victory in the final.

The Australian Bi-Centenary XV did Rugby proud, with a fine victory in a magnificent running match against a star-studded World XV.

This set the stage for a demanding season, first an eight match visit by England, followed by a thirteen match New Zealand tour.

The Australian team defeated England in both Tests and in so doing demonstrated its capability and potential to play well.

Against New Zealand, although the Australian team played to its own high standards, particularly in the drawn second Test at Ballymore, in the remaining two Tests it failed to withstand the teamwork and skill, of what is perhaps the finest All Black side to visit Australia since the Second World War.

The Australian Team is to be congratulated on its courageous effort during the season, as are the All Blacks, on their unbeaten tour record. The Australian Under 21 Team performed magnificently against its New Zealand counterparts at Ballymore. Down 13 points at half-time the team displayed enormous commitment and courage to come from behind and win the game in the final minutes.

In a close and exciting game in Brisbane, the Australian Under 17 team went down to New Zealand Under 17 and the players of both teams are to be congratulated on their fine display.

Australian referees shared the International stage with the appointment of Sandy MacNeill to the U.S.A. vs Canada game in the U.S.A. and Kerry Fitzgerald to the Fiji vs England game in Suva.

It is noted in writing this report that Sandy MacNeill has been appointed to referee two 1988 France vs Argentina Internationals in France and Kerry Fitzgerald will referee two of the Five Nations Matches in 1989.

Although the year produced its usual share of tension and strain with the Presidency and national coaching positions being strongly and unpleasantly contested, as well as the controversy attached to Concord and South Africa, there was nevertheless continued success in minimising the impact of these issues in the print and electronic media.

At all levels these days, there are no easy times for Rugby Administrators and 1988 was no exception as far as the Australian Rugby Football Union was concerned.

I therefore wish to record my thanks for the contribution and support of the following:-

- the Vice-Presidents, Members of the Executive and Council and our International Board Representatives;
- \* the Hon. Treasurer, John Howard, O.A.M., who unstintingly provides his financial expertise and valuable time;

- \* the retired Executive Director, John Dedrick, O.A.M., whose 13 years of devoted duty has already been recognised at a Testimonial dinner. His consent to delay retirement until the end of the 1988 season meant that I was able to settle into the Presidency with the minimum of concern.
- \* the current Executive Director, Bob Fordham, who has already justified the confidence of the Executive in his appointment from a most talented and large field of applicants. Our Union will not regret the appointment of Bob Fordham.
- \* the Union's headquarters staff of John Rheinberger, Marie Joseph, Samantha Yip, Katrina Francis and Joan Forno.

The Union is grateful for the services of the Honorary Managers, Coaches, Medical Officers and Physiotherapists of the many Australian teams.

Since assuming my position, I have been amazed at the enormous body of honorary officials who work behind the scenes, carrying out many different functions with little reward and recognition, leading up to and during tours. These wonderful honorary assistants work under the direction of the Executive Director, as medical and dental advisers, physiotherapists, team and media liaison officers, gear stewards, baggage masters, ground managers, ground assistants, rubbers and in other capacities.

A feature of the year was the gathering together in Sydney of representatives of all States and Territories specifically to acquaint them and to seek their views on the Union's Sponsorship and Television proposals, which also developed into an exchange of views regarding communication problems and other matters to improve nationwide administration.

So successful was the conference that, if feasible, consideration should be given to the continuance of the format.

As a result the Union called tenders to set up a marketing arm to sell television rights and negotiate sponsorship. Such a move was long overdue. The Australian Rugby Football Union has enormous sponsorship potential with Wallaby Tours abroad, international tours of Australia, and overseas television interest. C.S.I.'s success under Michael Watt in selling Australian Rugby to overseas networks this year demonstrates this point.

The Australian Rugby Football Union marketing arm is controlled by the Sponsorship Committee chaired by Deputy Chairman Ross Turnbull and consisting of Treasurer John Howard and the Executive Directors of the ARFU, NSWRU and QRU.

The proceeds will not only end up in ARFU coffers but will also be spread around the States and should assist the Southern States to employ development officers to promote the game at school and junior level.

We are deeply grateful and appreciative of the support of our sponsors without whom the Union would be unable to offer the players international competition in Australia, tours overseas, or the standard of accommodation or outfitting to which they have become accustomed.

The valued continued support of Adidas and Ansett is greatly appreciated, as is the special concessional arrangement from the Southern Pacific Hotel Corporation through their Travelodge and Parkroyal Motels.

Acknowledgement is also made of the support of the Rothmans Foundation and its Executive Director, Mr. Alan Davidson. The contribution of Rothmans in funding the activities of the National Director of Coaching, Mr. Dick Marks, over the past 14 years, has been significant and greatly appreciated and I thank the Foundation for its continued patronage.

It was with pleasure that we greeted new sponsors of the Australian team, RICOH for the whole year 1988 and Castlemaine XXXX on behalf of Allied Brewing (U.K.) for the Australian Tour of England and Scotland.

Our appreciation is conveyed to the Australian Sports Commission, first through the Honourable John Brown and secondly the Honourable Senator Graham Richardson, Ministers for Sport, Recreation and Tourism, both of whom have been supportive of Australian Rugby.

A special thanks is due to the Honourable John Brown who responded favourably to constant approaches for Rugby's admission to the Australian Institute of Sport. Rugby's admission to the Institute will be of immense value to the Union and our talented players' development. My appreciation is also conveyed to the A.I.S. Administrators Ron Harvey, Dr. Ross Smith and Bob Hobson, who have been most helpful in the preparation of the Union's induction.

I look forward to a bright future for Australian Rugby. The progress made in 1988 with the introduction of the 1991 Rugby World Cup Squad, and Rugby's introduction into the Australian Institute of Sport, should lay the foundation for the further development of the code throughout the Nation.

In conclusion I appeal to all Rugby people to strive for unity of purpose and a common goal so that our combined energies and time may be concentrated on the positive aspects of our great game.

#### INTERNATIONAL RUGBY FOOTBALL BOARD

Following the successful 1987 Rugby World Cup it has been decided that the 1991 Rugby World Cup will be held in the Northern Hemisphere, with matches played in England, Scotland, Wales, Ireland and France.

The Board also confirmed changes to the Tours Agreement, Regulations Relating to Amateurism, Resolutions and minor amendments to the Laws of the Game.

One Resolution received much criticism by the Union, 'the prohibition of players visiting overseas countries to play in the off-season until twelve weeks after their last game in their home Country unless special circumstances applied'. The Union acted immediately to condemn the Resolution, and in fact, have it rescinded.

The Union endeavoured again to have the scrummage laws amended in an effort to 'de-power' scrummaging. It submitted the Biomechanical Survey carried out by Dr. P. Milburn of the Wollongong University together with summaries and recommendations by our Medical Advisory chairman, Dr. Geoffrey Vanderfield and National Director of Coaching Dick Marks.

It was pleasing to see some progress, although not enough in the Union's opinion, in that the 'pause' was added to the engagement requirement of the scrummage. However, the Union is still committed to the introduction of as many amendments to the 'Laws of the Game' with the proven capacity to reduce injuries.

The introduction of the Rugby World Cup under the auspices of the Board and an increase from one to two meetings a year has placed an extra commitment on the Union's representatives as well as an enormous added time burden to them and financial burden to the Union.

Thank you for the time, effort and work to the Union's Representatives Dr. Roger Vanderfield O.B.E., who was re-elected this year for a further two years to add to the fifteen already served, and Ross Turnbull who comes up for re-election in 1989.

Terry was a delegate from the New South Wales Rugby Union to the Union's Council and appointed Hon. Treasurer during the years 1953 to 1955 inclusive.

He managed the Australian Team to Britain, France and North America in 1957-58 for a mammoth 44 matches.

Terry had a long association which spanned some 30 years as Secretary, then President of the St. George Rugby Union Football Club.

#### CONCLUSION

The year 1988, the Bi-Centennial year for Australia, was a big one. Challenging for the players and administrators alike in re-building a depleted team under a new coach and team management.

The Australian players would have been called upon for a personal contribution of up to three months from work and home. A huge sacrifice to them, their families and loved ones as well as their employers or study commitments.

In retrospect the players and most administrators did Australian Rugby proud and I am most grateful that I was privileged to be part of the 1988 development and share in the success.

The Union looks forward to continued development and success in 1989 and in this regard I wish the newly appointed Executive Director, Bob Fordham enjoyment and success in his office.

To all the Rugby players, administrators and officials throughout the world as well as the dedicated Rugby supporters in Australia, I extend my best wishes for 1989 and thank them for their kindness together with courtesies extended during my thirteen years as Secretary and Executive Director.

# Honorary Treasurer's Report

The net surplus for the year ended 31st October, 1988 was \$64,756. The corresponding figure in the previous year was a net surplus of \$733,733.

The tours by England and New Zealand yielded a surplus of \$286,919. The revenue from the Rugby World Cup in 1987 was diminished by \$146,600. This was due to the lodgement of additional expenses, some as late as July, 1988, and a paring down of the final dividend, to ensure that money is set aside as a contingency for any future liabilities.

While a deficit was forecast at the start of the year, the principal contributor to revenue came through the receipt of television fees. The agreement entered into with a specialist commercial operator proved to be of great value to the Union.

The commitment to provision of funds for coaching and development continued. Amounts of \$181,586 and \$323,887 were paid out in these areas.

During the year the Union entered into an agreement with the Australian Institute of Sport for a coaching programme. This will mean a contribution from the A.R.F.U. to supplement the funds supplied by the Australian Government. Approval has also been given to a reinvigorated coaching programme supervised by the National Coaching Panel. It is envisaged that the contributions to coaching and development will rise considerably.

From the start of this financial year, a number of changes have been instituted to streamline financial procedures. Additional computerised facilities have been set in place to facilitate bookkeeping requirements. A Financial Controller, Mrs. Joan Forno, has been appointed to centralise all financial matters within the office.

As usual, the staff of the Union have assisted me at all times. The work required of an Honorary Treasurer is sometimes very demanding, and growing in complexity all the time. The job would be much harder without the cheerful co-operation of the staff. This year has seen quite a changing of the guard; to both the old and the new I offer my thanks for the help given to me.

Your attention should be directed to the Notes accompanying the Annual Accounts which form part of the presentation.

# Notes To and Forming Part of the Accounts for the year ended 31st October, 1988

#### 1. SUMMARY OF ACCOUNTING POLICIES

#### (1) Accounting Basis

The accounts have been prepared under the historical cost convention and therefore do not reflect changes in the purchasing power of money or, except where specifically stated, current valuations of non-monetary units.

The disclosure requirements of the revised schedule 7 as in force 30 September 1987 have been adopted. This has resulted in the reclassification of certain comparative information.

#### (2) Amortisation and Depreciation

Motor vehicles, furniture and equipment are depreciated on a straight line basis so as to write off the cost of each fixed asset over its expected useful life. The Directors are satisfied that in the event of disposal of the Company's real estate in the normal course of business, the net amount recovered would not be less than the present carrying value shown in the accounts. Accordingly there is no depreciable amount and depreciation is therefore not considered necessary.

#### (3) Doubtful Debts

The provision for doubtful debts shown in note 7 is of a general nature to cover unforeseen eventualities. All known bad debts are written off.

#### (4) Government Grants

Grants are offered by the Australian Government in accordance with its financial year, i.e., year ending 30 June. The Government's accounting period therefore varies from that of the Australian Rugby Football Union Ltd. Amounts are taken by the Union as they are received.

#### (5) Skills Award Scheme

An amount of \$46,359 is held by way of sponsorship solely and exclusively for the promotion of skills in young players. This amount has not been included in the company's accounts and is held in an Advantage Saver account at the Royal Exchange branch of the Westpac Banking Corporation Limited.

(6) Inventory Stocks of Ties, Pullovers and Jerseys have been valued at the lower of cost and net realisable value on a first in first out basis.

(7) Leases

Assets of the company which are subject to finance leases are capitalised. The initial amount of the leased asset and corresponding lease liability is the present value of minimum lease payments. Leased assets are amortised over the life of the relevant lease, or where it is likely the group will obtain ownership of an asset, the life of the asset. The interest components of lease payments are charged against profits.

#### 2. MEMBERS' LIABILITY

In the event of the winding up of the company members may be required to contribute a maximum of \$100 each.

#### 16. SUPERANNUATION

The company has established a superannuation plan. At present, two employees are members. Benefits are based upon the accumulation of assets in the fund.

The members are required to contribute to the plan at a flat rate of five per cent of the member's base salary. The company has a legally enforceable obligation to contribute at a rate equal to the member's contribution,

To date, no actuarial valuations have been carried out. In the event of the fund's termination or voluntary or compulsory termination of employment of the member sufficient assets are available to meet all benefits payable.

#### 17. COMMITMENTS

In the ordinary course of business the company has entered into commitments and undertakings to support the coaching and development of the game of rugby union.

# **Review of Member Unions for 1988**

New South Wales Rugby Union Ltd.

In this Australia's Bicentennial year, Rugby has been a dynamic contributor both on and off the field. New South Wales Rugby, in particular, made 1988 another milestone in its long history.

For Sydney Rugby's showpiece, Concord Oval, the season has been one of consolidation and imagination.

The consolidation of international Rugby at its new home and the foresight and imagination to make the project a major success.

Leading into the season's first games in April, final work was being done on the roof and the corporate boxes in the newly constructed Eastern Grandstand. These additions thus balancing its appearance with its counterpart on the western side. Continuation of improvements to the ground's facade, allied with a heavy and most challenging representative season, assisted the image of Rugby greatly following an arduous year in 1987.

Dual tours by the industrious Englishmen and the indominable world champions, New Zealand provided great fuel to fire the enthusiasm of both supporters and the press. Anticipation of media exposure and the continuing desire to attract corporate support for the code led to the announcement of a major new sponsorship, the Ricoh Challenge.

Overall, the senior State side enjoyed a mixed year. Following a slow start the team produced some of its finest football to record good wins over England and their arch rivals, Queensland. In the same way, the 'B' team saved some of its most determined performances for the touring teams and gave many players invaluable experience at the highest level.

The continuing emergence of player talent from the Under 21 and Under 19 representative teams underlines the importance of encouraging competitive matches at this level. Both sides showed skills that will transfer well to Senior football.

Similarly the depth and quality of player strength was again highlighted by the strong Championship clubs and New South Wales suburban competitions.

Standards of play were of the highest order as typified by the willing challenge by the Randwick Club to the awesome All Blacks team.

At the school level, New South Wales found strong opponents in England and New Zealand as well as those nations involved in the Asian Pacific Tournament. Such competition allied to the School's new coaching programme can only benefit Rugby at this emerging level.

Once again the efforts of all members of the Executive Committee as well as all honorary officials and employees of the New South Wales Rugby Union are to be congratulated. The demands on time and expertise in making this season a fruitful and satisfying one were great. The benefits of such dedication must continue to accrue into future Rugby endeavours.

While 1989 approaches with new challenges, the competition and commitment will remain strong. With the Lions providing a stern opposition to all and the established representative and domestic competitions giving supporters a wealth of flowing Rugby, the new season approaches as another beauty for New South Wales.

# Queensland Rugby Union

1988 was to be a watershed year for Rugby Union in Queensland, with some of the more experienced representative players retiring from the game and with many young prospects graduating to Senior representative ranks.

Although the Queensland Team's on-field performances were disappointing compared with the results of the last decade, notice was given that it will not be long before the team ascends to the pinnacle of recent years.

Despite the downturn in on-field performances, seven Queenslanders represented Australia in Test matches against England and New Zealand and eleven Queenslanders were chosen for the Wallaby Tour of England, Scotland and Italy.

Gates were up on 1988 despite the massive competition from other sports and Expo and sponsorship continues to rise.

Additional corporate support was generated by the sale of thirty-five corporate boxes at Ballymore.

The Queensland Under 21 team enjoyed a successful season, defeating A.C.T. and New Zealand, whilst losing to New South Wales. Queensland Under 19 defeated New South Wales and Italy, whilst losing narrowly to Auckland.

North Queensland earned Country supremacy by winning the XXXX Championship, North Queensland also took out the Metway State Secondary Schools Championship.

The Queensland Rugby Union is greatly indebted to Norbert Byrne and Bob Templeton for their incomparable service to Queensland Rugby.

Negotiations are currently under way to finance the construction of a stand on the eastern side of Ballymore, which will take the capacity of the ground to approximately 29,000.

The Union is currently engaged in a strategic planning exercise with a Review Committee under the Chairmanship of Barrie Ffrench in place.

In conclusion, the Queensland Rugby Union takes great pride in the election of Past President Joe French, as President of the Australian Rugby Football Union and looks forward to a bright future under the Presidency of leading Queensland businessman, Leo Williams.

# Australian Capital Territory Rugby Union Inc.

1988 — ACT Rugby Union's Golden Jubilee year, was a year of change and success.

The Representative XV played 8 matches during 1988 with annual fixtures against Queensland, NSW and Sydney. A successful 3 match tour of New Zealand's South Island prepared ACT for its International fixture against the New Zealand All Blacks sponsored by Readymix. The ACT XV gave a magnificent display with the result New Zealand 16, ACT 3. The International fixture was followed by an extremely enjoyable and successful dinner at the New Hyatt Hotel Canberra. The Hotel Canberra was the venue of the 'All Blacks Ball' held fifty years ago in 1938 after the first ACT v. All Blacks match.

The 1988 highlight was the selection of Brad Girvan and Paul Cornish for the Wallaby tour of England, Scotland and Italy. Geoff Didier and Jim Taylor played for South Australian Invitation XV against England. Mark McInnes and Paul Cornish played for Victoria Invitation XV against the All Blacks, and Paul Cornish, Geoff Didier and Brad Girvan were selected to play for the Barbarians.

The ACT Under 21's had a mixed year with results not reflecting the standard of play. They defeated Sydney and lost to a Royals XV, NSW and Queensland. Geoffrey Logan, John Ross and Victor Kucharzewski were selected in the Australian Under 21 Team. Logan made Australian Rugby history as the first player ever to play for the Australian Under 21 team and the Australian Schoolboys team in one year, all after breaking his leg in pre-season.

The ACT Schoolboys had a busy representative season with International games against England and New Zealand as well as the annual NSW Country fixture. They won the Australian Championship in Perth by defeating NSW 1: 18-6. Geoffrey Logan, Dean Zammit, Ves Soldo, Todd Louden and Matthew O'Connor (Captain) were selected in the Australian Schoolboys team.

Marist College won the coveted NSW Waratah Shield defeating St. Edmund's College, who had won the Shield for the past four years, in the semi final and going on to defeat Oakhill College in the final

On the Junior scene the ACT Under 16's won the Australian Under 16 Championship in Sydney by defeating Queensland Country.

The local competition was again dominated by Royals which won 5 premierships out of a possible 7, defeating Daramalan (in the top 3 grades), Easts (in 4th grade) and Norths (in the Monaro 3rd grade). The Monaro Division first grade won by Cooma and second division by Jindabyne. The first grade Grand Final was one of the most exciting matches in many years. Royals managed to just overcome Daramalan 4-3 by scoring a try in the last minute of the match.

The new Board of Management administrative structure controlled the day to day business of the Union with a high degree of success. The Board proved to be a very effective and efficient decision making body. With the day to day decision making well in hand the Club Presidents were required only quarterly to determine overall policy and direction of the Union. This gave them more time to work on their own club matters.

The grateful thanks of our Union is again extended to our major sponsors; Readymix, Carlton and United Breweries, Canberra Wine Supplies/Kegs of Canberra and the Canberra Times. Also Radio 2CC, Ansett, Corkhill Bros., Hughes Bros., I.C.L., Capital 7, and Civil and Civic sponsored the Union as representative position and match sponsors. Two of the largest contributors to the Union's finances this year with hefty grants were the Rugby Union Club at Barton and the ACT administration.

# South Australian Rugby Union Inc.

The 1988 season has been one of consolidation. Many programmes which commenced in prior seasons have been completed. They included the erection of a covered grandstand at our Headquarters and the introduction of Walla Rugby.

The highlight of our season was the first ever visit to Adelaide by the Rugby Football Union when England played the South Australian President's XV. The final score did not truly indicate the

closeness of the play and both the South Australian members of the team and our guest participants acquitted themselves extremely well.

We were also honoured on the occasion by the presence of three Presidents (past, present and elect) of the Rugby Football Union in the persons of Messrs Mickey Steele-Bodger, John Burgess and John Simpson. Also present were the President of the Australian Rugby Football Union, Mr. Joe French, A.M. and the past Executive Director, Mr. John Dedrick, O.A.M.

Our State side also travelled to Victoria where they put up a commendable performance only to go down to our old rivals in the last minute of a very hard fought game.

The Under 21 team performed creditably in Hobart. They too suffered the narrowest of defeats by the eventual Championship winners.

Our Junior Union had a most successful season with the regaining of the Southern States Shield at the Under 16 National Championships this year held in Sydney in July. A period of some five years has seen this trophy out of the State.

Also the setting up of the 'Ken Grayling Junior Rugby Scholarship' which will enable junior players to travel to coaching camps. This year's recipients will travel to a camp in Rockhampton, Queensland in January, 1989.

One of the most important factors in the recent success of the Australian Rugby Team has been the improvement in its playing standards brought about by the regular contact with New Zealand teams at all levels. This has been recognised by our Junior Union who this year have initiated a most ambitious plan to visit New Zealand for a three match development tour each year at Under 19 level. The first team already has experienced a beneficial tour in 1988.

The Schools Union hosted both St. Bede's College from New Zealand and the touring English Schools team. No doubt the experience gained from playing such superior opposition must help to improve our local game.

They also participated in the National Championships in Perth and although they were not successful in winning the 'Charles Blunt Cup', five of our players were selected in the Australian Division Two Team.

1988 saw at last, the introduction of Walla Rugby. As Walla Rugby becomes introduced to Primary Schools we can hope to see more youngsters progressing to club rugby. Due to the efforts of our Development Officer we also saw an encouraging addition of new schools to the exisiting school competition.

On the local scene, West Torrens won the Division I Premiership for the first time in twenty seven years. This was richly deserved and a fine team effort.

To say that in 1988 sporting sponsorship in South Australia has been revolutionised would be an under-statement, with the introduction of legislation banning tobacco company participation. What will be left from the tax-generated pool for amateur sports such as Rugby Union after the professional.S.A.N.F.L. was recently promised \$1,000,000 remains to be seen. We can only trust that our submission on behalf of Rugby received genuine and generous consideration.

Plans are underway for the 1989 season. They include our annual game against Victoria, the Interstate Championships in Perth and we are also negotiating with New South Wales Country for a fixture.

A Coaching Course will be held in March and we trust this will be as successful as the last where we achieved a 95% pass rate.

As outlined many goals have been achieved in 1988 and the enthusiasm shown by members of the South Australian Rugby Union suggest that this trend will continue in 1989.

# Victorian Rugby Union Inc.

1988 was a very big season for everyone associated with Victorian Rugby.

The heaviest touring schedule for many years, both incoming and outgoing, was undertaken to help improve the playing standards within Victoria.

The highlight of the year was the visit of the New Zealand All Blacks. Despite losing 84-8, Victoria scored 2 tries, the last try against New Zealand being scored in 1926. The team was strengthened by the inclusion of several fringe Wallaby players. The largest crowd for many years turned out to see the game under floodlights.

The State Team defeated Sydney, South Australia and NSW Country (Riverina), before narrowly losing to an Invitation XV featuring players from Interstate as a warm-up to the All Blacks' visit. The Under 21 State Team defeated South Australia and Tasmania before going down in Perth to Western Australia in the final of the Interstate Championship.

1988 saw the emergence of an Under 19 State Team and we were privileged to host the Italian Under 19 Team, whilst the Victorian Schools hosted the England Schoolboys team. No fewer than 11 touring teams visited and played Rugby at schoolboy level in 1988.

The Victorian Club Competition saw Moorabbin become Major and Minor Premiers, defeating Harlequins in the Grand Final, although Harlequins were the overall Club Champions for 1988.

On an International level, Ewen McKenzie has been selected to tour with the Wallabies to the United Kingdom. Although now playing in Sydney, Ewen is a Victorian product of our Junior and Schools system and, we hope, is the first of many more internationals from Victoria. Victoria also had eight boys selected in the Australian S.S. Under 17 Team which lost to a strong New Zealand Under 17 Team in Melbourne.

In addition to the excellent pre-season courses he organised, Colin co-ordinated the highly successful 'Bicentennial Alcoa Coach in Residence' programme. We were most fortunate to have Mr. Peter Rossborough appointed to the position. Peter has had many

years coaching experience, has been a Rugby Football Union Coach since 1981, and gained seven Caps for England during 1971-1975. He proved to be a fine ambassador and his presence, along with those of his family's, were welcome sights amongst the rugby fraternity in Western Australia. The long term gain for Western Australian Rugby will have to be assessed in the future. The pertinent final report by Peter should be studied by all. His criticism, particularly in the ball skills of our backs is already being corrected, but it will take time and effort, especially by coaches, to overcome the identified deficiences. The coaching panel under Colin's guidance will be involved. Hopefully, a Coaches Group, similar to the Referces Society, will result. The interaction and discussion by coaches in our game is essential if we are to improve. The running games played against Randwick were a fine demonstration of the path we should follow.

Inter-Club Rugby has had variable success. The difference between the top sides in the Premier Grade has narrowed but there is still a considerable gap in the bottom placed A Grade sides. The standard of 2nd Grade Rugby has considerably improved with many young local players participating. It is sad to see the decline in numbers of players involved in 3rd and particularly 4th Grade. The creation of a Country Championship in the South West of the State has had a slightly shakey start. The standard of Senior Colts Rugby remains high but the Junior Colts competition needs an infusion of players, coaches and active participation by all clubs.

The representative sides have had a most successful year. The senior state side successfully played in the Home Building Society Invitation International Match, honourably lost to the All Blacks and thrashed Randwick RUFC. This brief description fails to show the pride we have in such a fine side which has represented this State and Rugby at the highest standard. All concerned but particularly coach Mal Siddons and Manager John Dawson have our thanks. The high standard set by the Seniors was matched by the Under 21's in Tasmania, who under coach Geoff Stooke and Manager Dominic O'Connell were undefeated in the Under 21's Championships. It is hoped that the nucleus of this group next year, whilst still Under 21, will compete against representative sides from New South Wales, A.C.T. and/or Queensland.

The Under 19's participated in the Pan Pacific Youth Championships in Taiwan. They lost in the semi-finals 16-6 to the champion school from New Zealand (from Invercargill). The New Zealand school then lost heavily in the final to a superb Tongan side.

Touring sides at Under 14, 15 and 16 participated Interstate.

The Schools Union should be congratulated on a most successful year. In addition to hosting sides from New Zealand and England, they also very successfully hosted the National Schoolboy's Championships. WA won the Charles Blunt trophy for the most successful Second Division State Team and had five players selected for the Second Division Representative Side.

The P.G. Hampshire Annual Dinner and Presentative Night was attended by players, officials and for the first time, their partners. It was held at the Langley Plaza Hotel and resulted in a very pleasant evening.

John Pead from Cottesloe won the P.G. Hampshire Trophy for the Fairest and Best player in 1988. Other award winners were the Laurie de la Hunty Trophy for the most improved player in Western Australia; awarded to Nick Foster-Jones, the Kendrew Trophy awarded to the best player in the Grand Final, to John Pead, the George Newstead Trophy for the most outstanding Colt aged player awarded to Wanneroos' Jamie Joseph and the Marlow Trophy for the most improved Colt Team was won by Associates Club.

The Home Building Society Trophy for the leading try scorer was awarded to Chris Miles (Nedlands) and Peter Hay (Perth). The General Agency Trophy for the best player in an International went to Robert Edwards (Arks).

The Rothwells Premiership in First Grade, went to Cottesloe, the Grand Final being played in 32 degree heat. Thanks to our Publicity Committee we managed to get television coverage from Channel 9 who then showed about 15 minutes of highlights on their Wide World of Sports Programme the following Saturday. Second Grade Premiers were Nedlands, Third Grade Cottesloe, Fourth Grade Nedlands, Senior Colts University, Junior Colts Western Suburbs. The Club Championships was won by Nedlands.

We look forward next year to the visit of the British Lions and the Southern States Championships. The Senior Side will have plenty of Representative games in the first half of the season. The large crowds at the '88 State games has resulted in a good cash flow. This hopefully will be swelled by a large crowd for the Lions' game in June. However, after 1989, we have a lean period with no International fixtures and our coffers will become depleted. To capitalise on our present strength is essential. The present strong position has been achieved by many participants, the committeen by our Chairman of Management, Geoff Stooke, along with a hard working Executive Committee have been essential factors in this year's successes. Thanks must also go to George Newstead, our Registrar, the Ladies of R.U.L.A. the Rugby Union Club, the club officials and coaches, our media man Mark Drummond, Bob Messenger, Russell Davis, Bernie Whelan and Joe

O'Sullivan. Our sponsors must also be thanked. Without their help and participation, this year would not have been the success it has been.

# Tasmanian Rugby Union Inc.

Following the re-structuring of the Union in November 1987 it is pleasing to report that many of the goals set at that time have been achieved.

One of the more satisfying aspects of the year under review has been the success in recruiting referees. The Referee's Association has acted with foresight and efficiency to such an extent that it has been able to provide touch judges frequently for major club matches. This has been a major step forward and has contributed to the improving standard of club games throughout the State.

The Union's Headquarters at Rugby Park, Hobart, now boasts a clubhouse which will provide a focal point for meetings and the social life of Rugby. New dressing rooms are to be built in the close season and a new pitch will be ready for use next season.

The administration and forward planning of the Union has been co-ordinated by the Board of Management most creditably. However, a few problems are still to be solved — notably in the area of communication with clubs, and the Union is looking to appoint a full-time salaried Executive Director as a main priority. Lack of finance precludes this appointment in the immediate future.

At State representative level the Tasmanian team visited Sydney in July to play the NSW Suburban Rugby Union in the curtain-raiser to the first Australia V New Zealand Test Match at Concord. The prospect of this galvanised the players and competition for selection was fierce and dedicated. Though the team was defeated the Tasmanians had the satisfaction of outscoring their opponents after the first 20 minutes.

Tasmania hosted the Southern States Under 21 Championship in Hobart during May. Western Australia are to be congratulated on winning the Championship and although the Tasmanian team failed to win a game they managed to give each of their opponents a fright and a hard time. The team was by no means disgraced.

Over the last two years it has become apparent to the gap between Tasmania and mainland States on the Rugby field is closing and Tasmania's representative teams are now opponents not to be taken lightly.

Rugby in the schools has remained one of the main problem areas. Although some success has been achieved with the recruitment of new teams and the improvement in the general level of play a concerted effort is needed to increase numbers and quality. This is to be addressed seriously over the next few months prior to the 1989 season.

All Tasmanian clubs again participated in the State-wide competition held over the greater part of the season. Playing standards have improved generally with the Launceston area in particular showing a greater depth in playing numbers. The Hobart Club, Harlequins, carried off the major award in this competition — the Imperial Trophy.

Northern Competition Premiers were Riverview who defeated Glen Dhu 18-3 in an entertaining final. The southern final was won by Harlequins who defeated Taroona 15-6 in the welcome presence of ARFU President Mr. Joe French and the outgoing ARFU Executive Director Mr. John Dedrick.

# Northern Territory Rugby Union

1988 was a year of big changes for Rugby in the Northern Territory. The outstanding features have been the lighting of Darwin's Rugby Park and the establishment of local competitions in Katherine and Alice Springs.

The A Grade competition was won by South Darwin with Palmerston taking out the B and C Grade Premierships. Bayside won the Under 17 flag for the second time in a row.

The quality of our younger players was shown by the solid performance of the team that participated in the Rugby Football Tournament in Taiwan. They won 2 from 5 games, losing to Korea, New Zealand and a team from China, Some strange refereeing decisions influenced the result of all games except the one against New Zealand.

Rugby in schools continues to flourish with all high schools in the Darwin area entering teams. St. John's College proved too strong in both the senior and junior divisions this year. The junior competition is steadily growing more with young players coming in to rugby. The lighting of Rugby Park will enable junior games to be played at times which do not clash with other sports, thus allowing more young people to play and enjoy rugby. This will lead to more players adopting rugby as their major sport.

The senior representative side travelled to Mt. Isa and Alice Springs, winning both games by handsome margins. The unavailability of some of the more established players weakened the side but the results achieved by the team highlight the strength of the game in the Northern Territory. The Northern Territory Rugby Union hope to send the strongest squad available to the Southern States' Carnival in 1989 and thus gauge our playing strength against other States. South Darwin Club hosted an early season 7's Tournament which featured the Ellis Club from Japan and was won by the Randwick Team.

The Australia Day 7's will attract many overseas teams to the top end in future years. With the support of Bond Brewing, our major sponsor, the Northern Territory Rugby Union looks forward to 1989 with the anticipation of seeing rugby expand to be a major sport throughout the Territory.

# **Review of Affiliated Unions for 1988**

# Australian Services Rugby Union

The 1988 National Inter-Service Carnival for the Caldwell Trophy was held in Canberra. Navy defeated Air Force (48-15) and went on to win the series with a close defeat of Army (18-9). Although an anti-climax, the final match was closely contested with Army emerging as 18-15 victors in a game which either side could have won.

The Australian Services side was selected immediately after the Carnival and commenced their tour the following morning. Matches were played against NSW Southern Province (lost 6-15), NSW Eastern Province (won 48-7) and Sydney (lost 3-17). A further game which was to have been played against an ACT President's XV was cancelled due to heavy rain.

1988 saw the continuation of ASRU's coaching and development programme supported by the ARFU and Rothmans Sports Foundation. Over thirty Service coaches completed the Level 2 coaching course. An Under 21 coaching weekend was held in March after which a team was selected to take part in the NSW Country Championships at Bathurst. These activities will be continued in 1989 but restricted as in 1988 to NSW based servicemen.

The Interstate Championship in Perth will be the highlight of Service Rugby in 1989 in a season which will be disrupted by major Defence exercises.

The withdrawal of the RAAF from Buttleworth in Malaysia marked the end of participation by Australian servicemen in the Malaysian Rugby Union's MALAYA CUP, an involvement which had continued over thirty years. Teams from RAN ships played matches in South East Asia and the Pacific. Domestically unit teams participated in civilian competitions in Victoria, New South Wales, ACT and Queensland.

# SCHOOLS RUGBY FOUNDATION

The Board of the Foundation has been broadened to include representatives from most States, thus making possible the finalisation of its incorporation in the A.C.T. under the Companies Act.

The Foundation now has approximately \$300,000 invested and pledges which will see it reach at least \$500,000.

In 1988 the Foundation commenced payments and grants for Schools Rugby activities, supplying the finance for development grants for each State.

In 1989 it is anticipated that this will continue together with some special 'one-off' type development grants for particular projects.

#### CALENDAR

The Calendar produced this year, to replace the Diary of past years, proved popular. It was made available to 25 or so senior Rugby players in each school in Australia.

#### HANDBOOK

This was produced once more through the generosity of Dunhill and gave excellent coverage of State and National Schools Rugby events which occurred in 1987.

## ADMINISTRATION

A word processor improved the office efficiency, making possible the handling of the vastly increased workload in 1988.

The Hon. Secretary indicated that, as he was being transferred to Sydney, he could not continue in his present capacity under the exisiting arrangements.

Consequently, discussion with the ARU have enabled almost all of the administration, as well as development activities, to be transferred to the ARU office - with the Hon. Secretary liaising as needed.

#### NEWSLETTER

A major innovation in 1988 was the production and direct mailing of an Australian Schools Rugby Newsletter to all Rugby playing schools in Australia.

This was produced four times in 1988.

# INTERNATIONAL SCHOOLS RUGBY CONGRESS

This was held in Canberra from September 1st to 4th - leading up to the Australia V England Schools Bicentennial Test Match.

Representatives from England, Ireland, Scotland, Wales, Fiji, New Zealand, Japan and Australia attended. The papers and outcomes of this very successful Congress will be published shortly.

### **UNDER 19 LAWS**

The revised Laws were successfully introduced in 1988, with generous help from the A.R.U. with the videos and publications.

A review of these is being undertaken, but all schools groups implemented the 1988 Laws uniformly, thus helping ensure a good trial of the changes.

# AUSTRALIAN RUGBY UNION

The A.R.U. were once more most supportive and generous in their assistance.

The new administative arrangements take this support to yet another level and promise well for the future of Schools Rugby.

#### **SPONSORS**

Caltex — our major sponsors — helped again in more than financial ways.

Breville and the Commonwealth Bank continued as co-sponsors.

1988 saw Equiticorp undertake a joint sponsorship of the Australian and New Zealand Schools Rugby bodies in sponsoring the annual Australia V New Zealand Schools game.

# Australian Society of Rugby Referees Inc.

The Australian Society of Rugby Referees, under the guidance and leadership of Dick Byres, had what can only be described as a most successful Bicentennial year. Some of the highlights of the year and aspirations for 1989 are recorded below.

The year commenced on a very high note when the Society, in conjunction with the ACT Rugby Referees Association, hosted the biennial convention in Canberra. Over 200 referees and partners from all Referees Associations in Australia attended. We were also pleased to welcome representatives of the New Zealand and Papua New Guinea Rugby Referees Associations to the Convention. A high calibre of speakers addressed the event and a publication containing copies of all papers presented was distributed to all referees in Australia. The Society would like to record its appreciation to our major sponsors of the convention — ICL Computers, Ansett, the ACT Rugby Union Club Inc, the ACT Rugby Union and the Australian Sports Commission for the assistance the Society received.

Australian referees again acquitted themselves particularly well on the domestic scene.
