## Cuatro Vientos back on track

Texas Department of Transportation officials said Wednesday they have been given authority by the Federal Highway Administration to use an estimated \$6 million in federal funds to aid in right-of-way acquisitions for the Cuatro Vientos project.

The Cuatro Vientos project will extend north to Loop 20 at its intersection with Texas 359 and south to U.S. 83 at Espejo Molina Road in Rio Bravo, providing approximately 10 miles of highway as an alternative route to U.S. 83.

The money is part of the federal government's Coordinated Border Infrastructure Program and will go toward the purchase of the remaining right-of-way acquisitions of land that run the length of the proposed project, according to TxDOT Advance Planning Director Melisa Montemay-

At a recent public meeting to discuss the proposed southern extension of Cuatro Vientos, Mike Graham, the environmental coordinator for the Laredo District Office of TxDOT, said the agency's original plan was for construction of the thoroughfare to coinciae with the construction of Mangana-Hein Road. The setback, Montemayor said, was a lack of funds for the land acqui-

reviews of Cuatro Vientos parcels because it was thought the appraisals would expire before a funding solution from TxDOT could be found.

**Interim County Engineer** Mike Cabello said Tuesday the appraisal process should begin again in January. Webb County Judge Danny Valdez said he was hopeful construction could commence as early as fall of

Montemayor said the funding for the project is split between TxDOT, responsible for 80 percent, and the city and county, which must fund the rest. Leroy Medford, the executive administrator to the county judge, said the city and county would probably split the costs equally because the land in question falls almost equally within county and city limits.

Mediora added that the city and county's share of the costs might be decreased even further if the entities qualify for grant money under the Economically Distressed Area Program.

# Banquet recalls 'P-9' pot pies

Banquet brand frozen chicken and turkey pot pies as well as some generic brand not-readyto-eat pot pies with the number "P-9" on the package have been recalled by the Food and Drug Administration.

The recall was issued after receiving a warning from the Centers for Disease Control and Prevention linking the Salmonella bacteria to the consumption of the pot pies.

Salmonella can cause gastrointestinal illness primarily fever, diarrhea, and abdominal cramps. Of most concern are persons with poor underlying health conditions or the young who could develop a systemic infec-

Although no cases have been reported in Laredo, the Health Department is urging the public not to consume and to dispose of any chicken or turkey pot pies with "P-9" printed on the side of

Laredo Health Department sanitarians continue to check stores and retailers and ask the public to know if they have this brand number "P-9" to dispose of it, call the Health Department and take the label to your retailer where you bought it for a possible refund.

All local retail outlets are being inspected to assure this product is removed from the shelves, a news release from Health Department said. This is a precaution as not all of the pot pies may have salmonella contamination, the release said.

Everyone is advised to follow the cooking instructions on the package (especially those of chicken and turkey) to reduce the risk of illnesses related to Salmonella contamination.

According to ConAgra Foods, the maker of Banquet pot pies,
