Statement by the Chair

Happy New Year Section Members!

2012 marks the fifteen year anniversary of the ASA Section on Sexualities. And, it is shaping up to be a ground-breaking year for us in several ways. Thanks to our student representatives, Trevor Hoppe and Eric Grollman, we now have an exciting (and up-to-date) website and a Facebook page. These new formats are enabling much more interaction and discussion between members, and showcasing our impressive history as a section.

As Chair, I want to acknowledge three recent and upcoming section "firsts":

- 1) For the first time on record, one of the plenary sessions at the 2011 annual meeting was dedicated to the theme of sexualities. This plenary session operates, in some ways, as a legitimizing symbol, as it suggests that sexualities research warrants "general membership" space at the annual meeting. Such inclusion is welcome at this point in time, as many section members still face colleagues and departments that are hostile to sexualities research, and find it difficult to get funding for their research.
- 2) Showing the tenacity and vibrancy of sexualities research, we achieved 500 members in 2011, which is a new, and very exciting, record. A large portion of new members are graduate students, which ensures a long and healthy life to the section in years to come. And, we are rapidly approaching 600 members, which would give us 4 sessions at the annual meetings.
- 3) To celebrate the growth of the section, we are hosting the first sexualities "mini-conference" in August of this year prior to the annual meeting. One of the many exciting parts of this conference is that it is a format to bring together the people who made this section possible in 1997 with the people who are ensuring the future relevance of the section in the years to come. I strongly encourage our members to take part in the mini-conference, as it is going to be a key moment in the history of the section. You can come to present, to volunteer, or just to interact with other members of the section. Crossing Boundaries, Workshopping Sexualities The 2012 Sociology of Sexualities Mini-Conference

Co-sponsored by the ASA Section on Sex and Gender

August 15-16, Tivoli Student Union, University of Colorado-Denver (Downtown)

Crossing Boundaries, Workshopping Sexualities, the first national mini-conference on sexualities studies in sociology, will be held August 15-16, just preceding the 2012 ASA Annual Meeting in Denver, Colorado.

Crossing Boundaries, Workshopping Sexualities will bring together scholars working in the field of sexuality studies for an intensive two days of workshops, geared towards mapping and advancing the field, while building community and collective knowledge. To celebrate the vibrant life of the Sexualities Section, the conference also will include keynote panels by eminent sexualities scholars who will discuss the past, present, and future state of the field of sexualities research within sociology. This conference aims to unite junior and senior scholars working in related areas in an effort to share theoretical and methodological advances, create intellectual networks, and promote rich collaborations within the field of sexualities studies.

Conference participants can be involved in several ways. First, registered participants will be provided with a list of possible thematic workgroups to join. These workgroups are specifically geared toward networking and intellectual synergy. Second, conference participants can apply to present their work in one of three formats:

- 1. Dissertation Master Classes: Participants will submit a short version of a dissertation proposal to be workshopped in a small group with other scholars working in related areas. A senior scholar will lead each group, providing feedback on the methodological approach, theoretical import and feasibility of the proposed research.
- 2. Works-in-Progress Panels: Participants will submit a work-in-progress (e.g. a book chapter or a journal article). Selected scholars will receive feedback from panel attendees, who will read the work in advance.
- 3."Critical Issues" Workshops: Participants will present a brief (10 pages double-spaced maximum) "position paper" or "thought paper" on a topic related to sexualities broadly.

These panels and workshops are designed to foster common investigation of theoretical and methodological approaches across specific research topics.

We invite submissions on a range of topics, including intersectional analyses of race and sexuality; qualitative and quantitative methodologies; transnational, postcolonial, and/or decolonial queer people of color approaches; homophobia, heteronormativity and critical heterosexualities; transgender studies; LGBT social movements; mental and physical health among LGBT populations; queer theory; sexualities across the life course; organizations; and much, much more... Come to present your work in one of several formats, or simply to attend the varied sessions and think with scholars in the field.

2012 Simon-Gagnon Award

The Simon and Gagnon Award honors career contributions to the study of sexualities as represented by a body of work or a single book. This award commemorates decades of research and writing on sexualities by Professor William Simon (University of Houston) who died on July 21, 2000, and his longtime collaborator, Professor John Gagnon (SUNY-Stony Brook). The recipient of the award will make a presentation to the Sexualities Section at the 2012 Annual Meeting, in Denver.

Martin P. Levine Memorial Dissertation Fellowship

The Martin Levine Memorial Dissertation Award was established to honor the memory of Martin Levine, who died of AIDS in 1993. It provides \$3,000 to a graduate student (and \$500 to an honorable mention) in the final stages of dissertation research and writing, who is working on those topics to which Levine devoted his career: 1) the sociology of sexualities, 2) the sociology of homosexuality, and 3) HIV/AIDS research. It is designed to help students complete their dissertations; the committee therefore evaluates dissertation proposals rather than completed work.

Best Graduate Student Paper

Papers co-authored with faculty are not eligible. The focus of the paper should be sexualities broadly defined. Winner(s) will receive the award at the annual meeting of the ASA in Denver in 2012.

Sexualities Section 2012 ASA Sessions

Session I (Co-sponsored with the Section on Collective Behavior and Social Movements)

Session Title: Sexualities, Social Movements, and Institutions

Description: This session will examine how social and political movements related to sexualities and/or sexual issues interact with institutions, such as the media, the law, governmental agencies and bodies, marriage, and the family. Topics might include (but are not limited to) media representations of sexualitycentered social movements, legal struggles over rights for existing and emerging sexual minority groups, the strategic use of institutions by social movement actors, and the outcomes of institutionalization on sexualitybased activism. Papers on transnational and/or U.S. movements are welcome.

Session Title: New Transnational Research on Gender and Sexualities

Description: This session showcases recent research on gender and sexualities in a transnational context. Topics might include (but are not limited to): research on gender and/or sexuality based social movements and not-for-profits; constructions of gender and sexual norms in law, media, and government; HIV organizations/programs; same-sex marriage; hate crimes; reproductive rights movements; transgender policies; sex work and trafficking; gender and sexualities in the global south. Comparative research is welcome.

Session III

Session Title: The Charmed Circle and the Outer Limits: Thinking Sexualities

Description: In Gayle Rubin's canonical article, "Thinking Sex," she theorizes sexualities as a series of circles. At the center sit sexual practices and identities deemed "normal" and normative, and at the outer edge lie "deviant" sexualities. This panel invites research that examines the social processes that create, reproduce, and challenge sexual normativity & deviance. Topics could include (but are not limited to): constructions of "normal" and "deviant" sexualities in medicine, demography, law and psychology; heterosexuality studies & critical heterosexualities; demographic studies of sexualities; allegiances and/or boundaries between marginal sexual groups/identities; relationships between sexualities at "the center" and those at "the margins," normative and anti-normative sexualities-based social movement agendas; "sex panics;" and historical research on shifting sexual boundaries.
