**FIFA Futsal World Cup open for bidding:**

**FIFA Futsal World Cup 2020**

The FIFA Futsal World Cup is held every four years and 2020 will be the 9<sup>th</sup> edition. 24 teams will participate in the final competition and, as a result, three to six halls fulfilling FIFA's requirements would be required. The duration of the competition is approximately three weeks and is expected to take place between September and November.

**The bidding timeline is as follows:**

24 March 2016	Deadline for the member associations to declare their interest in hosting the FIFA Futsal World Cup 2020 by submitting the completed and signed Declaration of Interest form.
8 April 2016	FIFA to send out the bidding and hosting documents to those associations that have declared an interest.
6 May 2016	Deadline for the member associations to re-confirm their interest in the bidding by submitting the signed Bidding Terms and Conditions.
5 August 2016	Deadline for the member associations to submit the definitive bid including all signed bidding and hosting documents (including the Hosting Agreement, Host City Agreements, Government Guarantees, etc.).
December 2016	Appointment of host by the FIFA Council.
