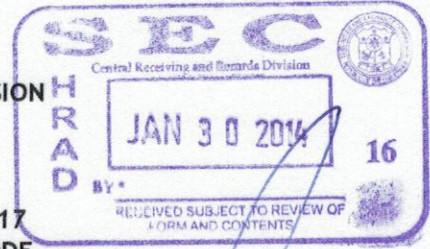

DISCLOSURES

On 29 January 2014, Macay Holdings, Inc., formerly Maybank ATR Kim Eng Financial Corporation (the "Corporation") received the Certificate of Filing of Amended Articles of Incorporation and Certificate of Filing of Amended By-laws, in which the Securities and Exchange Commission approved the following changes in the Corporation's Articles of Incorporation and By-laws:

1. Amendment of the Articles of Incorporation:
 - (i) Change in the corporate name to "MACAY HOLDINGS, INC.";
 - (ii) Change the primary purpose of the Corporation to reflect the business of a holding company; and
 - (iii) Removal of the secondary purpose relating to the tire manufacturing business.


2. Amendment of the By-Laws:
 - (i) Include a statement that the annual stockholders meeting may be held on May 8 of each year;
 - (ii) Include a Management Report in the order of business in the annual meeting of the stockholders;
 - (iii) Amendment on the composition and functions of executive officers of the Corporation; and
 - (iv) Change in the corporate seal to "MACAY HOLDINGS, INC."
