## **Scope and Contents**

The Prints, Drawings and Photographs Department Records document the activities of the department and date from its creation in 1930 to 2012, spanning 15.3 linear feet. The Records contain a wide variety of material including correspondence, financial papers, newspaper clippings, research, notes, minutes, reports, and ephemera.

The Records were created by the department's staff including: Adelyn Breeskin, Victor Carlson, Jay Fisher, Jan Howard, Susan Dackerman, and Darsie Alexander. Highlights include correspondence and other material from the earliest days of the department in the 1930s, research for exhibitions featuring works on paper such as *Felix Buhot, Peintre-Graveur: Prints, Drawings, and Paintings* and *Theodore Chasseriau: Illustrations for Othello*, records from the department's friends groups, and documentation of the long running Print Fair.

## Arrangement

The Prints, Drawings and Photographs Department Records are arranged in six series: 1. Correspondence 2. Collectors 3. Exhibitions and Events 4. Print, Drawing & Photograph Society 5. Friends of Photography 6. Administration. Within these series, the majority of the material is in chronological order.

The Collectors Series contains correspondence, lists, photographs, appraisals, published catalogues, and internal memos relating to collectors of works on paper who gave all or portions of their collections to the BMA.

The George Dalsheimer materials contain two annotated copies of an appraisal of his art collection with accompanying notes from BMA staff. The second part of each appraisal is labeled "Wish List."

The Kay Hillman materials include transcripts of a significant oral history Curator Jay Fisher conducted with Hillman in 1991. The original tapes of the interview were sent to the American Friends of the Israel Museum in New York in 1998.

#### **Scope and Contents**

Series 3. Exhibitions and Events is divided into eight subseries reflecting prominent exhibitions and events of prints, drawings, and photographs at the BMA. Some additional material relating to exhibitions may also be found in the Correspondence Series.

The Various Subseries contains material related to exhibition activities in the mid to late 1930s. During this time, Adelyn Breeskin was the department's Curator. These files include correspondence, notes, loan information, object lists, and other research material for exhibitions.

The *Félix Buhot, Peintre-Graveur: Prints, Drawings, and Paintings* exhibition organized by curator Jay Fisher was held July 10th to August 28th, 1983. The bulk date of records included in this Subseries date from 1978 to 1983. The records contain photocopies of articles, correspondence, research notes, loan lists, photographs and publication drafts. Most of the material including the correspondence,

research articles, and loan lists are in French. The correspondence and drafts of Colles Baxter, project collaborator, and Jean-Luc Dufresne, Buhot scholar, are included in the records. These individuals played significant roles in the realization of this exhibition, and their scholarship is included alongside Jay Fisher's in the exhibition catalogue.

The *Théodore Chassériau: Illustrations for Othello* exhibition Subseries contains the records of curator Jay Fisher. This exhibition took place November 11, 1979 to January 6, 1980. The bulk of records for this Subseries date from 1976 to 1980. Documents include photocopies of scholarly articles, grant information, correspondence with museums and dealers, loan information, publication drafts, and research notes. The records include a large group of photographs of Chassériau's Othello prints corresponding to images included in the catalogue. A large part of the records are in French as Jay Fisher conducted research in France and worked with international collectors, museums, and galleries to identify works for the exhibition. International lenders included The National Gallery of Canada, Bibliothèque Nationale, Musée du Louvre, and the Archives Paul Prouté. The records also include correspondence with Mlle. Paule Cailac and the unpublished manuscript of her father Jean Cailac's catalogue raisonné of Chassériau prints.

The *Claude Monet: Impressionist Masterpieces from the Museum of Fine Arts, Boston* exhibition Subseries includes the Monet Exhibition Course, a packet of educational programming related to the exhibition. This exhibition took place October 13th, 1991 to January 19th, 1992.

The *Laurie Simmons: The Music of Regret* exhibition, organized by assistant curator Jan Howard, was held May 28th to August 10th, 1997. The bulk records for this Subseries date from 1995 to 1998. The records include a grant proposal, research, budget, correspondence, loans, object lists, public programming, and publication drafts for the exhibition. The correspondence between Jan Howard and Laurie Simmons shows the artist's active participation in the planning and development of this exhibition.

The *Joyce J. Scott Kickin' It with the Old Masters* Subseries documents the collaboration between MICA and the BMA, with George Ciscle of MICA serving as a guest curator. MICA students enrolled in Ciscle's *The Curatorial Experience* course had the opportunity to actively collaborate with BMA staff in the development of this exhibition. This exhibition took place January 23rd to May 21st, 2000. The bulk of records date from 1998 to 2000. The records include joint planning meetings, photocopies of articles, research notes, budget, essay drafts, program planning, and correspondence. Scott also had

an active role in shaping the exhibition. The records include information about Scott's site-specific installation created for the show, along with a planned performance piece.

The Unrealized Subseries documents the correspondence, agendas, meeting minutes, and research for exhibitions that were not fully realized. The exhibitions within this Subseries are from 1998. The unrealized exhibitions include *Time*, *Visibility*, and a Kerry James Marshall exhibition.

The Print Fair, sponsored by the BMA's Print and Drawing Society / Prints, Drawings and Photographs Society, began in 1990 as an opportunity to view and purchase works from contemporary print dealers. The Print Fair Subseries includes the records of several curators, assistant curators, and PDP staff including Ann Shafer, Jan Howard, and Darsie Alexander. The event was held annually from 1990 to 2002 and every two years beginning in 2004. The Print Fair material spans 1990 to 2012, with the bulk ranging from 1990 to 1995 and 2006 to 2010. Records include floorplans, correspondence with dealers, internal memos, financial information, publicity, brochures, invitations, and other materials related to planning the event. Many files in this Subseries contain duplicate material from prior years of the Print Fair used as reference for planning.

#### Arrangement

The arrangement for *Félix Buhot, Peintre-Graveur: Prints, Drawings, and Paintings* and *Laurie Simmons: The Music of Regret* Subseries are based on the order of activities in the planning, development, and realization of an exhibition. This chronology begins with research articles, notes, and correspondence. As curators conduct research and correspond with artists, dealers, and collectors they begin to define the scope of the exhibition. The curatorial activities continue to include loan information, object lists, drafts of publications, and public programming. Correspondences and curatorial notes are not only present in the beginning stages of planning but are interspersed throughout the development of an exhibition. Records created at the end of an exhibition deal with press information and feedback from museum professionals and visitors to the show.

The other exhibitions included in this Series follow a similar arrangement but maintain the original order of the record creators.
