REPORT ON THE REGIONAL CONFERENCE ON PARLIAMENTARY OVERSIGHT OF IPA FUNDS 12 -13 OCTOBER 2013 OHRID, MACEDONIA



1. Summary

More than 40 MPs, parliamentary staff, experts, government and NGO representatives committee staff and regional researchers from Albania, Montenegro, Macedonia, Bosnia and Herzegovina, Serbia, Scotland and the UK participated at a regional conference Ohrid Macedonia, October 12th and 13th to discuss parliamentary oversight of IPA funds in the Western Balkans.

Hosted by the committee on European integration from the Assembly of the Republic of Macedonia and organised by the WFD(Westminster Foundation for Democracy) and NPC (Network of Parliamentary Committees on Economy, Finance and European Integration in the Western Balkans) the regional conference examined key aspects of parliamentary oversight of IPA funds in the parliaments across the Western Balkans region.

During the two day conference MPs, parliamentary staff and experts were able to discuss how parliaments in the region conduct oversight of IPA funds, what tools and mechanisms can be used to conduct effective oversight on IPA funds and shared best practises and case studies from the region. Participants also had an opportunity to hear from Scottish parliament representatives on effective parliamentary oversight and share oversight practises and experiences from various committees from the Western Balkans.

In cooperation with the European Policy institute WFD developed a four lingual toolkit on parliamentary oversight of IPA funds which was delivered to all the parliamentarians. At the end of the conference participants passed a number of conclusions and recommendations for future consideration by the parliaments in the Western Balkans region.

WFD is supporting the Network through a three-year programme, from 2012-15, to strengthen the role of parliaments in the Western Balkans in promoting competitiveness and economic growth.

2. Conference conclusion and recommendations

The conclusions' and recommendations from the regional conference were grouped in 3 main areas.

- A. Role of parliament
- B. Capacity of Parliaments
- C. Preparation for IPA II

A. Parliaments role in the oversight of IPA funding:

- The Network members recognize the importance of IPA funding for preparing Western Balkans countries for future EU accession and the important role that Western Balkan Parliaments should play in oversight of these funds.
- 2. The Network encourages parliaments to create more awareness among their members on IPA funding and play a more prominent role in keeping their citizens informed about the objectives and benefits of IPA.
- 3. Parliaments should be encouraged to develop an oversight culture of regular annual oversight hearings around IPA and other EU funding.
- 4. Parliaments are encouraged to include civil society and other non-state actors in these oversight hearings.

B. Developing Parliaments oversight capabilities:

- 1. The Network encourages parliaments to share and adopt best practice on financial oversight of EU and other structural funds.
- 2. The Network encourages governments to ensure that regular reports and access to information sources are made available to parliamentary committees especially as IPA implementation becomes more decentralized.
- 3. The Network and donors should support the development of parliamentary committees research and scrutiny capabilities. We also encourage parliaments to assign members and staff to be focal points for monitoring IPA funds.
- 4. The Network should undertake more training and development of parliamentary staff to equip them with the knowledge and tools necessary to support the oversight of IPA funds.

C. Preparation for IPA II

- 1. The Network encourages parliaments to engage early in discussions with their Government and EU delegations on country strategy papers, sectorial strategies, priorities, framework agreement and long term programmes.
- Parliaments should engage more with the relevant European Parliament Committees working on the monitoring of IPA funds. The Network should consider a visit by the IPA Working Group to the EU Parliament to see how best the Western Balkan parliaments can develop these links.
- 3. Parliaments should work closely with Government and State Audit Institutions to understand the challenges and lessons from implementing IPA I.
- 4. Parliaments should continue to positively support and encourage government administrations to improve absorption levels of IPA funding
