

# Save Our Streets

hanks to the efforts of many of our members and communityminded individuals, your Police Association gathered signatures to the largest petition ever seen in this State. The Police Association met interested members of Parliament on the steps and officially served the petition on Parliament. Politicians from all parties in both the Legislative Assembly and Council were invited. Parliamentarians present were both happy to meet with the Police Association, but at the same time sad that we had to go down this path to highlight the dire straights front line policing is in Victoria. The petition will be officially tabled by the Parliamentarians who received our petition in the Legislative Assembly in the next session.

### **Police numbers commitments**

The Save our Streets campaign and petition highlight the need for more police in Victoria. There is irrefutable evidence that Victoria spends less per capita on police and has less police officers per capita than any other State or Territory in Australia. The Police Association has called for political parties to commit to improving the numbers and outline that to the community prior to the State Election.

The opposition under leader Ted Baillieu and National's leader Peter Ryan have committed to an extra 1700 police officers over and above attrition rates over the life of the next government, if elected. At the time of writing, the Government, led by Premier John Brumby and Police Minister Bob Cameron, have not as yet made any such commitments in this regard.

There is no doubt that further resources need to be committed to policing in this State if we are going to reduce crime and violence on the streets and enforce traffic laws to reduce deaths and injuries on our roads. We can only play our part if the Government of the day gives us the resources to combat the biggest single issue facing Victorians.

### **Enterprise Bargaining**

Our preparations for enterprise bargaining are continuing with Delegates gathering again in late April to fine tune out our claim. This is an important step to ensure the thoughts of our members are encapsulated in our claim through elected representatives. At this point, the Association Executive will consider the Delegate's input for endorsement. Once this is 'ticked', The Association's administration will conduct a further round of membership meetings across the state so that as many members as possible are familiar with our claim ahead of a special meeting of members where the claim will be considered for endorsement by the membership in July. Once endorsed, our log of claims will be ready for presentation to Victoria Police. Negotiations will formally commence in December.

### **Gordon Charteris**

Last month we farewelled the highly respected officer, Inspector Gordon Charteris. Gordon was a loyal police officer who served in many fields of policing throughout his career. Gordon was the PSA manager for Hastings who took a stand against the continued reduction of resources in his area and highlighted the lack of numbers restricting his ability to properly police. Community leaders rallied behind their police and Gordon. Police command did not heed the call for extra resources but instead vilified Gordon for speaking out. Gordon was surrounded by friends and family including many junior police officers who admired the

pril saw your Association involved in representing our members across a wide range of subjects in both the public arena and "in house".

Internally, the Delegates endorsed the Log of Claims for the next round of Enterprise Bargaining, and the Executive will now deliberate on whether the Log, in its' current format, will be put to the general membership for endorsement.


We have continued to develop our 'manifesto for community safety' which will outline how (contrary to the views of some) law enforcement, and not social engineering and advertising, plays the major role in community safety. The manifesto will be published shortly and delivered to all political parties and the media.

Carl Williams died and Rob Stary lost his star client. No-one, under any circumstances, should be murdered; but it's hard to imagine that the community will mourn Williams' death. Of more concern to us is the fact that, the very day after we joined with the Rail, Tram and Bus Union in calling for more police and Authorised Officers on trains, a young man was murdered at Clayton Railway Station.

The State Coalition has committed to an additional 100 police for the Transit Safety Division, as part of an overall package of 1,700 additional police, and has outlined its' proposal to deploy PSO's to railway premises. We now wait on the Government's plan to make public transport safe.

We do know this; this situation simply cannot be allowed to continue, the public and our members have had a gut full of rhetoric, and the party that commits to the best Community Safety policy will be hard to beat on 27 November.

We delivered the "Save Our Streets" petition to Parliament. The former Chief Commissioner reluctantly and eventually was forced to admit the role she actually played on Black Saturday. Despite her claims that she is pursued by corrupt police, or it's all because she is a woman (even Minister Bronwyn Pike dismissed such a suggestion), the simple fact is this: She did not comply with the legislative requirements of the Emergency Management Act on that dreadful day. She did not do her job – a view that was publicly stated by former Chief Commissioner Kel Glare.

While many members were working in excess of 24 hours straight, placing their lives at risk to rescue and assist Victorians, she was attending to private affairs. Then she gave her version of *her* truth, which neatly omitted all of the embarrassment that she must have known would follow information from a Royal Commission in the witness box.

Those are the issues with which we take exception, because nothing less is demanded of our members than that they do their duty to the best of their ability and give truthful and satisfactory evidence afterwards. How good they might or might not be in some future employment counts for nought.

While it was she who wrote the 'open letter' to the *Herald-Sun*, further fuelling public debate it is, finally, a matter for the Royal Commission and the Premier.

A busy month? We believe it is a measure of how much interest Victorians now place in matters relating to their police force – and that interest is unlikely to diminish before the State Election.

# You did it – more than 70,000 signatures to Save Our Streets

ast month The Police Association delivered its record-breaking petition demanding more police to State Parliament. Opposition

politicians met Association representatives to receive the petition and show their support for the Association's call for more police. Unfortunately the Government didn't send a representative.

"The Victorian public has spoken in record numbers on the need for 3000 more police in our state. It's time our decision-makers listened," says Association Secretary Greg Davies.

National Party leader, Peter Ryan said it was "reprehensible" that the Association had to collect these signatures. "We've promised the first 1700," he told Greg Davies on the steps of Parliament.

In the past 12 months, street crime and violence has become the number one issue for Melbourne people. The idea that it may not be safe to walk the streets after dark in parts of the city is depressing. It trashes our self-image as a friendly and livable city.

Our members have been telling us for years that you have been losing the fight for the

streets. You feel outnumbered, outgunned, and outdone. You feel unable to fulfill their prime responsibility of making Victorians feel safe.

Two years ago, the Association commissioned research amongst police and the general community to explore more deeply how people felt about these issues and what could be done to fix them.

One of the strategies to emerge from the research was to gather the biggest petition in the history of the Victorian Parliament to show our legislators how strongly the public felt about the need to boost police resources to meet the challenge of street violence. The campaign was launched under the banner of *Save Our Streets*.

Petitions carry no formal weight in our parliamentary system and some may feel they appear quaint as a method of communication with our MPs in these days of twitter and email. But this one is hugely symbolic of public sentiment about one of the prime responsibilities of government – keeping people safe.

The previous largest petition presented to the Victorian Parliament was signed by 65,588 people on petrol pricing in 1995. Another notable petition was the 1891 women's suffrage petition, signed by 30,000 women and delivered on a cloth 260 metres long.

Politicians will ignore our petition at their peril. A recent survey of our members showed that you are willing to convert your feelings on this issue to political punishment at the ballot box.

"I suspect it is a vote-changer in the general community too," says Greg.

Independent research by the National Institute of Economic and Industry Research showed that another 3000 police are needed to provide adequate coverage.

"This shortfall is confirmed by the Productivity Commission figures this year. They show that Victoria needs a little under 3,000 police to bring Victoria to the national average.

"If the Government fails to act, the sense of insecurity and fear in Victoria will grow. It will be fuelled by an atmosphere of arrogance and immunity amongst the perpetrators. The problem will escalate. It is time to listen to the people."

# SOG bears the brunt of police shortages

Despite the promise of an increase in Special Operation Group (SOG) numbers post 2003 the Force has now proposed a winding-back of resources, leaving the unit severely short.

With only one intake course per year, numbers were already dwindling – the removal of 15 positions will further strain the unit.

The anti-terrorism group is to be cut as part of a Force reshuffle in order to supply resources for an additional Critical Incident Response Team (CIRT) at the Force Response Unit.

Currently the operational strength of the SOG is 49 and is made up of 10 sergeants and 39 troops (senior constables and leading-senior constables.) The Force plans to take two sergeants and 13 members, the resultant number a dire 34.

The relocation of members will take effect from July 1 with the Force stating the move will transpire through attrition.

However, the impact of this change will be felt immediately, with 15 SOG personnel to be rostered to operate a CIRT van four days a week from July 1.

This decision has left SOG members feeling that, they too, are now being made to bear the brunt of the chronic police shortage.

It has severely impacted on the morale of the squad which some members say has never been as bad as now.

SOG members had raised many Occupation Health and Safety issues, particularly stress and workload-related concerns and felt they were directly related to the restructure.

This reduction in SOG numbers comes despite numerous recommendations by various government agencies since September 11, 2001 to boost police resources to combat potential terrorist attacks.

# PCET travel claims resolution

We have previously advised of a systematic, non-payment of travel entitlements to some PCETS.

In response to the Association taking this mater up, the Force agreed to conduct an audit of PCETS who haven't received their rightful entitlement.

The Force has now completed their audit and identified PCET members who are entitled to unpaid travel claims.

Members who the Force believes are eligible for the payment are in the process of being contacted in writing.

This comes four months after The Police Association finalised negotiations with the Force, ending the confusion which surrounded travel allowance entitlements for PCETs undertaking training at the Motor Driving School and Traffic Alcohol Section.

# Inadequate accommodation allowance – Mountain Ash Alpine Resort

Members who lodged at the Mountain Ash Alpine Report whilst on duty during the 2009 Black Saturday Bushfires will be granted a special Inadequate Accommodation Allowance.

The Force has identified the majority of eligible members and is in the process of contacting those of whom the allowance applies. The below-standard of accommodation available to members has been recognised, with the amount of \$60 per night to be paid to members – more than double the standard Inadequate Accommodation Allowance of \$25 per night.

If you believe you are eligible for this allowance and have not been contacted by the Force, please contact the industrial relations sections of the association on 9495 6899.

# Unpaid availability – payments finalised

Your Association has, in the last month, settled a claim on behalf of hundreds of members for unpaid availability.

Members who have previously advised the Association of an unpaid availability claim should expect their payments to arrive prior to the end of this financial year.

# TPU review recommendations to be implemented

Since the establishment of the Transfer and Promotions Unit, The Police Association has received many complaints about the current selection system.

As a result, the Association together with the Force conducted a review in the later half of 2009.

From that review, a number of recommendations were put forward. Of those, 12 will be implemented.

These include;

> applicants being required to declare authorship of their applications and validate examples in their Key Selection Criteria (KSC) statement

> applicants being required to address all six KSCs

- > a pro forma referee check to be undertaken on all applicants
- > unsuccessful applicants having access to selection report for themselves and the selected applicant
- > feedback to be provided by the local representative on the panel
- > the reintroduction of promotional exams

Not all recommendations put forward in the review process were agreed upon by the parties and some of those are not capable of being implemented.

However, the parties have committed to the further discussions in order to continue the change to the existing framework and increase the integrity and robustness of the transfer and promotion system.

# Variable hours roster dispute continues

Following the termination of variable hour shift, including 12-hour shifts at various locations, the Association instigated legal action against the Force in the Federal Court, in a resolute bid to overturn these decisions.

The legal action asserts that the actions of the Force are in breach of the Workplace Agreement.

On April 20 a court-ordered mediation was convened. The mediation was then suspended for eight weeks for the parties to consider a number of issues. It will then be re-convened.

The Police Association remains determined in our attempts to restore all variable hours shift arrangements which were, in our view, unlawfully and unfairly terminated against the wishes of our members.

# **Superannuation forfeiture:** Explaining the facts and exploding the myths

he Association has fielded many calls from concerned members with regards to their superannuation entitlements and specifically, forfeiture resulting from disciplinary action.

The main cause for these enquiries has been the concerns of members who have been of the view that their superannuation entitlements may be forfeited post-dismissal or, after their having been discharged from the Force due to misconduct arising from a disciplinary decision.

Members need to be aware that their retirement entitlements, including superannuation, cannot be taken from them by the Force.

The rules governing our members' superannuation entitlements and their administration fall under the *Emergency Services Superannuation Act 1986*, they do not contain any provision that enables the superannuation entitlements of members to be forfeited in any circumstances.

Under Part III of the *Police Regulation Act* 1958, forfeiture of superannuation provisions exist that on the face reflect an authority of the Chief Commissioner to withhold superannuation entitlements of members who were dismissed for misconduct or other breaches of discipline. However, these powers only applied to members defined under the now repealed *Superannuation Act* 1958.

In any case, the introduction of the *Superannuation Act* 1963 by its very construct has repealed the forfeiture provisions contained within Part III of the *Police Regulation Act* 1958.

That said, Victorian courts do have the power to make a "superannuation order" as a sentencing option where a person has been convicted of a serious indictable offence that reflects a breach of trust. A "superannuation order" is a document issued by a Judge of the Supreme or County Court which gives the power to have an offender's superannuation forfeited.

This power is conditional upon conviction for the offence that the person was charged who at the time:

- > was a public sector employee; and
- > was convicted of a corruption type offence; or
- > Perverting the Course of Justice; or

> an offence where their office had been abused (e.g. misconduct in public office).

Such an order cannot be invoked on members who are dismissed due to misconduct, or any discipline charge which has been found proven as it relies solely

upon a conviction arising out of a finding of guilt of a criminal charge of the kind referred to above.

The application of the Chief Commissioner's no confidence dismissal powers (Section 68 of the *Police Regulation Act* 1958) do not allow for the forfeiture or interference of a members' superannuation, should a member be ultimately dismissed through the application of this process or any other discipline action contained within the *Police Regulation Act* 1958.

# EB 2011 Log of Claims takes another step forward

RIGHT: This motion was endorsed unanimously he development of our next Enterprise Bargaining claim took another step forward last month, with Association Delegates further fine-tuning the claim at a Special Delegates' Conference held in Melbourne.

This highly constructive feedback provided by your delegates in relation to the comprehensive log of claims will be considered for endorsement by your Executive at its May meeting.

Once a final log of claims document is ratified by the Executive, the Association will schedule a series of membership meetings to be held at workplaces across the state in June.

The workplace meetings will provide members with the opportunity to have all aspects of the log of claims explained in detail and to have all their questions answered. The Association will intensively publicise this schedule of meetings as soon as it's finalised.

Following our membership meetings, a Special General Meeting (SGM) of members will be held in Melbourne in late July to ensure that members have the final say on the shape and content of the log of claims that will be presented to the employer on their behalf.

Under the current Workplace Agreement, negotiations on the next Enterprise Bargaining round will commence in December this year. The current agreement expires in mid-2011.

Members will have ample opportunity to receive a comprehensive explanation of the entire log of claims during the forthcoming series of member meetings to be held in June.

Members will then have the final say on the final log of claims at July's SGM in Melbourne.

The EB log of claims to this point has been heavily based on feedback obtained directly from members at previous workplace meetings and via feedback members have provided to their delegates for presentation at the past several Delegates' Conferences held since the last EB round in 2007.

The Police Association is committed to taking all necessary steps to ensure that all members' views are represented in our next EB log of claims and that we prosecute our final membership-endorsed claim as vigorously as possible.

# Members doing it tough in the home of the 'Gift'

**The members at Stawell are** under the pump. Numbers are down and there are days when they can't even put a van on the road. The bosses are doing their best to get people there, but it's proving to be difficult.

tawell is a pretty town on the edge of the Grampians. The majority of its population of 9,000, 54 per cent, earn less than \$16,000 per annum. Just two percent earn more than \$60,000.

That 54 per cent create most of the work for the local police. Family violence and poor behaviour involving alcohol around the town's licensed premises are major policing issues. There is also a lot of work on the Western Highway with 2,500 trucks, including B-Doubles, passing through town every day. That's one every 20 seconds.

Stawell is not a sleepy hollow. It is a busy town for the police, yet members are reluctant to come here.

OC at Stawell, Senior Sergeant Paul Margetts is concerned about the welfare of his members and his community. He doesn't like the fact that his members have to work night shifts with a minimum break. He doesn't like the fact he has trouble putting a van on the road. He doesn't like that fact there are days when he just can't put a van on the road. He doesn't like the fact he can't provide valuable proactive police operations for the community.

Stawell should have one senior sergeant, six sergeants and 29.5 o/rs. There are only 22.5 o/rs on the roster at the moment.

"When we are at full bottle we can have a sergeant and three on every shift. That is ideal - a supervisor, two in the van and one in the watch house. We can do foot patrols. We can do bike patrols. We can give people a corro day. We can do lectures at the schools. It's been 12 months since we've had enough people."

A few days after *The Police Association Journal* visited Stawell there was only one member on duty for the day shift. That member had to ask a detective on duty in the CIU to come down and mind the phones so he could go to the toilet. This situation is just not good enough.

"We'd like to have a van on the road 24 hours a day, but we don't," says Paul Margetts. "We often share a van with Ararat because we have vacancies and members on long-term sick leave. We are fortunate that Ararat is only 26 ks away."

Ararat and Stawell also share the night-shift supervisor role as a matter of course. There is one sergeant on night shift supervising both stations. This gives sergeants time

to do the portfolios because they are not on quick turnaround night shifts.

"At the moment, while we are a bit short, the sergeants on day-shift are part of the van crew. This means their portfolio work drops away. But our number one priority is to keep the service delivery going. There are days I am on the van," says Paul.

Having sergeants on the van is not an ideal situation on many levels. It means the supervisor is responding to jobs and not supervising. One acting sergeant told *The Police Association Journal* that he is keen to take promotion but when he is upgraded he

spends as much time in the van as he does when he is doing his normal duties.

The acting sergeants take on all the responsibilities of being a part of the station management team including checking briefs and portfolio work but they are still doing their old jobs.

The roster sergeant tries his best to fulfil members' requests for days off but it is hard. He gets a balance between the needs of the members and the needs of the station.

When Paul Margetts offers his members training courses to help them develop their skills it means the entire station staff pulling together to make it happen.

Three Stawell members completed Vehicle Safety Testing School at Horsham recently. The only way Paul could give them the time to do the vital training course was to ask other members to hold off on their rest days for that period of time.

At Easter the Stawell Gift sees the town's population more than double with 10,000 visitors. The only members to get days off over Easter are those on days off after a seven-night night shift.

"As a team we make the commitment to each other to all work through Easter

and support each other. I do all the 265 shifts. We have a van on every shift and the three-up brawler every night. The bike patrol was out every day. We were able to do that because everyone supported each other."

Next year Stawell is expecting to get six members out of the ATO Buy Back over Easter. This will mean the Stawell members will get at least one day off over Easter for the first time in years.

Easter this year the police responded to 21 tasks. Not one visitor was involved – just the locals, just that troublesome 54 per cent. Alcohol was a major contributing factor.

"We didn't have one job over the weekend involving someone from the crowd. Even though our population doubles they don't give us any trouble," says Paul Margetts.

The camaraderie at Stawell is extraordinary. "And they are doing great work. Not only are they supporting each other, they do great work for their community," says Paul.

"They don't have access to the specialist areas you can get quickly in Melbourne. They demonstrate high levels of initiative. They take on jobs with limited supervision and bring back great results."

As one member puts it, "we are our own worst enemies. If we didn't get the job done they'd have to do something about the shortages."

"Touch wood – we haven't had a major incident when there hasn't been a van on the road – but it might happen one day."

# Fancy a country job? Why not try Stawell?

hy don't people want to come to Stawell? Senior Sergeant Paul Margetts doesn't know the answer to that question. Stawell is a terrific town and has plenty to offer single members and those with families.

There are good schools and a university campus in town for the students. The medical facilities are first class. There are also plenty of employment opportunities for family members in health, education, tourism and local government. If you like the outdoor life there's bushwalking, camping and fishing just kilometres away. Halls Gap is just 25 ks away. And there are plenty of wineries around the area. There is an active station social club that organises informal functions and the major Christmas 'do'.

Sport is a priority with football, netball and basketball.

One up-side to the minimum break night shifts is that members from out of town have a chance to go home during their six days off, giving them access to the support network that is vital for every police member.

People coming to Stawell on a special category transfer do their time and go. "I am happy about that. I am working at putting training around those members, giving them the chance to build up their skills. While they're here they can maximise their skills and when they go they have that as part of their foundation learning. That will make their time here more interesting and may encourage them to stay on longer. POLICA

# Safer Travel, Safer Stations

**In an historic joint initiative** The Police Association and the Rail Tram and Bus Union have called for a new approach to deal with crime and safety on Melbourne's train network.

he Safer Travel Safer Stations initiative would nearly double the number of staffed stations, dramatically increase the number of Authorised Officers patrolling stations and surrounding areas and deliver a major boost to police numbers.

The *Safer Travel Safer Stations* initiative calls on the Government to commit to:

> 100 additional authorised officers to patrol stations, station car parks and public areas around stations;

> Staffing an extra 48 stations across the system; and

> Recruiting extra transit police.

"Public safety at and around train stations is a major problem in Melbourne and it is time we had a response from the decision-makers that recognised the public want to be safe on public transport," said Police Association Assistant Secretary Bruce McKenzie.

"The current approach is little more than a band aid approach with limited resources being moved around to trouble spots without the problem ever being fixed," said RTBU Secretary, Trevor Dobbyn.

"We need an approach that activates and staffs train stations, makes sure that areas around stations are patrolled and ultimately that there are enough police to respond when needed. The current level of resources and staffing are simply inadequate," he said.

Bruce McKenzie said that while the whole initiative would need to be rolled out over the next three to four years, immediate funding should be provided in this year's State Budget.

"We believe that our *Safer Travel Safer Stations* initiative will make a significant contribution towards making our public transport system safer and should be supported by both the Government and Opposition," said Bruce.

The unfortunate murder of a young man in broad daylight at a suburban railway station the day after this announcement only serves to reinforce our calls for a greater visible security presence at our train stations and transport system in general.

# Sergeant John McNally

# 16th October 1856, aged 30

The system of registered numbers for police hadn't been introduced when Sergeant John McNally was murdered on the Mt Ararat goldfields in 1856. He had joined the Victoria Police Force the previous year after service with the Royal Irish Constabulary.

On October 16, 1856 Sergeant McNally and Constable John Moore were told that

Whilst I have been humbled by your response, I have also been saddened by many of you who have also expressed your frustration with the lack of resources and the resultant stress you are facing with no William Turner, a wanted robber was staying in a tent in a camp about two miles away. Turner tried to flee but the police wrestled him to the ground. Turner call for help from his associate, William Twigham. Also known as Cockney Bill, Twigham came out of the tent armed with a double-barred shotgun. He fired, killing Sergeant McNally and wounding Constable Moore. Turner and Twigham escaped and a reward of £400 was offered for their arrest. They were arrested a week later at the Adelaide diggings after being recognised by a shopkeeper.

After a trial held at Castlemaine, Twigham was convicted of murder and sentenced to death. He was hanged at the Melbourne Gaol on March 11, 1857.

Turner pleaded guilty to the lesser charge of manslaughter and was sentenced to 15 years hard labour on the roads and other public works.

# Acting Sergeant Darren Brown

The Police Association Journal recently spent time chatting with the Northern Grampians Delegate Darren Brown about the job, the Association and life in general.

### Why and when did you join the job?

I joined the job in February 1990. I'd always wanted to be a police officer and my time was running out because of the age requirements in those days.

### What did you do before joining the job?

# Fingerprint Branch A time for sworn members to return?

ince the beginning of last century fingerprints have been the primary way of identifying people. It is still a faster and cheaper form of identification than DNA. Established in 1903, Victoria's Fingerprint Branch now has almost one million sets of prints on record.

Using the modern 'live-scan' technology members print a suspect or offender and those prints are sent straight to Canberra and checked against the national data base. If there is a match the experts at Victoria's Fingerprint Branch check the match and confirm it by a manual check. This can take as little as five minutes.

"We can give the information to the members while they still have the crook with them. It's all done in real time," says fingerprint expert and Association Delegate Sergeant Tom Brady. "It is a fine art. Some people just can't see fingerprints and can't do comparisons between prints found at crime scenes and prints on record."

The Fingerprint Branch is now an area only open to unsworn personnel. They arrive with a science degree and after five to six years on the job training they are considered experts in their field. The sworn members are an aging bunch with four of them over 60. Many believe it's time to open up the branch to sworn members again.

Tom Brady has been with the branch for 34 years and would like to see a return to the

days when sworn members could come to the branch. They would be able to build up their skills and still have the option of moving to other areas of the Force and returning to the branch. Tom Brady says members working on crime desks would be ideal candidates to work at the Fingerprint Branch. And their training to expert status probably wouldn't take the five years it currently takes.

They could develop the skills gained at the crime desks and then return to other workplaces with increased ability to collect prints at crime scenes and from suspects.

"This transportability would mean we would not lose experienced members to other organisations. The Department of Immigration is looking for fingerprint experts now."

Over the years hundreds of thousands of fingerprints have been recorded and stored. In March more than 5,900

sets of prints arrived at the branch and thousands were destroyed because of legislative requirements. "I destroyed 12,000 myself," says Tom.

The Fingerprint Branch is not just an area where you sit in front of a computer and examine prints. Members are required to identify bodies and there are times when have to use their ingenuity to get a good set of prints. Some of the more unusual efforts are held in a display case in the branch's St Kilda Road office.

"You can put the skin of the deceased's hand over your own hand, like a glove, to ensure you can get the prints clearly. We've had to print 135 bodies so far this year."

This more unusual area of the branch's work is now conducted at the morgue. The smell got a bit too much for other workers in the St Kilda Road building!

The branch also has its celebrity prints – Squizzy Taylor, Ronald Ryan, William O'Meally – they're all there. And there are the idiots' prints – like the burglar who photocopied his hands when he broke into an office. All the experts had to do was reverse the images on the photocopier and match them to the suspects record !

From birth to death, your fingerprints don't change. They are yours for life. And, according to Tom Brady, there is nothing better than the human eye to match a set of prints. "And the longer you're here the better your eyes get."

# The Wall to Wall Ride for Remembrance

Police union members from around the nation will head up a special memorial motorcycle ride from Melbourne and Sydney to Canberra this year.

> he inaugural Wall to Wall Ride for Remembrance will honour Australia's 700-plus police officers who have given their lives in the line of duty since 1803.

The Victorian riders will set out from the Police Memorial in Kings Domain on September 17. Police Association of New South Wales members will lead riders out of Sydney the next day to meet up with their Victorian counterparts on the outskirts of Canberra.

From there, Australian Federal Police motorcycle officers will escort the combined party of riders through the streets of Canberra to the National Police Memorial for a special commemorative service.

Association President Brian Rix, who chairs the ride committee in Victoria, says he welcomes police from other jurisdictions.

"We're encouraging our colleagues in South Australia, Tasmania and Western Australia

to come over and join us," he said. "We can then all ride from here in Melbourne and stop overnight in Merimbula.

"And, then, we'll ride over the top of the mountain to Canberra and meet up with everyone for the commemorative service. That will take place after we all ride around Parliament House and onto the National Police Memorial in Kings Park."

It is expected that friends and family members of fallen officers will join the ride. Others likely to take part in NSW, where Assistant Commissioner Mick Corboy heads up the ride committee, are Commissioner Andrew Scipione and former Commissioner Tony Lauer. It is hoped that Deputy Commissioner and Wall to Wall Ride to Remember patron Sir Ken Jones, a keen motorcycle rider, will also participate.

Organisers hope that the ride will not only serve as a tribute to fallen police but also raise awareness of motorcycle safety and promote Police Legacy. The longstanding charity will receive money raised through the event.

"Members in Victoria donate voluntarily out of their pay to Police Legacy. It supports children all the way through into university. Riders will be able to donate money to their respective states' police legacies."

The Victorian committee has mapped out a designated route from Melbourne through to Merimbula and onto Canberra.

"We will encourage people to follow that route, and a support vehicle will follow along behind," he said. "There will also be certain points to meet and ride out from in Merimbula and the outskirts of Canberra. but it will be at everyone's own pace."

The idea for the ride had come from a conversation Brian had had with Federal Labor MP Chris Haves (Werriwa, NSW). Mr Hayes and former federal Liberal Party leader Brendan Nelson had heard of and discussed the Ride for the Fallen, staged annually in Texas.

"It is a big motorcycle ride they have over there commemorating police officers who are killed on duty," Brian said. "So, from that grew the idea to ride from the memorials in Melbourne and Sydney and all meet up for a commemorative service at the memorial in Canberra."

The interest in the ride is already high. If you'd like to take part think about putting September 17 in the 'request book' soon.

Brian Rix and the other organisers hope the Wall to Wall Ride for Remembrance will grow and, ultimately, become an annual event.

The ride's webpage - www.walltowallride. com.au – will be up and running soon.

# Pre-nuptial agreements - do they protect me?

re-nuptial agreements, legally known as Financial Agreements provide an outlet for parties in a relationship to nominate their preferred method for the division of assets should their marriage or de facto relationship breakdown.

Binding Financial Agreements exclude the jurisdiction of the Family Court. As a contract, signed by each party, it explicitly expresses that the parties do not want the Family Court to make a decision regarding the division of their assets in the event of a separation.

Today sees an increasing number of couple's cohabitating prior to, or without the intention of, getting married. Increasingly people are bringing to relationships, marriage or de facto, a number of assets obtained independently of their partner such as property, money and superannuation. This complex set of circumstances may lead some parties to elect to enter into an Agreement with their partner, should the relationship disintegrate, to ensure they are no worse off financially at the conclusion of their relationship than they were when they entered into it.

People who potentially will benefit the most from entering into a Financial Agreement are:

- > People who are entering into their second marriage and wish to avoid the stress and cost associated with the potential breakdown of their second marriage and to provide for pre-existing children;
- > Couples employing asset protection. For example, a situation where a house is put in one parties name only, an Agreement can be filed acknowledging the other parties financial interest, regardless of the name listed on the property;

> People who seek to protect their interests in substantial assets and require a level of certainty.

It is important to ensure that the Agreement is carefully and accurately drafted, and that the parties approach entry into the Agreement with the full disclosure of all relevant details and circumstances.

Under the Family Law Act in order for a Financial Agreement to be binding it must meet the following criteria: > The Agreement must be signed by both parties;

> Each party must have received independent legal advice from a Legal Practitioner, prior to signing the Agreement. This must be acknowledged within the Agreement;

> The Agreement has not been set aside (declared invalid) by a Court; and

> After the Agreement is signed the original Agreement is given to one of the parties and a copy to the other.

A Binding Financial Agreement can only be terminated (during its operation) by the parties entering into another written Agreement, known as a Termination Agreement.

There are some circumstances in which a Binding Financial Agreement may be declared invalid and set aside. There is no guarantee that even though a party may have entered into a Binding Financial Agreement that this will be held to valid if it is challenged in the Family Court.

ersonal finances can be complex and sometimes the last thing you want to do after a hard week at work is to study the numbers. But doing some homework up front can save you a lot of money in the long run.

# **Credit cards**

With hundreds of credit cards on the market. each with particular features, you can easily get confused. 


