

4. VENUE AND FACILITIES

The venue includes a 25m diving pool, a 50m competition pool and a 50m warm-up pool, (all outdoors), and will be opened for competition and training during all the period.

Competition Pool (Field of Play)

The field of play for competition will contain a 30m by 25m area and a 3m-depth. The water temperature will be set in accordance with FINA Rules. The dimensions of start platform is, as follows: width= 26m, depth= 4 m, height= 1m.








Warm-up Pool

50m x 25m x 3m depth, it will be available for warming-up and training.



Diving Pool

30m x 25m, it will be available only for training.

ATHLETES FACILITIES

- 1. Physiotherapy and massage areas will be around the warm-up pool; please, note that Organising Committee will provide 10 physiotherapy beds to be shared among the competitors. They will be located at warm -up pool.
- 2. Landrill area;
- 3. The vanity area will be in the restrooms. Urns will be in place to provide hot water along with mirror space.
- 4. Ice Crushed will be available at the athlete preparation area.

6. ATHLETES UNDER 18 YEARS OLD

According to Brazilian Federal Law 8.069/14 (Child and Adolescent Statute), athletes up to the age of 18, must have the appropriate authorization form completed and provide proper documentation to be eligible to compete.

This authorization is obtained through a Mandatory Court Permit, which requires a special procedure. The procedure for minors participating in this Event requires the follow documents:

- Registration form, signed by the parent or legal guardian of the athlete, expressly containing the name of the person authorized to accompany and be entirely responsible for the minor during competition;
- 2. Copy of the ID or passport of the athlete that contains her photo and the name of her parents or legal guardian;
- 3. Copy of the ID or passport of the athletes' parent or legal guardian that signed the authorization form;
- 4. Copy of the passport or ID of the person indicated in the authorization form to be responsible for the athlete during the competition days;
- 5. Medical certificate;
- 6. Schooling statement;

The lack of documentation or proper procedure to obtain authorization of the minor may obligate the athlete to abandon the competition due to on-site inspection from Minor's Court authority or even cause the cancelation of the competition. When Rio 2016 is the responsible for the licensing and management of the competition, the lack of these documents will cause the athlete to become ineligible to compete.





7. MUSIC

Team managers/coaches are responsible for labelling 3 individual discs (CDs) for each routine as to speed, name of competitor and National Federation.

In order to accelerate the process of receiving the music prior of the start of practice sessions, each delegation can send the music for synchrotestevent@rio2016.com (It will be possible using we transfer for example).

IMPORTANT: The option to send the music by e-mail **do not eliminate** the necessity of to bring three (3) CDs as determined by FINA rule SS 15.3.

As part of the Brazil copyright regulations, please ensure the music submission form is fully completed and give it back in information desk on March 1st, after the Teams Leaders Meeting.

8. COMPETITION RULES

The FINA Olympic Games Synchronised Swimming Qualification Tournament 2016 will be held according to the rules of the FINA Handbook 2013-2017.

FINA assumes the responsibility for the technical control and direction of the event.

The FINA Technical Synchronised Swimming Committee is the management committee for the event and has the exclusive right to decide in all matters related to the conduct of the event and to nominate the technical officials.

The FINA Olympic Games Synchronised Swimming Qualification Tournament is the last qualification event to the Rio 2016 Olympic Games.

PROTESTS AND APPEARLS

Protests and appeals are possible and shall be resolved under FINA Rule GR 9.2 and GR 9.3.





COMPETITION FORMAT

The FINA Olympic Games Synchronised Swimming Qualification Tournament 2016 will comprise of two women's events.

TEAMS	DUETS
Technical Routine	Technical Routine
Free Routine	Free Routine (first round and second round)

TEAMS

Technical Routine: each team of eight competitors will perform the technical routine (SS 4.2)

Free Routine: each team of eight competitors will perform the free routine (SS 4.3) The total result will be the combined score of the technical routine (100 per cent) and the free routine (100 per cent).

Teams that finish in the first three (3) places will be qualified for Rio 2016 Olympic Games.

DUETS

Technical Routine: each duet will perform the technical routine (SS 4.2)

Free Routine first round: each duet will perform the free routine (SS 4.3)

The total result will be the combined score of the technical routine (100 per cent) and the free routine (100 per cent).

After the free routine first round, 20 duets will have qualified: duets with team (the eight (08) NOCs qualified for the team competition), continental championships (the best ranked NOCs in each of five Continental Championships), plus the next better duets in first round.

Free Routine second round: the duets, which placed 21-28 after the first round, will swim again the free routine. Duets that finish in the first four (4) places will be qualified for the Rio 2016 Olympic Games.





ROUTINE PANELS

Three panels of five judges will be used to judge each event. The FINA Technical Synchronised Swimming Committee will determine the composition of the panels .

Free routines:

1. panel one: execution

2. panel two artistic impression

3. panel three: difficulty

panel one: execution

9. TRAINING

PRE COMPETITION DAYS

Scheduled and opened training opportunities will be available at the Maria Lenk Aquatic Centre from 28th FEB to 1st MAR.

Two of the scheduled sessions will be with music, one session in the competition pool and the other in the warm-up pool (30mx25mx3m).

Training schedule will be sent to the lead team contact one week before arrival. The latest copy will be available at the hotel information desk.

COMPETITION DAYS

Competition Pool

Every day, after competition, the competition pool will be opened for training with music. The training will be organised according to the start list of the next day of competition.

Warm-up pool

Every day, after the competition, the warm-up pool will be opened for training with music. The training will be organised according to the start list of the next day of competition.

Diving pool

The diving pool will be available for training (without music) every day. In the competition days it will be closed 1 hour before the competition start. Please note that the diving pool will not be available for Synchronised Swimming training during the Olympic Games.





10. MEETINGS

Team Leader Meeting Venue: Press Conference Room at Maria Lenk Aquatic Centre

Date: March 1st, 10:00 (data checks from 9:30)

Teams Free routine will be drawn after Teams Technical routine competition, and the Duets Free Routine second round will be drawn after Teams competition finished.

Technical Officials Meeting Venue: Press Conference Room at Maria Lenk Aquatic Centre

Date: March 1st, 11:00 (data checks from 10:30)

11. OPENING CEREMONY

The opening Ceremony will take place on March 1st before Duets Technical Routine.

For each country the OC kindly request two athletes of the country to participate.

More details will be explained during Team Leaders Meeting.

The OC expects the athletes in their official federation tracksuits with appropriate footwear.

12. VICTORY CEREMONY

The Duets Victory Ceremony will take place on March 03rd after Duet Free Routine First Round event, and the Teams Victory Ceremony will take place on March 06th after Team Free Routines.





A medal chaperone will assist each medal-winning athlete in getting to the assembly area on time for their Victory Ceremony. Athletes are asked to respect the schedule runs as planned on time, and should attend all Victory Ceremonies in their official federation tracksuits with appropriate footwear.

Detailed information about athlete parades will be provided in the Team Leaders Meeting.

13. DOPING

Minimum of 12 (twelve) doping control tests will be made in accordance with the FINA Rules. All athletes may be subject to doping control sample collection and testing throughout the event in accordance with FINA Doping Control Rules. On completion of an event, an anti-doping representative will notify the athletes of their selection. If an athlete is selected for testing, a chaperone will escort the athlete up until the time when they report to provide a sample.

14. TRANSPORT

AIRPORT ARRIVALS/ DEPARTURES

For this event OC will provide arrival and departures services for all delegations, from February 27th to March 07th, at Tom Jobim International Airport (GIG) or Santos Dumont Airport (SDU).

In order to ensure an efficient service upon your arrival, it is essential that you provide flight details in your entries forms (GMS).

FINA delegates, officials and teams will be informed of their departure transport arrangement at least 12 hours prior to departure time.

LOCAL TRANSPORTATION

During the entire event, will be available a special transport (hotel-pool-hotel) for athletes, team officials, judges and FINA members.

19. MEDIA AND PRESS CONFERENCE

Athletes are kindly requested to exit poolside via the mixed zone after each session. More information on press conference arrangements will be provided in the Team Leaders Meeting.

20. MEDICAL SUPPORT

Lifeguards will operate at all times during training and competition.

First aid Field of play teams and Ambulance will be available during the entire event.
