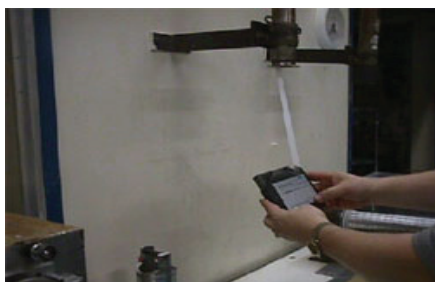

Removing old material from cartridge

Graham's recycling process extends to Graham Brand "new" cleaning cartridges by providing cleaning cartridges with recycled shells, containing new cleaning material to produce 3480/90, 3590, 9840 and 9840D Cleaning Cartridges.

Our process includes:

- Physical inspection of shells to assure mechanical pricess
- Remove old material from cartridges
- Clean inside and outside of empty shells
- Remove all previous labels
- Re-load new cleaning material into cleaned shells
- Apply new Graham Brand cleaning cartridge labels
- Re-inspect and package

Graham's Cleaning Cartridge Respool Program

In addition to providing "new" cleaning cartridges as stated above. Graham also offers a Cleaning Cartridge Respool Program. Just save your old cleaning cartridges and Graham will provide a postage paid, pre-addressed container to return them to Graham to be respooled. Not only does this service provide additional cost savings, it also promotes a positive environmental impact toward "Green" initiatives.
