and physical abuse, domestic violence, adult sexual assault, elder abuse, drunk driving and survivors of homicide, assault, robbery, theft and property crimes. Services to crime victims will be provided in the counties of Outagamie, Winnebago and Calumet, specifically in the cities of Appleton, Neenah, Menasha, Town of Menasha, Grand Chute, Kaukauna, Hortonville and Fox Valley Metro area, which includes Combined Locks, Kimberly and Little Chute.

La Crosse Police Department's Crime Victims Project (CVP) will provided immediate, on-call crisis response including information and referral services to crime victims and their family members in La Crosse County. Types of crime will primarily include domestic violence, sexual assault, elder abuse, violent/threatening personal crimes, and some property crimes.

The Child Victim Services Counselor (CVSC) will provide counseling and de-briefing for children with verbal skills (approximately ages 3 through 17) who have witnessed domestic violence as well as work with non-offending parents (of any age) in La Crosse County. The CVSC gets referrals from CVP, La Crosse County Child Protective Services, area mental health agencies, Family Court Commissioner, Family Resources Family Exchange Program, and from the La Crosse Police Department's Domestic Abuse Reduction Team (DART) and other law enforcement agencies.
