Hockey Australia formed in November 2000 and commenced operations on 1st January 2001 following the amalgamation of the Australian Hockey Association and Women's Hockey Australia and is a full member of the International Hockey Federation (FIH). It comprises membership of all eight States and Territories. Each State Association is comprised of regional associations, which are in turn made up of clubs. In some States, clubs affiliate directly with the State body.

Hockey Australia exists to provide Australians with the opportunity to play hockey from junior levels through to elite competition, including the Olympic Games. It is responsible for delivering these benefits to Australian hockey players through its Member States and ensuring hockey in Australia achieves consistent success, a strong and positive public profile and continuing player and spectator support at all levels.

PRESIDENT'S REPORT



There has been much to celebrate this year, both on and off the pitch. While the detail of those achievements is covered elsewhere in this report, there have been a number of successes and developments I

would like to draw attention to.

Following the Olympic Games Hockey Australia committed to Australia's Winning Edge. Led by John Wylie AM, Chair of the Australian Sports Commission, the program will move Australian sport from world class to world's best and will form a key pillar in our next strategic plan.

On the pitch, the Kookaburras' outstanding performances in front of a home crowd at the Champions Trophy will live long in the memory. A record fifth consecutive gold medal will almost certainly never be beaten.

Elsewhere, the Hockeyroos' return to the podium at the Champions Challenge and World League semi-final tournaments shows clearly that our women's team is continuing to make considerable progress on the world stage.

Our successful hosting of the second edition of the International Super Series in Perth and the Champions Trophy in Melbourne demonstrates that Australia continues to rank among the world's best hosts for international tournaments.

In recognition of the work undertaken in game development through the Hookin2Hockey and HockeyEd programs, Hockey Australia became the first organisation to win the prestigious Etienne Glichitch Medal. Presented by the International Hockey Federation (FIH), it is awarded for making a significant contribution to the growth and development of hockey.

The first year of a new major partnership with the Australian National Preventative Health Agency saw hockey rank highly among the 16 partner sports while a number of other significant commercial partners have extended their associations with Hockey Australia and our national teams.

The investment by Hockey Australia and the state/territory hockey associations in a new national database and competition management platform has already begun to prove beneficial.

Financially, a fourth consecutive year of operating profit has allowed us to continue to build our reserves and further improves the financial stability of the organisation.

In January, we welcomed Sandra Sully and Tracey Scott to the Board. Both have made excellent contributions in their first year and I look forward to continuing to work with them next year. I would like to express my appreciation to Danni Roche OAM, Stuart Carruthers and John Hall, all of whom left the Board this year, for their dedicated service to the sport and to their fellow Board members.

At international level Australia continues to be represented across a number of significant FIH committees. The hard work of our representatives is appreciated not just here at home but also globally as they dedicate their time and expertise for the good of the worldwide hockey family. My thanks go to Renita Garard OAM and Richard Aggiss whose time on the FIH Executive and Rules committees respectively came to an end this year. Thanks also to Ken Read and Don Davies for their continuing service and to Katrina Powell and Liam De Young, who joined the Rules and Athletes committees respectively.

I'd like to pay special thanks to Mark Anderson who left Hockey Australia in April after four and a half years as Chief Executive. During his time in hockey he oversaw the implementation of a new constitution and strategic plan, the introduction of new gold-level partnerships, the hosting of three successful Champions Trophy tournaments, the creation of the innovative Hockey 9s format and the strengthening of relationships with key government and state/territory partners. He presided over an unprecedented period of financial stability for the sport that has left us in a strong position for the future.

And thanks, too, must go to Greg Hill who guided the organisation as Interim Chief Executive following Mark's departure.

To him and the rest of the Hockey Australia staff, thank you for your unstinting professionalism this year.

I'd like to welcome Cam Vale as Hockey Australia's new Chief Executive from August 2013.

Cam brings a wide breadth of sports administration experience and knowledge to the role, having previously been the Interim Chief Executive Officer of the North Melbourne Football Club in the AFL.

I look forward to working collaboratively with Cam on the new 2014-2016 Strategic Plan for Hockey Australia.

Finally, and importantly, I would like to acknowledge my fellow Board members. The strength of our Board has been recognised by external partners. Each member of the Hockey Australia Board has contributed their expertise, their time and their passion to ensuring that the organisation and the sport can continue to achieve the successes it has this year and into the future.

CHIEF EXECUTIVE'S REPORT





It is my absolute pleasure to present this annual report on behalf of the Board and staff of Hockey Australia.

The 2012-13 financial year has been a fascinating one for our sport on the pitch, beginning with

the Olympic Games in London in August 2012. Whilst neither our men's team nor our women's team achieved their medal objectives, both teams performed admirably over the fortnight of Olympic competition. After a heart-breaking loss to Germany in the semi-finals, our Kookaburras responded strongly in their final game to bring home the bronze medal. Our Hockeyroos were unfortunate to miss the medal rounds on goal difference only, leading the tournament in the fewest goals conceded (two) and finished the event in fifth place, two spots better than their world ranking at the time.

The year ended with the FIH World League events in Rotterdam and London. For these events, both teams left Australia with three objectives – qualify for semi-finals and therefore World League Round 4; achieve a top-three result and qualify for the 2014 World Cup; and win the tournament. Despite falling in the final on a shoot-out to an improving Belgium, the Kookaburras ticked two boxes for the tournament and will advance to those marquee events in 2014. On this occasion however, the men's team was outdone by the women's team, with the Hockeyroos winning the tournament final against England.

Between those bookend international competitions, 2012-13 was another busy year for Hockey Australia, with a key focus on major events.

In November 2012, Hockey Australia hosted the second instalment of the International Super Series Hockey 9s tournament in Perth. While the attendance figures were lower than we would have hoped, the involvement of our Kookaburras and Hockeyroos as well as international teams from England, India, Pakistan and Malaysia, as well as, for the first time, our Jillaroos, meant that the onpitch action was the same high quality and exciting hockey as the 2011 event. Pleasingly, our Australian teams were able to achieve success in both the men's and women's events. I would like to thank our staff and the staff of Hockey WA as well as the group of volunteers for the delivery of another fun, world class tournament. I also need to acknowledge the ongoing support of our events partners, Tourism WA / Eventscorp, the Australian Sports Commission and ABC TV, without whom this event could not be possible.

In December 2012 Hockey Australia was privileged to host the 34th Men's Hockey Champions Trophy in Melbourne. On every metric this event was a success with impressive crowds throughout the week, enthralling hockey fixtures and an amazing "golden goal" overtime victory to our Kookaburras in the final match. This event generated a net economic benefit to Victoria of approximately \$7.0m and will become the benchmark for future international hockey tournaments within Australia. With thanks to our event partners, Victorian Major Events Company, City of Melbourne, the Australian Sports Commission and ABC-TV, Hockey Australia is very proud of the event that was delivered for the hockey public. I also need to thank the hard working volunteers and staff of Hockey Australia and Hockey Victoria who delivered this fantastic global event.

On a financial front, Hockey Australia is pleased to report an operating profit of \$129,854; our best operating result (excluding major events) since 2001-02. This is the fourth consecutive operating profit for our organisation and is a tribute to our staff and management team who have "owned the budget" throughout this financial year. These funds will be reserved for Hockey Australia future projects and will provide increased stability for our organisation for vears to come.

This year Hockey Australia in partnership with all of the state/territory hockey associations, embarked on a major technology project; changing database, competition management and website provider and forging a new partnership with IMG Sport Technology Group. Whilst the project has not been without challenges, our sport is starting to be rewarded with the fruits of our labour. After just over six months, our national database has 105,000 accurate records, allowing our sport to better understand our member

cohort, speak directly with our participants and in future, forge commercial partnerships that will benefit the entire sport in Australia.

In April 2013, Hockey Australia said farewell to long-serving Chief Executive Mark Anderson who accepted the CEO role with Swimming Australia. On behalf of the staff, I would like to thank Mark for his work with our organisation and in leading our team. I personally would like to thank Mark for his ongoing mentorship and am confident that it will stand me in good stead for the future. I wish Mark the very best of success in his new role.

I would also like to personally thank the Hockey Australia Board for allowing me to lead the organisation through the interim period. Whilst challenging, it has been thoroughly enjoyable and I am humbled by the faith that the Board have shown in me throughout this opportunity.

The 2013-14 year will be a challenging one both on and off the hockey pitch. On-field, the year begins with the third instalment of the International Super Series in Perth, followed by the Oceania Cup in Tarakanki, NZ. Both teams then begin preparation for crucial tests against the world's best at the FIH World League Finals in Argentina and India, and then commence their World Cup campaigns in the lead-up to the June 2014 event in the Netherlands. Off field, the implications of the Australia's Winning Edge funding program will need to be clarified and then the business managed accordingly. Key sponsorships with Fortescue, Ausdrill and ANPHA are all due to expire at the end of this year and a key focus for our organisation will be to retain our strong relationships with these Australian partners.

Hockey Australia's recent financial performances have the organisation well placed to face these future challenges. We will continue to work with our national hockey partners to strengthen and grow our game and look forward to future successes.

Our tenth placing in the medal table at the London Olympic Games continued a downward trend over the past three games.

Through Australia's Winning Edge 2012-2022, our game plan to move Australian sport from world class to world best, we are changing the role of the Australian Institute of Sport (AIS) and the delivery of the high performance program, improving the financial performance and position of national sporting organisations (NSOs) and strengthening the governance structures and standards of NSOs.

We have initiated a fundamental reform process to improve Australian sport, by linking high performance sports funding more closely with performance; ensuring the AIS is the world's best high performance sports institute; modernising governance structures in a number of sports; investing to improve coaching, leadership skills, talent identification and innovation in Australian sport; and reinforcing public confidence in the integrity of sport. These reforms will create lasting change and improvement.

In 2013-14, the Australian Government, through the ASC, is investing almost \$120 million in national sporting organisations for high performance programs and to promote grassroots participation in sport.

Our partner sports can expect a much sharper focus by the ASC in future on best practice governance and administration, intellectual property ownership, athlete management and support structures and general accountabilities by the sports. Equally, the ASC is committed to changing to meet the

needs of contemporary sport. Importantly, the ASC is focused on promoting community sport participation has a profound long term dividend, and remains a vital objective of the ASC.

The ASC looks forward to working in collaboration with the sport sector to encourage more people into sport and to drive Australia's continued international sporting success.

HIGH PERFORMANCE DIRECTOR'S REPORT X



Hockey Australia's (HA) high performance (HP) system and national programs have and will continue to experience significant change and challenge as HA responds to the ASC strategic direction 'Australia's Winning Edge (AWE) 2012 – 2022'. Key aspects to this include a restructure of the AIS to focus on strategy and investment, rather than program delivery, new National Sports Organisations (NSO) funding principles, greater levels of accountability for results and an increased emphasis on evidence based monitoring.

Over the last year HA has positioned itself well to both respond to the AWE strategy and to maximise opportunities that will arise from this shift in direction. While the operations of the HP Unit are transitioning to be fully managed and financially underwritten by HA, program activity remains much the same, with national programs focusing on international success and running centralised camps based programs out of Perth.

These programs continue to be underpinned by the National Training Centre (NTC) network, hosted through the State Institutes and Academies of Sport (SIS/SAS), with their primary focus being sustainable international success. Through the eight centres and 12 NTC coaches, over the last year HA supported approximately 180 nationally and state identified athletes in their home environment.

COACHING

National and NTC coaches were provided with high quality opportunities for acquiring experience and on-going professional development.

National Assistant coach Graham Reid 'head coached' the Kookaburras to a gold medal at the 2012 Champions Trophy

ACTAS coach Ben Bishop participated in the AIS Olympic Games study tour, joining coaches from across a range of Olympic sports

Junior Men's coach Paul Gaudoin and NSWIS coaches Larry McIntosh and Katrina Powell attended international drag flicking camps in the Netherlands, working with world renowned coach Toon Siepman

WAIS and SASI coaches Chris O'Reilly and Tim White led a men's development tour to China gaining invaluable international coaching experience

Three National and NTC coaches were supported by HA to complete the NCAS Advanced Coach Course and to attend the 2012 Champions Trophy in Melbourne

COMPETITION

• HA continues to balance International and national domestic competition with a range of targeted opportunities for national development, junior and futures athletes.

Highlights:

Australia A programs for National Development Squad athletes continued around senior international events across 2012 and 2013

The Jillaroos competed in the 2012 International Super Series in Perth gaining a unique and valuable experience

Australian teams won the 2013 Youth Olympic Games Festival hockey events in Sydney

National U21 teams, the Burras and Jillaroos, qualified for the 2013 Junior World Cups winning Oceania qualifying events

The Junior men's team toured Europe playing test matches against Germany, Belgium and the Netherlands

RESEARCH AND INNOVATION

HA has increased its commitment to proactively driving research and innovation and is currently supporting a number of targeted projects including an ACL Knee Research project (UWA/HA), Comparative Performance Analysis PHD (PHD Student/CU/ HA) and Enhanced Real Time Performance analysis project (HA/AIS).

HA acknowledge the generous support of the SIS/SAS network, state associations and respective State Governments in their continued investment into our high performance system. These partnerships are critical to HA continuing to provide strong pathways and high quality programs for athletes to progress into the national and international arena.

MEN'S HIGH PERFORMANCE PROGRAM REPORT



The Olympic Games saw the Kookaburras fail to finish at the top of the podium for the first time in four years when they fell short against Germany in the semi final after leading with 16 minutes to play. They rebounded to secure the bronze two days later but the disappointment with a medal performance was palpable in the group. Three months later they secured their fifth straight Champions Trophy in an extra time thriller against Netherlands in the final. Five in a row is unlikely to ever be repeated in this competition.

Again the Kookaburras secured an International Super Series Hockey 9s victory in Perth in November and during January and February many Kookaburras competed

in the inaugural Hockey India league while seven players returned to the Netherlands to play in that league. In April, a young team with five debutants again secured the Azlan Shah trophy beating Malaysia in a tight and thrilling final before a sell-out crowd. A few weeks later a further five players made their debuts against Korea in a series in Perth where the Kookaburras were again undefeated

In May and June the team made their way to Europe for the World League Semi-Finals with three aims...to qualify for the 2014 World Cup, qualify for the World League Finals in India and to win the tournament. Over the three weeks the Kookaburras played nine matches with one loss. Unfortunately,

we finished level in the final against Belgium only to lose in a sudden death shootout. Earlier the Kookaburras ensured World Cup and World League Final appearances.

Also during the period, a number of Kookaburras embarked on penalty corner training in the Netherlands accompanied by Luke Doerner, while a development team visited China in June where test matches were played against provincial teams.

WOMEN'S HIGH PERFORMANCE PROGRAM REPORT



2012-13 was a challenging year for the Hockeyroos, but one that demonstrated considerable progress.

COMPETITIONS

Our Olympic Games performance was the culmination of an 18 month preparation phase which exposed 43 athletes in 68 matches. After finishing equal top on points in our pool, we missed the semi finals on goal difference. In defeating China we finished a credible fifth position, two places higher than our world ranking at the time. This result marked the beginning of a promising year for the Hockeyroos.

After a short break and a number of retirements (Hope Munro, Megan Rivers and Jacklyn McRae) a new look Hockeyroos team competed in the Champions Challenge in Dublin. The Hockeyroos displayed their dominance throughout, completing the tournament undefeated, scoring a tournament high 26 goals and conceding a tournament low of four.

This performance was then backed up with an emphatic victory at the World League Semi Finals in London with a 3-0 win over England. Once again, the Hockeryroos finished with a tournament high 'goals for', whilst conceding the fewest of any team. This victory ensured qualification into the 2013 World League Finals in Argentina and 2014 World Cup.

JUNIOR WORLD CUP PREPARATION

The completion of the Olympic cycle in 2012 saw the appointment of ex Olympian and South Australia Sports Institute Head Coach, Craig Victory as the new National Junior Coach. With Craig driving this program, the Jillaroos have had an extensive competition and camps program which included games prior to Australian Youth Olympic Games and Oceania Qualifier tournaments, along with games against Australia 'A' and a tour to Japan.

THE DAILY TRAINING ENVIRONMENT

After a comprehensive review of our Olympic preparation and performance, several new initiatives were introduced into the daily training environment to ensure athletes are prepared to 'Worlds Best' standards. A more extensive program of team training individualised small group work and increased physical load has been achieved through increased access to athletes through the week and by training during the middle of the day.

Supporting this programming change, the Women's High Performance Program (WHPP) have also documented the physical performance benchmarks desired by athletes along with minimum standards now required for national senior team selection. A culture of personal best performances has quickly evolved which has seen considerable physical progress continue to be achieved.

KEY STAFF APPOINTMENTS

In addition to Craig Victory, the beginning of 2013 also saw the appointment of other key staff members.

With goalkeeping being of critical importance, Mark Hickman was appointed as an Assistant National Coach in the combined role of Goalkeeping and Resources and whilst it was disappointing that Matt Burgin (psychologist) was unable to continue to work with the program, Darren Everett now holds this role after having worked with the National Junior Program. Darren has already had a significant impact in building on the high performance culture we have been developing since 2011.

PLAYER MILESTONES

Of the 33 athletes who have represented the Hockeyroos in the last year, we had six play their first game (Edwina Bone, Jane Claxton, Karri McMahon, Kirstin Johnson, Brooke

Peris and Mariah Williams) and a number reach significant milestones (Madonna Blyth – 250, Megan Rivers – 200, Casey Eastham – 150, Ashleigh Nelson and Georgia Nanscawen - 100).

SUPPORT

The High Performance Program would not be possible without the generous support of the ASC, AIS, State Sporting Organisations and the various financial and support services provide through the NTC Programs. We would like to thank all of these key stakeholders for their ongoing support. In addition we would like to thank our sponsor, Ausdrill for their unwavering support over the last two years.

THE FUTURE

Continued work on building depth, improving our physicality and increasing our skill base will remain a focus in the coming 12 months and with the support and persistence from our key stakeholders, we plan to continue our recent progress and to take another step towards becoming World's Best, again.

COMMERCIAL REPORT 🔀

SPONSORSHIP & GRANTS

The 2012-13 financial year was Hockey Australia's busiest and most successful year for some considerable time.

While servicing two new major partners (Fortescue Metals Group & Ausdrill) in their first 12 months with the organisation, we renewed both national teams' apparel sponsors (Kukri & ASICS) and one other (Atteris).

Kukri have re-signed for a further four years with an increase in the cash component and a considerable increase in contra apparel. ASICS also re-signed for four years, this time with a cash component attached to the sponsorship and an increase to the medal incentive bonus and apparel contra. Further to this, both Kukri and ASICS are now partners of the two national junior teams (Jillaroos & Burras) as their Official Apparel sponsor for the next four years.

Australian National Preventive Health Agency (ANPHA) finished their first year as a major partner of the organisation with all benefits and reporting completed for 2012-13. The feedback received from ANPHA is that out of the 16 sports they deal with, Hockey Australia is ranked very highly.

A second year of Government funding for Women in Sport has allowed the organisation to increase the level of photography, media and online match streaming to continue to build the profile of the Hockeyroos and our marquee players.

COMMUNICATIONS

WEBSITE

The single largest development in communications this year was the redevelopment of the Hockey Australia website. IMG-STG developed the new site, providing the organisation and the sport with a more dynamic 'shop window' with which to promote hockey, the Kookaburras and Hockeyroos and the work of Hockey Australia. The new site framework allows for better functionality and flexibility in displaying information, with a focus on making information easier to find and more attractive to site users.

TOURNAMENT COMMUNICATIONS

Continuing the work started in the previous year, a strong emphasis was placed on generating engaging, interesting and informative content with the Hockeyroos and Kookaburras around major tournaments. That content was used as the basis of Hockey

Australia's coverage of the national teams at major events on digital and social media channels. This year, this approach included video interviews and diaries, written blog posts and the employment of a number of freelance communications assistants to join the teams at the World League competitions in Europe. This allowed Hockey Australia to generate fresh content on a regular basis on the ground. As ever, match reports were written up and distributed to the media along with relevant photography within an hour of the Kookaburras and Hockeyroos' matches finishing. Every capped match was also covered live on Twitter and Facebook.

LIVE STREAMING & BROADCAST

The ongoing partnership with the Australian Broadcast Corportaion (ABC) continued in the back half of 2012 with live broadcast of the International Super Series Hockey 9s and Men's Hockey Champions Trophy Melbourne 2012.

The Hockey 9s was broadcast on delay for the Thursday and Friday and shown live nationally on Saturday and Sunday but broadcast numbers were disappointing across the four days. In contrast, the Champions Trophy was a huge success, smashing previous broadcast figures.

Cumulative audience figures across the ABC and Fox Sports networks reached 1,421,700 in comparison to 533,000 for the same event in 2009. The Champions Trophy was broadcast into approximately 30 countries. The Americas, Asia Pacific and Europe over a total of 356 programs, with a cumulative audience of 25,553,000 viewers.

Eight matches against Korea were live streamed from Perth via the Hockey Australia website in March and April. It was considered a worthwhile experiment but in review, the reach and audience penetration achieved by streaming non-tournament matches was deemed fairly low and future consideration will be given to the higher impact afforded by television broadcast, albeit with the acknowledgement that this would likely result in the need to show fewer matches due to cost implications.

Australia ranked favourably in viewership for the live online streaming by the International Hockey Federation of the men's and women's World League Semi-Finals in June and July with matches also shown live and on delay on Foxtel.

DIGITAL& SOCIAL MEDIA

This year saw an increased emphasis on engaging with followers and participants through social media channels and a focus on providing content and dialogue appropriate for each platform. All of Hockey Australia's primary social media channels saw excellent growth. All three Facebook pages (Hockey Australia, Kookaburras and Hockeyroos) saw growth in the region of 60-80% while the three Twitter accounts all saw followers more than double. Increasing the frequency of new video content available on the Hockey Australia YouTube channel and an undertaking to produce more content with the Kookaburras and Hockeyroos squads led to more than 400,000 views of videos on the channel in the past 12 months, accounting for 43% of all views since the channel was launched in 2010. The most popular new content of the year was the slow motion hockey video filmed at the Champions Trophy, which was watched more than 19.000 times.

The implementation of the membership database in conjunction with IMG-STG enabled Hockey Australia to relaunch its e-newsletter directly to registered participants across the country. It marked the first time that Hockey Australia has had the ability to communicate in a targeted fashion on a one-to-one basis with such an accurate database of participants and resulted in open and engagement rates significantly above those of traditional eDMs, measuring between 30-40%.

MEDIA

Hockey Australia continued to engage with mainstream media on a regular basis, fulfilling media requests and placing heaviest focus on media engagement in the build-up to major tournaments including the International Super Series Hockey 9s, Champions Trophy, Hockey India League, World League and Junior World Cup. Athletes and coaches were put up for interview, including a media conference call with Kookaburras Head Coach Ric Charlesworth prior to the World League. This format was well received by the media and will be utilised again for future events.

GAME DEVELOPMENT REPORT X





The Game Development (GD) department is pleased to report on its activities for the 2012-13 year.

The year saw a consolidation of new programs as well as growth and new initiatives that will further assist in growing the game. All development programs look to recruit or retain players and officials in a manner that is sustainable to all. The environment we all work in to undertake the recruitment and retainment has never been so crowded and competitive and we must continue to evolve to ensure further growth.

More than \$350,000 was allocated from Hockey Australia to state hockey associations to assist with the recruitment and education of players and officials. Along with outstanding work from these state bodies as well as volunteers in clubs and associations across the country, hockey was once again able to grow its numbers. It is very pleasing to report that 18,500 new players between 5- 12 years of age joined and played hockey for the first time this year. These new players along with the formal education of 2,600 coaches and officials, were highlights of the year and will ensure that the game continues to thrive.

Of the 18,500 new players just under 10,000 joined hockey clubs and associations from the national grass roots program Hookin2Hockey. The revamped Hookin2Hockey program is only in its fourth year but already it is having a major impact on numbers with the brand gaining traction in the competitive market place that is junior sport. Clubs and associations have greatly

assisted this by providing outstanding junior programs in family friendly environments.

During the year, the GD department of Hockey Australia was very proud and excited to be awarded the prestigious Etienne Glichitch medal by the FIH at the World Hockey Congress. The Glichitch medal is awarded to a person or federation that has made a significant contribution to the growth and development of hockey at local, national or international level. It has previously only been awarded three times (to individuals) and Hockey Australia is the first National Association to win. Hookin2Hockey and HockeyEd were specifically mentioned by the FIH as innovative programs that have greatly assisted in driving more young players into the sport as well as educating coaches and officials.

Only 18 months ago we recognized that hockey was extremely under resources in the coaching and officiating areas. In a short period of time we have gone a long way to rectifying this with manuals, websites, apps, twitter accounts, YouTube account, DVDs and CDs all being produced to assist the ongoing education of these key people in our game. We were particularly proud during the year of producing an advanced hockey app for iPhone and iPad that, for almost no cost to the user, replicates software programs that cost many thousands of dollars. In a further exciting project we are funding two pHD students for the next four years who will be undertaking major research in game modifications and observational learning with the results from these studies to greatly assist development decision making in the

It was an exciting year with the Champions

Trophy being hosted in Melbourne. The GD department was heavily involved in kid's activities as well as professional development activities for coaches and officials. Seminars, meetings, conferences and courses were all conducted with excellent attendance across the board. We had outstanding feedback from all activities but especially in relation to our live twitter feed from expert coaches during the finals which was very innovative and informative.

No Australian sport conducts more national and international championships than hockey, with over 35 events across the year. All of these events have rules, procedures, umpires, technical officials, judges and tournament directors. The standard of all of these was once again world class. We would like to sincerely thank all who were involved in these tournaments that are not only enjoyable for all participants but that go towards creating a pathway that ensures that Australia continues as a world hockey power in all areas.

2012-13 has seen some tremendous results in development but it has also highlighted the continued need to evaluate and evolve. With limited resources the development department has continued to implement proven programs while at the same time develop new initiatives to continue to grow the game. As exciting as the year was, the next year will be even better.

EVENTS & TOURNAMENTS

The Olympic Games London 2012, International Super Series Hockey 9s and the Men's Hockey Champions Trophy Melbourne 2012 made for an exciting six months in Hockey Australia's event calendar.

OLYMPIC GAMES, LONDON 2012 - 27 JULY-12 AUGUST

The Olympic Games was the first major event of the period and delivered a second consecutive bronze medal for the Australian men's hockey team and a fifth place for the Australian women's hockey team.

The Kookaburras went into the Games as favourites in the men's competition and began the tournament strongly with comfortable victories over South Africa and Spain in the first two matches. Jamie Dwyer opened his third Olympic Games with a hattrick against South Africa.

Two draws followed against Argentina and Great Britain, but then Ric Charlesworth got his men back on the right path with a seven-nil drubbing of Pakistan in the final pool match.

Kieran Govers and Glenn Turner scored in the first 42 minutes of the semi-final to give the Australian's a 2-1 lead in the clash against Germany. The final 16 minutes of the match

were shattering for Australia, conceding three goals and going down 4-2, and missing out on the chance to play in the Olympic final.

A 3-1 victory against Great Britain in the bronze medal match secured the Australian men's hockey team a second consecutive bronze and a sixth consecutive Olympic medal.

The Australian women's hockey team only lost one match for the tournament and finished an impressive fifth.

An opening round loss to New Zealand meant the Australians missed out on a top two spot in their pool by goal difference and played off in the 5-6th play-off match against China.

Wins against Germany, USA and South Africa and a brave final round draw against eventual silver medallists Argentina, were the highlights of the tournament for the young group.

INTERNATIONAL SUPER SERIES **HOCKEY 9S, PERTH 22-25 NOVEMBER 2012**

The second edition of the International Super Series was once again played at the Perth Hockey Stadium in Western Australia. Arranging teams for the event proved difficult due to the financial implications of the London Olympics and Champions Trophy. The men's competition saw the Kookaburras take on Hockey 9s debutants England and regulars India and Pakistan. In the women's competition, the Hockeyroos faced Malaysia and the Australian U21 team, the Jillaroos,

The event was broadcast domestically by the ABC. Crowd attendance was significantly less than the previous years, as were broadcast figures in Australia.

The Kookaburras and Hockeyroos defended their titles and were crowned Hockey 9s champions for the second year in a row.

MEN'S HOCKEY CHAMPIONS TROPHY MELBOURNE 2012 1-9 DECEMBER 2012

The Kookaburras were out to make amends for their bronze medal in London by looking to continue their amazing Champions Trophy record, and secure their fifth consecutive Champions Trophy. The Kookaburras looked strong throughout the event that saw them play in a thrilling gold medal match against the Dutch in which they won in 'Golden Goal' extra time with a strike by Kieran Govers. Kieran Govers and Jamie Dwyer again top scored for Australia with three apiece.

In the last 12 months, we've made tremendous progress in the areas of competitions, indoor and officiating. There is much more work to be done but the activities by those directly involved have been greatly appreciated and have already resulted in many positive outcomes. The rejuvenated approach in all areas is extremely encouraging as we strive to ensure our actions and outcomes are geared towards the betterment of hockey in Australia.

INDOOR CHAMPIONSHIPS 💢



The Indoor Advisory Committee was formed in 2012 and first met via Teleconference on 6th September with subsequent meetings held 15/11/12, 10/1/13 (at Open Nationals in Canberra), 12/3/13 and 25/7/13. Additional meetings have been held between Lyn Hill (chair of Committee) and the Australian Coaches at the Nationals to provide more feedback to the Committee on their plans for National Squads and tours.

The 2012-13 season trialled the change to four day tournaments running back-to-back with Open/Under 21s in Canberra and Under 18/Under 15 in Launceston. Dates were –

Hockey ACT also hosted a very successful Under 13 invitational tournament on the Australia Day weekend with seven boys and seven girls teams attending from ACT, NSW, VIC and QLD. NSW were successful in both

Train-on squads for men and women were selected at the Open Championships and available players trained for three days (during the Under 21s) and stayed at the AIS as a squad.

Feedback from these tournaments was extremely positive in regard to the structure change with teams playing two games per day. Less time away from home is a bonus for leave and the ability to utilise players as coaches/managers in the back to back tournaments also received positive feedback.

Dates have been set for the 2013-14 season as follows -

The Open Indoor Nationals will be held in NSW in January 2014. The Under 21 Nationals will follow shortly after in NSW as well.

Under 15 Championships 12 – 15th January and Under 18s 17th - 20th January/21st January, 2014 – Venue – Kedron State High School, Brisbane, Queensland.

On the international scene, the FIH announced rule changes from 1st September 2013 which will include a reduction to the number of on-field players from six to five as well as the "own goal" not being played in indoor hockey. These changes will be played at all National Championships in 2013-14.

With the Indoor World Cup set for early 2015, it is an exciting time for indoor players with the opportunity to represent their country at a World Cup Event.

The Australian men are currently preparing for their European tour in January under the guidance of Anthony Potter (Coach), Brent Deans (Manager), and John Hooper (Assistant Coach/Video Technician).

The Australian women are also working towards a European tour in January 2014 and an Asian visit in October under the guidance of Stewart Fenton (Coach), Karen Seaman (Manager/Assistant Coach), John Trueman (Assistant Coach/Video Technician) and Alex Lupton (Assistant Coach).

All of our coaching and management team have been working hard behind the scenes to provide cost effective and worthwhile opportunities for both the Australian men's and women's squads.

AUSTRALIAN MASTERS COUNCIL



This year has been an exciting one for masters hockey with a number of significant achievements being realised.

Masters hockey has been given the recognition it deserves by FIH. The President's ambition to include masters hockey as one organisation under the umbrella of the FIH was articulated during his presentation at the last Congress held in November 2012 in Kuala Lumpur. The vision of FIH is to have a totally inclusive sport for everyone from 5 to 75+ including parahockey. It has been recognised that masters hockey events worldwide are growing and offered potential links with the FIH Foundation for the development of the sport.

In June 2013, the FIH agreed to set up a "Masters Panel", to be chaired by a member of FIH Executive Board with representation of the international masters organisations (International Masters Hockey Association and World Grand Masters Hockey Association) and two members of FIH staff.

The inaugural Masters World Cup was held in Canterbury, England in August 2012 where Australia fielded both men's and women's teams. The Australian contingent was very successful winning gold in the men's over 55s age group and silver in the women's 40s and 50s age groups. Australian Master's expertise is well recognised around the world with Robyn Bannerman and Peri

Buckley fulfilling key roles during this event as Umpires Manager and Judge/Technical Officer respectively.

At the same time, a Grand Masters World Cup was organised in Oxford, England where our Australian Over 60s, 65s and 70s competed. Australia won gold in the 70s and silver in the 60s, while the 65s lost the bronze medal game in a shoot out.

New Zealand was the host for the 2013
Trans Tasman Masters Challenge. A ten
team contingent travelled to Auckland and
competed in atrocious weather conditions.
Australian teams were successful in seven
out of the ten age groups winning the
coveted trophy. During this event a trial of
over 60s women's competition was held
with successful negotiations resulting in
this age group being included in the next
Trans Tasman to be held in Australia in 2015.
Australia was successful in the women's over
60s age group as well.

The HA Masters Council continues to work with the Oceania Hockey Federation to support the development of hockey in this region. The development program includes teams travelling to places such as Fiji to provide much needed competition, development of umpires and technical officers and provision of funding or donations of equipment.

The Masters Council continues to enjoy a collaborative approach to the national program with successful joint initiatives and events. Masters hockey has agreed to adopt the HA logo exclusively for all future uniform and other apparel. To be seen at international events as one unified contingent representing Australia is very important to the Council.

Both committees have organised Australian Championships catering for all their age groups with the over 35s for men steadily growing in interest and participation. Just Hockey continues to be an active supporter of Masters hockey throughout Australia.

The Masters Council values the support provided by HA staff and committees. We continue to work together for the growth and improvement of our sport.

It has been another very active year for Hockey Australia's 'Country' section. In what has become an important and permanent part of the HA Country schedule, the HA Country U21 teams once again represented Australia at the Oceania Pacific Cup in Fiji during December 2012.

In a very close competition, the women finished with a silver medal whilst the men, for the first time came home with the gold medal after defeating hosts Fiji in a game fitting of a final.

The senior teams toured to Singapore followed by a week in Hong Kong. The Singapore leg of the tour clashed with an international junior competition that meant games against the national sides were cancelled, however the local clubs, including expat teams provided worthwhile competition. Following the Singapore leg of the tour the teams moved on to Hong Kong and were treated to fantastic hospitality and competition from our hosts. The 'tests' against the national teams were a treat and honours were shared evenly.

Hockey Victoria hosted a successful 2012 Australian Country Championships in

Bendigo. At the conclusion of a week's competition, highlighted by top quality hockey and close competition, NSW women took home the gold medal and WA proved too strong for NSW in the men's final.

Moving forward, we still await commitment for teams being fielded in future Australian Country Championships by those states and territories not traditionally represented.

HIGH PERFORMANCE ACHIEVEMENTS

Oceania Hockey Federation congratulates Hockey Australia and their national teams on their performances throughout 2012-13, especially as both teams qualified for the FIH World Cups in 2014. The Kookaburras dominance at the Men's Champions Trophy, taking their fifth consecutive title, is a significant achievement while the Hockeyroos achieved success in winning the FIH World League semi-final in England. At the 2013 Oceania Junior Nations Cup qualifiers held in the Gold Coast in February Australia was successful in taking both titles. A big thank you to local hockey communities and clubs in the Gold Coast and in northern NSW who provided billets, specialist coaching and practice match opportunities for Papua New Guinea and Vanuatu players and management.

HOCKEY AUSTRALIA BOARD AND STAFF

The relationship between the Oceania Federation Executive, Hockey Australia Board and Mark Anderson, former Chief Executive of Hockey Australia has been extremely positive. Hockey Australia board member, Norman Same, was elected to the Oceania Federation Executive in February and this has enhanced communication further. This year saw a continuation of regular consultations, resulting in even greater sharing of resources and a real recognition of the specific needs of the developing island hockey members.

AUSTRALIA COUNTRY U21 MEN AND WOMEN

Australia Country Men and Women have represented Hockey Australia at Oceania Pacific Cup Tournament in Fiji since it started in 2008. Congratulations to the Australia Country U21 men, who won the 2012 title for the very first time, while the women took the silver medal in a close tussle with Fiji. It was the first time that Fiji women had won the title and reflects the contribution that Australia Country teams have made in helping to lift the level of performance of the Pacific Island teams. Oceania Hockey Federation acknowledges the contribution and organisation of Australian Country

Chef de Mission, Michael Nelson. Each year, umpires have come with the teams and this has been very positive in helping to develop local officials. The 2012 umpires were Rhiannon Murrie, Chris Mutton and James Stewart. The donated equipment that Australian country players bring to share with island participants is greatly appreciated.

OHF OFFICIATING AND COMPETITION COMMITTEES

Oceania Hockey Federation added a competition committee to its structure in 2013, after starting an officiating committee in 2011. With more competitions occurring on the Oceania calendar these two committees complement each other and there has been significant strategic discussion over the venues, appointments of officials, types of competitions and new formats of competition that will help to encourage participation in hockey, especially in the Pacific Islands. Thanks to David Peebles for accepting the position as Chairman of the Competition Committee and the work achieved in its inaugural year.

AUSTRALIA HOCKEY MASTERS

The organisation has made a significant contribution to the development of Pacific Islands Hockey, over the past year. Regular communication has developed with the Oceania Executive re events, development tours to Fiji and ways in which Masters groups can help grow the sport. Vanuatu was incredibly grateful to the Australia Masters men who contributed funds to supply their two teams - who were participating in their first FIH event in Fiji in December 2012 - with mouth guards, shinguards and shoes. Australia Masters women have kept Oceania briefed on their plans for 2013-14 and donated a large amount of equipment during their trip to Fiji in 2012. This type of support is magnificent and Oceania Hockey Federation acknowledges the positive involvement.

An example of the influence of the recommendations of the Rules Board is the most outstanding recent change to our game - the introduction of the self-pass. Richard has been strong and determined in his representation of Australia while on the Rules Board. Richard is far from lost to the game as his recent publication on the history of hockey shows.

Renita Garard's time on the FIH Executive committee came to an end following this year's election.

Renita was a highly valued member of the Executive Board of FIH. Such was her standing with the Executive Board that from the President down they all expressed complete surprise with the result. There is no doubt that Renita will be greatly missed. Not only has the Executive Board lost its last Australian member but it has lost a dual gold medallist and a lady whose training placed her well to audit income and expenditure during a time of important strategic change. Renita has a broad grasp on the issues that confront our game at all levels. She will be greatly missed from the Executive Board.

Liam de Young joined the Athletes Commission and Katrina Powell the Rules Committee. We wish them both all the best and hope for long contributions. It is only after much time that one gains the type of traction and international respect that Richard and Renita had.

The Chief Executive forum is now an integral part of the FIH. It provides our Chief Executive with access to the FIH staff and to the thinking of other Chief Executives. It is an open and inclusive body to which Australia must commit the resources to enable its Chief Executive to attend. Without committing resources to this forum Hockey Australia will not be a player in the international scene that properly influences decision making at the highest level.

On the playing field, Australia has fared well securing a bronze at the Olympics for our men, with the women claiming fifth. Given the result of the Hockevroos in London. it seems that we are now back amongst the world's best.

HOCKEY ACT







Hockey ACT, like many state sporting organisations, works hard to ensure the sport grows and remains an option for new participants in a tight competitive sporting market. With the new strategic plan in place, much of Hockey ACT operations and direction was committed toward participation growth and improving retention outcomes.

With the growth and relevance of the sport very much front of mind, Hockey ACT also used the 2012-13 period for establishing a self-sustaining facilities usage model. Self-sustaining facilities would ensure the burden of owning and maintaining the more than \$20 million worth of facilities doesn't fall on the hockey playing members. Ensuring the sport is affordable and accessible has become an important part of the current and future planning.

FACILITIES

The sustainability of Hockey ACT-owned facilities remains an ongoing focus for past, present and future Hockey ACT boards. Hockey ACT in many ways is not unique as a state sporting organisation. It is unique in the ACT however as it owns, operates and manages significant sporting facilities which have been established over more than twenty years. With five artificial outdoor playing surfaces, an indoor hockey facility and two separate club house facilities across two sites, the ongoing ownership and upkeep becomes both a threat and an opportunity for the sport in the ACT.

In 2013 Hockey ACT began a program to identify and explore new opportunities to grow revenue streams, particularly where gaps in the current usage of Hockey ACT facilities existed. With office space made available for new tenants, and recreational and commercial sport delivery opportunities to be developed, the long term hope is to create a self-sustaining facilities model,

which reduces/removes the cost burden from the sport of hockey, while creating new ways to promote the sport within the ACT.

HOCKEY PROGRAMS

With a focus on increased participation and improved retention, Hockey ACT embarked on a range of new hockey delivery programs. In 2012 -13, Hockey ACT established the School Ambassador program, with key staff identified within the school network, who would act as a conduit between the sport and school children and who would serve to assist with recruitment of new hockey participants.

The retention of new members was also an important focus and Hockey ACT changed the junior hockey programs to recognise the various entry points into the sport and to provide all participants an opportunity to experience and enjoy the full hockey experience. By defining the competition purpose, modifying junior competitions, removing the need for finals or premiers, and a more inclusive accepting competition model, Hockey ACT is offering rewarding sporting experiences for all participants

NATIONAL CHAMPIONSHIP HOSTING

The profile of hockey within the ACT remains very important. To host national competition and showcase the best athletes of each gender and age group, forms an important part of the hockey profiling model. In the 2012-13 period Hockey

There have been a number of new corporate partners which has given the organisation more financial and commercial focus, as well as a number of game development initiatives which will see sustainable growth in participation over the coming years.

The introduction of the IMG-STG database system brings about a new era in hockey in Australia. Although there have been challenges, we all look forward to future years when the issues are resolved and we can all benefit from the full potential of the new system.

The Board of Hockey NSW have outlined a number of strategic priorities which cover important areas such as association reform, facility and association sustainability which will remain a focus beyond 2013.

SPONSORSHIP

2012-13 has seen a real growth in sponsorship funds with a number of new corporate partners. Hockey NSW has a new merchandise partner; Fi-Ta Performance Sportswear, a new financial partner; Bridge's Finance and a new banking partner; Catalyst Money. The camps were again extremely well received and planning is already underway for an expanded model next year incorporating the U12, U13 and U18 age groups. The camps are an important strategic move for Hockey NSW both as a tool for increasing participation and retaining players.

STRATEGIC PRIORITIES

The Hockey NSW Board has outlined a number of Strategic Priorities for 2013 in line with the Strategic Plan 2010-2014. Strategic priorities encompass; association reform,

succession planning, development planning and growth, stakeholder engagement, sustainability (facilities and Associations/ Clubs) and governance framework.

Together, these priorities are crucial to the sustainability and growth of the game in NSW, particularly at grassroots.

Hockey NSW has taken the steps to set up a working group with participants from the wider hockey community in order to gather information in relation to financial status, business planning (including sinking fund), competition viability and participation numbers. The aim of this group is to help support associations by outlining appropriate business planning to not only gain financial stability but the introduction of initiatives to grow the game in their region.

Finally I want to thank on behalf of the Board of Hockey NSW and all those volunteers who assist the organisation on a daily basis, which includes Hockey NSW State Championships and state teams. This great game of hockey cannot run without help and assistance from our trusted volunteers and we look forward to your ongoing support in the foreseeable future. I would also like to take this opportunity to also thank the dedicated and hardworking staff at Hockey NSW for all their efforts over the past 12 months who serve the NSW membership so diligently.

REFRESHED VISION FOR HOCKEY IN QUEENSLAND

During the 2012/2013 season there have been many highlights on the field; most notably the Queensland Blades taking out the 2012 Australian Hockey League title. The Blades once again proved to us why they are one of the most successful teams in Australian hockey.

The Queensland Under 18 Women's win at the National Championship in Newcastle was another playing highlight of the season and showed us that Queensland is in a good position 'on the field' moving into the future. National victories were also claimed by the Men's Under 21 team, State Masters 40+ (Men), 60+ (Men) and 45+ (Women) - congratulations to all Queensland teams who competed at a national level in 2012/13.

Hockey Queensland is also excited to announce two new roles and appointments within the Hockey Queensland community. The first is our new State Development Manager, Grant Noyce. Grant's major project will be to consult with our members and stakeholders to establish a State Development Plan as a key component of Hockey Queensland's vision to lead and grow hockey in Queensland. The second role, which is new to hockey in Queensland and fits within the Queensland Academy of Sport (QAS) is the position of High Performance Hockey Manager. This role will lead the development and implementation of the High Performance Plan for hockey in Queensland to build upon our success in high performance and our partnership with the QAS.

The floods that hit Bundaberg and much of Queensland in early 2013 affected the hockey community greatly with the turf and club house of Bundaberg Hockey all but destroyed. A major activity for Hockey Queensland was to assist by setting up a fundraising account and activities to assist the devastated association. With the assistance of Hockey Australia and the Hockey Queensland member associations money was raised throughout the season including during the Be The Influence U21 National Championships.

2013 SIGN-ON

Recruiting new players to the sport was the challenge set by Queensland member associations at the 2012 Members Forum. After a rigorous planning process the response from Hockey Queensland was to implement an integrated marketing plan with the goal of attracting new players to the sport. This strategy involved the production of a TV commercial and associated media spend (featuring hockey great Nikki Hudson), a specific sign-on website, plus online, press and social media advertising. The campaign was called 'Get into Hockey' and the result was a sensational 700+ boost to our 2013 player numbers. We are currently in the planning phases of the 2013/14 sign-on campaign and look forward to even more positive results.

SUPER LEAGUE

The second annual Hockey Queensland Super League tournament was run in June 2013 and was a massive success for the Queensland hockey community. The introduction of several off-field activities and attractions created a real carnival atmosphere for the tournament. These attractions included an official player party featuring live music, as well as a classic exhibition match featuring past and future Queensland stars. The final day of the Super League tournament was also live streamed through the Hockey Queensland website to ensure regional Queensland hockey fans could enjoy the action. As we continue to grow this tournament we hope it grows to be a stand-out tournament in Australia.

REMOTE PROGRAM

The Hockey Queensland Remote and Indigenous Program continues to go from strength to strength. The major highlight of this year was undeniably the Queensland Rubies (State Indigenous women's team) and Queensland Blaze (State Indigenous men's team) travelling to the Singapore Sixes Tournament. The Rubies were also featured in a documentary about their travels to this tournament which will air on NITV later this year.

During the past 12 months Hockey SA continued to implement changes aimed at improving the delivery of programs and services that we offer to our members and the community while striving for greater financial sustainability.

GOVERNANCE

A reinvigorated Board spent much of its time addressing contemporary issues faced by state sporting organisations. This included benchmarking and updating our board governance systems and policies in accordance with the Australian Sports Commission's Sports Governance Principles.

Together with our key funding partner – the SA Government's Office for Recreation and Sport – we participated in a 360° review survey. Through this initiative, we received feedback from our membership and stakeholders in key areas of their interaction with us, including experiences and relationships, aspirations for the future, and current needs and expectations. Key trends and themes are being analysed with action plans devised for implementation in 2013-14.

In parallel, the Board and CEO commenced the process of developing our next strategic plan including a detailed analysis of performance against the expiring plan.

MANAGEMENT, OPERATIONS AND PROGRAMS

Substantial changes to staffing have been affected covering all management areas of the Association. A dedicated marketing and

events role delivered key support in the area of communication. Our website content underwent a major overhaul while increased social media output was well received by our membership.

Our high performance and development programs are undergoing significant change to align them more closely to our national programs and initiatives.

The appointment of a new State Sport Academy of Institute Head Coach by the Office for Recreation and Sport has seen the beginnings of an even closer working relationship with our recently appointed Athlete and Coach Development Manager. Our high performance programs are being reviewed to increase depth of numbers with more rigorous programs being introduced from the U13 age groups through to AHL.

A major focus will be in the area of coach development as we seek to address low levels of qualified coaches – particularly at elite levels. We will address this issue from grassroots levels and in conjunction with the national HockeyEd program.

We continued to increase and service our Hookin2Hockey centres and, aligned with this, have covered numerous school visits both in the metropolitan and regional areas.

An overhaul of our umpire development program is underway aimed at increasing the quality and depth within our umpiring ranks. This should also provide increased national representation opportunities, particularly for female umpires.

We take great pride in acknowledging the achievement of umpire Tim Pullman who officiated at the 2012 London Olympic Games.

Once again the state was well represented by players at both male and female junior international levels with a range of talented female athletes also playing in senior tournaments across the year. We acknowledge a shortfall in representation in national senior men's teams and will look to address this in the coming period through our player development pathway initiatives.

Hockey SA successfully hosted a range of national tournaments during the past twelve months including under 21 women, under 15 men, national primary schools and the University Games.

FACILITIES

Work was completed on the replacement of the pitch lighting at the State Hockey Centre, once again bringing the facility up to international level.

Following the receipt of significant State Government funding, planning for our second international standard pitch at the State Hockey Centre has been completed.

ACKNOWLEDGMENTS

The support of our members and sponsors continues to be invaluable in operating our sport.

I wish to thank all members of Hockey SA for their dedicated volunteer input. I acknowledge, the South Australian Government, the Office for Recreation and Sport, SASI, Just Hockey, Amadio Wines, Kukri, Balfours, Haigh's Chocolates and the McLaren Vale Beer Company, for their continued financial assistance which we value greatly.

I thank the Board of Hockey SA - particularly Chair Helen Stone - and our various operating committees for another year of dedicated volunteer engagement. While the Board continues to govern hockey in tight economic conditions, the development of our new second pitch at the State Hockey Centre will provide avenues for greater economic sustainability of our organisation from 2013-14.

ADMINISTRATION

The Board arranged an independent review of the organisational structure of Hockey Tasmania during 2012. Implementation of that review began with the commencement of Andrew Winch as CEO in February 2013. The aim of the review was to better align staff of the organisation to the Hockey Tasmania strategic plan and to ensure that the needs of the organisation are able to be met.

2012-13 has seen a period of slight growth in the Hockey Tasmania's administration with an emphasis on the development of the game, both at grass roots level and within the coaching and officiating areas during 2012. The other area of increased emphasis has been the non-core business of functions, maximising the opportunities provided by the facilities at the Tasmanian Hockey Centre (THC).

FACILITIES AND EVENTS

Positive news for the facilities managed by Hockey Tasmania was the successful resolution of the No. 1 ground litigation at the Tasmanian Hockey Centre.

2012 was a busy year for Hockey Tasmania with three major events at the THC – the prestigious U21 Men's Championship in July followed by the School Sport Australia 16 & Under Boys and Girls Championships in August. The grand finale was hosting the Australian Men's Masters Championships in October. The true value and capability of the Tasmanian Hockey Centre and the dedicated staff and club volunteers from around the

state came to the fore during each of these significant events.

2013 opened with the U15 and U18 Boys & Girls Indoor Championships hosted in Launceston at the Silverdome, another excellent venue popular with all indoor hockey enthusiasts. An enthusiastic and experienced group of northern staff and volunteers ensured the Indoor Championships ran smoothly.

ACTIVE PARTICIPATION

In recognition of the need to make greater gains in the area of participation and development Hockey Tasmania appointed Melissa Jeliff as Game Development Manager in 2012 with the goal of improving direction and providing focus to the work of the Hockey Tasmania Development Officers in each region of the state. Leanne Bissett in the north west, Matt McGregor in the north and newly appointed Will Braid in the south continued the delivery of the well-established School Development Program, the Hookin2Hockey program, holiday clinics and participation in the Active After School Communities program.

COACHING & OFFICIATING DEVELOPMENT

With the valued guidance from Hockey Australia's John Mowat, the slow re-build of the coaching and umpiring stock in Tasmania continues. Volunteer committee convenors Ted Taylor and Janette Nielsen work closely with Melissa to continually create opportunities for officials and coaches to gain accreditation and development experiences. Hockey Tasmania continues to provide officials and coaches at national and local

levels. Both Minka Woolley and Peri Buckley were appointed to positions at the London Olympic Games in August 2012, and Brendan Moore was appointed Tournament Director for the Be The Influence U21 Men's National Championship in both 2012 & 2013.

PLAYER DEVELOPMENT

The development of elite players has been enhanced with the appointment of Ilene Carr as coach of the Emerging Talent Squad, which aims to bring younger players from around the state through to the next level of elite participation. This position is a partnership between the Tasmania Institute of Sport with Hockey Tasmania with both parties contributing to the cost of the position.

Tasmania entered teams in each of the recognised National Championships despite our significantly smaller player base. This is achieved by the State Teams Program ably led by volunteer coordinator Alison Monk.

CORPORATE AND GOVERNMENT SUPPORT

Several new sponsorship agreements were signed, including RACT and ANZ Bank during 2012. It continues to be a difficult market for sponsorship especially in a small state where it is often difficult to secure the support of corporations and large businesses. Just Hockey continues to provide long-term support to Hockey Tasmania together with local business IRIS Computing.

Both state and local government make a particularly significant contribution to Hockey Tasmania via Events Tasmania, Sport & Recreation Tasmania, the Tasmanian Institute of Sport and the Hobart and Launceston City Councils.

In 2013 and beyond, the Board of Hockey Tasmania will be concentrating on achieving the strategic goals of increasing participation, increasing Tasmania's representative success and maintaining and improving the hockey facilities.

Over the last twelve months, and building on the foundations set over the past few years, Hockey Victoria (HV) has continued to review and enhance the programs, competitions and support services that we provide our clubs and associations with the key objectives of increasing the participation and development opportunities for all of our members and creating safe, welcoming and inclusive hockey environments.

MEN'S CHAMPIONS TROPHY

The Men's Hockey Champions Trophy held at the State Netball Hockey Centre from 1st - 9th December 2012 was a spectacular success with the Kookaburras clinching a record fifth consecutive Champions Trophy title 2-1 over the Netherlands when Kieran Govers scored in extra time. Approximately 30,000 people attended the event and ticket sales surpassed the levels achieved for the 2009 event also held in Melbourne.

The television broadcast and media coverage of the event was excellent and this vital exposure will have lasting positive impacts at all levels of our sport. During the event, several hundred junior players were provided with the unique opportunity to accompany the international teams onto the pitch for the start of each game or perform ball kid duties. It was a pleasure to see the smiles on the faces of these juniors as well as the pride of their parents as they contributed to the success of the event.

PARTICIPATION & DEVELOPMENT

In July 2012, HV was successful in receiving \$150,000 in funding under the Victorian Government's Victorians More Active

2012-2015 program which aims to support participation, membership, coaches and officials, and club capacity at all levels of community sport. This program perfectly complements the participation and development strategies established under the Australian Sports Commission (ASC) participation funding program.

HV continued to work collaboratively with Hockey Australia to increase the number of participants (players, coaches, umpires and officials), as part of the ASC participation funding. HV comfortably achieved the key performance indicators set for 2012 which resulted in additional funding from Hockey Australia in 2013

In 2013, HV introduced an individual membership model and the revenue generated through this model enabled HV to fund the appointment of two additional Development Officers to support the existing two Development Officers. We are already seeing the benefits of these additional resources with in excess of 23,000 primary school children receiving a hockey clinic in the first five months of 2013. A healthy percentage of these children have successfully transitioned into formalised junior participation programs and competitions within a club environment and hopefully we can make them hockey players

HV has continued to increase participation and development opportunities for women and girls in hockey as part of our 2011-2014 VicHealth State Sporting Association Participation Program funding.

HIGH PERFORMANCE

There continues to be a strong contingent of Victorian athletes in the national squads and this is a testament to the hard work invested by the athletes and the Victorian Institute of Sport Head Coaches Katie Allen and Jay Stacy. Both coaches have also positively contributed to the underpinning development programs managed by HV and we are very grateful for their assistance. One of most outstanding and memorable achievements in 2012 was the Victorian Vipers, winning the women's Australian Hockey League in Perth.

FAIR GO, SPORT!

I am extremely proud of the hard work that HV has been doing to promote sexual and gender diversity in our hockey clubs through the Fair Go, Sport! project. The project has been supported by the ASC, the Victorian Equal Opportunity & Human Rights Commission, VicHealth and Sport and Recreation Victoria. The flexible model of engagement that was developed as part of the project is now being used by several other State Sporting Associations. HV is committed to developing safe, welcoming and inclusive hockey environments.

Hockey WA over the last 12 months has undertaken a substantive restructure of the organisation including the appointment of a new CEO.

The Board and management of the organisation, as a consequence of issues identified within a Strategic Review, have remodelled Hockey WA across five key areas of operations:-

- Organisation to operate to best practice organisational standards
- Finance to diversify revenue streams and manage costs to improve financial sustainability
- High Performance to produce successful state teams, coaches and officials
- Participation and Promotion to increase participation in the sport of hockey across WA
- Infrastructure to provide sustainable high quality facilities

A number of strategies and operational plans were implemented over the last 12 months including:

- Tighter financial controls resulting in lower costs of operation, stronger cash flows and better reporting. In turn, the
- resulting efficiencies have lowered the labour costs from 19 FTE's to 13 FTE's, all with better focus, producing better outcomes for the organisation.
- Greater focus has been given to the selection, development and coaching of identified athletes through HWA development programs. The roles of

- development and administration within High Performance have now been split, again providing better focus for both roles.
- Overall participation increased by 3.5% over 2012, with the greatest growth in Masters Women at 4.9%. Junior growth was at 2.2%.
- The development of a strong social media presence, including the streaming of 'games of the week', the streaming of a pre and post-match show and the provision of a Club segment showcasing the activities of a number of clubs within the Perth area.
 This has all assisted in the 100 % increase in corporate sponsorship achieved in the last
 12 months.

- An overhaul of the seating at the Perth Hockey Stadium has both improved comfort for spectators and due to their design has reduced the maintenance and cleaning cost of the facility.
- The staging of a regional round of our Premier Men's Competition in Albany also assisted in the promotion of the game and a large crowd watched the game which was accompanied by a number of workshops on coaching, officiating, plus junior and elite player coaching clinics.

These initiatives both achieved and yet to be implemented are all due to the efforts of the staff of Hockey WA, both those present today and those who have contributed over the last 12 months. They deserve the thanks and gratitude of the CEO and the hockey community.

To the sponsors, especially the Department of Sport and Recreation, Healthway and Melville Toyota for their continued financial support of hockey in Western Australia, thank you.

Finally to the Board and volunteers who have worked many hours with no other reward than to assist the sport to grow and to be enjoyed by the hockey players of WA, THANK YOU.

The amendment (part of AASB 2011-9 'Amendments to Australian Accounting Standards - Presentation of Items of Other Comprehensive Income' introduce new terminology for the statement of comprehensive income and income statement. 3. SIGNIFICANT ACCOUNTING POLICIES

FINANCIAL REPORTING FRAMEWORK

The company is not a reporting entity because in the opinion of the directors there are unlikely to exist users of the financial report who are unable to command the preparation of reports tailored so as to satisfy specifically all of their information needs. Accordingly, these special purpose financial statements have been prepared to satisfy the directors' reporting requirements under the Corporation Act 2001.

For the purpose of preparing the financial statements, the company is a not-for-profit entity.

STATEMENT OF COMPLIANCE

The financial statements have been prepared in accordance with the Corporation Act 2001, the recognition and measurement requirements specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101 'Presentation of Financial Statements', AASB 107 'Cash Flow Statements', AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors' and AASB 1054 Australian Additional Disclosures.

BASIS OF PREPARATION

The financial statements have been prepared on the basis of historical cost. Cost is based on the fair values of the consideration given in exchange for assets. All amounts are presented in Australian dollars, unless otherwise noted.

CRITICAL ACCOUNTING JUDGMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the company's accounting policies, which are described below, the directors are required to make judgments, estimates and assumptions about carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

LONG SERVICE LEAVE

Management judgement is applied in determining the following key assumptions used in the calculation of long service leave at reporting date:

- future increases in salaries and wages;
- future on cost rates; and
- experience of employee departures and period of service.

PROPERTY, PLANT AND EQUIPMENT

Useful lives and residual value of property, plant and equipment are reviewed annually. Judgement is applied in determining the useful lives of property, plant and equipment. Any reassessment of useful lives and residual value in a particular year will affect depreciation and amortisation expense (either increasing or decreasing) from the date of reassessment through to the end of the reassessed useful life for both the current and future years.

PROVISION FOR DOUBTFUL DEBTS

Management's judgement is applied in determining the provision for doubtful debts. If the estimated recoverable amount of the debtor is less than the amount of revenue recognised, the difference is recognised in the provision for doubtful debts.

The following significant accounting policies have been adopted in the preparation and presentation of the financial report:

(A) INVENTORIES

Inventories relate to rulebooks, coaching materials and other hockey related merchandise and are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis.

(B) PROPERTY, PLANT AND EQUIPMENT

Property, plant and equipment are carried at cost. All assets are depreciated over their useful lives to the company commencing from the time the asset was held ready for use.

The depreciation rates used for each class of depreciable asset are:

(C) CASH AND CASH EQUIVALENTS

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash, which are subject to an insignificant risk of changes in value and have a maturity of three months or less.

Bank overdrafts are shown within borrowings in current liabilities in the statement of financial position.

(D) INCOME

Government grant revenue is recognised when the company gains control of the funds.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Dividends and interest are brought to account when received.

Gains and losses on disposals of items of plant and equipment are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and comprehensive income.

(E) INCOME TAX

Hockey Australia Limited is a registered not-for-profit entity and is exempt under the provisions of the Income Tax Assessment Act 1997 (as amended) and as such is not subject to income taxes at this time. Accordingly, no income tax has been provided for the company in these financial statements.

(F) IMPAIRMENT OF ASSETS

At each reporting date, the company reviews the carrying amounts of its assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

Recoverable amount is the higher of fair value less costs to sell and value in use.

In respect of not-for-profit entities, where the future economic benefits of an asset are not primarily dependent on the assets ability to generate net cash inflows and where the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciable replacement cost of an asset less, where applicable, accumulated depreciation calculated on the basis of such cost to reflect the already consumed or expired future economic benefits of the asset. The current replacement cost of an asset is its cost measured by reference to the lowest cost at which the gross future economic benefits of that asset could currently be obtained in the normal course of business.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised in profit or loss immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised in profit or loss immediately.

(G) EMPLOYEE BENEFITS

A liability is recognised for benefits accruing to employees in respect of wages and salaries, annual leave, and long service leave when it is probable that settlement will be required and they are capable of being measured reliably.

Liabilities recognised in respect of employee benefits expected to be settled within 12 months, are measured at their nominal values using the remuneration rate expected to apply at the time of settlement.

Liabilities recognised in respect of employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the company in respect of services provided by employees up to reporting date.

Contributions are made by the company to an employee superannuation fund and are charged as expenses when incurred. The company has no legal obligation to provide benefits to employees on retirement.

(H) UNEARNED REVENUE

To the extent that specific grant funding remains unexpended at balance date, the surplus is brought to account as a liability 'Grants in advance', consistent with provisions embodied in the service agreements. Unexpended funds are fully refundable until expended on specified programs. Membership revenue which is received before balance date and relates to the subsequent financial year is brought to account as a liability.

(I) GOODS AND SERVICES TAX (GST)

Revenues, expenses are recognised net of GST except where GST incurred on a purchase of goods and services is not recoverable from that taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis. The GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

HALL OF FAME

MARJORY RIGG (CROSSEN)

Australian Representative 1951 – 1960

Western Australian half back Marjory Rigg was first selected in an All Australian Blue Riband team in 1951.

Marjory was selected in the team on eight other occasions. Marjory represented Australia in 25 matches between 1953 and 1960, in which the team won 17 matches, drew 4 and lost 4.

A 1960 tournament saw Marjory appointed as the Captain and Coach of the team.

Following her international playing days Marjory moved into coaching including the role of New Zealand coach in a 1971 IFWHA tournament played in Auckland.

Following this, a trophy 'The Rigg-Crossen Trophy' was introduced in Marjory's honour to be contested between Australia and New Zealand.

A true legend of the game.

JIM ABEL

Australian Representative 1922 – 1927 Jim Abel was the first Australian Men's hockey team captain.

The appointment came in 1922.

Jim continued in the role for four test matches, and also played for Australia in 1923, 1925 and 1927.



JAY STACY

Australian Representative 1987 - 2000

Jay Stacy, a Victorian midfielder, made his Australian debut in 1987 and retired following the Sydney Olympics in 2000.

During this period, Jay played 321 games, he is currently Australia's men's record holder for most games played.

Representation included four Olympic Games which included a silver medal in 1992 and Bronze medals in 1996 and 2000, as well three World Cups and 14 Champions Trophies.

In 1999 Jay was awarded the 'FIH World Player of the Year'. Following his retirement from playing, Jay moved into coaching and has coached club teams in Belgium and the Netherlands.

Today he is the men's VIS coach.

LIFE MEMBERS

BARRY DANCER

Barry Dancer started his international hockey career as a player, he was a member of the national squad from 1973-1979 playing 48 games. These games include a silver medal at the Montreal Olympics in 1978, a bronze at the 1978 World Cup in Buenos Aires and a 5th at the 1975 World Cup in Kuala Lumpur.

From 1998-200 Barry was the English Men's National Coach whilst also being the Men's Great Britain National Coach 1999-2000.

Barry returned to Australia in 2001 having been appointed National Coach/AIS Head Coach. He fulfilled this role until the end of 2008. During this time Barry coached the team to a medal finish at almost every major tournament in the world that the team took part in. Including the first Olympic Gold men's hockey medal for Australia in 2004. The other wins are:

In 2004 Barry was awarded 2004 Coach of the Year at the Australian Sports Awards and 2004 WA Coach of the Year.

FRANK MURRAY

Frank Murray started his hockey career as a player. He played for WA in 1973 before a five-year stint from 1976-1980. He was a member of the 1977 & 1979 Championship teams

From 1989-93 he became the National Head Coach. During this period Frank oversaw the establishment of a players development program for elite players which saw the need for them to re-locate to the AIS in Perth where the central program is still based. Intensive training centres were established in eight locations. Frank designed and directed these programs.

On the pitch, Frank coached the team to three Champions Trophy gold medals, two World Cup bronze medals and a silver Olympic medal. In which time he was also named the WA Sports Federation Coach of the Year in 1990 and 1993.

From 1994-96 Frank was the Men's National Head Coach & Head AIS Coach. He continued

to develop the player development program with the integration of a de-central program into a full elite development program with a central and de-central component. He also coached the team to a bronze Olympic medal, making the men's team the only Australian hockey team to medal at the 1992 and 1996 Games.
