**Dr. Ed Morse** is managing director and the head of Global Commodities Research at CitiGroup Global Markets, Inc., in New York City. Early in his career, Mr. Morse worked at the State Department, and later was an advisor to the United Nations Compensation Commission on Iraq, and the Departments of State, Energy, and Defense as well as to the International Energy Agency on issues related to oil, natural gas, and the impact of financial flows on energy prices. Mr. Morse has held positions at Lehman Brothers, Louis Capital Markets, Credit Suisse, and Hess Energy Trading Co.

A former professor at Princeton University and the author of numerous books and articles on energy, economics and international affairs, Mr. Morse was the publisher of

Petroleum Intelligence Weekly and other trade periodicals.

Widely cited in the media, he is a contributor to journals such as *Foreign Affairs*, the *Financial Times*, the *New York Times*, and the *Washington Post*.



**Rear Admiral Noam Feig** is the former deputy commander of the Israeli Navy, where he spearheaded technology acquisition projects and was responsible for developing the Israeli Navy's relations with foreign militaries. He retired in 2009.

Today, Rear Admiral Feig is the CEO of N. Maritime Consulting, which supplies and integrates maritime security solutions, and security solutions for ports and strategic assets. During his career in the Israeli Navy, Rear Admiral Feig served as Head of Naval Operations, Head of the Intelligence Division, Commander of the Missile Boats Flotilla, Head of Intelligence for the Operations Department, and Commander of a Maritime Control Unit.

Rear Admiral Feig holds an Executive MBA from Tel Aviv University, a B.A. in Economics and Business Administration from Haifa University, and is a graduate of Israel's Naval Officers School.



**Dr. Michael Makovsky** joined JINSA as CEO in April 2013. Before that, he served as Foreign Policy Director of the Bipartisan Policy Center, where he managed policy projects on Iran's nuclear development, Russia, Turkey, Yemen, Egypt and other foreign policy issues. Prior to that, Makovsky served as special assistant for Iraqi energy policy in the Office of Secretary of Defense and Director of Essential Services in the Washington office of the Coalition Provisional Authority, the postwar Allied entity that governed Iraq. Before his work at the Pentagon, Makovsky worked for a decade as a senior energy market analyst for various investment firms.

Makovsky has written articles and op-eds on Iran, Iraq, Yemen, and Middle Eastern energy and diplomatic issues, and is the author of *Churchill's Promised Land* (Yale U. Press, 2007), a diplomatic-intellectual history of Winston Churchill's complex relationship with Zionism. He has a Ph.D. in diplomatic history from Harvard University, an MBA in finance from Columbia Business School, and a B.A. in history from the University of Chicago.
