SUBJECT:	<u>ATTENTION -</u> <u>FINANCIAL REPORTING AND FILINGS</u> : ANNUAL AND QUARTERLY STATEMENT REQUIREMENTS UNDER ARK. CODE ANN. §23-63- 216, et al, COMMENCING JANUARY 1, 2004

2004 Filing of Annual and Quarterly Statement Requirements

The provisions of Ark. Code Ann. § 23-63-216 require disclosures of financial information in reports, specified as to form and format by the Commissioner, about insurers and other licensees, and require electronic financial statements for review by the Department and the National Association of Insurance Commissioners (NAIC). Other laws, including foreign and alien surplus line insurers doing business in Arkansas, and reporting under Ark. Code Ann. §23-65-310(b); and those for licensed, domestic fraternals, reporting under §23-74-602; and § 23-75-102 for hospital or medical service corporations, as well as §23-75-114; and §23-76-113 as to hospital and medical service corporations and HMOs, and those for foreign and alien risk retention groups registered and doing business in Arkansas, and reporting under Ark. Code Ann. §23-94-205(B); all require various licensed entities to supply annual and/or quarterly financial reports.

Domestics - For Arkansas domestic entities commencing with the Annual Statement as of December 31, 2003, due for the Commissioner's review and analysis <u>no later than March 1, 2004</u>, and thereafter, the electronic annual and quarterly statement filings with the NAIC in its Kansas City offices shall satisfy the Arkansas requirements for electronic filing specified under Ark. Code Ann. §23-63-216, et al.

Therefore, commencing on January 1, 2004, only hardcopies of the filings will be required to be filed with the Arkansas Insurance Department in Little Rock so long as the insurers and other entities timely file electronic and hardcopies with the NAIC on or before March 1, 2004 or other appropriate due date, or under extensions of time agreed by the Commissioner for good cause in advance of the statutory due date and in writing. Should the Kansas City or Arkansas filing prescribed by the Commissioner be late, the usual monetary penalties will be imposed by Department letter on the delinquent companies.

Non-domestics - For foreign entities, commencing with the Annual Statement as of December 31, 2003, due for the Commissioner's review and analysis <u>no later than March 1, 2004</u>, and thereafter, the manual and electronic annual and quarterly statement filings with the NAIC in its Kansas City offices shall satisfy the Arkansas requirements specified under Ark. Code Ann. §23-63-216, et al. Therefore, commencing on January 1, 2004, no electronic or hardcopy filing with the Arkansas Insurance Department in Little Rock will be required <u>so long as</u> the insurers and other entities submit an Affidavit of Filing and Financial Statement Attestation Form (copy attached) with the Department and timely file with the NAIC on or before March 1, 2004 or other appropriate due date, or file under extensions of time agreed by the Commissioner for good cause in advance of the statutory due date and in writing. Should the Kansas City filing prescribed by the Commissioner be late, the usual monetary penalties will be imposed by Department letter on the delinquent companies.
