This notice is required by the provisions of Ark. Code Ann. §23-63-613 to allow the Commissioner to specify that domestic insurers and other domestic reporting entities shall use this most recent 2004 edition of APPM, no sooner than eight (8) months after distribution of the required statutory notice.

Therefore, please be advised that the <u>effective date</u> for the prescribed use of this edition of the APPM for Arkansas domestic reporting entities shall be for the Annual Statement as of December 31, 2004, to be filed with this Department by or before **March 1, 2005**.
