Division of Elections Recount Appeal	

The State has filed a motion to lift the stay in this matter and set an expedited schedule for briefing and decision. The motion is **GRANTED**; the stay of this recount appeal is hereby **LIFTED**.

The superior court is hearing the related election contest in case number 3AN-16-09015CI. Trial in that matter is set to begin September 27 and is expected to end by October 3. The decision in that case shall be issued no later than **Thursday**, **October 6**. If an appeal is filed from that matter, it will be consolidated with this case for briefing, argument, and decision pursuant to this court's order of September 20, 2016.

The court has tentatively outlined the following schedule for the appeal, assuming the superior court decision is issued on October 6:

This schedule will allow a decision to be made in time to allow the State to distribute ballots in a timely manner.

Briefs shall be filed by email, in PDF format, sent to mmay@akcourts.us and mmontgomery@akcourts.us. No paper copies of the briefs need to be filed; the court will make the necessary copies for its own use.

If the superior court decision is issued prior to October 6, the schedule will be revised forward, and the clerk will issue the new schedule in writing. Simultaneous opening briefs will likely be due two to three days following the superior court's decision.

The clerk shall communicate with the parties as soon as practicable to determine the feasability of the proposed schedule.
