## Family Law Workshops

#### **Dissolution PETITION/RESPONSE:**

Provides an overview of the Divorce/Legal Separation process. Includes step-by-step instruction in completing the petition/response form packet. Class Time: 2 to 2.5 hrs.

### Request for Order (RFO) & Establish Parent Relationship/Paternity (EPR):

Form assistance will be provided to complete a request to obtain temporary orders on issues such as custody, visitation, child support, spousal support, and injunctions. Form assistance for unmarried parents who need to open a court case to establish paternity (parental relationship). Instructor will provide a basic understanding of court procedures and what to expect. Class Time: 1.5 hrs.

**JUDGMENT:** ALL CASES require FINAL PAPERWORK known as a JUDGMENT. If finishing a case by agreement, both parties must be present. For Divorce, Legal Separation, and Nullity cases: You must have completed an Income & Expense and a Schedule of Assets/Debts prior to attending this workshop. <u>Financial</u> <u>Disclosures Packet</u> **Tuesdays: 8:30 am, 9:30 am, 10:30 am, 1:30 pm, & 2:30 pm.** Class Time: 1 hr.

## MSC (Mandatory Settlement Conf.):

Provides instruction on how to prepare for your settlement conference, including how to complete your Financial Disclosures, Property Declarations, and Settlement Brief.

**Letters Rogatory:** Assistance with completing forms for service of the summons, petition, and other filed pleadings upon Respondent who lives in Mexico. This class could take up to 2.5 hours.

**Child Support Clinic:** Assistance with completing government applications/forms from the child support agency (DCSS) <u>or</u> Court forms related to child support.

Family Law Forms Review: You can obtain a review of your completed court forms at 7:30 a.m. to 8:30 a.m. or 3:00 p.m. to 4:00 p.m. each day, except on court holidays or days designated No Assistance. (Forms should be 85%-90% completed for the review.)
