The GWG is the forum for the National Systems for Geospatial-Intelligence (NSG) representatives to manage GEOINT standards, exchange ideas and communicate issues regarding GEOINT standards requirements, application, and conformance. Persons interested in facilitating the adoption, promulgation and use of GEOINT standards for enabling technologies, data architecture, and software tools are encouraged to participate.

MISSION: The primary responsibilities of the GWG are to 1) coordinate population of the DoD IT Standards Registry (DISR) with GEOINT standards and 2) serve as the NSG Community of Interest for all standardization activities and functions related to GEOINT.

GEOINT STANDARDS enable the discovery, access, use, integration, dissemination, exchange, and exploitation of GEOINT. The GEOINT standards of interest to the GWG also form the thematic basis for the GWG Focus Groups and include:

- Still and motion imagery and gridded data content, format and compression
- Application schemas for geospatial feature encoding, data dictionaries and catalogues
- Geospatial portrayal
- Metadata for geospatial intelligence
- Geospatial intelligence reporting
- Information transfer, exchange and architecture of GEOINT services
- Sensor models for GEOINT services, production and applications

GWG – A REGISTERED COMMUNITY OF INTEREST

Within the DoD and the Intelligence Community, a Community of Interest (COI) includes any group whose goal is to enhance net-centric information sharing. With COI registration, the GWG can advance its membership, program of work, and the standards necessary for achieving optimal interoperability.

MANAGING GEOINT STANDARDS IN THE DISR

The GWG Core Members vote on GEOINT standards for inclusion in the DoD IT Standards Registry (DISR). The GWG Focus Groups coordinate among the community's experts to make recommendations for standards to be adopted. The use of DISR standards in an architecture's Technical Standards View (TVs) is mandated for the upgrade of existing systems and acquisition of new systems throughout the DoD.
