Subject: FY 2012/2013 Mid-Year and FY 2013/14 Rate Changes

The California Technology Agency, Office of Technology Services (OTech) is implementing rate adjustments for FY 2012/13 mid-year and FY 2013/14. The FY 2012/13 mid-year rate adjustments are retroactive to January 1, 2013. The FY 2013/14 rate adjustments are effective July 1, 2013. The rate adjustments were approved by Department of Finance on May 14, 2013. The purpose of the rate adjustments are to:

- Bring each service to, or as close to, break-even as possible.
- Provide new technologies to customers while reducing overall costs.

The rate adjustments are for the following services and rates for new services:

- Mainframe CPU
- Mainframe Disk Storage
- Mainframe Tape Storage
- OTech Fiber Ring
- California Statewide Government Network (CSGnet) Retirement Fee
- Secure File Transfer
- Tenant Managed Services
- Geographic Information Systems
- Disaster Recovery for CA.Mail
- Mobile Device Management

The following is a summary of the key rate changes:

#### Mainframe CPU

The mainframe system is hosted on IBM z/Series central processors running z/OS, the IBM operating system for large-scale processing applications, and provides access to a range of mainframe software products and databases. This service also offers customers high performance, availability, and reliability; as well as a robust, scalable and secure operating environment.

# **OTech Fiber Ring**
