## TERMS OF CONTRACT ADDENDUM:

Effective October 1, 2016, the undersigned hereby agree to add staffing to the existing Inmate Substance Abuse and Mental Health Contract No. DOC1202-MENTAL in support of the James T. Vaughn Correctional Treatment Center. Connections Community Support Programs, Inc. (CCSP) shall implement and staff a special treatment center and perform all other services contemplated under the settlement approved in *Community Legal Aid Society, Inc. v. Coupe*, C.A. No. 15-688 (GMS).

The costs for implementation and additional staffing to support the treatment center shall not exceed \$568,102.00 for the period beginning October 1, 2016 through June 30, 2017. This cost is based upon the prorated amounts identified below in Table 1. CCSP shall submit separate monthly invoices based upon actual staffing costs with supporting documentation to accompany each invoice. Costs will only be reimbursed for positions that are filled, and when positions are transferred to the Treatment Center, when the positions that are vacated are hired and backfilled. Costs for staff recruitment, supplies, and overhead will be reimbursed based upon actual costs and hiring date for each staff position. In no case will costs associated for supplies, recruiting, and overhead exceed \$60,375.00 without approval by the Department.
