GENERAL STATEMENT:

A. The Mandatory Pre-bid meeting was held at the Bethany Beach Training Site Building 115 on December 1, 2015 at 11:00 am.

 - 4. The last addendum will be distributed on December 17, 2015.

B. Key topics

- 1. Bids
 - a. Make sure you identify the project name on the front of your envelope when you submit your bid and indicate DO NOT OPEN.
 - b. Prime contractor shall provide their DE business license with bid. Sub contractors shall provide DE business license within 30 days of award.
- 2. Building Access
 - An optional walk thru will be conducted during week ending 12/11/15 between 9:00 a.m. and 2:00 p.m. There shall be no walk through on 12/9/15. Call Chief Charles Conaway at 302-326-7693 (desk) or 302-841-5793 (cell) if you wish to do the optional walk thru. Meet at the Bethany Beach Training Site Building 115. Contractor shall provide 24hr notice. Contractors may NOT appear on site without prior notice.
 - b. All buildings shall remain open during construction.
 - c. All site access is through the south gate.
- 3. Clarifications
 - a. All questions must be submitted in writing and must be faxed to DEDC, LLC, Attn: Mike Finamore, Fax 302 738-7175 or E-mailed to <u>mfinamore@dedc-eng.com</u>. Phone calls will not be accepted.
 - b. All permits required for this effort to be obtained by the contractor.
 - c. Contractor to have full time superintendent or working foreman.
 - d. This is a Prevailing Wage project.
 - e. This is an army base, so review the security procedures in the spec book. DEARNG holds the right to perform background checks on any personnel entering the site. Valid identification is required to access the site.

- f. DEARNG will work with winning contractor to coordinate off hour work with 72 hour notice. See attached schedule for DEARNG days off.
- g. Contractors are required to design, furnish, install, and obtain all required approvals for complete code compliant systems. Project intent is to not have a fire pump by oversizing the main water feed.
- C. Subcontractor Listing
 - 1. Be sure to list your company name if your company is performing this work.
 - 2. All companies listed must be registered in the State of Delaware to perform this work.
- D. Meetings
 - 1. There will be progress meetings on this project every 2 weeks on a specific day and time, to be determined at the kick off meeting.
 - 2. Contractors shall provide 3 week look ahead schedule at each meeting to indicate work areas and shut downs.
- E. Base Bid/Alternates
 - 1. This project contains a base bid and an alternate. The base bid includes the installation of fire alarm and fire protection for building 115. The alternates include the installation of fire alarm in buildings 139 and 140.
- F. Allowances
 - 1. This project contains three (3) allowances.
 - a. First, \$10,000 contingency for miscellaneous items.
 - b. Allowance 2 and 3 have been changed to be alternates. See attached bid form.
- G. Construction Time
 - 1. Substantial completion of all the work within 120 calendar days of the Notice to Proceed. See attached bid form.

 - 1. Does the floor need to be protected during construction? *RESPONSE: Yes*

 - 4. Is there any ordinance in the ground? *RESPONSE:* It is believed that there is no ordinance in the ground.
