5	Can you please clarify the existing elevations on the Grading Plan (Drawing C-103) and additional plans? It isn't clear if the grade is increasing or decreasing with the exception of the storm water management ponds.	Existing contours are shown on Sheet C-101. There is a contour line marked "30" at approximately the middle of the south edge of the site, and a contour line marked "25" running north-south through the middle of the site. While there are no obvious additional contour elevations marked to determine if the site continues to slope down or if 25 is the low point, there are benchmarks provided on Sheet C-102. Benchmarks 402, 404, and 407 are at elevations (roughly) of 22 and 23 feet, indicating that the site continues to fall in those directions.

4	Is there still a sound barrier wall system involved in the project for Contract No. T200612502.02 (Lewes Park & Ride & Site Work)? If so, are there any notes on length and height, or square footage? I can't seem to find any in the specs or plans.	No sound wall in this project.			
3	What is the diameter around each tree and shrub?	The mulch diameter around shrubs and trees is 4 to 5 feet.
