1	MR. KOVACS: Good afternoon,
2	everyone. My name is Bob Kovacs, and I'm a
3	contracts coordinator here with DelDOT. This
4	is Mr. John Kotula. He's the project manager
5	for this project. This is a mandatory pre-bid
6	meeting for Contract No. T200612502.02. This
7	is for the Lewes Park & Ride and Site Work in
8	Sussex County.
9	We have a sign-in sheet going
10	around. Please sign in. Try to write as neat
11	as you can. You must sign in in order to
12	submit your bid, so I want to make sure I have
13	all your information so everyone's able to
14	submit.
15	The reason for the meeting, one
16	is to pass along some information, and two is
17	we are required to come up with a
18	subcontractor category list for this project.
19	So at some point we'll need to do that.
20	Once we get all the categories,
21	I'll publish them on the website as an
22	addendum, and then all I need you to do is go
23	out there and grab that new category listing
24	and fill it out completely and submit that



1	with your bid. You must submit it with your
2	bid, actually.
3	In fact, we've had some problems
4	in the past, so I just want to go over a few
5	things. The listing as so published shall be
6	final and binding upon all bidders and the
7	agency and shall be filled out completely in
8	full without any abbreviations.
9	So the list is going to look,
10	obviously, something like this, and I'll list
11	the categories that we come up with. You'll
12	just need to fill in each category. Don't
13	abbreviate. If a bidder intends to do any
14	subcontract work themselves, they need to list
15	themselves as that subcontractor. In other
16	words, don't leave it blank. Fill it in.
17	But you only want to do that if
18	you, the bidder, is duly licensed by the State
19	to engage in such specialty work, that you
20	customarily perform that specialty work as a
21	subcontractor would, and that the bidder is
22	recognized in the industry as a bona fide
23	subcontractor who does the work routinely.
24	And if that's the case and you want to do it



1	yourself, then just list yourself.
2	If you have any questions after
3	the meeting that you don't think of during the
4	meeting, just send it to our dot ask web
5	address, our email box. It's right here. If
6	you don't have it, just grab it on your way
7	out. And we'll answer the questions as quick
8	as we can, and then we'll post them for
9	everyone to read, the questions and answers,
10	make sure we all try to stay on the same page.
11	When asking questions today, I
12	ask that you please state your full name, who
13	you represent so we can get a good recording
14	of who's speaking. And just please do that
15	every time you need to ask a question.
16	I want to go over a few bidders
17	notes real quick just as a reminder. There's
18	a breakout sheet with this project. I just
19	want to reiterate the breakout sheets must be
20	submitted either with your bid documents or
21	seven calendar days following the bid due
22	date. So you can fill out the breakout sheet
23	and turn it in with your bid, or you have up
24	to seven calendar days to turn it in to us



1	after the bid opening.
2	This project incorporates an
3	Appendix A. It's out on the web. I'm sure
4	you guys are all aware of it. That's just a
5	reminder to make sure to look at that.
6	This particular proposal has
7	Federal Transit Administration language. I
8	believe it's six five extra forms you'll
9	need to fill out.
10	The first one is Buy American
11	certification, and it's listed in the
12	proposal. You'll see it in the package. As a
13	reminder, this deals with steel and iron, and
14	any steel and iron must be manufactured in the
15	United States. And when you fill out this
16	form, you're either filling in the top
17	portion, a certification of compliance, or the
18	bottom portion, which is noncompliance. Don't
19	fill them both out. Just whichever one
20	applies to you, fill that one out, turn it in.
21	There's a certification of
22	eligibility that needs to be filled out. It's
23	a small form but needs to be notarized, as a
24	reminder. So please make sure you sign it and



1	get it notarized.
2	Same with the certificate of
3	non-collusion, needs to be notarized as well.
4	Then we have two more forms that
5	don't need to be notarized but they need to be
6	signed and filled out and dated. One is the
7	certification of restrictions on lobbying.
8	The other one deals with debarment,
9	suspension, and other responsibility matters.
10	So just as a reminder, make sure
11	you fill in these forms completely and fill
12	as well as the regular certification statement
13	and your bid bond, just make sure you fill all
14	this out together when you turn in your bid as
15	well as the breakout sheet unless you want to
16	turn that in seven days later. It's up to
17	you.
18	This project also has a DBE goal
19	of 7 percent, which basically means that
20	7 percent of your total bid you need to use
21	DBE DelDOT certified vendors to accomplish
22	that portion of the work.
23	And there's DBE language in the
24	proposal itself as well as you can go on our



1	deldot.gov website and click on civil rights,
2	and that will explain everything there, and it
3	also will give you a listing of the DBE DelDOT
4	certified vendors as well.
5	C.G. WARE: Chuck with Kent
6	Construction. Does due diligence come into
7	play here?
8	MR. KOVACS: As far as?
9	C.G. WARE: DBE. If we can show
10	documentation of where we contacted and nobody
11	wants to play in our sandbox.
12	MR. KOVACS: Yes. Just like in
13	the past where you can fill out that, send it
14	in, and that will be looked at.
15	That's all I have for now. I'll
16	turn it over to Mr. Kotula. And when he's
17	finished we'll attempt to get together a
18	subcontract category list, then we'll wrap it
19	up.
20	MR. KOTULA: I'll just briefly
21	describe the work that we're doing here. This
22	is the park and ride, which is a 248-space
23	park and ride. And the park and ride portion
24	will be pervious concrete. Then we have the



1	entrance off of Route 1 and the exit. This is
2	the bus lane, and the bus alighting area will
3	be coming in this way.
4	We'll have roads that connect to
5	Shady Lane. There will be an exit that is bus
6	only. And then the main entrance for
7	passenger vehicles will be coming in off of
8	Shady Lane, and that's how they will be
9	leaving also. There will be gated roadways
10	for the buses, so passenger vehicles don't
11	utilize those roads.
12	There will be a bathroom
13	facility, shelters for passengers waiting.
14	There is a utility room, which is in the
15	plans, and you can see that. Then throughout
16	there's lighting for the site, and there will
17	be site security requirements.
18	With the parking lot, just note
19	that there are electric car charging stations
20	to be incorporated, and then there's the
21	stormwater management retention areas. The
22	only roadwork outside of the project is along
23	Shady Road.
24	There is a building that needs to



1	be demolished. And there is an existing
2	underground storage tank, an old heating oil
3	tank.
4	When the contract is ready to go
5	into construction, the facility will be fully
6	abated. We've had most of the asbestos
7	removed. There's only some flashing that
8	needs to be taken, very minor work that only
9	involves a day or two of work, so we'll have
10	plenty of time to take care of that.
11	C.G. WARE: Chuck with Kent
12	Construction. Has any soil testing been done
13	around that heating oil tank?
14	MR. KOTULA: No. Not to my
15	knowledge. I would have to go back and
16	revisit it, but I don't believe there was any
17	testing done.
18	C.G. WARE: They had issues out
19	at Pearsons Corner where they were doing work
20	and there was an old gas station there and
21	there was no testing done prior to the work
22	starting, and it caused all kinds of problems.
23	I was just wondering if
24	MR. KOTULA: I would recommend to



1	ask any questions. We had questions on this
2	last time, and I'd much rather go back to my
3	notes to specifically answer them, such as the
4	size, which I don't believe is known, but
5	because it's heating oil, we have an estimate
6	on it.
7	I don't remember any DNREC
8	violations, and I forget offhand if it was
9	even registered with DNREC. So if you could
10	ask the question, I could give you the proper
11	answers.
12	MIKE DAVIS: Mike Davis, Diamond
13	Materials. So removal of the tank is under
14	this contract?
15	MR. KOTULA: Yes.
16	MIKE DAVIS: As part of removal
17	of structures and obstructions?
18	MR. KOTULA: Yes. Now, it's an
19	underground storage tank, so there is the
20	issue of abandoning in place.
21	MIKE DAVIS: The option?
22	MR. KOTULA: Yes.
23	MIKE DAVIS: Second question, why
24	wasn't the contract awarded the first time



1	around?
2	MR. KOTULA: The contract wasn't
3	awarded the first time around. That was a
4	decision that was made that due to the budget
5	that was established for the contract, that it
6	exceeded the budget and we wanted to try to
7	handle it in pieces, as in different phases.
8	And that's what we're going to do. This is
9	the first phase of essentially a very similar
10	project.
11	MR. KOVACS: Any other questions
12	you can think of? Like I said, if not, just
13	send it to us, and we'll get them answered as
14	quick as we can.
15	PETE GERARDI: Pete Gerardi,
16	Gerardi Construction. Is there any fuel in
17	that tank now?
18	MR. KOTULA: I do not I don't
19	remember offhand.
20	MR. KOVACS: Anyone else?
21	MATT TARR: Matt Tarr, Guardian
22	Environmental. Is there a permit required for
23	the building itself, or is it a prefab
24	building?



1	MR. KOTULA: They're prefab
2	buildings.
3	MR. KOVACS: Has everyone signed
4	in? Can you pass that back, sir?
5	Since we're sitting here, do you
6	guys want to come up with a quick list of
7	subcontract categories? I mean, I have a few
8	that we think may be needed such as pervious
9	concrete, plumber, asphalt, electrical,
10	regular concrete. How does that sound?
11	CORKY JACOBI: The only building
12	is that maintenance building, that little
13	shed?
14	MR. KOTULA: The buildings
15	technically are two passenger shelters, a
16	prefabricated bathroom, and a prefabricated
17	utility building.
18	CORKY JACOBI: So what do you
19	need the plumber for?
20	MR. KOTULA: To hook up the
21	you have to get the plumbing in place to the
22	bathroom.
23	CORKY JACOBI: So there's going
24	to be plumbing. You got soil on site?



1 MR. KOTULA: Yes. 2 THE REPORTER: Can I have your 3 name, sir? 4 CORKY JACOBI: Corky Jacobi with The Cobi Group, C-o-b-i. 5 MR. KOVACS: Is there anything 6 7 you want to add or take away or don't care? 8 It's like pulling teeth trying to get 9 subcontractor categories anyway. Like I said, 10 does that sound right to you guys? 11 CORKY JACOBI: Yeah. 12 MR. KOVACS: Everyone is in 13 agreement? The fewer the 14 MIKE DAVIS: Yes. 15 better. 16 MR. KOVACS: All right. So, once 17 again, it's pervious concrete, plumber, 18 asphalt, electrical. I had said concrete, but 19 asphalt pretty much. 20 MR. KOTULA: You have asphalt and 21 Do you want them separated? concrete. I think they would 22 MIKE DAVIS: 23 be two different trades. So those five items. 24 MR. KOVACS:

3	tomorrow afternoon for everyone. That's all I
4	have.
5	Do you have anything else?
6	MR. KOTULA: No.
7	MR. KOVACS: If nobody else has

9	make sure everyone signs in so you're all
10	eligible to submit a bid.
