## **ABOUT MARINE PROTECTED AREAS**

In the ocean, as on land, some places are more important than others. Consequently, coastal societies around the world have chosen to protect these important areas in order to sustain their ecological, cultural and economic benefits for this and future generations. Marine protected areas are special places with long term protection, and have a critical role in America's future. Familiar examples include National Marine Sanctuaries, National Parks, National Wildlife Refuges, and their state, local and tribal counterparts.

#### **MPA CENTER MISSION**

The National Marine Protected Areas Center (MPA Center) was established under Executive Order 13158 (May, 2000) to connect and strengthen the nation's diverse marine protected area programs and to create a National System of Marine Protected Areas. The national system enables MPA programs to increase their impact by working together strategically on shared conservation goals.

## **How WE WORK**

The MPA Center is located within NOAA's Office of National Marine Sanctuaries and works with the Department of Interior to serve as a resource to all federal, state, territorial and tribal programs responsible for the health of the nation's oceans. The MPA Center works in partnership with federal, state, tribal, and local governments and stakeholders to build a National System of Marine Protected Areas, and to support and enhance existing marine protected area programs.





#### **KEY FUNCTIONS**

The MPA Center focuses on three primary functions:

- Building capacity of federal and state marine protected area programs to more effectively manage natural and cultural marine resources.
- Communicating with and engaging stakeholders to help connect marine protected areas to communities.
- Serving as a unique and neutral source of marine protected area-related science, information and tools for coastal and ocean decision-makers.
