Dear Mr. Calkum:

Following are the Wyoming Department of Agriculture (WDA) scoping comments pertaining to the Kemmerer Bureau of Land Management Field Office's (BLM) proposed Allotment Management Plan (AMP) for the Albert Creek Allotment #11202 (Allotment) and associated management plans from the Uinta County Conservation District and Natural Resource Conservation Service (Conservation District).

Our comments are specific to our mission: dedication to the promotion and enhancement of Wyoming's agriculture, natural resources and quality of life. As the proposed project could affect our industry, citizens and natural resources it is important that you continue to inform us of proposed actions and decisions and continue to provide the opportunity to communicate pertinent issues and concerns.

We support incorporating the Conservation District plan as it is complete with goals, objectives and has been developed with the cooperation of the permittee(s). Due to the large size of the Allotment and the intermingling of private, state and federal lands it is important the BLM uses as much on-the-ground knowledge from the permittees and the Conservation District as possible. In the scoping notice, the BLM identifies some key issues, many of which are accounted for with the Conservation District plan. BLM should tier the AMP to the proposed management methods and tools as laid out by the Conservation District plan in conjunction with the permittees.

We do have some concerns regarding the following identified issues:

- Protection of Sage-grouse lekking and nesting habitat. The WDA believes any protection should be determined using the best available science and on-the-ground knowledge regarding recent fluctuations in bird numbers or lek attendance. We strongly suggest the BLM avoid blanket statements or prescriptions pertaining to sage-grouse management on the Allotment. We urge the BLM to make rational decisions on a site-by-site basis and work closely and early with permittees to identify areas for improvement and areas where improvements are unnecessary or unfeasible.
- 2) Impacts from Haystack Mine. In regard to Comment 1 above, BLM should consider impacts from Haystack Mine to Sage-grouse. We strongly urge the BLM to address these possible impacts when considering management strategies pertaining to livestock grazing and insist no changes are made to Animal Unit Months or season of use.
- 3) *Trespass by cattle or sheep from neighboring allotments.* We urge the BLM, and permittees, to resolve any trespass issues in order to properly discern use levels from permitted livestock versus trespass animals. This is especially important to keeping in line with Allotment goals and objectives.
