Good afternoon,

The Q3 2011 ARRA Reporting cycle begins on **October 1, 2011**. Please be sure to review all DUNS and CCR registrations prior to the start of the reporting cycle. Log on to www.CCR.gov soon to review your current registration and update your information, including Points of Contact, as needed.

Note: CCR registration expires and must be renewed. If your registration has expired, you will not be able to report until it is renewed. It takes at least 48 hours for any CCR changes to be reflected on www.FederalReporting.gov, so reviewing your registration ahead of time is key. Please complete this process at least two days prior to the reporting period.
