The District of Columbia, Office of Contracting and Procurement, on behalf of the Department of Behavioral Health (DBH) (District) has a requirement for a Contractor to provide a customizable solution of online databases services covering content, tools, and services – electronic academic journals, full-text articles, instruments and measurements in the area of health sciences and mental health processes for DBH staff. The Contract is required to assure that the Health Sciences Library is equipped with the technological tools that hospital residents, interns, faculty, and DBH staff need to enhance research discovery and improve practice at the hospital and in the community. The specific online access must include a comprehensive suite of the following:

- PsychARTICLES with Full Text
- PsychBOOKS or its equivalent
- PsychINFO or its equivalent
- Health and Psychosocial Instruments
- Ovid HealthStar
- Access to health and psychosocial instruments and the mental measurement yearbook is also required.

2. FAIR AND REASONABLE PRICE:

The Contractor designed and implemented this proprietary product for the Department of Behavioral Health. The Contractor's price is fair and reasonable at a not-to-exceed price of \$24,195.00 as it shall cover the cost of the license for the library. The library is a required facility for the hospital to maintain the psychiatry residency program.
