# Licensing Requirements for Contractors in Louisiana

## Licensing requirements for contractors in Louisiana

#### **Residential License**

Residential construction or home improvement projects exceeding \$75,000 must be bid or performed by a licensed Residental Building Contractor.

Residential subcontractors who bid or perform work in one of the specialty areas listed below must be licensed for that specialty when the work exceeds \$7,500 (including labor and materials) on any new single family residential home, duplex, triplex, or fourplex.

- Residential pile driving
- Residential foundations (Including Forming; Steel Reinforcement Placement; and Concrete Placement and Finishing)
- Residential framing
- Residential roofing
- Residential masonry/stucco
- Residential swimming pools

Subcontractors performing work under any specialty classification above for homeowners who are building their own home must be licensed for that specialty.

#### Applications must include:

- A financial statement showing a minimum of \$10,000 net worth, current within 12 months of application
- Passing score on the Business and Law exam
- Passing score on the trade exam
- Proof of general liability insurance with a minium amount of \$100,000
- Proof of workers' compensation coverage

#### **Commercial License**

Commerical projects with a value of \$50,000 or more must be bid or performed by a properly licensed commercial contractor. Subcontracts with this value must be performed by a properly licensed subcontractor.

#### Exceptions:

- Electrical/Mechanical/Plumbing require a license for projects exceeding \$10,000
- Asbestos, Hazardous Waste, Lead-Based Paint Abatement/Removal, Underground Storage Tanks require a license for projects with a value of one dollar or more

#### Applications must include:

- A financial statement showing a minimum of \$10,000 net worth, current within 12 months of application
- Passing score on the Business and Law exam
- Passing score on the trade exam, if applicable



#### **Home Improvement Registration**

Home improvement projects with a value exceeding \$7,500 but not in excess of \$75,000 must be bid or performed by a home improvement registrant or a licensed contractor.

#### Applications must include:

- Proof of general liability insurance with a minimum amount of \$100,000
- Proof of workers' compensation coverage

#### **Mold Remediation License**

Mold remediation projects with a value of one dollar or more must be bid or performed by a licensed contractor.

#### Applications must include:

- A financial statement showing a minimum of \$10,000 net worth, current within 12 months of application
- Passing score on Business & Law exam
- Completion of 24 hours of approved mold remediation and mold assessment training
- Completion of four hours of instruction in Louisiana's Unfair Trade and Consumer Protection Law
- Proof of general liability insurance with a minimum amount of \$50,000
- Proof of workers' compensation coverage
