CATHERINE BOONE APPOINTED ASSISTANT TREASURER FOR DEBT MANAGEMENT IN STATE TREASURER'S OFFICE

Treasurer Nappier Cites Strong Track Record, Professionalism in Appointment

State Treasurer Denise L. Nappier today appointed Catherine S. Boone of Middletown as Assistant Treasurer for Debt Management.

Nappier said Boone is "a first-rate professional, whose experience, track record and administrative skills" have already contributed significantly to Connecticut's debt issuance program. Connecticut has \$11 billion in debt outstanding. Professional management of those obligations can save Connecticut taxpayers millions of dollars each year. I'm absolutely committed to the highest possible standards of professionalism at the Treasury and that's why I'm delighted to have Cathy Boone heading up this critical function," Nappier continued.

Boone, who has been Deputy Assistant Treasurer since March 1995, has been a member of the Debt Management staff in the State Treasurer's Office since 1991.

As the public finance department of Connecticut state government, the Debt Management Division is responsible for issuing and managing the State's debt in a prudent and cost effective manner. The Division issues bonds to finance capital projects, manages debt service payments and cash flow borrowing, maintains the State's rating agency relationships, administers the Clean Water and Drinking Water loan programs and manages the State's tax-exempt debt compliance with IRS regulations.

There were 10 strong bond sales during 2000 administered through the Division, for a total of \$1.7 billion. The issues provided capital funding for the University of Connecticut, the State University system and Community Technical Colleges, local school construction projects, housing and economic development programs, state roads and bridges, Second injury settlements and a much-needed parking garage at Bradley International Airport.

Among the achievements in the various bond issues were lowered borrowing costs – thus providing savings to taxpayers; a credit upgrade on UConn and Second Injury Fund bonds, and increasing retail participation in General Obligation sales to record numbers.
