

THE CATHOLIC UNIVERSITY OF AMERICA APPLICATION FOR NONDEGREE STATUS

Admission as a nondegree student is limited to a single semester or summer session, unless renewed by the dean of the school for registration in subsequent consecutive semesters or summer sessions. Registration for consecutive semesters will be approved for students completing a certificate program. No fee is charged for such renewal.

Nondegree students who subsequently wish to apply for degree study must file additional application documents and be accepted officially for degree study. Since the mere accumulation of courses will not satisfy degree requirements, one should consult the appropriate dean or department chair before enrolling. A nondegree-seeking student may take up to nine credits, which may be counted toward degree requirements if full acceptance to a degree program is granted.
