Proposed Action Title: (0208-1695) Sustainable Energy Solutions LLC - Cryogenic Carbon Capture (Phase 2)

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Utah; Wyoming

Proposed Action Description:

Funding will support development of a cryogenic carbon capture (CCC) process for separating carbon dioxide from flue gas via desublimation of the flue gas and compression of the resulting solid and liquid products.

Proposed work will consist of (1) design, fabrication/acquisition, and testing of components for the pilot-scale prototype CCC system; (2) integration of the components into a skid-mounted, pilot-scale prototype CCC system; and (3) testing of the skid-mounted, pilot-scale prototype CCC system using actual or simulated flue gas streams.

Sustainable Energy Solution LLC (SES) will carry out the proposed design, fabrication/acquisition, and testing of components and integration of the components into a prototype CCC system at its laboratory facilities in Orem, Utah. SES plans to carry out the testing (i.e., proof-of-concept) of the prototype CCC system using actual flue gas streams at the Intermountain Power Project (IPP) plant in Delta, Utah, the Jim Bridger power plant in Point of Rocks, Wyoming, or at a smaller scale fossil fuel-fired power plant located nears its facilities in Orem, Utah. If testing at a commercial location is not possible, SES plans to test the prototype CCC system using simulated flue gas streams at the BYU campus in Provo, Utah.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.


