American Recovery and Reinvestment Act:

Funding will support laboratory research, design, testing and fabrication of a nano-engineered, membrane-based liquid desiccant with a vapor compression cycle air conditioner for warm and humid climates that will realize substantially higher efficiency percentages than the existing state of the art. The proposed work is consistent with the goal of BEETIT: to develop energy-efficient building cooling technologies that will reduce energy consumption and GHG emissions.

Proposed work consists entirely of RD&D work to be completed in laboratory and testing facilities located at UTRC's Corporate Research Center (East Hartford, CT) and two manufacturing and testing facilities of Pall Corporation (Cortland, NY; Port Washington, NY). The work performed will be limited to on-site research, design, development, testing, and evaluation.
